An Act to incorporate the Klondike and Dawson  
City Bank.

**W**HEREAS the persons hereinafter named have, by their <sup>Preamble.</sup>  
petition, prayed that it be enacted as hereinafter set  
forth, and it is expedient to grant the prayer of the said  
petition: Therefore Her Majesty, by and with the advice and  
5 consent of the Senate and House of Commons of Canada,  
enacts as follows :—

**1.** John Morris Catton, of the city of London, England, <sup>Incorporation.</sup>  
Charles Thomas Dupont, Leopold J. Boscowitz, David A.  
Boscowitz and Newton Spicer, all of the city of Victoria, in the  
10 province of British Columbia, together with such persons as  
become shareholders in the corporation, are hereby incorpor-  
ated under the name of "The Klondike and Dawson City  
Bank," hereinafter called "the Bank."

**2.** The head office of the Bank shall be in the city of <sup>Head office.</sup>  
15 London, England.

**3.** The persons named in section 1 of this Act are hereby <sup>Provisional directors.</sup>  
constituted provisional directors of the Bank.

**4.** The capital stock of the Bank shall be five hundred <sup>Capital stock.</sup>  
thousand dollars.

**5.** This Act shall, subject to the provisions of section 16 of <sup>Duration of Act.</sup>  
20 *The Bank Act*, remain in force until the first day of July, one  
thousand nine hundred and one.
