BILL.

An Act to authorize the Courts of Common Law and Equity in Upper Canada, in their discretion, to admit D'Alton McCarthy to practise as an Attorney and Solicitor therein.

WHEREAS D'Alton McCarthy, of the town of Barrie, in the county of Simcoe, in Upper Canada, gentleman, hath by his petition truly set forth, that he hath been duly admitted and hath practised for 5 some years as an Attorney and Solicitor in the Courts of Common Law and Equity in Dublin, Ireland, and hath prayed that the Courts of Common Law and Equity in Upper Canada may be authorised, in their discretion, to admit him to practise the law as an Attorney and Solicitor 10 therein, and it is expedient to grant the prayer of his petition: Be it therefore enacted, &c.

That it shall and may be lawful for the Courts of Queen's Bench and of Common Pleas for Upper Canada, in their discretion, to admit the said D'Alton McCarthy as an attorney of the said Courts respectively, and for the Court of Chancery for Upper Canada, in its discretion, to admit him to practise as a solicitor in the said Court, any law or usage to the contrary notwithstanding.
