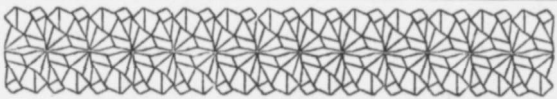



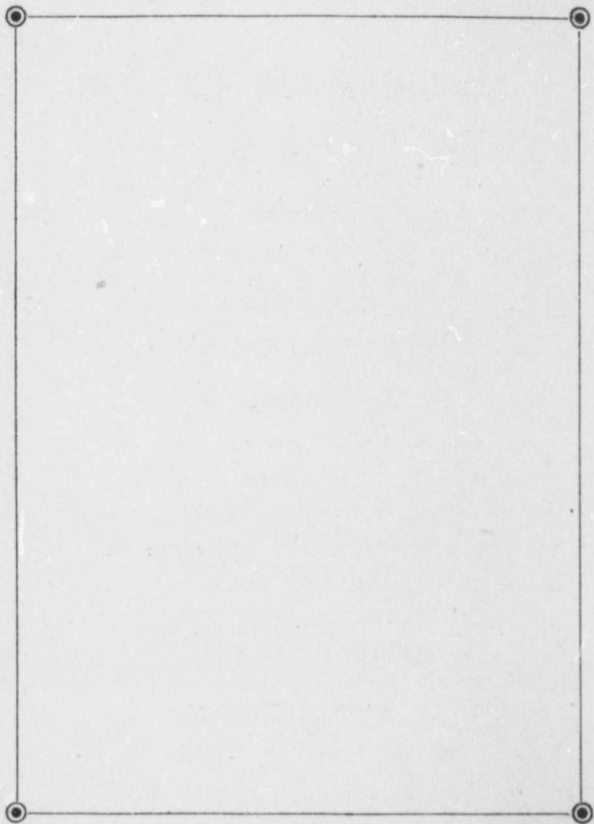

RULES



I. NAME.

The name of the Club shall be the
"VICTORIA HUNT CLUB."

II. OBJECT.

The objects of the Club are for
cross country riding and steeple-
chasing.

III. OFFICERS.

The Officers of the Club shall consist of a President, Vice-President and Secretary-Treasurer, who shall be elected at the Annual General Meeting in each year.

IV. COMMITTEE.

There shall be a Committee of Management who shall have full powers, and shall consist of the Officers and Seven Members who shall be elected at the Annual General Meeting.

Four to form a quorum.

In the event of vacancies occurring after any such annual election the remaining Members of the Committee shall have the power to select other Members of the Club to fill such vacancies.

The Committee shall have the sole management of the affairs of the Club, the power of making and altering the Rules, and of electing Members.

The decision of the Committee in

all disputes and matters referred to them shall be final.

V. MEMBERSHIP.

The membership shall consist of Riding, Non-Riding and Non-Resident Members.

No one shall be considered a Non-Resident Member who resides within 20 miles of Victoria.

VI. SUBSCRIPTION.

The Annual Subscription for Riding Members shall be Ten Dollars (\$10), for Non-Riding and Non-Resident

Members Five Dollars (\$5), payable on election in case of new Members.

VII. PAYMENTS.

Subscriptions are payable in advance, on the First day of October in each year.

VIII. ELECTION OF MEMBERS.

A candidate for election must be proposed and seconded by Members of the Club, who shall send his name and address to the Secretary-Treasurer in writing. The proposer of a candidate shall be liable for his

Entrance Fee and first year's Subscription if not paid within the year.

IX. HONORARY MEMBERS.

Officers of the Royal Navy and Army not permanently stationed at Victoria shall be considered Honorary Members and allowed all privileges of the Club, without payment of subscription; except the privilege of speaking and voting at Meetings, and riding and entering a horse at Race Meetings.

X. QUORUM.

The quorum at a General Meeting shall be not less than ten Members.

XI. EXTRAORDINARY GENERAL MEETINGS.

The Committee may call an Extraordinary General Meeting when any matter of importance shall occur, and shall be bound to do so on receiving a requisition signed by ten Members of the Club.
