



REPORT OF THE SPECIAL COMMITTEE APPOINTED TO REVISE AND CONSOLIDATE THE BY-LAWS OF THE COUNTY OF OXFORD.

To the Warden and Members of the Council of the County of Oxford:

GENTLEMEN,

Your Committee, appointed to revise and consolidate the By-laws of this county, beg to report as follows:

1. That they have carefully examined all the By-laws of the County and find first, respecting By-laws in force on the date of the last revision and consolidation of the County By-laws, viz., 8th June, 1889.

- 4. That By-laws numbered 386 and 395 are in force only as to clauses 3, 4 and 5 respectively at this date.

To provide for the purchase of Assessors' and Collectors' Rolls and Notices for the Minor Municipalities, and also for the purchase of stationery and stationers' supplies for the County Officers and other purposes.

WHEREAS, it is necessary and expedient to restrain and prevent the practice of immoderate riding and driving of herses or other animals upon the highways of this County, and to regulate the travelling thereon, therefore the Corporation of the County of Oxford, by the Council thereof, enacts as follows:

1st.—That from and after the passage of this By-law it shall not be lawful for any person to engage in or pursue the practice of racing, with horses or other animals, either by riding or driving in running or trotting races on any of the highways in the County of Oxford; and any person guilty of riding or driving any horse or horses, or other animals, in a race, whether the same be by running or trotting, upon any of the highways in the County of Oxford, shall, upon conviction thereof, incur the penalties imposed by this By-Law.

2nd.—That no person shall drive furiously any horse or other animal, or shout, or use any blasphemous or indecent language upon any highway; and in case any person so drives, or shouts, or uses blasphemous or indecent language, he shall incur the penalties imposed by this By-Law.

3rd.—That every person travelling upon any highway in the said County of Oxford with a sleigh or sled, drawn by horse or mule, shall have at least two bells attached to the harness.

6th.—That in case of one vehicle being met or overtaken by another upon any of the highways in the said County of Oxford, if by reason of the extreme weight of the load on either of the vehicles so meeting, or on the vehicle so overtaken, the driver finds it impracticable to turn out as aforesaid, he shall immediately stop, and if necessary for the safety of the other vehicle, and if required so to do, he shall assist the person in charge thereof to pass without damage.

7th.—That in case any person in charge of a vehicle or of a horse or other animal used as the means of conveyance or travelling, or being on any highway as aforesaid, be through drunkenness unable to ride or drive the same with safety to other persons travelling on or being on the highway, he shall incur the penalties imposed by this By-law.

8th.—That it shall not be lawful for any person to ride or drive any horse or horses or other animal through any body of men assembled on the highways of the said County of Oxford at a faster rate than a walk, under the penalty imposed by this By-law.

9th.—That if any person contravenes this By-law, or any part thereof, and such contravention be duly proved by the oath of one creditable witness before any Justice of the Peace having jurisdiction within the locality where the offence has been committed, the offender shall incur a penalty of not less than one dollar, nor more than twenty dollars, in the discretion of the Justice, with costs.

10th.—That if not paid forthwith, the penalty and costs shall be levied by distress and sale of the goods and chattels of the offender, under a warrant signed and sealed by the convicting Justice; and the overplus, if any, after deducting the penalty and costs and charges of sale, shall be returned on demand to the owner of such goods and chattels.

11th.—That in default of payment or distress, the offender shall, by warrant signed and sealed as aforesaid, be imprisoned in the Common Gaol of the County of Oxford for a period of not less than one day and not more than twenty days, at the discretion of the Justice, unless such fine, costs and charges be sooner paid.

12th.—That every fine collected under this By-law shall be paid to the Treasurer of the local municipality or place in which the offence was committed, and shall be applied to the general purposes thereof.

And be it further enacted that if any person or persons shall wilfully or maliciously commit any damage or injury to or upon any of this timber, stones or other materials growing, lying or being upon any of the County Roads in this County, shall be prosecuted, and upon conviction before any Justice or Justices of the Peace, acting within this County, shall forfeit and pay such sum or sums of money, not exceeding fifty dollars, as shall appear to such Justice or Justices to be a reasonable compensation for the damage committed, and in default of payment to be levied by distress-warrant under the hand and seal of the said Justice or Justices upon the goods and chattels of the offender, and in default of sufficient goods and chattels said offender shall be confined in the Common Gaol with or without hard labor for any term not exceeding twenty-one days.

Be it further enacted that if any two or more adjoining Municipalities deem it expedient for the better maintenance of the roads and bridges, they may direct the application of statute labor thereon as well as such other monies as they may from time to time have at their disposal.

Be it further enacted that the Reeves of said adjoining Municipalities be, and they are hereby authorized and empowered to sell any

timber, stones, gravel or other materials growing, lying or being on any allowance for road between said Municipalities, to expend the proceeds thereof in the improvement of said roads.

And be it further enacted that all persons rated on the Assessment Rolls, or otherwise liable to perform statute labor, residing on lots adjoining any County Roads dividing any two Municipalities within the County, or on County lines adjoining other Counties, although such roads may deviate so as in some places to be wholly or in part within one Municipality, shall perform their statute labor on such County Roads or pay a commutation of money in lieu thereof; provided, however, that such persons residing on corner lots adjoining side lines may, under direction of the Reeves, perform statute labor on said side lines or pay a commutation of money therefor, and that such statute labor or commutation money shall be performed or expended on said County roads and bridges whenever and in whatever manner the Councils of such Municipalities shall through their proper officers direct.

4th.—That he shall deposit to the credit of this County all sums of money, from whatever source received by him as such Treasurer, in the agency of the Canadian Bank of Commerce in Woodstock, or such other Bank as may hereafter be directed by resolution or By-law of this Council, and all monies payable by this County for any purpose whatever shall be paid by cheque signed by him as Treasurer of the County of Oxford, and that no account or part of an account, not authorized to be paid by the Statutes of Ontario, shall be paid by him, unless it shall first have been audited, or otherwise examined or authorized by the County Council or County Board of Audit.

5th.—That he shall in everything, not contrary to law, obey the directions of the County Council.

6th.—That the books of accounts and the bank account of the County Treasurer shall be open at all times to the inspection of the County Auditors, or any other person or persons duly authorized by the County Council to inspect the same.

- 2. That the amount of the existing debentures debt of the Municipality of the County of Oxford now is the sum of \$207,300 and that none of the principal or interest thereon is in arrear.
- 3. That there is on hand and invested in a sinking fund money amounting to the sum of \$181,818 for the purpose of paying the said sum of \$207,300 of the existing debenture indebtedness of the County of Oxford.

And whereas, it is desirable and necessary that the sum of \$155,000, for which debentures are to be issued under the authority of this By-law, should be repaid in twenty years from the day on which this By-law takes effect, together with interest thereon at the rate of four cent. per annum, the same to be payable by annual instalments during the twenty years next ensuing after the date of this By-law coming into effect,

And whereas, the total amount to be raised annually by special rate for the payment of interest on the said sum of \$155,000 is the sum hereinafter set forth.

And the total amount to be raised annually for the payment of the principal of the said sum is the sum hereinafter set forth.

The whole of the money to be raised annually for the payment of the principal and interest during the said period of twenty years being the sum of \$11,405.17

That the County Auditors, at the time of making their annual Financial Report, shall also report any irregularity or illegal expenditure of the County money, or any other matter or thing in connection with the performance of their official duties, which, in their judgment, it is important and right that this Council should be made
- 3. That the members of the Board of Audit, appointed by this Council shall from time to time, as opportunity offers, report in writing in more or less condensed, but intelligible form, the classes of accounts paid by them, the amounts thereof, and as far as practicable, to whom paid, and they shall at the same time report any matter or thing in connection with the performance of their duties as members of the Board of Audit, which, it is in their judgment, important and right that this Council should be made aware of.

- 3. The County Treasurer shall advise the Treasurers of the several Minor Municipalities the bank in which the County Account is kept, and shall also give immediate notice to the said Treasurers of the removal of the said account whenever made to any other bank.

- 5. The County of Oxford Current Account shall only show upon its credit side transfers of moneys from the County of Oxford Special Account to be made from time to time as the needs of the County may demand.

The bank in which the moneys of the County are deposited, and in which the County Account is kept, is hereby directed to reduce the amount at the credit of the County of Oxford Special Account only by transferring from time to time to the credit of the County of Oxford Current Account such amounts not exceeding at any one time Five Thousand Dollars, as may be necessary to meet the current expenses of the County, and the said transfers shall only be made upon the written order of the County Treasurer, countersigned by the Warden of the County and the County Clerk.
- 7. That the Bank in which the moneys of the County are deposited, and in which the County Account is kept, is hereby authorized to pay upon the written order of the County Treasurer any moneys at the credit of the County of Oxford Current Account from

time to time as he may require them to meet the current expenses of the County.

BY-LAW NO. 419.

Of the Municipal Council of the Corporation of the County of Oxford, to Authorize the Purchase of Assessors' and Collectors' Rolls and Notices, Printed Blanks and Forms for the Magistrates of the County and Others, and Stationery and Stationers' Supplies for the County Officers.

WHEREAS, it is advisable to continue the practice for many years followed by this Council to purchase the Assessors' and Collectors' Rolls and Assessment Notices required by the Minor Municipalities, and

Whereas, it is also advisable to provide printed blanks and forms required by Magistrates and others within the County, and

WHEREAS, it is necessary to purchase and supply all proper and necessary stationery and stationer's supplies for the use of the County officers and for the departmental examinations held within the County,

The Municipal Council of the Corporation of the County of Oxford therefore enacts as follows:

- 1. That the County Clerk is hereby authorized and directed to purchase where most convenient and on the most advantageous terms the Assessors' Rolls, Collectors' Rolls, Assessment Notices, Assessors' Guides and other blanks required by the Minor Municipalities of the County, (Woodstock excepted), in accordance with the Assessment Act, and to distribute the same to the Clerks of the several Municipalities not later than the 1st day of February in each year, or as directed by this Council.
- 2. That the Town of Woodstock be paid annually by the County Treasurer. (who is hereby instructed to pay the same) the sum of Twelve Pollars in lieu of Assessors' and Collectors' Rolls and Notices which they have expressed the desire to order for the use of their Municipality themselves.
 - 3. That printed blanks for the use of the Magistrates of the

County and all printed forms which it is the duty or custom of the County to supply to Magistrates or others shall be ordered by the County Clerk from the County Printer (whenever practicable), in such quantities as he may judge necessary from time to tune, and shall by him be supplied to the Magistrates of the County or others requiring the same on receipt of either written or verbal requisition.

- 4. That all necessary and proper stationery and stationers' supplies required for the use of County officers in their official work, and also for the departmental examinations held within the County shall be purchased by the County Clerk where most convenient and on the most advantageous terms from time to time by tender or otherwise as he muy judge best, and he shall store the same in his office and distribute from time to time as requisition, either written or verbal, is made upon him to the following officers: The County Treasurer, the Public School Inspector, the County Gaoler, the Manager or Inspector of the House of Refuge, and the Inspector of Public Schools or one of the examiners in connection with the departmental examinations.
- 5. That all bound blank books required for the use of the County, and which the Council of the County are compelled by law to pay for, shall be purchased by the officers requiring the same to the best advantage, and the accounts for the said books shall in each case be certified by the officer ordering or purchasing the same as correct, and presented to this Council for audit and payment.
- 6. That no stationery or stationers' supplies of any description shall be purchased or ordered upon the credit of the County by any person other than the County Clerk, and this Council will not be responsible and will not pay for any of the articles or goods referred to in this By-law unless obtained in the manner herein directed.

WHEREAS, it is expedient and necessary to provide for the Maintenance, Superintendence, Care and Management of the Industrial Farm and House of Refuge, and to define the duties of the Officers in connection therewith.

The Municipal Council of the Corporation of the County of Oxford, therefore enacts as follows:

- 1. That a Committee composed of three members of this Council, to be called the Standing Committee on Industrial Farm and House of Refuge, shall be appointed at the January session of this Council in each and every year, whose duty it shall be,
- A. To obey all instructions from time to time given by this Council, whether by By-law, Report or Resolution.
- B. To direct and oversee the Management of the Industrial Farm and House of Refuge.
- C. To have under their control and supervision all matters and things relating to and connected with the Care, Management, Support and Employment of all Inmates.
- D. To authorize the Purchase of all Supplies and the Employment of all Help.
- E. To Examine and Audit not less frequently than once in each quarter all Accounts and Claims in connection with the Industrial Farm and House of Refuge.
- F. To report fully to this Council upon all matters connected with the management at their regular sessions of Council in June and December in each and every year.

To report in detail at the June session of the Council in each year their estimates of the amount of money required to be raised for the ensuing year for the Maintenance and Care of the Industrial Farm and House of Refuge, said Report to be in the Clerk's hands upon the first day of the said session, if possible, but in no case later than the second day.
- 2. That persons shall be received by the Manager as inmates of the House of Refuge, only,
- A. Upon the written order of one of the members of the County
- B. On the receipt of a properly certified copy of a Resolution passed by the Council of one of the Minor Municipalties of the County.
- C. Upon receiving a certified copy of a Resolution of this Council or of the Standing Committee of the Industrial Farm and House of Refuge.
- D. Upon the joint written order of the Inspector and Chairman of the Standing Committee.
 - E. When born upon the premises.
- 3. It shall be the duty of the Standing Committee and the officers of the institution to obey as rigidly as practicable the provisions of S. S. 3, S. 15 of the Act for the prevention of cruelty to and better protection of children, and those to whom the privilege of commitment is granted by this By-law are hereby cautioned against the commitment of children between the ages of two and sixteen years to the House of Refuge.
- 4. All expenses in connection with commitments under S. S. B. of section 2 shall be borne by the municipality from which the commitment is made, and all expenses in connection with commitments under remaining S. Ss. Section 2 shall be borne by the County.
- 5. That the Inspector of the House of Refuge and the Chairman of the Standing Committee, acting jointly, may, if in their judg-

ment the circumstances of any case presented to them would warrant their action, make a commitment subject to ratification by the Standing Committee at their first ensuing meeting.

- 6. That the Standing Committee may authorize by resolution the retention of inmates so committed jointly by the Inspector and Chairman, or they may authorize the reception of others by the Manager, subject, however, in both cases to ratification by this Council at their first ensuing meeting.
- 7. That one year's continuous residence within the County immediately prior to application for admission to the House of Refuge shall constitute a claim for commitment, should the applicant be otherwise a suitable inmate, and one year's continuous absence from the County immediately prior to application for admission shall destroy all claim for commitment, but the Standing Committee or this Council may at any time consider the circumstances and particulars of any application made for admission and take such action upon the same as they may determine.
- 8. The cost of maintenance and keep of all inmates regularly committed under this By-law, unless other arrangements have been made, shall be borne by the County.
 - 9. It shall be the duty of the Inspector

To act as Secretary of the Standing Committee.

To visit the Industrial Farm and House of Refuge at least once in two weeks.

To see that all rules and regulations are duly enforced.

To hear all complaints made by inmates or others.

To report all complaints, direliction of duty and insubordination to the Committee or Council, as he may think best.

 - D. A. Cash Book showing all receipts and expenditures.
- E. A Ledger which shall properly separate in its accounts under headings authorized by the Standing Committee all receipts and expenditures.

To report to this Council at their January session in each and every year for the year ending on 31st December of the previous year a full detailed statement of the affairs of the Industrial Farm and House of Refuge in form of Schedules approved by Standing Committee.

To check the inventory of personal property and value of produce on hand on the 31st December in each and report the same to this Council at the time of making his Annual Report.

10. It shall be the duty of the Manager

To receive as inmates of the House of Refuge only such persons as are committed in accordance with this By-law.

To examine all persons received, note such facts as are important to be preserved, cause them to be thoroughly cleansed and suitably located, having reference to their age, sex and character, treating with considerate care and kindness all children and sick and infirm inmates.

To Superintend the Management and Care of the Industrial Farm and House of Refuge, and to devote his time to such work upon the Farm as the requirements of the several seasons of the year demand and generally to give his attention, energy and time to the benefit of

the Institution and to the carrying into effect all the rules and regulations from time to time adopted by the Council or authorized by the Standing Committee.

To see that all provisins and general supplies are good in quality, and also according to contract as regards quantity and price.

To see that the provisions furnished to the inmates are good, properly cooked and sufficient, and that no waste thereof is at any time permitted.

To prohibit carefully all use of intoxicating drinks upon the premises and promptly to report to the Inspector and Committee the names of any person or persons discovered by him to have brought upon the premises any intoxicating drinks of any description.

To see that every part of the premises and all furniture and utensils are kept neat and clean and in order, and that all provisions, fuel, implements, clothing, and every other article or thing consumed or used upon the premises are used with the strictest care and economy.

To be upon the premises and on duty at all times when not authorized by the Committee or permitted by the Inspector to be absent. He must, however, always make suitable and ample provision for the care and proper government of the inmates and premises during his absence.

To report regularly to each meeting of the Committee the probable needs of the Institution until the next ensuing meeting of the Committee.

To report the death of any inmate immediately and by the quickest available method of communication to one (or both if practicable) of the representatives of the County Council Division from which he was committed or to the head of the Municipality if committed by resolution of a local Municipal Council, or to the Chairman of the Committee if received by resolution of Committee or Council, and in any case to the Inspector, and also to the nearest known relative.

To grant, as far as possible, in accordance with the law and directions of the Council and Committee, the wish of the friends of the deceased as regards the disposition of the body, provided all expenses are being borne by the friends of the deceased.

To secure for his future guidance such particulars regarding each

Of sales of all stock and surplus products, and of all monies paid or received from whatever source in connection with the Industrial Farm and House of Refuge.

To purchase under the direction of the Inspector or under resolution of the Committee, provisions or other necessaries required for the Institution.

To report to this Council at their June and December sessions in each and every year the names of all persons who have died in the House of Refuge, where they were committed from and what disposition was made of the body together with such other particulars in connection therewith as may be deemed important.

To obey the law of the Province respecting the registration of all deaths upon the premises.

To obtain an invoice or bill of all purchases made for the Institution, and in cases of sales to give an invoice or bill and obtain where possible the initials of the purchaser either upon a duplicate or upon the counterfoil of the bill or invoice.

To inflict suitable punishment at his discretion for disobedience or bad conduct by any of the inmates, but no improper means are to be employed and not more than twenty-four hours confinement to be inflicted unless by direction of the Inspector.

To keep the following books:

A. A Blotter in which he shall enter a full particularized memorandum of all purchases and sales, and from which the Inspector may be able to make the proper entries in his Cash Book.

B. A Petty Cash Book in which are to be entered all his re-

ceipts and payments as they occur to be balanced at the close of each month, also for the Inspector's use,

- C. A Book in which he shall keep a particularized memorandum of the employment each day of each inmate.
- D. A Book in which he shall enter the particulars of the products and also of the live stock of the Farm.
- E. A Book in which he shall keep a correct and particular account of each and every article of wearing apparel issued to the inmates and also a complete and regularly corrected inventory of all personal property in and about the Industrial Farm and House of Refuge; especially shall this be done with everything properly valued up to the 31st December in each year.
- F. A Book in which all parties visiting the House of Refuge shall be invited to enter their names with any remarks or comments they may see fit to make.
 - 11. It shall be the duty of the Matron

To do, superintend, take charge of, and generally direct all indoor work.

To see that all children and female inmates are provided for according to their respective needs.

To detail all inmates under her charge to such work as in her judgment they are best fitted to perform.

To see that cleanliness and order is preserved, both as regards persons and apartments.

To see that at proper and seasonable times the clothing of all inmates and all bedclothes are kept in a state of good repair and changed and replaced with clean apparel.

To prevent and prohibit all waste and to enforce the strictest care and economy in the use of everything furnished by the County for the use of the Institution.

To superintend and direct the sanitary condition of the premises.

To visit the House of Refuge at least once in each week, and in cases of sickness whenever called upon by the Manager or Inspector.

To attend and prescribe, supply at his own expense and prepare medicines for all cases of sickness and surgery that may occur and generally to have the charge of the health of all the inmates, including the Managar and Matron and the Servants of the Institution.

To examine and report to the Manager or Inspector when called on all cases of inmates supposed by them or either of them to be feigning sickness or otherwise as to their ability to work.

To report to the June and December Sessions of Council in each year all Births, the number and causes of Deaths, cases of sickness, nature of sickness, number of visits made, sanitary condition of the Institution, and such other particulars as may in his judgment be important.

To enter in books, provided for the purpose, all cases treated by him, and the medicines prescribed in each case.

All Deaths and the cause in each case to be properly certified by his signature, all births within the House of Refuge.

- 13. The Standing Committee shall meet once in each month in the office in the House of Refuge for the transaction of all business in connection with the Institution. A special meeting may be called at any time by the Inspector, or he may ask for consultation with the Chairman of the Committee.
- 14. All accounts or claims for supplies or services rendered in connection with the Industrial Farm and House of Refuge shall be certified as correct by the Manager or Inspector, and shall at the first ensuing meeting of the Committee be presented for audit and payment and the County Treasurer is hereby authorized to pay upon the order of the Chairman of the Standing Committee all accounts or claims which are certified by the Inspector as having been passed by the Committee.
- 15. The County Treasurer shall keep in his books the two following accounts, viz.:

- A. House of Refuge Capital Account.
- B. House of Refuge Expense Account.

The Capital Account shall include

- (1) The cost of land.
- (2) The cost of all permanent improvements.
- (3) The cost of buildings.
- (4) The cost of furniture, implements and plants generally.
- (5) Such expenditure as may from time to time be added by resolution of Council and shall be credited with such deductions as may from time to time, on account of wear and tear, death or loss, be ordered by resolution of Council.

The Expense Account shall include,

- (1) All Expenditures for Salaries, Wages, and Committee Expenses.
- (2) All Expenditures for Food, Clothing, Light, Fuel, Stationery and Sundries.
- (3) All Expenditures for Maintenance, which are not directed by resolution of Council to be added to Capital Account.
- (4) An amount equal to four per cent. annually of the Capital Account.
- (5) Such an amount on account of wear and tear, death or loss, by depreciation or otherwise, as may from time to time be transferred by resolution of Council from Capital Account and shall be credited with all moneys received from hiring of help, sales of goods, donations or gifts or from any and every source other than advances by Council or moneys properly belonging to Capital Account.
- 16. That a correct account shall be kept by the Manager of the number of weeks each inmate is maintained and kept in the House of Refuge, and the cost for maintenance per week per inmate shall be ascertained, and the Inspector shall make a return of the same in his Report to the Council each year.

- 17. That the Committee shall at least once in each year make a report to the Council upon the state of the House of Refuge Capital Account, making such recommendations as regards increases and deductions as they may deem expedient and just.
- 18. That after all the entries upon debit and credit sides of the House of Refuge Expense account have been made for the year, and balance remaining upon the debit side thereof shall be by the Treasurer conveyed to the debit side of the County General Account.
- 19. That sufficient ground in some suitable part of the Farm shall be set apart for a Burial Ground, to be fenced in neatly and planted with trees and otherwise beautified, properly laid out in tiers or rows and the graves plainly numbered. A plan of the ground shall also be made and kept together with a proper register of the burials in the office of the Insspector.
- 20. That any child from the House of Refuge may be hound out as an apprentice to any lawful trade, calling or profession, employment or service on the following conditions:
- (1) That the moral character and repute of the person to whom the child is to be bound out is good.
- (2) That if the Inspector so determines, the child may be taken out for a time on trial.
- (3) That the child is apprenticed or bound out in conformity with the law governing in the case.
- (4) That provision is made for the proper education of the child and for its proper keep.
- (5) That at the expiration of the apprenticeship or service he or she shall at least be furnished with a new outfit of good and comfortable clothing.
- 21. That the right at any time, for continued bad conduct, depraved character, contagious diseases, or for any other cause which appears to them as sufficient reason, is reserved to this Council or their Standing Committee to summarily discharge any inmate, or they may before doing so, if they so determine, correspond with the representatives of the Division from which he was received, or the head of the Municipal Council by whom committed, and the liability for the ex-

- 22. That all books directed to be used under this By-law shall be purchased by the Inspector or Manager under the direction of the Standing Committee. All stationery required for the use of the Institution shall be obtained by requisition from the County Clerk in the usual way, and all Schedules and Forms authorized by this By-law shall be prepared by the Inspector and approved by the Standing Committee before being printed, and all printing and advertising of whatever description shall be done at contract prices by the County Printer.
 - 23. That the following Rules shall govern the inmates:
- (1) Every person admitted must be thoroughly cleansed by bath, his hair cut short and properly clothed with clothing provided by the County, if clothing in addition to his possession is necessary.
- (2) All inmates who are able shall arise at 6 o'clock a. m. during the months of April, May, June, July, August and September, and at 7 o'clock a. m. during the remaining months of the year.
- (3) All inmates who are able shall work at whatever work is assigned to them by the Manager or Matron, and shall faithfully in all things obey their directions.
- (4) No inmate shall leave the premises without permission from the Manager, who shall in every case fix the hour at which he or she is to return.
- (5) Inmates are to be allowed to attend their several places of worship on Sunday, but they shall return immediately after the service, unless permission for a longer absence has been given by the Manager.
- (6) All inmates shall take the places assigned them at the table for meals, shall always present themselves with clean faces and hands and hair properly combed, and shall while at table observe good order.
- (7) No profane, obscene or improper language or immoral conduct shall be permitted on the premises.
- (8) No spirituous or malt liquors of any description shall be allowed on the premises.

(9) All Inmates shall be within the building at 7 o'clock p. m. and shall retire not later than 9 o'clock, p. m. during the Summer months and 8:30 o'clock p. m. during the Winter months.

- (10) No inmates shall trade or exchange clothing or any other thing with any person whomsoever or beg from or receive any money or other articles from visitors or travellers without the Manager's consent.
- (11) Any inmate guilty of drunkenness, disobedience, immorality, obscenity, dorderly conduct, profane or indecorous language, theft, waste, absence from the premises without leave, injuring or defacing any part of the building or furniture, or destroying, damaging or wasting any of the County's property, shall be punished as the case may seem to demand.
- (12) No conversation except as directed by the Inspector or Manager, shall be held with inmates in confinement, and the food of such shall consist of bread and water only, unless otherwise ordered by the Inspector or Surgeon, and any inmate who shall disobey this rule shall be subject to a like punishment.
- (13) The Sabbath Day shall be strictly observed, and no irreligious diversion or unnecessary labor indulged in, and during any religious service which may be held in the House no noise or disturbance shall be made in any part of the building or grounds.
- 14. Any inmate who feels agrieved may prefer his complaints to the Inspector or to any member of the Committee.
- (15) Any rules or regulations made for the orderly conduct of the inmates by the Manager, with the approval of the Inspector and not in opposition to the above rules shall be obeyed by the inmates until amended, supplemented or withdrawn by the order of the Standing Committee or Council.






BY-LAW No. 422.

Of the Municipal Council of the Corporation of the Courty of Oxford to Consolidate and Repeal By-Laws Numbered 357, 379, 398 and 399 of this County and to Provide for the Salaries and the Payment Thereof of the Saveral Officers in Connection with the Industrial Farm and House of Refuge.

Whereas, it is at times desirable and necessary for this Council to impose executive work upon officers, Commistees and individuals, and

WHREAS, it is necessary to fix the salaries of the several officers in connection with the Industrial Farm and House of Refuge, and to provide for the payment thereof,

The Municipal Council of the Corporation of the County of Oxford, therefore, enacts as follows:

- 1. That the Inspector of the Industrial Farm and House of Refuge shall be paid an Annual Salary of One Hundred Dollars.
- 2. That the Manager and Matron thereof shall be paid jointly an Annual Salary of Four Hundred Dollars.
- 3. That the Matron shall in addition to the above salary be paid an extra allowance annually of One Hundred Dollars.
- 4. That the Surgeon of the House of Refuge shall be paid an Annual Salary of Two Hundred and Fifty Dollars, which shall be for his professional services in addition to the supply of all medicines at his own expense that are required for the Institution.
- 5. That it shall be the duty of the Treasurer to pay the salaries mentioned in this By-law upon the application of the parties to whom the same are payable quarterly, and this By-law shall be the Treasurer's sufficient authority for such payments.
- 6. That By-laws numbered 357, 379, 398 and 399, and all or any By-law or clauses of By-laws inconsistent with the provisions of this By-law are hereby repealed.

BY-LAW NO. 423.

Of the Municipal Council of the Corporation of the County of Oxford to Provide for the Licensing, Regulating and Governing of Auctioneers and Hawkers, Pedlers or Petty Chapmen Within the County of Oxford and to Repeal By-law No. 321 of this County.

WHEREAS, power is granted by Sec. 495-553 of the Consolidated Municipal Act, 1892, of Ontario to Counties to pass By-laws for Licensing, Regulating and Governing Auctioneers and Hawkers, Pedlars or Petty Chapmen and to fix the sum to be paid for such license and the time every such license shall remain in force, and

WHEREAS, it is expedient to pass a By-law for these purposes and to repeal By-law No. 321 of the County of Oxford.

The Municipal Council of the Coporation of the County of Oxford therefore enacts as follows:

1. That from and after the passing of this By-law it shall not be lawful for any person to act as auctioneer or sell or put up for sale any goods, wares, merchandise or effects by public auction within the County of Oxford, nor shall it be lawful for any person to carry on the business of Hawker, Pedlar or Petty Chapman or to go from place to place or to other men's houses on foot or with any animal bearing or drawing any goods, wares or merchandise for sale within the County of Oxford without having first purchased and obtained a license to exercise his calling of Auctioneer, Hawker, Pedlar or Petty Chapman, provided always that this By-law shall not apply to or effect a bailift offering for sale goods or chattele seized as a distress for rent, and such bailiff shall not require any license to entitle him to sell such distrained goods or chattels by public auction to satisfy such rent and the cost of seizure and sale, previded also that no such license shall be required for hawking, peddling or selling from any vehicle or other conveyance any goods, wares or merchandise to any retail dealer, or for hawking or peddling any goods, wares or merchandise, the growth, produce or manufacture of the Province of Ontario, not being liquors within the meaning of the law relating to Tayerns or Tayern Licenses, if the same are being hawked or peddled by the manufacturer or producer of such goods, wares or merchandise or his bone fide servants or

employees having written authority in that behalf, and any such servant or employee shall produce and exhibit his written authority when required so to do by any Municipal or Peace officer, provided also that no such license shall be required by any colporteur or person engaged in sale of Bibles or Testaments only, provided also that in the event of any licensed Auctioneer being seized with any illness that renders him incapable of continuing his sale it sha'l be lawful for him to call upon any person at the time present at the sale to take his place and continue his sale for the balance of the day and his substitute shall not be held by such action to have contravened this By-law; but he shall only he permitted to sell as such substitute during the portion of the one day on which the said licensed Auctioneer is incapacitated by illness, and the said licensed Auctioneer shall, if required so to do by any Inspector resident in the County Council Division in which the sale is conducted, furnish him with an affidavit to the effect that he was rendered incapable by illness during the progress of the sale to continue his work of selling.

- 2. That in accordance with Sec. 495 of the Consolidated Act of 1892 as amended by Sec. 16 of the Municipal Act, 1896, of the Statutes of Ontario, the word "Hawker" in this By-law shall include all persons being agents for persons not resident within the County, sell, or offer for sale, Tea, Dry Goods, Watches, Plated Ware, Silver Ware, Furniture, Carpets, Upholstering and Milliaery, or Jewelry, or carry and expose samples or patterns of any of such goods to be afterwards delivered within the County to any person not being a wholesale or retail dealer in such goods, wares or merchandise.
- 3. That licenses shall be issued and sold by the County Clerk only for each of the callings named in the preamble of this By-law signed by the Warden and Clerk of the County and sealed with the seal of this Corporation, each such license to be for the period one year from and including the first day of January in the year of the issue thereof, and every such license shall expire on the thirty-first day of December in the year of the issue thereof.
- 4. That every such license shall be issued subject to Section 495 A of the Municipal Act, and to any and every law of the Province of Ontario that has been or may be enacted affecting the same.
 - 5. That every such license shall be issued to and in the name of

an individual, and in no case shall a license be issued to a Company.

- 6. That for every license to practice the calling of Auctioneer within this County the sum of Twenty Dollars shall be charged and
- 7. That for every license to practice the calling of Hawker, Pedlar or Petty Chapman within this County the sum of Twenty Dollars shall be charged and paid. If one animal is used for the purdise the sum of Twenty Dollars in addition to the Twenty Dollars above mentioned shall be charged and paid. If more than one animal is used for the said purpose of bearing, drawing or delivering such goods, wares or merchandise, the sum of Forty Dollars for each animal so used in addition to the Twenty Dollars first above mentioned shall be charged and paid.
- 8. That any and every person when exercising either or any of the above callings within the County shall have with him his license, and shall, upon demand being made by any Inspector of Licenses, Municipal or County Councillor or Clerk or Peace Officer in the County or by any of the Ratepayers of the Municipality in which the demand is made, produce the same, and if he neglects or refuses to do so he shall be held to be acting without a license and shall be liable to the same penalties as if he were exercising his calling without license.
- 9. That if any Auctioneer, Hawker, Pedlar, or Petty Chapman, or other person shall act contray to or contravene any of the provisions of this By-law such person shall for such offence on conviction before one or more Justices of the Peace in and for the County of Oxford forfeit and pay a fine of not less than Fifteen Dollars nor more than Twenty-five Dollars exclusive of costs for each offence, and if not forthwith paid the same shall be levied by distress and sale of the goods and chattels of the offender, and in default of such distress the offender shall be imprisoned in the common gaol of the County, with or without hard labor, for any term not exceeding twenty-one days, unless such fine and costs shall be sooner paid.
- 10. That all fines and penalties collected under the provisions of this By-law shall be paid one moiety or half part thereof to the informer or prosecutor and the other half part thereof shall be paid to the Treasurer of the County for the use and benefit of this Corporation.

Of the Municipal Council of the Corporation of the County of Oxford to Consolidate and Repeal By-laws Numbered 319 and 390 of This. County and to A thorize a Reward to be paid for the Arrest and Conviction of Horse Thieves.

BY-LAW NO. 425.

Of the Municipal Council of the Corporation of the County of Oxford to authorize the County Printing to be Done Under Contract and to Direct County Officers and Others in Reference to Printing and Advertising for Which the County is Liable.

Whereas, the Printing and Advertising for which the County is liable is a very large item of expenditure and it is desirable and proper that the same shall be performed under contract, if possible, with one of the printing offices within the County from which is issued a weekly newspaper.

The Municipal Council of the Corporation of the County of Oxford therefore enacts as follows:

- 1. That Tenders be annually invited from the printing offices of the County during the month of January in each year by the County Clerk to be submitted for approval and acceptance of the Council at their January session.
 - 2. That when acceptance has been made of any tender for the

County Printing by this Council a contract bond shall be executed by the proprietor of the office whose teader has been accepted.

- 3. That in the event of refusal or failure at any time on the part of the party whose tender has been accepted to implement either his tender or his contract, the County Clerk is hereby directed to convene the Printing Committee who are hereby given full authority and power to act for this Council in accordance with their best judgment and secure the work to be done whether in the County or elsewhere.
- 4: That advertisements of sessions of Council, Notice to Farmers' Sons and such other Advertisements as are ordered by this Council shall be inserted in not more than three issues of the weekly newzpaper having the contract and not more than one insertion in other weekly papers published in the County who shall be given the epportunity of publishing the said advertisements at the same rate as the County is under contract to pay the County Printer.
- 5. That Advertisements of the Courts and all other advertisements for which the County is liable or has at any time agreed to pay by whomscever authorized shall be published only in the weekly paper issued by the Printing Office holding the contract, and in future no other bills or accounts will be recognized or paid by this Council.
- 6. That all printing and advertising ordered by the County Clerk shall be paid for at contract rates upon the order of the said Clerk, and the Treasurer is hereby directed to pay upon his orders all such printing and advertising.
- 7. That all other printing and advertising by whomsoever ordered shall be properly certified by the officer ordering the same, and the accounts for all such shall be laid before the Council in the ordinary way at their next ensuing session for audit and payment.
- 8. That this Council while in session, notwithstanding the provisions of this By-law, may deviate therefrom if in their judgment such action is necessary to meet any emergency or juncture of circumstances not foreseen by them, and it shall not be necessary for them to

BY-LAW NO. 426.

Of the Municipal Council of the Corporation of the County of Oxford, to Consolidate and Repeal By-law Numbered 313, 340, 342, 351, 359, 366, 378, 387 and 388 of this County, and to Provide for the Payment of Members of this County Council and the Salaries of County Officers.

WHEREAS, it is necessary to provide by By-law for the remuneration of Members of this Council and for the payment of the salaries of the County Officers.

The Municipal Council of the Corporation of the County of Oxfor therefore enacts as follows:

- 1. That each member of this Council shall be paid the sum of Three Dollars for each day's attendance at any regular or special meeting of the Council or any Committee thereof, and also the additional sum of ten cents per mile for each mile necessarily travelled thereunto.
- 2. That the Messenger of this Council shall be paid the sum of Two Dollars for each day's attendance upon the Council.
- 3. That the Clerk of this Council shall be paid the sum of Five Hundred Dollars per year for his services as such Clerk.

- 4. That the Treasurer of this County shall be paid the sum of Nine Hundred and Ffty Dollars per year for his services as such Treasurer.
- 5. That the County Auditors shall each be paid the sum of Forty Dollars per year for his services as such Auditor and the additional sum of ten cents per mile for each mile travelled to the Treasurer's office.
- 6. That the Janitor of the Court House shall be paid the sum of Four Hundred and Fifty Dollars per year for his services as such Janitor.
- 7. That the Gaol Surgeon shall be paid the sum of One Hundred and Fifty Dollars per year for his services as Gaol Surgeon and for the supply of all medicines that shall be required for the imates of the Gaol.
- 8. That the Assistant Clerk of this Council shall be paid the sum of Two Hundred and Fifty Dollars per Year for her services as such Assistant Clerk.
- 9. That each member of the Board of Audit for this County shall be paid Three Dollars per each day for their attendance at such audit and five cents for each mile necessarily travelled in respect thereof in going to and coming from such audit.
- 10. It shall be the duty of the Treasurer to pay the sums mentioned in this By-law out of any moneys in his hands not otherwise appropriated, upon the application of the parties to whom the same are payable, as follows: To the members of the Council and Board of Audit on the last day of each session and to all other parties hereinbefore mentioned, quarterly, and this By-law shall be the Treasurer's sufficient warrant for such payments.

BY-LAW NO. 430.

Of the Municipal Council of the Corporation of the County of Oxford, to Consolidate and Repeal By-laws Numbered 320, 335 and 354 of this County and to Provide for Assuming, Building and Maintaining Certain Bridges Within and on the Boundaries of the County of Oxford, and for the Appointment of Commissioners to Superintend the Construction and Repairs of Such Bridges, and also to Provide for the Payment of Necessary Expenditures therefor.

Whereas, it is expedient and necessary that certain bridges described in the Municipal Act and Amendments thereto shall be built and maintained by the Counties within and on the boundaries of which they are situated together with any and all other bridges, which the Council of the County may by By-law assume.

The Municipal Council of the Corporation of the County of Oxford therefore enacts as follows:

- 1. That from and after the passing of this By-law the bridges contained and enumerated in the Schedule hereto attached (and which Schedule shall form part of this By-law) together with such other bridges as properly come within the provisions of the Municipal Act of the Province of Ontario and its Amendments referring to County Bridges shall be deemed to be County Bridges of the County of Oxford, and those situated within, shall be wholly, and those situated on the boundaries shall be proportionately built, maintained and repaired by the said County of Oqford, and the expenses of so building, maintaining and repairing shall be paid out of the funds of the said County.
- 2. That the duty of superintending the construction and repairs of the aforesaid bridges shall be performed by a Bridge Commissioner, to be appointed by the Council of this County from year to year, (and who may be a member of the Council of the County) together with the members of the County Council who are hereby appointed, and whose duty it shall be to act as Commissioners for their several County Council Divisions.
- 3. That the duty of superintending the building or repair of any particular bridge not situated on the County boundaries shall be performed by the Bridge Commissioner and one of the members of the County Council Division or Divisions in which the bridge is situated, or if on the County boundaries, by the Bridge Commissioner and one of the members of the County Council Division in which the bridge is situated, acting in conjunction with the Commissioners of the adjoining County.
- 4. That if in the opinion of the Councillors of any of the County Council Divisions acting as Commissioners the amount necessary for the repair or construction of any of the County bridges within their Division will not exceed Three Hundred Dollars it shall not be necessary to consult the Bridge Commissioners, and the said Councillors may proceed and execute the necessary work of construction or repairs, but if work in construction or repairs of any bridge is necessary to an amount greater than Three Hundred Dollars the Bridge

Commissioner shall be consulted before proceeding, provided always that nothing herein contained shall be held to prohibit any of the said Councillors from consulting the Bridge Commissioner upon any work of construction er repair of any bridge within their several County Council Divisions when they shall deem such consultation advisable.

- 5. That the Bridge Commissioner is hereby authorized and empowered to expend such sum or sums of money as may from time to time be granted and appropriated by the County Council for the purpose of constructing and repairing County Bridges.
- 6. That the Bridge Commissioner and members of this Council acting as Commissioners shall be paid for each day's service in the performance of his or their duties in connection with County Bridges a sum equal to his pay while in session in the County Council, together with an allowance of five cents per mile of necessary travel.
- 7. That the Bridge Commissioner shall present to the Council of the County at their June and December sessions in each year a detailed report of his own, together with the proceedings of Councillors acting as Commissioners, and of all expenditures in connection with County Bridges, and to this end Councillors acting as Commissioners shall make a full statement to the said Bridge Commissioner of all their proceedings and expenditure in connection with County Bridges.
- 8. That for the purposes of this By-law all bridges on boundaries with a span of ten feet and over shall be considered bridges to be maintained by the County, and all spans of less then ten feet shall be condidered culverts.
- That By-laws numbered 320, 335 and 354, and all other By-laws, or parts of By-laws, in anywise contrary to the provis-visons are hereby repealed.
