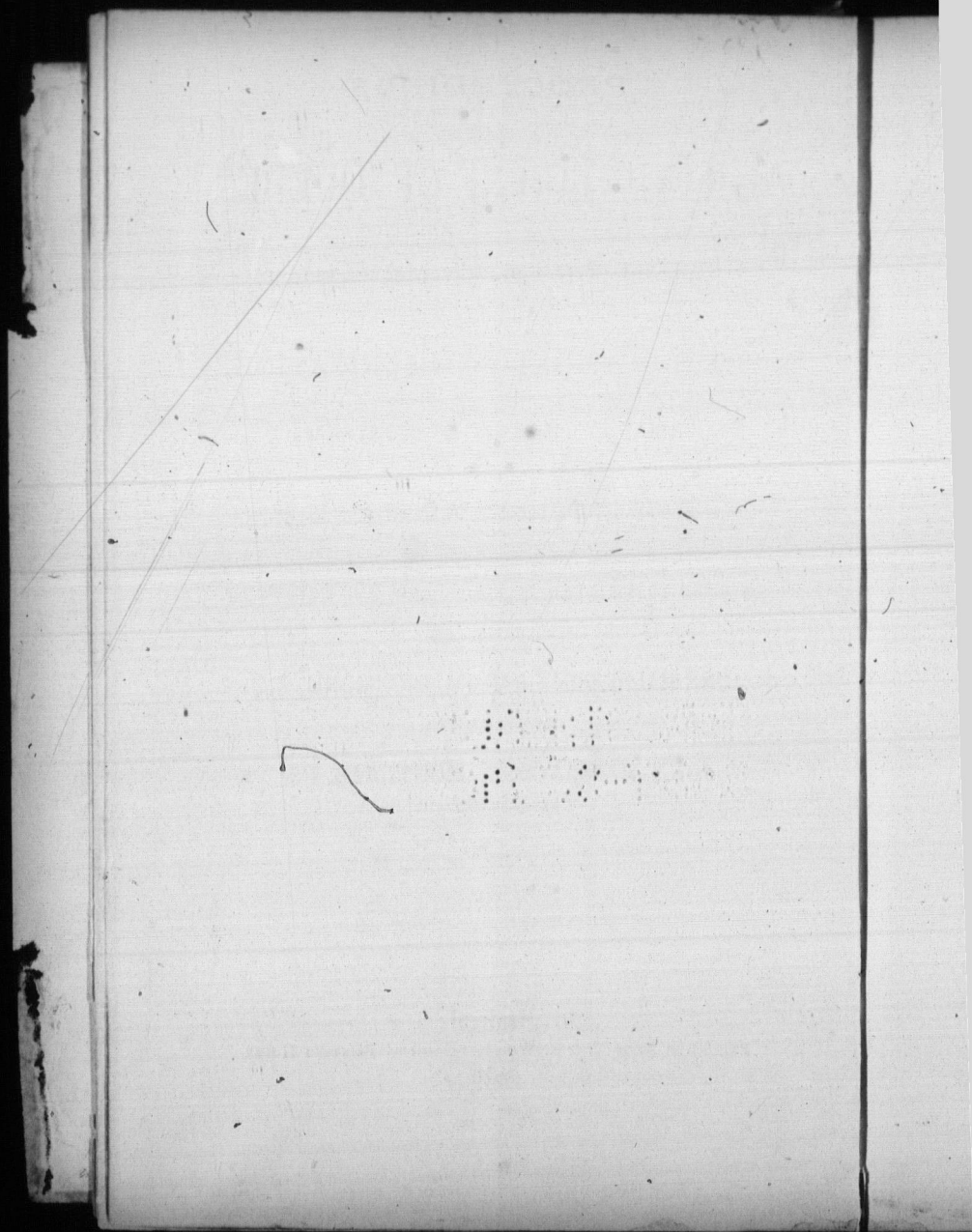

The Grand Secretary proceeding to read the minutes of last Annual Communication of Grand Lodge, it was moved by R. W. Bro. J. H. Stearns, seconded by R. W. Bro. H. M. Alexander, and

It being then 1.30 p.m., Grand Lodge was called from labor to refreshment, to resume work at 2.30 p.m.

At 2.30 p.m., Grand Lodge was called from refreshment to labor.

Officers and members as in the morning session.

The Grand Chaplain besought a blessing from the G. A. O. T. U.

The Grand Representatives of Foreign Grand Lodges were introduced and received with grand honors.

The M. W. Grand Master then delivered the following address :

*To the Most Worshipful the Grand Lodge of Ancient Free and Accepted Masons of the Province of Quebec.*

BRETHREN,—In opening the Sixth Annual Communication, on the day fixed by the Constitution, it is my pleasing duty to congratulate you upon the steady progress and continued prosperity of this Grand Lodge. Five more Grand Lodges have established fraternal communication with us during the past year, making in all forty-three Grand Lodges by which this is recognized as the sovereign Masonic authority in and for the Province of Quebec. We have now sixty lodges and more than three thousand members in good standing under our jurisdiction.

Two important events in the history of Masonry have occurred since our last meeting. The first was the installation, in the month of April, of His Royal Highness the Prince of Wales as Most Worshipful Grand Master of the Freemasons of England. This ceremony took place under circumstances of unsurpassed splendor, in the presence of 8,000 brethren. In this Dominion, and especially in this Province, where His Royal Highness Prince Edward, Duke of Kent, the grandfather of the Prince of Wales, honored the Fraternity by accepting the office of first Right Worshipful Provincial Grand Master of Masons in Lower Canada, the announcement that the Heir Apparent to the Throne of the great British Empire had openly patronized our mysteries and joined our assemblies, was received with feelings of peculiar gratification and pride. It affords the highest testimony to the merits of our Society, and is the best answer to those who endeavor to traduce and detract from it, not knowing its legitimate objects or benefits. That auspicious occasion enabled Most Worshipful brother the Earl of Carnarvon, Secretary of State for the Colonies, thus to speak : "Freemasonry presents many titles to respect, even in the eyes of the outer world. It is, first, of great antiquity—an antiquity extending into the sphere of immemorial tradition; secondly, it is known and practised in every country, in every clime, by every race of civilized men; and, lastly, in this country, above all, it has associated itself with human sympathies and charitable institutions. Let me say further that, while it has changed its character in some respects, it has lost nothing which can claim the respect of men who formerly, through the dim periods of the middle ages, carved its records upon the public buildings, upon tracery of the mediæval windows, or the ornamentation of palaces. Now it is content to devote itself to works of sympathy and charity, and in them it finds its highest praise and reward. Let me draw one further distinction, and that is an important one. In some other countries it has been unfortunately the lot of Freemasonry to find itself allied with faction and intrigue, with what I may call the darker side of politics. In England it has been signally the reverse. Now the Craft here has allied itself with social order and the great institutions of the country, and, above all, with monarchy, the crowning institution of them all." His Royal Highness the Prince of Wales also stated in unmistakable terms his opinion of the Craft, saying : "It is difficult for me to find words adequately to express my deep thanks for the high honor that has been bestowed upon me—an honor which has already been bestowed on several members of my family, my predecessors—and, brethren, in whose footsteps it will always be my most ardent and sincere wish to walk, and by God's help to fulfil the duties of the high office to which I have been called to-day in the same way that my illustrious predecessors fulfilled them. It would, brethren, I feel sure, be useless for me,

at a moment like this, to recapitulate anything which has been so ably told you by the Pro. Grand Master relative to Freemasonry. Every Englishman knows that the two watchwords of the Craft are 'Loyalty' and 'Charity.' As long as these are our watchwords, and as long as Freemasonry keeps itself from being mixed up with politics, so long will, I am sure, this great and ancient order flourish, and its benign influences tend to maintain the integrity of this great Empire." I make these extracts of words advisedly spoken, because much misapprehension exists in this Province as to what Freemasonry really means under our system. We know it inculcates the practice of every social and moral virtue, and conduces to make all those honorable who are strictly obedient to its precepts. Let us so act then that, if its credit cannot be advanced with the prejudiced, it will not be lessened by us who belong to the Order.

The formal dedication of the Masonic Temple in New York on the 2nd of June was the second memorable event. It was one of the most imposing displays in the history of Masonry in America. The procession on that occasion was probably the largest parade of the kind ever witnessed on this side of the Atlantic, about 23,000 Masons being in line. As observed by a leading New York newspaper (*The World*), at the time, "It would not be easy to surpass from the whole census of the Union, it would be impossible, we should say, to surpass from the lists of any given commonwealth or of any particular class and calling of men in any commonwealth in the Union, the general average of visible health, strength, decency and intelligence presented by the twenty-five or thirty thousand 'free and accepted Masons,' Knights Templars and what not, who were gathered together from all quarters of the country." And another organ of public opinion in the same city (*The Herald*) remarks: "The American people will be slow to believe that an Order of which Washington was a zealous member has any aims inconsistent with public or private virtue. There must be some merit in an institution which had attractions for a man of his solid understanding and moral worth. His name alone would render Masonry respectable; but a large proportion of the illustrious men whom American citizens delight to honor were also Masons; Lafayette was a Mason; Andrew Jackson and Henry Clay were Masons. We should make a long catalogue indeed if we were to insert all the names of illustrious patriots who belonged to this fraternity. We know no reason for thinking that the order has degenerated since those men belonged to it. Nobody could have scanned the faces of the several commanderies which marched up Broadway yesterday evening just as the sun was setting without recognizing in their lineaments intelligence and moral worth, which stamped them as men of sincerity and probity. We have never looked out at a procession which had a larger proportion of honest, intelligent faces." These citations are made to show how Freemasonry is regarded on this side of the Atlantic, as I have already shown how it is in England.

The magnificent Temple erected in New York cost about a million of dollars, is an ornament to the city, and a lasting monument to the enterprise of our Brethren there. As one honored with an invitation to be present at the dedication ceremonies, I can never forget the demonstration, nor the civilities extended to the Grand Secretary and myself.

Early in the year official communication was received of the decease of Judge William Mercer Wilson, LL.D., Grand Master of Masons in the Province of Ontario. I at once directed that the Lodges under this jurisdiction should go into mourning for the great loss sustained by the death of the Grand Master of the sister Province, who was well known to most of the Brethren here present as a venerated and zealous Mason. In 1855 he was



elected as first Grand Master of the Grand Lodge of Canada, and occupied the chair for five years, retiring in 1860, but being again elected in 1866, he sat for two years, when in consequence of a judicial appointment, he declined to offer himself for re-election. He was in 1872, however, prevailed upon to preside over the Order, and consented, and was re-elected in 1872 and 1873 and last year, remaining in office until his death. His eminence in the Order is evidenced by the fact that a Masonic district and several Lodges in Ontario bear his name. Anxious to do all in his power for the promotion of harmony in the Craft,—whose first motto is brotherly love—his name will long be treasured in our memories, in connection with the difficulties with which the formation of our Grand Lodge was attended, as the great peace-maker of Masonic Canada. We know what is the reward of those who act in this wise, and let us hope that when we have fulfilled our earthly destiny we may have the equal consummation of our wishes in seeing lowering clouds disappear, and knowing that our hand helped them to melt away beneath similar benign influences. I have no doubt the Grand Lodge will express its sympathy to its sister Grand Lodge by passing a vote of condolence on the death of their Grand Master.

We were again called upon in May to regard the uncertainty of human life in the demise of one whose face was still more familiar in our own Grand Lodge. I refer to Right Worshipful Brother M. R. Meigs, M.D., Past District Deputy Grand Master of the Bedford District. No one who like myself has attended the meetings of Grand Lodge since its formation, or of the Board of General Purposes or the several Committees of Conference, can ever forget the unwearying interest, the straightforward line of conduct, and the ability manifested by this brother. His unremitting exertions to promote and extend the interest and welfare of the Grand Lodge of Quebec should receive our warmest acknowledgments of gratitude, and Grand Lodge cannot but offer to his young widow the assurance of its deep sympathy and condolence in the severe loss which she has sustained. The obituary of the year includes among other less prominent brethren, Vicomte de Ponte Ferreira, Past Grand Master of Hungary, a very faithful member of the Craft under trying circumstances.

The Grand Lodges which, since the last communication, have been officially announced to be in correspondence with our Grand Lodge are: Maryland, Ireland, Minnesota, New Jersey and Florida. The following is a list of my appointments of representatives of this Grand Lodge to them:—R. W. Bro. Tyson, of Baltimore, near the Grand Lodge of Maryland; V. W. Bro. George Hill Major, near the Grand Lodge of Ireland; R. W. Bro. E. D. Porter, near the Grand Lodge of Minnesota; R. W. Bro. George B. Edwards, of Jersey City Heights, near the Grand Lodge of New Jersey; and R. W. Bro. William Taylor, near the Grand Lodge of Florida. I have recommended as Grand Representatives of these Grand Lodges near Quebec: R. W. Bro. E. M. Copeland, for Maryland; R. W. Bro. Benjamin Burland, of St. John's for Ireland; R. W. Bro. William Nivin, for Minnesota; R. W. Bro. H. D. Pickel, for New Jersey; and R. W. Bro. Thomas Allen, of St. Andrew's Lodge, Montreal, for Florida.

In April last a letter was received from the Grand Secretary of the Grand Lodge of England, informing us that at its Quarterly Communication of the 3rd March, on the recommendation of the M. W. Grand Master, the following resolution was unanimously passed:

"The M. W. Grand Master has received official information from the Hon. Sir John Macdonald, K.C.B., the representative of this Grand Lodge at the Grand Lodge of Canada, that the difficulties subsisting between the

latter and the newly formed Grand Lodge of Quebec, have been happily adjusted, and the Grand Lodge of Quebec recognized by the Grand Lodge of Canada. The M. W. Grand Master, therefore, having in view the various applications from the Grand Lodge of Quebec for recognition, and interchange of representatives, which could not be entertained until the above mentioned difficulties were settled, now recommends Grand Lodge to accede to the wishes of the Grand Lodge of Quebec, on the same conditions as were agreed to by the Grand Lodge of Canada, viz., that the Grand Lodge of England agrees not to grant any new warrants within the Province of Quebec, but that the three Lodges still working under English warrants within that Province, shall continue to do so as long as they desire to retain their allegiance to the Grand Lodge of England.

"*Resolved*,—That the recommendation of the M. W. Grand Master be adopted and the Grand Lodge of Quebec acknowledged on the conditions referred to, and that the Grand Secretary be directed to forward a copy of this resolution to the Grand Lodge of Quebec."

I commend this communication and other correspondence on the subject to your careful consideration. I shall be sorry if any rigid or uncompromising ideas as to exclusive jurisdiction in this Province (as to which I am and always have been fully alive,) delay the laying of the capstone of Masonic recognition. Twenty years ago when the Grand Lodge of Canada was formally recognized by the Grand Lodge of England, similar terms were proposed and accepted and have since been submitted to. I am in favor of leaving it to time, rather than to immediate coercion to bring into our ranks the few lodges in this Province now working under other jurisdictions. Let the advantage of belonging to the Grand Lodge of the country of one's adoption or birth—duly recognized as such by all other Masonic bodies,—be made apparent, and I have no doubt how properly constituted minds will choose.

The proceedings of the organization of Grand Lodges for Manitoba and Prince Edward Island, as Provinces of the Dominion, will be submitted to you, and if found in accordance with the ancient usages and landmarks of the Order those bodies are entitled to recognition as regularly constituted Grand Lodges.

The only dispensation which I have granted for opening a new Lodge is that for St. John's Lodge, Montreal, the petition for which was strongly recommended. From the standing in the Craft of those engaged in its formation I am sure the work has been carried on in such manner as will enable Grand Lodge to issue a warrant of confirmation.

The sub-division of Masonic districts is well worthy your consideration. It seems to me that some districts, such as Montreal, which now includes Lodges in Hull, Aylmer and Shawville, on the border of Ontario, and in Huntingdon and Ormstown, near the frontier, might well be rearranged so as to render it less difficult for the District Deputy Grand Master to visit the Lodges in his district.

No less than seven notices of motion to amend the Constitution have been given for this session. These are of more or less importance, but whether adopted or not I recommend that as the Book of Constitution is out of print it be republished with such amendments as Grand Lodge shall deem it necessary to make.

The desirability of an amalgamation of the duplicate Lodges at present existing has often presented itself to my mind, and I hope all brethren

interested will concur with me in regarding this as the shortest and most certain way of putting an end to conflicting claims for property, now being made or held in abeyance.

The attendance of the Grand Secretary and myself at the dedication ceremonies at New York, the more recent dedication of the new Temple at Albany, and the laying the foundation stone of a new Masonic Hall at Halifax, Nova Scotia, impress me with the conviction that the time has arrived when I should urge the erection of a Masonic Temple in Montreal. The necessity of a lasting home for our Grand Lodge is apparent, and I am confident it requires only to be brought prominently under your notice to secure the requisite funds to purchase the building lot (for which I am told the times are favorable) and to start the project.

While awaiting the erection of such an edifice it would be conducive to a knowledge of all that appertains to our Craft were our Grand Lodge to have a library such as most other Grand Lodges possess. A step has been made in the way of Masonic literature by the publication of *The Canadian Masonic News*, which well deserves the patronage of all readers of what is interesting to the Fraternity; and I bespeak for it and for the suggestions I have just made, the consideration which I believe they merit.

I am glad to say that during my administration of the office of Grand Master I have not had submitted to me for decision any matter requiring my direct interference. I am compelled to remind brethren that all matters of Masonic complaint and jurisprudence should by the Constitution be referred through the Grand Secretary, and that his opinion, however valuable, is not that to which official weight is attached. The District Deputy Grand Master is the direct channel of communication in such matters.

Shortly after the last Communication of Grand Lodge, the following old jewels were presented by our esteemed Most Worshipful Brother Harington, Representative of the Grand Lodge of Quebec near the Grand Lodge of Canada: 1st, Square—the gift of H. R. H. Prince Edward, Duke of Kent, father of our Queen; 2nd, Key—the gift of Prince William Henry, Duke of Clarence, and William the Fourth. I now lay these relics before you, and I am sure they will be carefully preserved, both out of regard to their original and illustrious donors, and to him who has now given them to us.

The Grand Lodge Regalia, the purchase of which was authorized at the annual communication of 1873, has at last arrived and enabled the officers and brethren to appear in their proper jewels and clothing. I am informed it has cost £200 sterling, but it was an indispensable outlay.

In terminating this address I am bound to acknowledge the great assistance I have received in the discharge of my office from the Deputy Grand Master, who has been most attentive to his duties as President of the Board of General Purposes, and from our experienced and indefatigable Grand Secretary and our very careful Grand Treasurer.

And now, Brethren, having thus briefly brought before you the various subjects likely to engage your attention during the present Communication of Grand Lodge, it only remains for me to express the hope that whatever be your decisions all things may be settled upon such sure foundation that none of us may have cause hereafter to regret any of our proceedings, and

that all may return to their homes conscious of having done their duty towards this venerable institution.

May our labors thus begun in order, be conducted in peace and closed in harmony.

It was then moved by R. W. Bro. James O'Halloran, D.G.M., seconded by R. W. Bro. Hon. Thos. Wood, and

*Resolved*,—That the very able address of the M. W. the Grand Master, just delivered to this Grand Lodge, be referred to the Board of General Purposes to report thereon as soon as possible.

R. W. Bro. O'Halloran, D.G.M., President of the Board of General Purposes, submitted the following report:

*To the M. Worshipful Grand Master, Officers and Members of the Grand Lodge of Quebec.*

The Board of General Purposes beg leave to present this their first report.

Your Board having taken into consideration the able and instructive address of the Most Worshipful Grand Master, delivered at the opening of the present Communication, are gratified to find the prosperous condition of our Order, and congratulate our brethren on the healthy progress of our Craft in this Province.

With reference to that portion of the address referring to the conditions offered by the Grand Lodge of England in regard to the recognition of this Grand Lodge, your Board have unanimously agreed to refer the same back to Grand Lodge for such action to be taken thereon as Grand Lodge in its wisdom may determine.

It was moved by R. W. Bro. H. M. Alexander, seconded by R. W. Bro. John Renshaw,

That the report just read be received and adopted.

The motion was carried.

The Grand Secretary, in reply to the M. W. the Grand Master, announced that he had received no report from the Committee on Foreign Correspondence, of which the Rev. Bro. Reid, P. G. Chaplain, was Chairman.

The Grand Secretary in explanation stated that R. W. Bro. Reid had only consented at a late period of the past year to accept the position of Chairman of this Committee, and it was feared that the Rev. and R. W. Bro. had not had sufficient time to prepare a report.



## NOTICES OF MOTION.

M. W. Bro. Thomas White, jr., gave notice that at the next annual meeting of this Grand Lodge he would move,

That Article 17 of the Book of Constitutions, relating to the place of meeting of Grand Lodge be amended by striking out the words "at Montreal" in the third line, and substituting therefor the words "alternately at the cities of Montreal and Quebec."

R. W. Bro. Alexander Murray gave notice, that at the next annual meeting of Grand Lodge he would offer the following motion:

That a clause be added to the Constitution of this Grand Lodge, restricting the rites of Masonic burial to officers of Grand Lodge, Past Grand Officers, Past Masters and actual Masters and Officers of Masonic Lodges only, except by special dispensation from the District Deputy Grand Master, previously obtained.

W. Bro. Woodford gave notice that he would, at the next Annual Communication of this Grand Lodge, move,

That no Mason shall belong to more than one Lodge at the same time (except he be an honorary member, as provided for by the Constitution). This, however, not to apply to brethren who are members of more than one Lodge at the time of passing this resolution.

Any member of a Lodge wishing to affiliate with another Lodge, must present his application in the usual form, and if his application be accepted in said Lodge, his membership shall remain in abeyance until his demit from the former Lodge to which he belonged is surrendered to the last mentioned Lodge, when he shall become a full member.

The following reports from the District Deputy Grand Masters were read, received, and referred *seriatim* to the Board of General purposes:

## MONTREAL DISTRICT.

*To the M. W. Grand Master and Grand Lodge of A. F. and A. M. of Quebec:*

In conformity with the requirements of the Constitution, I submit my report on the condition of Masonry in the District of Montreal.

The Lodges in this district working under the jurisdiction of this Grand Lodge are 22 in number, including St. John's Lodge under dispensation.

It gives me great pleasure to report that these Lodges with one or two exceptions are in good working order, the majority of them are prospering well, the brethren are busily employed in adding fresh material to our Masonic structure, and from the number of notifications I have received of persons being rejected as not being the kind of material required I have every reason to believe they are careful in their selection.

The work generally speaking is well executed, the Masters and Officers attentive to their duties, and the majority of the Lodges well attended by the members; there is one requisite, however, which would be of great benefit, and which I would respectfully recommend to Grand Lodge to speedily obtain—that is, a regularly authorized and established Ritual for the instruction and guidance of the brethren; there is a great diversity of work in the



Lodges of this district, which sometimes creates confusion and is detrimental to the proper instruction of the brethren.

I regret very much that I am compelled to recommend the withdrawal of the warrant of Clarke Lodge, Ormstown, No. 28, which has made no returns to Grand Lodge since 1873, and then only one initiation was returned with nineteen members on the roll; it has had since then only three meetings, at two of which I have had to preside; the last time I visited this Lodge was in August last, having previously notified the W. Master that I would visit officially, but it was a failure, as only the W. Master and one member made their appearance; the books of the Lodge, however, are in good order, and I believe there is sufficient money in the hands of the Treasurer to pay Grand Lodge dues and other expenses.

Hoyle Lodge, Lacolle, No. 9, has also been in a dormant state for some time. I have visited this Lodge twice this year; the first time I was accompanied and ably assisted by the R.W. Grand Secretary; the second time by the Grand Senior Deacon, V. W. Bro. Wm. Young, who ably assisted me to install the newly elected Officers; the newly installed W. Master (W. Bro. Daniel Salt,) is one of the oldest and best instructed members of the Lodge; I therefore believe that under his guidance the Lodge will again prosper.

I am also sorry to report that Zetland Lodge, late C.R., has been placed in a very distressing and precarious position by the mismanagement, misconduct, and desertion of the W. Master, W. Bro. J. G. A. Leblanc; this Bro., after having defrauded certain brethren, absconded from this city, leaving the affairs of the Lodge in a state of great confusion. About the same time a complaint was made to me by Bro. George Mason, of St. Mark's Lodge, Glasgow, Scotland, then residing in this city, against Bro. J. G. A. Leblanc, he having as Bro. Mason alleged defrauded him and his employers of goods to the value of four hundred pounds twelve shillings stg.; on investigation, I found the complaint was substantiated by the evidence of Bro. J. V. Morgan, of St. Paul's Lodge, of this city, and of W. Bro. John Street, Past Master of St. George's Lodge, late C. R. I therefore considered it my duty to suspend Bro. J. G. A. Leblanc from all Masonic rights and privileges, until such time as Grand Lodge should take action in the case. This Lodge, though labouring under difficulties, its books and papers missing, and its members disheartened, continued to meet and work under the management of the immediate Past Master and wardens, who deserve great credit for their energy and perseverance. The books and papers of the Lodge I am informed are in the hands of the Secretary, Bro. James Anderson, who will neither attend the Lodge nor give them up. I have therefore to request that action be taken by Grand Lodge against Bro. James Anderson, with the view of obtaining the books and papers of Zetland Lodge.

In the case of Mrs. Leitchfield, whose application for relief was laid before the Board of General Purposes at the meeting of the Board in March last, and referred to me for consideration, with the recommendation that assistance should be obtained for her if possible from the Lodges in this City. I have to report that I directed a circular to be issued to all the Lodges in this city, requesting them to donate a small portion of their funds towards her relief, but few answered to the call, and twenty dollars is all that she has yet received; the lady is in great want of assistance, and something should be immediately done in her behalf, but considering the circumstances, I would beg leave to state that this is not a case for the Montreal Lodges alone; the late husband of Mrs. Leitchfield was not a mem-

ber of any Lodge in this Province, nor had she resided in this City previous to her husband's decease; he was a member I believe of a Lodge in England, and affiliated with a Lodge in Ontario; it would be wise therefore for this Grand Lodge to apply to the Grand Lodges of England and Canada in her behalf, and in the meantime to relieve her from the benevolent fund of this Grand Lodge, failing which to levy a small tax on all the Lodges in the Province to supply her immediate wants.

The M. W. Grand Master was pleased to grant to R. W. Bro. J. H. Isaacson and other influential and able brethren of this city, a dispensation to form a new Lodge to be called St. John's Lodge, and I have great pleasure in recommending that a warrant of confirmation be granted to this Lodge by the M. W. Grand Lodge at its present session.

The usual dispensations were granted to several of the Lodges to wear Masonic regalia on the occasion of the festival of St. John the Evangelist, to Royal Albert Lodge to wear Masonic clothing on the occasion of their annual Ball, and to several brethren Masters of Lodges, to allow the brethren to wear Masonic regalia at the general Masonic Pic-Nic held at Chamblay in August last. I also granted a dispensation to St. Charles No. 29, to confer the second and third degrees on five brethren named in the returns of that Lodge, sea going mariners, at a less interval than one month, as provided for in page 59 book of constitution.

It yet remains for me to say a few words regarding the Lodges in this city working under foreign jurisdictions; there are three Lodges working under the jurisdiction of the Grand Lodge of England,—St. Paul's, St. George's, and St. Lawrence,—and one, the Elgin Lodge, working under the jurisdiction of the Grand Lodge of Scotland.

These Lodges continue to work with all the spirit and energy if not with the precision and regularity of our own Lodges. They are in our midst as it were without any one to supervise them, without any one to guide them, they are, one might almost say, Grand Lodges of themselves, for as far as their respective Grand Lodges are concerned they know nothing of how the business of the Lodge is conducted, how the work is performed, they know nothing of the general feeling of the members regarding the Grand Lodge of the Province in the midst of which they are at work, or what injury may be caused by them to the craft in general and to this Grand Lodge in particular.

These Lodges are governed solely by the W. Masters elected to preside over them. Be they wise, prudent, and discreet then the Lodges will prosper, be they differently disposed, then the reverse will be the consequence, and we as a Grand Lodge have no power to control them. The Grand Lodge of Quebec is looked to by the Grand Lodges of the world to see that the honor, reputation and usefulness of the craft is maintained in our Province. We are expected to fully maintain the principles and increase the prosperity and happiness of our order in the Territory over which we have been permitted to have Masonic jurisdiction and yet we have amongst us brethren over whom we have no control, brethren over whom we can exercise no power for good, should they be inclined to do evil, who are of us and yet not with us, who are our brethren and receive all the rights and privileges as such and yet unwittingly I trust, do us and themselves injury, who give us no support but rather discouragement, and who prefer to contribute to the maintainance of a Grand Lodge three thousand miles away rather than support the Grand Lodge of their own Province.

Some of us know full well how tender yet how strong are the ties which

bind one to the land from which he derives his birth and infant nurture, but a large number of the members of these Lodges (I might say the majority of them) were not born in England or Scotland they are natives of this Province, and even those of them who are not natives of this Province are equally bound to do nothing detrimental to the highest interests of the Craft in the land of their residence or adoption

M. W. Grand Master and brethren of the Grand Lodge the time has arrived when those brethren should be awakened to a knowledge of their error.

It lies with this Grand Lodge to say whether such a state of things will continue. It is a duty this Grand Lodge owes to itself, to the Grand Lodges who have given it their countenance and support, to the whole fraternity wheresoever disposed to assert its right to undivided supremacy and exclusive Masonic jurisdiction within the Province of Quebec.

His memory is revered, his good deeds are not forgotten, and his presence will be sadly missed by a wide circle of friends who mourn his loss.

I would suggest the propriety of inscribing a page in Grand Lodge proceedings in memory of our departed brother.

An unusual press of private business, (and at one time sickness) necessitated frequent absences from home which have prevented my visiting the various Lodges of this District to the extent I could have wished.

The number and names of the Lodges in my jurisdiction remain unchanged, namely, Albion No. 0, St. John No. 1, St. Andrew No. 5,

Harington No. 8, St. George No. 35, all in Quebec city; Tuscan No. 19, in South Quebec, Milton No. 18 and Shawenegan No. 25, at Three Rivers.

I would urge upon the M. W. Grand Lodge, to take some action towards procuring *uniformity of Ritual*, for whilst the work in each and every case is well performed, yet I cannot but deplore, that the conferring of Degrees and attendant ceremonial should be, (as is too frequently the case) left to the option of the W. M. for the time being.

No business of special importance has called for my official interference, nor have I heard of any complaints in my district.

I have exchanged fraternal correspondence with most of the Lodges, and have had the honor of being specially invited to be present and install the officers of St. John Lodge No. 1; a pleasure I was unwillingly obliged to decline, being called away from home at the time on business of special importance.

To Milton and Shawenegan Lodges of Three Rivers, and Tuscan of South Quebec, I return my sincere thanks for courtesies extended.

In conclusion allow me to return my best thanks for the honor conferred upon me in being elected to the office of D. D. G. M., of this important District, the duties of which office I fear have been by me but very imperfectly performed.

#### ST. FRANCIS DISTRICT.

*To the Most Worshipful the Grand Lodge of Quebec.*

In accordance with the requirements of the constitution I herewith submit the following report on the condition of Masonry in St. Francis District.

There are now nine regular Lodges in this District, but owing to the great extent of country over which they are scattered I have not been able to visit them all, but from what I can learn, I have every reason to believe they are all prospering.

On the seventh of May last I had the pleasure of constituting Lake Magog Lodge, and installing their officers, the warrant having been granted by this Grand Lodge at its last Annual Communication, and I have rarely visited a lodge where all its members manifested so lively an interest.

I granted a dispensation to St. Francis Lodge to wear Masonic clothing on the occasion of the Festival of St. John the Evangelist held at Danville, also to install their officers in Doric Lodge.

That all words after "Mason" in the first line of Article II., "Of Proposing Members," page 48 of Constitution of Grand Lodge of Quebec, to the word "until" in the fifth line of said Article, be struck out.

After debate on these motions, in which R. W. Bros. Miller, Edgar, Kemp, Renshaw, and Bros. Lecapellain, Shaw, Rose and Lesser took part, they were, by consent of the M. W. the Grand Master and the Grand Lodge, withdrawn.

Twenty-five dollars was voted in aid of Bro. Elder, and fifty dollars to assist Mrs. Galer.

The Board recommended that the printing of the Book of Constitution should not be proceeded with until after the meeting of G. L. in September next.

The Board recommended that the safe, the property of Grand Lodge be sold.

The Board directed the Grand Secretary to hire fitting premises wherein to transact the business of Grand Lodge at a rent not to exceed \$120.00 and to furnish the same.

The Board recommend the payment of actual expenses of its members attending its meetings.

The Grand Secretary was instructed to take the necessary steps to carry out the vote of Grand Lodge in regard to Grand Lodge regalia.

In view of the fact of the continual non-attendance of the members of

the Board at the semi-annual meetings it is recommended that all meetings of the Board in future be held at the same place where Grand Lodge meets. The whole respectfully submitted.

The motion was put to Grand Lodge and lost, as also was the motion of the Grand Chaplain, seconded by the D. G. M.:

At this stage of the business, M. W. Bro. W. B. Simpson entered Grand Lodge, and was received with grand honors.

On motion of R. W. Bro. James O'Halloran, seconded by R. W. Bro. Edson Kemp, it was

*Resolved*,—That the election of officers be the order of business at 11 o'clock on the morrow morning, then to have preference over all other business, unless it be unfinished business.

R. W. Bro. Nye gave notice that he would, at the next annual communication of Grand Lodge, move

That Art. 10, page 16, of the Constitution be amended by striking out the word "present," and inserting in lieu thereof the word "cast."

Grand Lodge was then called from labor to refreshment, to resume labor at 7.30 p.m.

#### EVENING SESSION.

Grand Lodge resumed labor at 7.30 p.m.

M. W. Bro. James Dunbar, Grand Master, on the Throne.

The Board of General Purposes made the following report on Finance:

The Board beg to report that it has carefully examined the books and vouchers of the R. W. Bro. Grand Treasurer, and found them correct.

The total receipts have been \$2703.34 the total expenditure \$957.51, leaving a balance of \$1745.83, but in view of a difficulty compelling the Grand Treasurer to keep his account open, arising from the fact of many subordinate Lodges, not paying their dues until the annual communication of Grand Lodge is in session; it is recommended that all dues owing to this Grand Lodge must be paid at least three days prior to the said communication, and lodges in arrears be reported thereat.

All of which is respectfully submitted.

On motion of R. W. Bro. Thompson, seconded by R. W. Bro. Copeland, the report was received and adopted.

The Board of General Purposes made the following report:

*The Board of General Purposes beg to present the following report on Charities.*

1. A letter has been received from R. W. Bro. Foss, suggesting that the appropriation of \$70 made by Grand Lodge towards a monument to the late R. W. Bro. Wiswell P.D.D.G.M. be transferred to the widow and family of the late Brother. It appears that a monument of a sufficiently substantial character has already been erected, and that the family are in great want. The Board recommend that the suggestion of R. W. Bro. Foss be acted upon, and that the money be placed in the hands of the D. D.G.M. of the St. Francis District for that purpose.

2. An application has been made by M. W. Bro. White for a donation to Mrs. Campbell widow of the late Bro Peter Campbell. The Board recommend that the sum of \$20 be granted to be paid through M. W. Bro. White.

3. The Board recommend that the sum of \$50 be granted to Mrs. Litchfield, widow of the late Bro. Litchfield, to be paid through R. W. Bro. Milton, and that a circular be addressed to the Lodges in the Montreal District, recommending her case as one worthy of Masonic charity.

4. An application has been made by Excelsior Lodge for the widow of the late Bro. Henderson, and the Board recommend that the sum of \$25 be granted, to be paid through the Most Worshipful Master of the Lodge.



5. An application has been made on behalf of Bro. T. C. King, to permit the patronage of the Grand Lodge of Quebec to be given to his benefit, to take place on Friday evening at Ben De Bars Opera House. The Board cannot recommend compliance with this application, but have to report that Bro. King deserves such patronage as Brethren individually can give him.

6. The Board recommend that an application be made to Grand Lodge for a grant of \$300 towards the fund of benevolence.

7. The Board recommend that the Benevolence fund, which now amounts to a little over four thousand dollars, be converted in six per cent bonds of the City of Montreal, and that hereafter the contributions for Masonic Charity be made from the interest, with such grant as Grand Lodge may at its annual communications make for that purpose.

That all the words in the above resolution after the word "that" be struck out, and the following substituted therefor: "The recognition of the Grand Lodge of England, as offered in the letter of R. W. Bro. Hervey, Grand Secretary of the Grand Lodge of England, be accepted by this Grand Lodge."

R. W. Bro. M. M. Tait, as an amendment to the amendment, moved, seconded by W. Bro. T. J. Butler,

That all the words after the word "that" be struck out, and the following be substituted:

That the consideration of the acceptance by this Grand Lodge of recognition by the Grand Lodge of England, in the terms proposed by the latter, as set forth in the address of the M. W. the Grand Master, be postponed until the next Communication of this Grand Lodge, and that a committee be appointed by the M. W. the Grand Master to confer with the Lodges now existing in this Province under warrants from other jurisdictions, with a view to effect, if possible, the amicable junction of said Lodges with this Grand Lodge, and that said committee report progress to the M. W. the Grand Master, from time to time, in order that such report may be submitted for the consideration of this Grand Lodge, whose decision only in the matter shall be final.

The amendment to the amendment, after a long and interesting discussion, was carried by a vote of 84 in its favor against seven opposing.

Grand Lodge was then called from labor to refreshment, to resume labor at 10 o'clock on the morrow.

## THE STATE OF MASONRY.

MONTREAL, 23rd Sept., 1875.

On this subject the Board has the pleasure to report that the state of Masonry in this Province, as shewn by the Reports of the D. D. G. M.'s, which have been submitted to G. L., is highly satisfactory. No report however has been received from the D. D. G. M. of the D. of Bedford, but there is every reason to believe that the state of Masonry in that District is most prosperous.\*

The Subordinate Lodges, with a few exceptions, continue to meet their obligations to G. L. with regularity, and the Board recommend that in this matter strict punctuality be observed.

which, on motion, was received and adopted.

The Board of General Purposes presented the following report on

## GRIEVANCES.

The Board has had before it a grievance from Bro. Kuhring of St. Andrew's Lodge, No. 5, complaining of the conduct of the W. M. of the Lodge, W. Bro. Colson, in improperly excluding him from the Lodge, and against the senior Warden R. W. Bro. Pratten for unmasonic conduct in relation to him.

As to the charge against R. W. Bro. Pratten the Board report that the duty of Bro. Kuhring was to bring the charge against that Brother in his own Lodge, and until an investigation has taken place there, or been refused, there is nothing to warrant this Board in taking cognizance of the charge now brought.

As to the charge against W. Bro. Colson, the Board have received a letter from that Bro. taking the preliminary objection that the charge should first have been submitted to the Grand Master or the Board of General Purposes, before any summons was issued, and that not having been so submitted, the summons issued by the Grand Secretary, with a copy of the charge, was not legally issued, and there is therefore no obligation on the brother summoned to answer it.

Upon this point the Board have to report that as the Worshipful Master was duly furnished with a copy of the charge and a summons to appear to answer it, the objection can hardly be understood, even if technically a good one, as one made in good faith, and in the interests of that peace which all Freemasons should desire to promote. The Board, however, are of opinion that the Grand Secretary acted in strict accordance with his duty as pointed out by the constitution, and that the summons was properly issued and should therefore have been obeyed.

\* A few days after the meeting of G. L. the report of the D. D. G. M. for Bedford district was received, and is included in the present report of proceedings.

Bro. Kuhring appeared before the Committee on grievances on the first day of Grand Lodge, and W. Bro. Judge appearing for W. Bro. Colson, stated that he had been unavoidably prevented from attending but would be here on the following, (this) morning. He has not however appeared, and Bro. Kuhring has been compelled to leave for his home.

Under these circumstances the Board recommend that the parties be summoned to appear at the semi-annual meeting of the Board when the charge will be investigated, and in the meantime, as the failure to investigate it at the meeting is due to the absence of W. Bro. Colson, that Bro. Kuhring be permitted to attend the meeting of his Lodge, as a Mason in good standing.

The Board has received a notification of the suspension of Bro. Mutton, for unmasonic conduct by Ionic Lodge, with a recommendation that he be expelled from the order.

The Board recommend that the suspension be confirmed, and that Bro. Mutton be summoned to attend the half yearly meeting of the Board to show cause why he should not be expelled.

The Board has also received a notification of the suspension of Bros. Henry Matthews and William Murray by Prince Consort Lodge, No. 47, for unmasonic conduct. It appears that both the Brethren have been convicted by the ordinary tribunals, and are now receiving the punishment of their offences in the penitentiary.

The Board recommend that the suspension be confirmed and that the parties be summoned to appear at the next semi-annual meeting of the Board to show cause why they should not be expelled.

All of which is respectfully submitted.

The report was received and adopted.

The committee named at the last annual Communication of Grand Lodge to re-number the Lodges, in accordance with Section III. of Articles of Agreement adopted by the Joint Conference Committee, reported that they were not prepared at the present to make their report, and asked for an extension of time, which was granted.

The Grand Chaplain then delivered the following address :

*Most Worshipful Sir, and Brethren :*

In addressing you once more on the occasion of our great annual gathering, I desire, in the first place, to give utterance to a sentiment to which, I trust, you will all heartily respond, in expressing our gratitude to the Great Architect of the Universe, who has spared us through all the vicissitudes of the past year and permitted us again to meet and consult together for the common weal. May He implant in all our hearts such a deep and abiding sense of His preserving and protecting care as shall impel us to show forth His praise, not only with our lips, but in our lives.

Since I last had the honor of addressing you in this place, we have had some startling illustrations of the truth so often brought before us in our ritual, of the vain and transitory nature of all earthly things, and of the consequent necessity of preparing ourselves for that other and abiding state, of which we know so little, and which is yet so very near to every one of us. During the past year some of our most prominent and best beloved brethren have been called to exchange the labors of life for the rest of Eternity. One, in particular, who seemed the very embodiment of physical

health and vigor, and whose heart was as large as the massive frame in which it was enshrined, has been suddenly cut down in the prime of his days, when every circumstance appeared to promise him a long career of happiness and usefulness. None of us, as we entered this hall to-day, can have failed to miss the genial smile and hearty greeting with which he was wont to meet us at the annual communication; and, although some of us may have differed with him in opinion, we shall all, I trust, be ready to do honor to the perfect, transparent *honesty* of his every word and deed as a man and a Mason.

In making these allusions to a departed brother, I have travelled somewhat out of the usual track of the Grand Chaplain's discourse, but I feel that I could not address you to-day without offering this humble tribute to the memory of one by whom I was initiated into Masonry, and who was ever after my faithful brother and friend. Out of the abundance of the heart the mouth has spoken.

And now, brethren, I would say a few words to you on some of the prominent characteristics of a true Masonic life.

First, then, I would remind you that he who is a Mason indeed is distinguished by his firm, unflinching *faith in God*, the Great Architect and Grand Geometrician of the Universe,—the Maker and Ruler of all worlds. This is the first lesson which we were taught when we presented ourselves as candidates at the threshold of the Masonic temple; and all the teaching that we have since received, as well as our experience of human life, must have deepened our conviction of its pre-eminent importance. Without this sure foundation, the stately edifice of Masonry would long since have crumbled in the dust, and it is only in proportion as this truth is deeply embedded in our hearts that we can hold our place as living stones in that mighty fabric. A strong, abiding confidence in the existence, providential oversight and wise, paternal government of the Supreme Being is absolutely necessary to the right discharge of our duties to the Brotherhood and to the world at large.

And next, resulting from this, there will arise a large and generous *trustfulness in our brother man*, who is made "in the image of GOD." This is neither the time nor the place to indulge in theological speculations as to the extent to which human nature has suffered by the fall; suffice it to say that man, when he came from the hands of his Maker, was a mirror of the perfection of Him who created him, and although that mirror has been sadly maimed and defiled, yet in its broken fragments it still reflects much of the glorious attributes of GOD. Masonry fastens upon this truth, and founds upon it the lesson of respect for the whole race of mankind, and a tender compassion for the faults and frailties of its individual members.

Again, a consistent Masonic life is characterized by *unselfishness*. This is a point on which there is much misunderstanding in the unenlightened world. The popular conception of our Fraternity is that it is a vast mutual benefit society, to which each member contributes a certain portion of his time, talents and means, in the expectation, in certain contingencies, of reaping corresponding advantages,—in a word, they suppose that when a man becomes a Mason he does so solely with a view of using his new position as a stepping-stone to his own personal welfare and aggrandizement. I need hardly say to you, my brethren, that such a view is entirely contrary to the tenets of our Order, and directly opposed to its teachings. "To do good and to communicate," not to grasp any advantage for oneself, is the great lesson which we are set to learn in our Lodges. He is the true Mason who is ever ready to forego his own for his brother's interests,



and who looks at all questions, not with the microscopic vision of the miserable self-pleaser, but with the broad, comprehensive view of one who has grasped the great principles of the universal Fatherhood of GOD and Brotherhood of Man.

Lastly, no Masonic life can be held to be complete unless it includes within it the habitual practice of *active benevolence*. It is unnecessary to dwell at any length on this point, because it necessarily flows from what I have already laid down. Where a spirit of unselfishness rules the breast, it will inevitably show itself in the eager seizing of every opportunity to benefit others. It is sometimes objected to our institution that our vows of reciprocal fidelity tend to contract our sympathies and to confine our good deeds within the comparatively narrow limits of our own membership. I need not say to you, my brethren, that such an assertion can only spring from the grossest ignorance of the very first principles of our Order. I boldly assert that the more deeply a man becomes imbued with Masonic teaching, the more earnest and active will he become in every good work for the relief of every form of human woe and suffering. The true Mason's ear, while it is peculiarly alert to catch the faintest cry of distress that is wrung from a brother's heart, is never closed to that cry, from whatever quarter it may come. Wherever a tear can be wiped from the cheek of sorrow, or the oil of kindness poured on a bruised and bleeding heart, there he will be found with his ready sympathy and his genial aid.

And now, my brethren, having in this and previous addresses urged upon your consideration some of the cardinal points of our Order, let me, with all due respect and affectionate earnestness, ask you to review your responsibilities as members of a society which inculcates such high and holy lessons. It cannot be denied that the system of morality in which we have been instructed is the very highest and best that the wisdom of man has ever devised. Nay, may we not say reverentially that in the symmetry of its plan and the completeness of its teachings, it reveals the handiwork of Him who "hath made everything perfect in its season?" Let each one of us, then, ask himself the question, Do I, as an individual member of the great Masonic body, in any adequate degree represent what ought to be the fruits of such a system? We speak sometimes of *typical men*, representative men; we say that we should choose such and such a man if we had to make a personal choice, to represent the English or the American character, or to represent any feature of modern civilization? Now, I ask, do we, as Masons, in any worthy degree, gather up the educational influences which are surrounding us and operating upon us, and express these in a life that cannot be mistaken, a life so unimpeachable, so pure and so noble that even those who stand at a distance must be constrained to admit the value of a system which can produce such beautiful and beneficial fruits? Let us honestly ask ourselves this question, and in dependence on that source of strength to which we are constantly taught to look for help and succor, let us resolve, from this day forward, to strive more earnestly to set to our brethren and to the world at large, the example of a pure, an earnest and consistent Masonic life.

It was moved by R. W. Bro. Tait, seconded by R. W. Bro. Myers,

That the thanks of this Grand Lodge are due, and are hereby tendered, to R. W. Bro. Nye for the able and eloquent address just delivered.

Carried unanimously.

The Grand Secretary was directed to have the address of the Grand Chaplain transcribed in the minutes and published with the proceedings of this Communication of Grand Lodge.

At 11 o'clock a.m. this day the election of officers for the ensuing year was proceeded with, pursuant to the resolution adopted yesterday by Grand Lodge.

The Grand Master briefly addressed Grand Lodge, thanking them for the honor conferred on him by his election to the very important office of Grand Master.

The Board of General Purposes through its President, made the following report:

The Board having taken into consideration the condition of Clarke Lodge No. 28, and Zetland lodge late 21, recommend as to the former that the warrant be withdrawn, and as to the latter that the Secretary or whom it may concern, be summoned to appear before the Dis. Dep. Grand Master, Montreal District, with the books and records of the lodge, to be dealt with as said D. D. G. M., who is hereby authorized in the premises, shall see fit.

The Board further recommend in regard to Nelson lodge late No. 8, C. R., and Clarenceville lodge No. 14, that they be admonished previously to more severe measures being taken against them.

The report on motion was received and adopted.

The Board of General Purposes made the following report:

The Wor. Master of St. George lodge No. 6, having, as requested by the Board, produced the original warrant of St. George lodge No. 440, E.R. and having stated that his lodge was willing to abide by the decision of Grand Lodge on the whole subject matter of dispute between said lodges, in view of the serious questions involved the Board recommend to defer final action until a thorough investigation of the whole subject can be had, the warrant in the meantime to remain in possession of Grand Lodge.

R. W. Bro. Jas. O'Halloran moved, seconded by R. W. Bro. Alexander:

"That the report be received and adopted."

R. W. Bro. Lecappelain moved in amendment, seconded by R. W. Bro. Renshaw:

"That the closing words 'Grand lodge' of above report be struck out and the words St. George lodge No. 6 be substituted therefor."

A vote having been taken the amendment was declared carried.

The Board of General Purposes made a report in favour of the recognition by this Grand Lodge of the Grand Lodges of Manitoba, Prince Edward Island and Wyoming, as being legally constituted Grand Lodges, and the report was cordially received and adopted.

R. W. Bro. H. M. Alexander, then moved seconded by R. W. Bro. Jas. O'Halloran.

That the thanks of this Grand Lodge are due and are hereby heartily



tendered to James Tasker Esq. Principal of the Business College in this city for the use of one of his commodious rooms for the purposes of the business of G. L.

The motion was carried unanimously and the Grand Secretary desired to carry it into effect.

A vote of thanks was also adopted in favor of the different railway and steamboat companies who had carried delegates and visitors to the present communication of Grand Lodge to and from Montreal at reduced rate of fare.

V. W. Bro. Lecapellain gave notice that he would at the next annual communication of Grand Lodge move.

That Art. 3, page 30 of the Book of Constitution be struck out.

R. W. Bro. Alexander Murray moved seconded by W. Bro. Butler

That hereafter the Grand Secretary be instructed to forward to every member of this Grand Lodge a copy of the printed proceedings.

There being no further business before Grand Lodge the Grand Secretary read the rough minutes of the proceedings to the close which were approved.

The Grand Chaplain offered the following closing prayer :

" We yield Thee hearty thanks, Most Gracious God, for all Thy mercies, and, particularly, for those which Thou has vouchsafed to us, during our present communication. We bless Thee for the peace and harmony which have prevailed in our deliberations, and for whatever good we have accomplished thereby. And now that we are about to separate, to go to our several homes, we pray that Thy blessing may be with us and our families.

" We ask for Thy special assistance in behalf of those who have been this day installed into office in this Grand Lodge. May they be endued with all necessary wisdom for a right discharge of the important duties which have been committed to them.

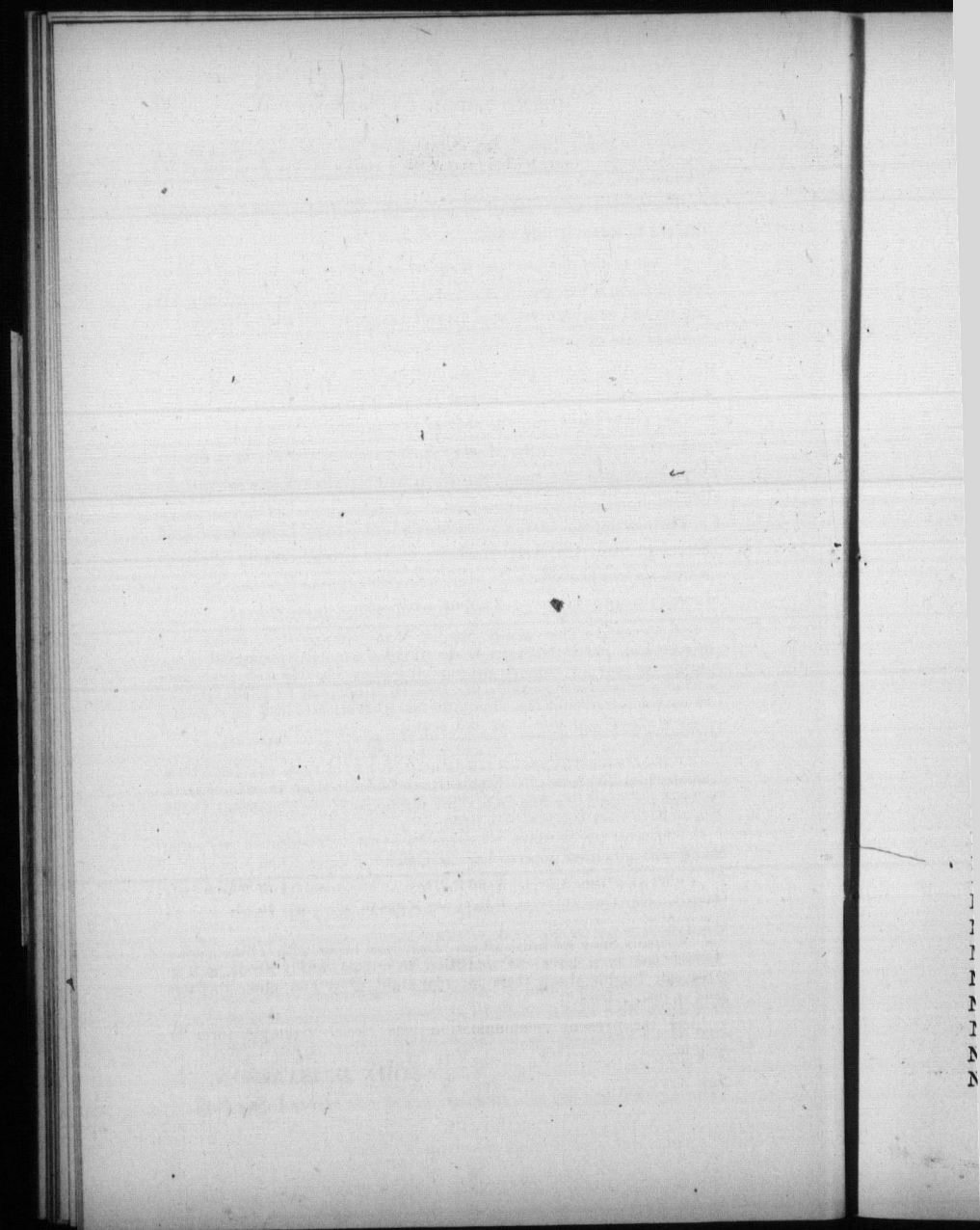
" Bless all our brethren, wherever dispersed; and grant speedy relief to all who are either oppressed or distressed.

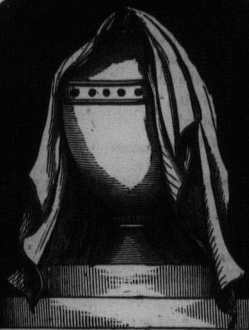
