CEREMONY OF THE PRODUCTION OF PARLIAMENT.

Parliament has been prorogued by the King in person.

About one o'clock, the different diplomatic personages entered the House of Lords, which was already crowded with peers, ladies &c. The French ambassador was the first to enter, and without a single exception, the whole corps diplomatique, for every country in the world having amicable relations with England, were present. A great many foreigners were in the house, and a fair sprinkling of Americans.

The peers wore their robes, and among those present were the Duke of Wellington, Norfolk, and Leinster, the Archbishops of Armagh and Canterbury, Lords Lyndhurst, Byron, Wharfedale, Dundas, Browlow, Charleville, Marston, Verulam, &c. The only Ministers in attendance were Lords Melbourne, Duncannon, Glenelg, Minto, and the Lord Chancellor.

A little after two, the King reached the House of Lords, and immediately passed to the robing room, being met on his way by the Premier, Lord Chancery, Earl of Shaftesbury, Duke of Norfolk, &c. Lord Melbourne carried the sword of state, Lord Shaftesbury the cap of maintenance, and the Duke of Norfolk his baton as Earl Marshal of England.

The King when robed (in a purple velvet cloak with ermine tippet) entered the body of the house and took his seat on the throne—first bowing to the ladies. The Commons were then summoned; the King desired the Peers to be seated, which desire was complied with, but the Foreign Ambassadors did not sit down. While the Commons were coming, the King chatted with the Premier and the Earl of Shaftesbury.

The Commons entered the House of Lords when the Speaker made a long speech recapitulating all that the Commons had done, in the law making line, since the opening of the session. After this, the King put on his spectacles and read the following "most gracious" speech.

[This speech has already been published in the Standard.]

The Lord Chancellor having received, kneeling, His Majesty's commands to prorogue the Parliament, said, "My Lords and Gentlemen: It is His Royal will and pleasure that Parliament be prorogued to Thursday, the 20th day of October next."

The Speaker with the Member of Commons retired.

His Majesty rose and quitted the throne, proceeding in the same manner, accompanied by the Great Officers of State, as on entering the House. After descending the two steps from the throne, His Majesty recognized the Duke of Wellington, who was standing near, to whom he addressed a few observations. Lord Melbourne, who preceded the King with the sword of state, waited until His Majesty was pleased to go on. The other Noble Lords likewise stood still. The King with the Officers of State, then left the House.

A very amusing debate took place on Wednesday, in the House of Commons, on the proposal of £400 to be laid out in the erection of a gallery for the accommodation of the ladies. That they should be allowed to listen to the debates was conceded (in fun) to the motion of the Hon. Granville Berkeley. The Earl of Lincoln and the Chancellor of the Exchequer said that they personally objected to the ladies being in the House. Mr. Ewart said they were as much entitled to attend the House of Commons as any other place. Mr. Tooke (an old barrister) thought "the admission of ladies would interfere with the safe discharge of Members' duties." "Which duties?" Mr. Porter hoped the House would not treat the ladies "as mere play things!" He was afraid I suppose, that the young legislators would be for toying with the fair ones! Sir J. C. Hobhouse objected to the presence of ladies, because many things were said in the House which would be indecent for ladies to hear, and the ladies would, he thought, make home miserable, by renewing in the day the transactions of the ever night. (Oh, Sir John!) Lord Palmerston said this was quite a private question. He could see no inconvenience that could arise from the presence of ladies during the debate. For the first night or two some trifling inconvenience might perhaps be felt, but it would be nothing when the novelty were off! What would Madame Vestris say to this? "The novelty wear off," after "some little inconvenience for the first night or two!" The motion was thrown out, and so ladies will not be allowed to hear the debates in the Commons. Tant mieux! Let them stay at home and mind their household affairs. What do they want with dull and dreary politics?

ADDRESS TO HIS MAJESTY.

Previous to the commencement of the Egmont races His Majesty was most graciously pleased to receive a deputation of the gentry and inhabitants of the Town and neighbourhood, with an Address of thanks for his late munificent grant of a free plate of 100 guineas to the races; to which His Majesty was pleased to return a most gracious answer.

LIVERPOOL, August 22. After a great deal of changing and chipping, you see the newspaper duty has been reduced. The London and Liverpool papers will sell at 6 pence each instead of 7 pence, (except the *True Sun*, which will be sold as low as four pence) and most of the country papers will be 4d 1-2.

Very expensive law charges are spoken of for Ireland. The Master of the Rolls, Mr. W. M'Mahon, is to have an English Peerage (Viscount) and a pension of £3000 a year for life. Sergeant O'Loghlin's place of Attorney General, and Shiel (the Quaker) will

be made Solicitor General. O'Loghlin and Shiel are Catholics.—These appointments will give satisfaction to the mass of the Irish people. In England they will not be so popular as the "No Popery" feeling is prevalent here.

The Lord Lieutenant of Ireland (Mulgrave) has been travelling through the South of Ireland, and at each large town has been received with the *cent mille félicités* (hundred thousand Welcomes). At Waterford on Monday, he dined at the Town Hall, with the citizens. Previous to the dinner, an attempt was made to burn down the building.

O'Connell is in the full tide of agitation. He has again thrown by what he calls "the cry for Repeal" and is strictly in favour of the Ministry. He goes further, however, than they will ever go, because he says that now he will not be content with less than a reduction of 50 per cent in tithes, and the total separation of church and state. He pledges himself to bring forward a measure next session for the total repeal of the English Church rates.

He has published an address to the people of Ireland, from the General Association of Ireland, calling upon them to put an end to faction fights (at faras, &c.) which disgrace the character of the country, and afford a pretext to the Tory judges for the enforcing of the most harsh laws. This address is powerfully written, and will certainly do much good.

The cost of collecting the public revenue of England is £3,559,338;—this includes all expenses of the collection for the five branches, viz: Customs, £1,356,725; Excise, £1,072,392; Stamps, £203,815; Taxes, £209,372; and Post office, £115,401. The ratio between the expense of collection and the gross receipts of the national revenue is at 1 to 13.

The Benevolence of a Miser.—Early in life Mr. Robert Gordon, a gentleman of good birth and family, determined to relieve the indigence of decayed merchants, a class whose poverty is ennobled by the recollection of better days, by endowing an institution for the education and maintenance of their sons. To do this he devoted a life of self denial and privation; scorned and laborious days. He resided in a miserable garret, without attendance; he used to pick up every trifling article that would turn to account, and so warm himself and save a fire. The cold winter nights he would walk through his room with a bag full of stones on his back. After his death the little bits of twine he had collected off the streets sold for several pounds. He left an endowment of £100,000 in Aberdeen known by the name of Robert Gordon's Hospital.

Banqueting.—Earl Spencer is presently on a visit to Lord Panmure, at Brechin Castle. The Earl is enthusiastically fond of cattle, and Lord Panmure, with the view of gratifying his Lordship, as well as placing before the eyes of a prize, the animals reared by the breeders in this quarter as the best, got a number of the beasts exhibited at the agricultural show last week brought to Barchill Park last Wednesday, when they were inspected by the Noble Agriculturist. His Lordship, we believe, expressed himself in terms of high commendation of the cattle exhibited, but thought, nevertheless, that the breed of some of the kinds was still capable of being improved by crossing. Lord Panmure, we understand, also takes Earl Spencer up to Milneden to the grouse shooting. Brechin Castle has also, this week, been visited by Lord Lynedoch.

An Act of Parliament has just passed, which settles a disputed point in regard to bills of Exchange, and which ought therefore to be known to men of business generally. The point alluded to is that respecting acceptors of referees for honour, in which no uniform practice existed, some houses presenting the bill so marked on the day when they became due, and others on the day after. It is now declared, however, that it shall not be necessary to present such bills of exchange until the day following that on which they become due, and if the address of the acceptors or referees for honour shall be in any other place than that in which the bills shall be made payable, they need not be forwarded until the day succeeding that in which they become due. If the following day shall be either Sunday, Good Friday, or Christmas Day, they need not be presented or forwarded until the day succeeding such day of non-business.—*London Times.*

Houston elected President of Texas, and Lamar Vice President.—Mexican prizes taken.—*Houston Reclamation.*—more Indian butchers in Florida—thirteen thousand Indians on their way to Arkansas.

TEXAS.

Gen. Houston has been elected President and Lamar Vice President of Texas. Another attempt had been made to rescue Santa Anna, by a Spaniard named Paves, who acknowledged he was in the pay of the Mexican consul at New Orleans. The army, 3000 strong had removed their encampment from Matagorda Bay to the Garcite. The Terrible had taken several Mexican prizes. General Houston has made a call for the organization of the militia to support Gen. Gaines' force. An attack from a body of Mexicans and Indians of the prairie being meditated on Nacodoches, and thereabouts.

BALLOON ASCENSION, AND UNFORTUNATE ACCIDENT.

Mr. Launier made an ascension on Saturday at ten o'clock at Rochester. There was an immense crowd collected, and all the houses in the neighbourhood of the amphitheatre from which he started, were covered with persons. A work-house, in which there was more than one hundred human beings, fell in with a horrible crash, made more fearful by the frightened screams of those upon it. The Rochester Daily Democrat, says: "We hastened to the scene, and beheld one of the most heart-rending sights that ever crossed our vision. Fifteen or twenty men and boys lay helpless among the fallen timbers, covered with blood and groaning in pain. Of the number, at least 6 had some of their limbs broken, while others were dreadfully mangled."

MARQUIS OF SLEGO.—H. B. M. frigate Belvidera, Chas. B. Strong Esq. commander, arrived off the Hook yesterday, last from Havana. She left Barbados on the 20th ult. with Sir Lionel Smith and suite, for Jamaica, to assume the government of that Island, and left thereon the 6th inst. with His Excellency the Marquis of Slego and family, late Governor of Jamaica, touched at Havana, and sailed for New York on the 14th. The frigate anchored on the bar yesterday, and will come up to Quarantine this morning, should the wind prove favorable. She is a fine looking frigate mounting forty two guns, and a crew of two hundred and sixty men. The Marquis intends going to England in one of our packet ships.

DESTRUCTIVE FIRE.—This town was visited on Tuesday morning by one of the most destructive conflagrations which have occurred here for several years. The fire broke out a little after midnight in the premises occupied as a Brewery, by Mr. Peter Morrissey, in Albermarle Street and before any effective assistance arrived, had obtained such an ascendancy, as rendered it impossible to arrest its progress until 2 thirds of the entire square in which it originated were destroyed. It was nearly four o'clock before the flames were extinguished. Mr. Morrissey we believe, a severe sufferer—his property was insured for £1500, but this sum will cover but a small portion of his loss. Dr. Head lost two houses uninsured. ALBION MINES.—TRADE OF PICTOU.—Owing to the greatly increased demand for Coal, we understand that the Albion Mining Association have it in contemplation to extend the Rail road from its present termination below New Glasgow to the loading station, and ultimately, to Abercrombie's point, opposite this town; when, in either case, Locomotive Engines will be employed in propelling the cars—and thus the enormous expense and delay occasioned by the present mode of conveyance down the river in Lighters, will be avoided. While we rejoice to see the company projecting measures commensurate with the importance of the Trade, in which they are engaged, we can perceive some important advantages that will accrue from the new arrangement; the expense of the doubtful scheme of deepening the river, will be rendered unnecessary; a much greater quantity of coal can be delivered on board in the same time and at much less expense than by the present mode, and if the railway is extended the whole distance we have mentioned, the additional advantages will follow, of their being able to ship a month or six weeks later, than they can now do in the weeks later, and there is a strong probability of their sinking a shaft or shafts at the north end of, or along the line of the Rail road, with equal success, as at their station up the river. There can be no doubt but that the coal fields extend along the whole line of the intended road.

We are happy in being able to inform our townsmen, that there is at present a strong probability of this port ranking first in the Province, in tonnage of shipping for the current year; and although our friends in Halifax, may exceed us in the value of their exports, yet the value of ours is vastly enhanced by the circumstance of its being created capital—it is wholly extracted from the soil, the set, or the bowels of the earth, by the industry and perseverance of the inhabitants; whilst the trade of the capital consists chiefly of the transit of goods from one country to another.

We have to congratulate our farmers also, on the prospects there are, of their obtaining Cash and high prices, for every article of farm produce through the Winter. The hay crop has been all secured; and on the whole is as good in quality and quantity as that of last year. The potatoe crop makes fair promises. Country produce is at a good price, and finds a ready sale. Butter is scarce, and has been selling at a shilling a pound. The barter system of this place is rapidly giving way to cash business. This is as it should be, and all classes of the community will benefit by the change. Lumber, fish &c. have this year commanded good prices generally in the West Indian market—and the return cargoes of our vessels meet with a ready sale. Dry codfish, are still in demand at a high price.—*Yarmouth Herald.*

Provincial.

COALS.—We called the attention of the public lately to the high price of firewood, and we now have to advert to the dearth and scarcity of Coals. Some mornings during the past week have reminded us feelingly of the approach of winter, and induced us to look out for the necessary supply of fuel. But to enquire we found that coals are at 22 2s. 6d. to 23 5s. per chaldron, and not readily procured at those prices. It reflects disgrace on this Province, that containing as it does an abundant supply of excellent coals being got at and raised, that coals should be allowed to attain their present high prices. During the past season, coals have been delivered at the mines on the bank of Salmon River at Ten shillings per chaldron, and although raised in the most unscientific manner and almost without mechanical aid, they yielded a fair profit to the miner. Why then cannot some spirited measures be taken for working the mines? They will be sure to yield a good profit at all times on a small investment, and at present prices, prove a source of unbounded wealth to the fortunate proprietors. The great increase in the number of our Steamers, all consuming coals, has caused the present scarcity, and the supply which reaches us yearly from England falls far short of the demand. The time has arrived therefore when our coal mines can be worked to great advantage for home consumption; the export of the article would no doubt prove highly profitable also. We trust some enterprising individuals will soon take up this business, as we can promise them a speedy reward. Let our mines be once properly opened, and worked in a regular manner and on a sufficiently extensive scale, and we should soon see a large portion of that numerous fleet constantly coasting the dangerous shores of Nova Scotia and Cape Breton to obtain a supply of coals for the American market, bending their course to this harbour, and where they would at all times and open, and where they ought constantly to find an article equal in all respects to the best ever furnished from the Sydney Mines.—*Courier.*

COUNTY OF CHARLOTTE.

On Tuesday the 4th inst. a Court of Oyer and Terminer and general Gaol delivery was opened here under Special Commission by Judge Parker. After the preliminary forms were gone through, the following Grand Jury was impanelled.

Previously to delivering his charge to the Grand Jury, Judge Parker stated that there were two persons named in the Calendar whose crimes this Court was not competent to take cognizance of, as they could only be tried in the Court of Vice Admiralty; and that there only remained one case of indictment to be brought forward. The admirable charge which His Honor delivered to the Grand Jury, we have not yet got transcribed, but we shall give it next week; as well as a condensed Report of the trial of James Robinson for the murder of Matthew Lynch, which occupied the whole day and resulted in a verdict of acquittal.

The Grand Jury on being discharged presented the following address:—

To His Honor Judge PARKER;
May it please your Honor,

It is with no common satisfaction that the Grand Jury of the County of Charlotte approach your Honor, on this first instance of seeing you preside in the Supreme Court to which high station it has pleased His Majesty to elevate you.

Known as your Honor is, in this dependency of the British Crown, it might be deemed superfluous for a sectional body to reiterate the voice of the people, already expressed nearly throughout all its bounds, in testimony of your Honor's exemplary character, whether in a domestic, legislative, or legal point of view; but with reluctance, reasonable exceptions which your Honor's profession took to judicial appointments from the parent Country to this Province, the Grand Jury of Charlotte wish to express their admiration of that gracious countenance which His Majesty has not withdrawn from the legal profession of this loyal Colony, but has given his subjects here an earnest of his paternal consideration for their welfare, by conceding to their wishes the appointment of an upright and talented native of the Province, in the person of your Honor, to a seat on its judicial Bench.

That you may long enjoy that seat, and continue in your course of usefulness, is the unqualified wish of the Grand Jurors of the County of Charlotte.
