## B I L L.

An Act to facilitate the execution of Judgments in  
Lower Canada.

**W**HEREAS it is necessary to provide more efficiently Preamble.  
for enforcing judgments of the Courts in Lower  
Canada in cases of resistance to the execution thereof:—  
Be it therefore enacted, &c.

5 I. That every Court of Justice shall have the same Powers of the  
Court.  
powers in case of resistance to its process as regards any  
sale or other incidental proceeding as it now has by the  
Laws of Lower Canada in case of such resistance as re-  
gards any seizure.

10 II. That every Judge of any such Court shall have in And of any  
Judge.  
vacation, at Chambers or at his residence, the same powers  
as the Court whereof he is a member, in all cases of re-  
sistance to its process.

III. That this Act shall apply to Lower Canada only. Extent of Act.
