An Act to detach the local Municipality of of the Parish of St. Antoine de l'Isle aux Grues from the Municipality of the County of Montmagny, and to erect it into a separate Municipality.

**MR. BEAUBIEN.**

An Act to detach the local Municipality of the Parish of St. Antoine de l'Isle aux Grues from the Municipality of the County of Montmagny, and to erect the same into a separate Municipality.

WHEREAS the Parish of St. Antoine de l'Isle aux Grues, and the Islands adjacent, in the County of Montmagny, are separated from the main land by a wide expanse of water, and it has become requisite that these localities together should form a Municipality, separate from and independent of any County Municipality; Therefore Her Majesty, &c., enacts as follows :

I. Upon, from, and after the first day of January next, the Parish of St. Antoine de l'Isle aux Grues, and the islands adjacent thereto, shall, together constitute a distinct and separate Municipality, under the name of the Local Municipality of the Parish of St. Antoine de l'Isle aux Grues; and the said Municipality shall not form part of any County Municipality, but shall continue to have its local council as provided by the Municipal and Road Act of 1855, and the Acts amending the same, and all appeals and revisions which ought to be made to and by County Municipalities in virtue of the said Acts, shall be made to and by the Circuit Court within whose jurisdiction the said Municipality is, and the said Court is hereby specially authorized to take cognizance thereof, and give judgment therein in the same manner as the County Municipality, the Clerk of the said Court acting in the stead of the Clerk of the Council.

St. Antoine de l'Isle aux Grues erected into a separate and independent Municipality.

Appeals, &c., to be to Circuit Court.

II. This Act shall be deemed a public Act.
