





DETAILED ACCOUNT of the MONEYS appropriated during the Third Session of the Fifth Provincial Parliament of Canada; specifying whether the appropriation was made by Act of Parliament, or by Warrant upon an Address of the Legislative Assembly.

(The Numbers subjoined to the undermentioned Bills, have reference to the preceding Schedule of Bills, by turning to which the Titles of the several Acts will be found at length.)

I.-WEEKLY POSTAL COMMUNICATION BY STEAMERS BETWEEN CANADA AND THE UNITED KINGDOM. (See Bill No. 176.) (Act 20 Vic., cap. 9.)

This Act authorizes the payment, out of the Consolidated Revenue Fund, of the sum of £50,000, per annum, for a period not exceeding 6 years, to aid in the establishment of Weekly Postal Steam communication between the River St. Lawrence and Liverpool in summer, and between Portland and Liverpool during the winter months, in order to render more complete the Postal arrangement between the United Kingdom and Canada

### APPROPRIATIONS.

II.--SHARE OF COST OF LIGHTHOUSES IN OR NEAR THE GULF OF ST. LAWRENCE. (See Bill No. 208) (Act 20 Vic., cap. 10.)

This Act authorizes the payment, out of the Consolidated Revenue Fund, of the sum of £750, as its share of the expenses incurred in creating and maintaining Lighthouses on Cape Race or elsewhere, as it may be agreed upon between the Imperial Government and this Province, for the safety of vessels navigating the River or Gulf of St. Lawrence.

#### III.—GRAND TRUNK RAILWAY COMPANY OF CANADA TO DISPENSE WITH GOVERNMENT DIRECTORS AND TO COMPLETE THEIR WORKS FROM RIVIERE DU LOUP TO SARNIA. (See Bill No. 224.) (Act 20 Vic., cap. 11.)

By this Act the appointment of Government Directors in the Grand Trunk Railway Company of Canada, is dispensed with; and it authorizes to grant further facilities to the said Company, on condition that they complete their Railway from Rivière du Loup to Stratford, and thence to St. Mary's to Sarnia, including the Victoria Bridge, and other works mentioned in the Act of 1856, within one year from the time limited by that Act, and maintain the same in operation,—the Province foregoes all interest on its claims against the Company,—until their carnings shall suffice to defray the working expenses, the rent of the Atlantic and St. Lawrence Railway,—interest on other Bonds of the Company,—and a dividend of six per cent. on the Capital.

IV.--SUPPLY BILL FOR 1857. (See Bill No. 395.) (Act 20 Vic., cap. 17.)

This Act authorizes the payment, ont of the Consolidated Revenue Fund, of the sum of  $\pounds 729,078$  11s. 8d. currency, for defraying the expenses of the Civil Government of the Province, and other purposes, for the year 1857.

It also authorizes the payment, out of the Consolidated Revenue Fund, of the sum of  $\pounds 225,000$ , for the necessary expenses of buildings and accommodation for the Government and Legislature at the permanent seat of Government to be selected by Her Majesty.

It further authorizes the issue of Debentures to the extent of £325,000, for expenses connected with the Public Works.

V.--THE FISHERY ACT. (See Bill No. 279.) (Act 20 Vic., cap. 21.)

This Act authorizes the appointment of two Superintendents of Fisheries; one for Upper Canada, and one for Lower Canada.

#### VI.—PRISONS FOR YOUNG OFFENDERS—THE BETTER GOVERNMENT OF PUBLIC ASYLUMS, HOSPITALS, AND PRISONS,—AND THE BETTER CONSTRUCTION OF COMMON GAULS. (See Bill No. 222.) (Act 20 Vic., cap. 28.)

This Act authorizes the erection of a Reformatory Prison for Young Offenders- one for Lower Canada, and one for Upper Canada; to each of which shall be appointed a Warden, a Protestant, and also a Roman Catholic Chaplain, a Surgeon and a Clerk; the Warden to appoint, with the consent of the Inspectors, such other Officers and Servants as may be required.

The inspectors to be appointed under the Act to be vested with the same powers and duties, as those of the Provincial Penitentiary.

It also authorizes a Hulk or Receiving Ship, fit for Ocean service, to be fitted up, if necessary, at or below Montreal; the Captain to be Warden, with powers alike to those above mentioned.

It also authorizes the appointment of five Inspectors of all Public Asylums, Hospitals. Common Gaols and others Prisons, in this Province.

It also authorizes the payment, out of the Upper Canada Building Fund, of one half of the expense, and not exceeding £1,500, for any one County in Upper Canada, to aid in making alterations in the Gaols of their respective Counties.

And it further authorizes the erection of a Criminal Lunatic Asylum, in the vicinity of the Provincial Penitentiary at Kingston, for the reception of Criminal Lunatics, and the; appointment of a Medical Superintendent and other Officers, with the same powers as those of the Provincial Lunatic Asylum at Poronto.

#### VII.---TO ENCOURAGE AGRICULTURE AND TO PROVIDE FOR THE PRO-MOTION OF MECHANICAL SCIENCE. (See Bill No. 385.) (Act 20 Vic., cap. 32.)

By this Act, (which re-organizes the Bureau of Agriculture, Agricultural Associations, Boards of Agriculture, and County and Township Agricultural and Horticultural Societies,) the following payments are authorized to be made :---

To each County (or Electoral Division) Agricultural Society in Upper Canada, subscribing not less than £25, a sum equal to three times the amount subscribed, to be limited to £200, in cortain Counties, and £250, to each of the remaining Counties, with a further sum of £100, for the encouragement of Horticulture, Agriculture, Manufactures, and Werks of Art. One-tenth of all such grants to be retained for the use of the Agricultural Association.

#### VIII.-COUNTY ATTORNEYS, IN RELATION TO THE LOCAL ADMINISTRA-TION OF JUSTICE IN UPPER CANADA. (See Bill No. 34.) (Act 20 Vic., cnp. 59.)

By this Act a County Attorney is to be appointed for each County in Upper Canada, who shall be allowed fees in certain cases, chargeable as part of the expenses of the Administration of Criminal Justice in Upper Canada; he shall also receive a per centage on the Fee Fund moneys from the several County Court and Division Court Clerks, and also a per centage upon all public moneys coming into his hands.

IX.--ACCOMMODATION FOR THE COURTS OF SUPERIOR JURISDICTION IN UPPER CANADA. (See Bill No. 860.) (Act 20 Vic., cap. 64.)

This Act authorizes the issue of Debentures of the sum of £10,000, at a rate of six per cent interest, per annum, redeemable within 20 years, as a further aid to enable the Law Society of Upper Canada, to erect buildings suitable for the accommodation of the Superior Courts of Law and Equity in Toronto. Provision is made for the payment and interest of these Debentures, by extending and continuing the provisions of the Act 9 Vie., cap. 93, imposing a tax on certain Law proceedings in the said Courts.
