
THE PREMIER AND HIS MASTER. THE PREMIER AND HIS MASTER. Sherbrooke is rather more than half French and a goodly battalion of ora-tors who speak that lancrage were turned loose on the ccuptry. 

MR. BLAIR'S FAILURE,

The report of the department of railways and canals is behind hand, like the rest of the blue books, but the short statement of Intercolonial rail way accounts goes to show that he has not made an astonishing success of the year's business. In general 1899 was a great year for the railways, most of the lines showing an increas of ten to twenty-five per cent. in gross earnings. Mr. Blair's road gains less than five per cent. when allow-ance is made for the additional mileage. The minister claims a revenue of \$3,738,331 and an expenditure of \$3,675,6866 showing a surplus of \$62,-645. he actual outlaw has been over a million dollars larger than is represented in the above statement, but this \$1,081,929 is called "apital expenditure, \$1,081,929 is called "apital expenditure, and is not charged against the vear's business. Of this, however, "640,000 is for rolling stock, Much of this plant is required to replace old ears and engines, and should go in as regular expenditure for the year. There is a charge of \$50,000 for iron bridges, which is also in the capital account. These are bridges replacing others found too weak for the large angines. which intimated as plainly as words could have done, that they considered the prisoner's fate to be sealed. Father Montmoulin himself listened with closed eyes, pale, but perfectly composed, his lips occasionally moving in eilent prayer. When his counsel rose to answer, he looked up at him almost compassionately, as it to say: My dear Sir, you have a difficult, and I fear a thankless task before you. Mr. Meunier was a conscientious

lawyer, but as a speaker he was by no means equal to the prosecutor. His defence was carefully elaborated. but it was dull and tedious, more suited to influence the judges than the jury. He began by portraying at considerable length the early years of the prisoner, depicting him as a clever pious boy, an exemplary Seminarist, a model priest, from whom the enemies of the clergy in general could not withold a tribute of praise. And now they were expected to believe that this gentle, guileless, upselfish man was a thief and a murderer! He, who would share his last crust with the poor, was said to have robbed his benefactress of a sum which was the property of the poor, and for the sake of this money, of which he could easily have obtained possession some other way -for instance, he might have said it had been stolen from his desk in the night-he had assassinated a woman most helpful to him, and moreover done so in such a clumsy manner as to cause suspicion to fall upon him immediately ! Who would be so credulous as to believe this possible ?- They were not in presence of a psychological problem, but of a psychological impossibility. Such a man could never have done such a deed!

There must be another answer to the question. Who committed the orime? than that given by the prosecutor, and any and every solution of the puzzle would appear more probable than his. The ocurt might perhaps think it ridiculous on his part, but in reality, he would sooner believe the extraordinary suggestion of the old servant, than believe so excellent a priest capable of the work of an aseassin.

But it was not necessary to have recourse to the preternatural, to find a key to the enigma. The sacristan Loser was just the sort of man to be guilty of such a deed, and the alibi proved by the prosecutor rested, as a matter of fact ; only upon the evidence of one railway guard who might well be mistaken. Indeed he must have been mistaken, as was shown by the evidence of the bar maid of Croy Rouge, as she confi dently asserted that she had seen the sacristan on the morning of the crime, and under very suspicious circumstances. True, the girl wavered somewhat afterwards in her statement, but it did not require very much of the skill of a lawyer, for the possession of which he scarcely envied his learned collesgue, to confuse and bewilder an ignorant peas-


