2. That the Privy Council of Canada, having passed the Remedial Order, is also bound to pass some kind of remedial legislation for the benefit of the minority in case Manitoba should herself refuse to remedy their grievance.

3. That the Conservative party has no desire to pass such legislation; that they rather prefer that Manitoba should of her own accord make some remedial or reasonable compromise, as Mr. Oustigan pointed out. The issue is not whether the school question is a remedial one, but whether the Catholic minority has been deprived of any rights, and the courts say they have.

At this stage it looks as if Manitoba will refuse to do anything, and that after a reasonable time has been given her to consider the whole question, the Government will bring in a bill to be passed by the House of Commons, which will be asked to pass a law which would exempt Catholics from paying Public school taxes in Manitoba. How Parliament could go much further so as to administer a separate school law in Manitoba, if it passed one.

It could only do this, as stated above, except Catholics from the Public school taxes. It could in this remedial legislation and certainly would declare that Manitoba had complete jurisdiction over any separate schools to regulate them; to prescribe text books and examinations for teachers, etc. But even to pass this mild remedial legislation will be a strain, in so far as the Province of Ontario is concerned. As the Government has no intention of interfering with the school question, the wisest course.

If the establishment of a civic plant on the effect of compelling these companies to reduce their rates by only ten per cent, we can save yearly \$90,000. That is a low estimate to make of the saving that will be effected. As soon as the city possesses of the plant, the facilities for furnishing light at the lowest possible cost, instead of securing a reduction of ten per cent, we would more likely get the benefit of twenty per cent reduction. This is the great argument in favor of the city establishing its own plant. If we had the means of dealing with the Gas Company, as we have in dealing with the electric light companies, we would soon see the former on its knees and offering gas at 75 cents a thousand feet. At most, the installation of a new plant would mean the expenditure of \$275,000. This sum is \$25,000 in excess of what the best prospective plant need cost. We say it is no exaggeration to state that the saving that citizens would effect by introducing competition would in three years wipe out the whole cost of the plant. Independent of this, however, we will actually save anything from \$10,000 to \$20,000 at the outset. If we operate our own plant, instead of giving the contract to an independent company. At this stage it looks as if Manitoba will refuse to do anything, and that after a reasonable time has been given her to consider the whole question, the Government will bring in a bill to be passed by the House of Commons, which will be asked to pass a law which would exempt Catholics from paying Public school taxes in Manitoba. How Parliament could go much further so as to administer a separate school law in Manitoba, if it passed one.

It could only do this, as stated above, except Catholics from the Public school taxes. It could in this remedial legislation and certainly would declare that Manitoba had complete jurisdiction over any separate schools to regulate them; to prescribe text books and examinations for teachers, etc. But even to pass this mild remedial legislation will be a strain, in so far as the Province of Ontario is concerned. As the Government has no intention of interfering with the school question, the wisest course.

THE PLANT PAID FOR IN THREE YEARS

The mere mention on the part of the city to establish its own electric lighting plant had the effect of bringing down the price from \$108 to \$74, which amounts to a saving of \$34,000 a year on one thousand lamps. The actual installation of a plant of our own will prove even more beneficial to the city. We pay yearly to the Gas Company about one hundred thousand dollars, and probably half that sum to the electric light companies for power and light supplied private individuals. If the establishment of a civic plant on the effect of compelling these companies to reduce their rates by only ten per cent, we can save yearly \$90,000. That is a low estimate to make of the saving that will be effected. As soon as the city possesses of the plant, the facilities for furnishing light at the lowest possible cost, instead of securing a reduction of ten per cent, we would more likely get the benefit of twenty per cent reduction. This is the great argument in favor of the city establishing its own plant. If we had the means of dealing with the Gas Company, as we have in dealing with the electric light companies, we would soon see the former on its knees and offering gas at 75 cents a thousand feet. At most, the installation of a new plant would mean the expenditure of \$275,000. This sum is \$25,000 in excess of what the best prospective plant need cost. We say it is no exaggeration to state that the saving that citizens would effect by introducing competition would in three years wipe out the whole cost of the plant. Independent of this, however, we will actually save anything from \$10,000 to \$20,000 at the outset. If we operate our own plant, instead of giving the contract to an independent company. We can certainly make our own light for \$65 per lamp, which with a 1,300-light system, would mean a saving of \$118,000 a year. But it is altogether likely, in the course of a year or two, we will be able to produce a light for \$50. In this estimate is, of course, included a saving of \$100,000 in the purchase of the plant, and the interest on the cost of the plant. Citizens should not be led by Mayor Kennedy's alleged warning. We will never have a better opportunity than the present for breaking up the light monopoly that now has Toronto at its mercy. If we ever intend to get rid of it, we must make a beginning now, and the sooner we make a move the better. Mayor Kennedy is willing to commit the city to a debt of \$1,000,000 in the construction of a trunk sewer, which is five or ten years ahead of our ability to pay for it, and the same number of years ahead of our requirements. On the other hand, he opposes a scheme that does not involve one-quarter of the expenditure, and that will not load us up with any debt, but will be a source of profit from the very day it is installed. The Mayor's principal argument is based on a philanthropic consideration of the company that now holds the contract. He claims that it would be wrong for the city to disturb the vested rights which are guaranteed to the company by the contract. He claims that the company has expended a very small capital in equipping its present plant. Such large profits have been made out of the city's business that the company has been enabled to set aside every year almost enough to buy its own plant as they went along, and at the same time to pay the shareholders good dividends. During the present year, for instance, the company will clear \$40,000 from its contract with the city alone. This is the kind of a picnic they have had for the past ten years, and to talk of interfering with their vested rights is pure guff. To rob is handicapped at the present time by having as its chief executive officer a gentleman who is so considerate of the interests of private individuals, as against the general welfare of the citizens as a whole.
