CLARENCE ATTACK MORE BELIEVABLE THAN REPORTED.

LONDON, Jan. 12.—Reports from Sandringham state that pneumonia, from which the Duke of Clarence is suffering, has developed into a more serious type than is announced by the physicians in their statements to the public.

The Queen, who is sojourning at Osborne House, Isle of Wight, is very anxious regarding the condition of her grandson and has ordered that information be immediately telegraphed to her of the slightest change in the Duke's condition. It is considered highly probable that unless there is soon a change for the better Her Majesty will not be spared.
