# The Keystone Oil Company

### (Non-Personal Liability)

1. The name of the Company is "The Keystone Oil Company, Limited," (non-personal liability).

2. The registered office of the Company will be situated at the City of Calgary, in the Province of Alherta.

3. The objects for which the Company is established are :---

(a) To acquire, manage, develop, work and sell mines, mineral claims and mining properties and to win, get, treat, refine and market minerals therefrom;

(h) To obtain hy purchase, lease, hire, discovery, location or otherwise and hold within the Province mines, mineral claims, mineral leases, prospects, mining lands and mining rights of every description and to work, develop, operate and turn the same to account and to sell or otherwise dispose of the same or any of them or any interest therein;

(c) To dig for, raise, crush, wash, smelt, assay, analyse, reduce, amalgamate and otherwise treat gold, silver, copper, lead, ores or deposits and other minerals and metallic substances and compounds of all kinds, whether belonging to the Company or not, and to render the same merchantahle, and to huy, sell and deal in the same or any of them;

(d) To carry on the husiness of a mining, smelting, milling and refining company in all of its hranches;

(e) To acquire hy purchase, lease, hire, exchange or otherwise such timber lands or leases, timher claims, licenses to cut timher, surface rights and rights of way, water rights and privileges, mills and factories, furnaces for smelting and treating ores and refining metals, buildings, machinery, plant or other real or personal property as may be necessary for or conducive to the proper carrying out of any of the ohjects of the Company;

To construct, maintain, alter, make, work (f) and operate on the property of the Company or on property controlled hy the Company any canals, trails, roads, ways, tramways, bridges and reservoirs, dams, flumes, race and other ways, water courses, acqueducts, wells, wharves, furnaces, sawmills, crushing works, smelting works and concentrating works, hydraulic works, electrical works and appliances, warehouses, buildings, machinery, plant, stores and other works and conveniences which may seem conducive to any of the objects of the Company, and, with the consent of the shareholders in general meeting, to contribute to, subsidize or otherwise aid or take part in any such operation though constructed and maintained by any other Company or persons outside of the property of the Company, and to huy, sell, manufacture and deal in all kinds of goods, stores, implements, provisions, chattels and effects required hy the Company or its workmen and servants.

(g) To build, acquire, own, charter, navigate and use steam and other vessels for the purpose of the Company;

(h) To take, acquire and hold as the consideration for ores, metals or minerals sold or otherwise disposed of or for goods supplied or for work done hy contract or otherwise, shares, dehcntures, bonds or other securities of or in any other Company; the objects of which are restricted as herein aforesaid, and to sell or otherwise dispose of the same;

(i) To enter into any arrangement for sharing profits, union of interests or co-operation with any other person or company carrying on, or ahout to carry on, any business or transaction which a Company specially limited under this Section is authorized to carry on;

(j) To purchase or otherwise acquire and undertake all or any of the assets, business, property, privileges, contracts, rights, ohligations and liabilities of any person or company carrying on any part of the business which a company specially limited under this section is authorized to carry on, or possessed of property suitable for the purposes thereof:

To borrow or raise money for the purposes (k) – of the Company; hut so that the amount so borrowed or raised shall not, without the sanction of a general meeting of the Company, exceed one-quarter of the amount of the paid-up capital for the time heing, and for the purpose of securing such money and interest or for any other purpose to mortgage or charge the undertaking or all or any part of the property of the Company, present or after-acquired, and to create, issue, make, draw, accept and negotiate perpetual or redeemable dehentures or dehenture stock, promissory notes, hills of exchange, bills of lading, warrants, ohligations and other negotiable and transferable instruments; PROVIDED, HOWEVER, that the restriction in this sub-section contained as to borrowing without the sanction of a general meeting shall not be deemed to be imperative and shall in no wise limit, control or affect any power of horrowing vesting in the Board of Directors of the Company or of the Company under the Memorandum of Association or the Articles of Association or Bylaws of the Company;
