



We learn that the Blanche was purchasing herring under the privileges this season. She was not exercising

the fishing liberties conceded by the Convention of 1818. It may be remembered that the Arbitrators at the Hague expressed in their award the unanimous opinion that Americans "cannot at the same time and during the same voyage exercise their Treatrights and enjoy their commercial privileges, because Treaty rights and commercial privileges are submitted to different rules, regulations and restraints."

Capt. Smith was exercising a commercial privilege. In doing so he was in the same position as if he had been in St. John's buying a cargo of dry cod, and whilst doing so had imported new sails. Had he done so, ne would have to pay duty on them here In other words, Americans are subject to all restrictions imposed on the importations of goods as any other persons would be, and, indeed, if they were exercising the fishing liberty under the Convention, that would not free them from any light, harbour, or other duty imposed upon Newfoundland fishermen, nor from any custor duty if they were allowed to exercis: the commercial privilege of importing goods, and the importation of sails is undoubtedly a commercial privilege.


