Japanese Sore At the French

Paris, May 9.—The arrival in Paris today of Paul Cambon, the French ambassador in London, following his conference with Foreign Secretary Lansdowne, will probably permit the authorities here to learn the sentiments in British official circles concerning French observance of neutrality. Thus the proposals of the French have been made from Great Britain, but it is gathered that informal talks between officials in London and Paris have permitted the British officials to see friendly counsels with both sides towards preventing the controversy from assuming an acute form.

The newspapers do not show a menacing attitude. The announcement was made today that the French government would publish a yellow book concerning French observations on the Japanese ultimatum. The publication will include the instructions sent to officers and agents of the Japanese Legation in London, and it is said that these will show the minute precautions which the government has taken to prevent a violation of France's neutrality.

Resentment Against France Tokyo, May 9.—The feeling of resentment against France for the assistance given to the Japanese ultimatum is increasing. The Japanese ultimatum is being regarded as a violation of the alliance between France and Japan.

Geo. Wyndham Explains Position

Former Chief Secretary for Ireland Gives Reasons for His Resignation.

Leader of Opposition Moves a Vote of Censure Which is Defeated.

London, May 9.—George Wyndham, who has been absent owing to illness since his resignation of the chief secretaryship for Ireland, returned to the House of Commons today and made a personal explanation of the reasons for his resignation. He said he had insisted on retiring from the cabinet because political and personal reasons had convinced him that he could better serve the government as an unofficial member. He had never had any change in the smallest degree in regard to the Irish administration. Union must be the fundamental principle of any sound Irish policy. The situation in both Ireland and England had become complicated by a personal misunderstanding, which he himself was partly to blame. He had never intended any delegation of legislative powers from the House of Commons, other than the power of dealing with purely private bills. Consequently, he had paid no attention as yet, as he ought to have done, to the earlier proceedings of the Reform Association. Sir Anthony Macdonnell, under secretary, had believed that (Mr. Wyndham) would approve of the proposals of the revolutionists, but as soon as he saw those proposals Mr. Wyndham had strong objections to them. Therefore, he had concluded that his power for doing further useful work in Ireland was ended. Sir Henry Campbell Bannerman, the Liberal leader, moved his resolution, which amounted to a censure of the policy and proceedings of, and subsequent to, the appointment of Sir Anthony Macdonnell.

The debate afforded opportunity for a wide expression of views by both sides and the resolution was carried. The speaker, William O'Brien, who took his seat for the first time since his election, said he would not vote either way. He held that the only way to settle the question was not by revolutionary tactics, but by conciliation. Unionist members uncomprehendingly demanded the retirement of Under Secretary Macdonnell.

Premier Balfour, at considerable length, reviewed the situation. He declared that the Earl of Dudley, Lord Lieutenant of Ireland, had shown a forward home rule. The Premier declared that he had not been in any of the failures before. Sir Henry Campbell Bannerman's resolution in reality was intended to force a question on Mr. Wyndham and himself, which was absolutely unjustifiable.

H. H. Asquith (Liberal) in closing the debate, maintained that there was no reason for Mr. Wyndham's resignation, which did not logically involve the resignation of the whole cabinet.

Sir Henry Campbell-Bannerman's resolution was rejected by a vote of 115 to 252.
