



LICENTIATE IN SACRED THEOLOGY.

Graduates in Arts of this University, or of other Universities recognized by it, and such other persons as shall have been accepted as candidates for Holy Orders by the Bishops of Quebec and Montreal, may become students in Divinity, and, after a period of two years of residence, may proceed by Examination to the title of Licentiate in Sacred Theology.

Such students are required to pass the Examinations at the end of every term during the two years.

MATHEMATICAL HONOURS.

In 1894 the Mathematical Honour subjects were divided into three stages. Each stage requires one year. Honours of the first grade require all three stages. The first and second stages constitute second grade honours. The first stage alone constitutes third grade honours.

Each stage will require one year. Examinations each Term. To obtain first grade Honours all three stages are necessary. To qualify for entrance as a candidate for Classical and Mathematical Honours, a student must pass the general examination at the end of the second year (or an equiva-

lent); he must obtain seventy-five per cent. in the Classical or Mathematical group respectively, and must have obtained fifty per cent. in the aggregate at such examination.

All candidates for Honours and options are required to take as Theological subjects in the year 1898-9.

REGULATIONS FOR HONOUR COURSE IN THEOLOGY

(ADOPTED JUNE, 1895.)

The Course of Honour Theology shall consist of three grades, the first or highest extending over three years, the second over two years, the third over one year.

The examination for entrance shall in each case be equivalent to that at the end of the second year in Arts, the candidate being required to attain at least 75 per cent. in the aggregate of the classical subjects. He must also have passed an examination in (1) St. Matthew's or St. Mark's Gospel, (2) Paley's Evidences, Part I., and (3) general knowledge of the contents of the English Bible. Besides this, he must have satisfied the Dean of the Faculty as to his capacity for English composition.

These qualifications attained, he may enter the *first* grade (or three years' course) either (1) immediately on admission into the university, or (2) on the completion of the first or (3) second year of his ordinary Arts course.

He may enter the *second* grade (or two years' course) on completion of the (1) second or (2) third year of his Arts course.

Or he may enter the *third* grade (or one year's course) on the completion of the (1) second or (2) third year of his Arts' course.

The course shall consist of five main branches, as follows:—(1) Holy Scripture, (2) Dogmatic Theology, (3) Church History, (4) Evidences of Christianity, (5) Criticism and Archæology.

Of these, the first three shall be obligatory; the last two alternative, one of the two being selected each year by the Dean of the Faculty with the approval of the Council. By the same authority, if No. 4 be selected, selection shall further be made of one of the three departments of the subject:—(1) Buddhism compared with Christianity, (2) Christianity and modern systems of thought, (3) Natural Religion and Revelation. If No. 5 be selected, selection shall be similarly made of one among the three departments:—(1) Old Testament Criticism, (2) New Testament Criticism, (3) Old and New Testament Archæology.

The second grade (or two years' course) and the third grade (or one year's course) shall consist, generally speaking, of the subjects assigned to the first grade in the years in which they happen to occur, as set forth in

the annexed table of those subjects as distributed over the three years of the course; care being taken, however, to secure completeness of treatment in the subjects so far as they are taken up, and all being done to the satisfaction of the College Council.

The selection of text books and books of reference (supplementary to those which are specified in the first four columns of the schedule as permanently obligatory) shall be made from time to time by the Professors of the Faculty of Theology, sanctioned by the Visitors and approved by the Council. Original authorities, as well in Church History as in Dogmatic Theology, shall be mastered in the original languages.

The Examinations are open to Boys and Girls from any Canadian school. The regulations for 1899 will be sent on application to the Principal, or to the Secretary, Rev. H. M. Tory, M.A., McGill College, Montreal.

AFFILIATED COLLEGES AND SCHOOLS.

Affiliated School—Bishop's College School, Lennoxville.

The School is recognized by the Department of Public Instruction as a School in which a Teacher's experience is counted as a means of obtaining an Academy Diploma on the part of Graduates of the University.

LECTURES ON ART OF TEACHING

WERE GIVEN BY DR. ROBINS DURING LENT TERM 1897.

Thirteen candidates passed the examination in 1897. The following has since passed the examination on the subjects treated of in the lectures May 20, 1898: Mr. A. H. Wunttele, B.A.

It is proposed to give a course of lectures on the Art of Teaching during the Session of 1898-9, as one of the qualifications for Academy Degrees.

BISHOP'S COLLEGE.

By an Act of the Legislature of the Province of Quebec passed in the year 1843, Bishop's College was constituted a body corporate, consisting of the Lord Bishop of Quebec (or in case of the division of the Diocese of Quebec, of the Bishops of the Dioceses into which the Diocese of Quebec should be divided), the Trustees of the College and the College Council.

By a subsequent Act of the Legislature of the Province of Quebec, passed in the year 1870, the governing body of the College was materially altered, with the object of bringing the College into more immediate connection with the Synods of the Dioceses of Quebec and Montreal. According to the terms of this Act, three Trustees and three members of the College Council are appointed by each of the Bishops of the two Dioceses now contained within the Province of Quebec, and five Trustees and five members of the College Council are selected from a larger number in each case nominated by the vote of their respective Synods; members of the Corporation hold their seats for three years and are eligible for re-appointment.

Bishop's College, which owes its existence to the earnest and untiring efforts of the late Bishop Mountain, of Quebec, was designed in its foundation to satisfy a two-fold need: first, to provide the Church of England in the Province of Quebec with a suitable place for educating her ministry; and, secondly, to offer to the Province at large the blessing of a sound and liberal education based upon religious principles.

The village of Lennoxville was selected as its site, on the grounds of its central position, in the midst of the English-speaking population of the Province of Quebec, and the prospect it afforded of moderation in the scale of expense to individual students, and in consequence of the efforts of Rev. L. Doolittle and other local churchmen.

Residence within the College is the rule and characteristic of the system of Education in Bishop's College, the common Collegiate Life, after the model of the great Universities of Oxford and Cambridge, being regarded as a training of great importance:

The work of the College began in October, 1845. Among the benefactions made to the College may be mentioned:—

1845. Liberal donations from friends of the Church in Quebec, Montreal and the neighborhood of Sherbrooke and Lennoxville, and \$5,000 from the S. P. G., and the same from the S. P. C. K.

1847. More than \$10,000 raised in England by the Rev. J. H. Nicolls, D.D., Principal of the College, including \$5,000 from S. P. C. K. About the same time \$30,000 was given to Bishop Mountain by a munificent friend, Thomas Churchman Harrold, Esq., of Little Horkesley Park, Essex; Miss Leeds, of Ipswich, Suffolk, giving \$1,000.

In 1848 the S. P. G. offered an annual grant of \$1,200, shortly afterwards commuted for a sum of \$16,000.

1849. Professor Hellmuth (afterwards Bishop of Huron) collected \$4,000 in England.

1861. Numerous donations towards new School Building erected on site adjoining College.

1862-3. Endowment Fund. \$10,000, carrying free tuition, subscribed by various friends in shares of \$500.

1865. Rev. Dr. Nicolls, Principal, collected funds in England to supplement endowment.

1874. Large subscriptions obtained by Rev. C. H. Badgley, Rector, and others towards rebuilding school.

1884. In this year and about this period the Harrold Fund for Professorship of Divinity (\$25,000) was raised by the untiring efforts of Professor Roe, D.D., (now Archdeacon of Quebec), and begun by noble gifts from two friends of the College in the Diocese of Quebec; also by the same initiative a fund now reaching \$11,000 was raised towards the endowment of the Principalship, since raised to the neighbourhood of \$20,000.

1886. The sum of \$29,000 was left to the College by two ladies of Quebec. Mrs. Davies and Mrs. Davidson, for a Professorship and Divinity Exhibitions. Part of this has been applied to the Professorship of Mathematics.

1886. Fund of \$6,000, raised by subscription, begun amongst the Alumni and Old Boys at the Alma Mater Dinner, to build the Bishop Williams Wing, on the suggestion of the Principal;

the insurance of this was applied towards the present Bishop Williams Hall, which is used as the Convocation Hall of the University.

1888-89. Fund of \$15,000 raised by subscription to build the Divinity House, collected by the Principal.

1888-90. A sum of \$11,000 raised by efforts of Archdeacon Roe towards the endowment of the Jacob Jehoshaphat Salter Mountain Professorship of Pastoral Theology, and \$4,000 was given to endow the Divinity House by Dr. Mountain, in addition to a liberal donation to the endowment of the Professorship.

1891. Special grant from Provincial Government, \$10,000, in consequence of disastrous fire of February, 1891. About the same time \$15,000 or more was raised to supplement the insurance money (\$41,000); and to provide for improved and more substantial buildings. Most of this was raised through the efforts of the Principal, Dr. Adams, and the Head Master, H. J. H. Petry, Esq.

The school has cost about \$57,000, and no debt remains on the building.

Of the \$15,000 raised in 1891, Mr. R. Hamilton gave \$4,000, and Colonel Charles King, of Sherbrooke, \$1,000, which was devoted to the Chemical Laboratory bearing his name.

The new buildings of the School are remarkably massive, and much has been done towards rendering the building fireproof.

Many friends have aided in the above benefactions, amounting to not less than \$100,000, during the years 1884-94. Amongst those who have rendered aid on a large scale may be mentioned R. Hamilton, Esq., D.C.L., Rev. Dr. J. J. S. Mountain and Hon. E. J. Price.

The College Chapel, originally built (1857) through the exertions of the late Principal, Dr. Nicolls, was enlarged (1875-8) in memory of the late Bishops Mountain and Fulford, the Rev. L. Doolittle, one of the earliest benefactors of the College, and finally of Dr. Nicolls himself. The chapel is well adapted for its sacred uses, and not altogether unworthy to be compared with some of the College Chapels of the great English Universities. It has been opened for worship since January, 1893. In January, 1898, the stalls, floor and western wall screen were completed, and all the

windows are now promised in stained glass, the whole set being from designs suggested by the Bishop of Quebec, and carried out by Messrs. Spence, of Montreal.

Memorial windows have been given by Bishop Dunn, one in memory of Rev. Dr. Lobley, the second Principal, and another of Rev. L. Doolittle; by Chancellor Heneker, to the memory of Bishop Williams; by the ladies of Lennoxville, in memory of the first Principal, Dr. Nicolls; by the late Mrs. Nicolls, in memory of Bishop G. J. Mountain; and by Rev. Dr. J. J. S. Mountain, in memory of members of his family.

The system of windows in the Chapel has been lately completed owing to the generous gifts of Hon. E. J. Price and the Lord Bishop of Quebec, and through the persevering efforts of the Rev. T. L. Ball, M.A., who collected more than \$300 towards the windows.

Some of these windows commemorate: the first four Chancellors, Colonel Morris, Rev. Dr. Reid, Hon. David Price, Mrs. Nicolls, Mrs. Williams, Edward Chapman, A. D. Nicolls, and W. Osgood (restored).

The College Buildings were restored in 1875, on an improved plan. Besides the Students' rooms and a dining hall, there are three lecture rooms and a reading room for the use of Professors and Students.

In 1890 a Divinity House was erected, containing a residence for the Professor of Pastoral Theology, two Lecture Rooms, a Common Room, a room used for devotional offices, and rooms for Students. The building was completed in 1893. It has cost \$15 000, of which Mr. Robert Hamilton has subscribed \$6,500, Hon. E. J. Price \$3,000, S. P. C. K. £300.

In May, 1897, Mr. J. H. R. Molson, who had already subscribed \$5,000 to the Jubilee Fund, bequeathed the sum of \$10,000 for the benefit of Bishop's College School.

Earlier in the same year Mr. A. D. Nicolls bequeathed \$3,000 to establish Scholarships in memory of his father, the Rev. J. H. Nicolls, D.D.

The Library has been to a certain extent replenished, and now contains upwards of 8,000 volumes, including many most valuable modern works in Theology, General Literature, Mathema-

tical and Physical Science, Classical and Philological Research, but requiring much liberality to keep it adequately equipped.

A small Museum of Geological and other specimens has been collected, and it is to be hoped will be greatly increased by contributions from Students and other friends of the College.

1898. Doolittle Scholarships Fund \$8,200 in hands of Synod; money invested and interest to be used for Divinity Exhibitions in 1899 and thereafter.

Grant of £1,000 received from S. P. C. K. to be divided between Principalship and Professorship Past. Theol. Endowment equally.

Miss Reid, Sherbrooke, gave \$1,000 to latter endowment.

JUBILEE OF BISHOP'S COLLEGE AND BISHOP'S COLLEGE SCHOOL.

LENNOXVILLE, PROVINCE OF QUEBEC, CANADA.

The institution began its work in 1845, and celebrated its jubilee in 1895. To mark this event, and to meet the continued demands of an ever-advancing standard of education, it was resolved to raise a Jubilee Fund, the sum aimed at being Fifty thousand dollars, at least.

The following have been aided by the Jubilee effort :

- A. The Headmastership of the School. \$25,000 (including residence).
- B. The Professorship of Classics in the College, at least \$20,000 is required for this, of which \$10,000 has been subscribed.
- C. J. J. S. Mountain Professorship of Pastoral Theology, raised to \$25,000.
- D. Professorship of Applied Science. (\$1,200 in hand).
- E. Principalship Endowment raised to \$20,000.
- F. Restoration of the Chapel and gifts of windows, nearly \$5,000.
- G. For a new Gymnasium, \$4,500.
- H. Extension of College, at least \$15,000 required.

The increase of students in 1894, 1895, 1896, 1897, and the reasonable anticipations arising from promised students for 1898 render an additional building to accommodate students an urgent necessity—at least \$15,000 would be required for this purpose, to carry out a complete scheme.

Gifts to the Jubilee Fund may be allotted by the donor to any one or more of the above subjects, and the needs here detailed would require a total of one hundred thousand dollars to have

been raised in all beginning with Sept., 1894. Of this about \$30,000 is still required.

Bishop's College is governed by a Corporation, the Members of which are appointed by the Bishops and Synods of the two Dioceses of Quebec and Montreal, which are co-extensive with the Province of Quebec. It is under the control of the Church of England, but its advantages are open to, and are use by all, irrespective of creed.

Bishop's College School is managed by an Incorporated Association, working in conjunction with the Corporation. It is administered on the model of the great English Public Schools.

An earnest appeal is hereby made to all friends of the higher education in this Province and elsewhere, as well as to all Graduates and Old Boys, for their assistance, both by their own contributions and by the use of their influence with others, in order that the foundations of the Institution may be strengthened, and that it may meet the constantly increasing requirements for improvement and expansion, which are characteristic of the education of the day.

The Calendar of 1896 contained a list of subscribers to the Jubilee Fund containing about 200 names.

The College offers an Academic Course in Arts and Divinity. The Course is modelled on the lines of Oxford and Cambridge. The College resembles the Colleges of those Ancient Universities in that the Students are resident within its walls. Mathematical, Classical and Theological Honor Courses are open to Students who pass a certain standard. *See ante.*

BISHOP'S COLLEGE.

ADMISSION.

Candidates for admission into the College are required to present testimonials of good conduct, and may be admitted either as matriculants or as candidates for matriculation in the **PREPARATORY CLASS** the members of which attend Lectures on the Subjects of Matriculation Examination.

Members of any other recognized University are admitted to the same standing on presentation of the necessary certificates under certain conditions.

Casual students, and such as cannot keep continuous residence, may, with the approval of the Principal, attend particular courses of instruction, without becoming regular students.

COLLEGE FEES.

The *Payments* required of Students, covering all necessary expenses, are as follows :

All Students, whether holding a Free Tuition or not, must pay the Library Fee of \$2.50 per annum included in the above; (Michaelmas, \$1.00; other Terms, 75c. each.)

Each room is furnished by the College with ordinary furniture, but each Student provides his own bedding and towels. These, however, are provided by the College to such Students as desire them, at a charge of \$2.50 per term. The Students have the use of the College Infirmary under due regulations.

Every Student pays a deposit of \$30 at the beginning of each Term, and the balance of his account at Mid Term.

COLLEGE ATHLETIC ASSOCIATION.

It is hoped that all members of the College will join this Association, the subscription to which enables a Student to join all the College games.

VACATIONS.

The vacations are one month at Christmas, and in the summer from the last Thursday in June to the second Saturday in September. Return tickets at reduced rates are issued for the vacations to all points on the Grand Trunk Railway, and on the Quebec Central and Canadian Pacific Railways for Christmas and Easter.

Terms are kept by residence in the College, with regular attendance at Chapel and Lectures, and the punctual performance of all exercises required by the various Professors and Lecturers. No Student is allowed to count any term as a term of residence of which he has not kept at least three-fourths. In the case of Students whose parents or guardians reside at such a distance from the College as to admit of regular attendance at Chapel and Lecturers, actual residence in College may be dispensed with.

All students will be supplied with a copy of Rules, etc., on entrance, and must apply at once on arrival to be registered.

All students are expected to have College Cap and Gown; also a surplice; and if candidates for holy orders, a cassock as well.

Regular attendance at chapel services on Sundays and week days is required of all. Non-members of the Church of England may obtain exemption on written request of Parents or guardians and guarantee of regular attendance on Sundays at other Churches.

Lectures are given in the College to the Students of the several years, on the work appointed for their respective yearly examinations. The progress of all the Students is further tested by an examination in the subjects of Lectures at the end of each term.

All Students are required to write Essays during Term on Subjects appointed by the Principal, and to perform such exercises in Reading and Public Speaking as he may think desirable.



EXHIBITIONS.

There are at present established in the College the two S. P. G. Jubilee Scholarships (or their equivalents.)

Two Davies and Davidson Exhibitions (one of which is in abeyance for a time.)⁴

One Mountain Jubilee Scholarship is available from 1894 onward. Besides these by the bounty of the venerable S. P. G., there are eight Exhibitions (four for Quebec and four for Montreal Diocese), of the value of about \$145 each and assigned by the Bishops of Quebec or Montreal respectively to students on passing an Examination in the Bible and in English Dictation. The S. P. C. K. also makes a grant for six Exhibitions; the holders of these must be of a standing to take Holy Orders within three years from the date of receiving the Exhibitions, and these Exhibitions are tenable only by natives of the Dominion of Canada. All these Exhibitions are tenable on certain conditions which are expressed in the following form or its equivalent which has to be duly signed as directed —

Form of Assignment and Conditions of Exhibitions.

ASSIGNMENT OF EXHIBITIONS IN BISHOP'S COLLEGE TO CANDIDATES FOR HOLY ORDERS.

I hereby assign to Mr. _____ Candidate for Holy Orders in the Diocese of _____ an Exhibition of the value of _____ per annum, for a period of _____ years; such Exhibition to be held by him subject to the following conditions:

1st. That he shall produce to me at the close of every Michaelmas and every Trinity Term a Certificate in the following form, duly signed:

We hereby certify that Mr. _____ has been in residence in Bishop's College during the last _____ months; that during that time he has applied himself diligently and faithfully to his studies, and has made satisfactory progress in the same; and that so far as we are in a position to judge from what we know of his general walk and conversation, we believe him to be a sincerely religious man, with satisfactory marks of vocation to the Sacred Ministry.*

* The signatures of the Professors will apply to this last clause only in the case of Students in the Divinity Course, and in the half year preceding it.

*Principal.
Dean of the Faculty of Divinity.
Professor of Ecclesiastical History.
Professor of Pastoral Theology.
Professor of Classics.*

And that in case he should at any time fail to procure and present to me such Certificate, the title to the aforesaid Exhibition shall thereupon cease and determine, as shall also his standing as a Candidate for Holy Orders.

2nd. That such candidate shall take the subject of Hebrew, and shall pass all the Examinations in the same throughout his College Course.

3rd. That such Candidate engages, as a just return for this benefaction, to serve the first five years of his Ministry in the Diocese of Quebec, (or Montreal if required by the Bishop of Montreal.)

4th. That if through misconduct, or any other cause except some infirmity which may incapacitate him for study, he should cease to be a candidate for Holy Orders in one of these two Dioceses, he hereby binds himself to repay the Bursar of Bishop's College whatever sum he may have received down to that time from his Exhibition.

Given under my hand at this day of 189

I hereby accept the conditions laid down in the foregoing document, and agree to forego all claim to the further use of the Exhibition now assigned to me in case I should at any time fail to procure and present to the Lord Bishop of the Certificate set forth above, duly signed by the Principal and Professors as therein required. I also accept the three other conditions as stated in the same.

Every student in the Faculty of Arts holding an Exhibition from the S. P. G. or S. P. C. K. is required, as essential to the continuance of his Exhibition, to pass annually an examination in the contents of a portion of the English Bible; and every student in the Faculty of Divinity is required to pass the same examination, as essential to the maintenance of his status in that Faculty.

These examinations for five years will be as follows:

1898.—Jeremiah to Malachi (inclusive.) Psalms. Book V. (cvii.-cl. Hebrews to Revelation (inclusive.)

1899.—Genesis to Leviticus (inclusive.) Psalms. Book I. (i. xli.) St. Matthew and St. Mark.

1900.—Numbers to Ruth (inclusive.) Psalms. Book II. (xlii.-lxxii.) St. Luke and St. John.

1901.—I. Samuel to II. Chronicles (inclusive.) Psalms. Book III. (lxxiii.-lxxxix.) Acts and Romans.

1902.—Ezra to Isaiah (inclusive.) Psalms. Book IV. (xc.-cvi.) I. Corinthians to Philemon (inclusive.)

In 1898 the examination will take place on September 21.

N.B.—Candidates for exhibitions must in their *first examination* pass in a *general paper only* of an elementary character *in the whole Bible*.

PROCEEDINGS IN MUSIC.

FOR THE DEGREE OF BACHELOR IN MUSIC (MUS. B.)

The candidate for this Degree must be either :

- A.—A Graduate of this or some other recognized University; or
- B.—A Clergyman in Priest's Orders; or
- C.—A Barrister-at-Law; or
- D.—One who can produce a + certificate, testifying that the applicant has employed at least five years in the study and practice of music.

The Degrees are open to women qualified under A. or D.

+ This certificate must be signed by a Graduate of this or some other recognized University, or by a known Teacher of Music.

The examination consists of Four Parts, viz.:

- Part I.—The First Examination.
- Part II.—The Second Examination.
- Part III.—The Exercise.
- Part IV.—The Final Examination.

These Four Parts can only be passed in their proper order.

Part I.—The First Examination, held on the first Tuesday in May, will comprise:—

- (a) The Rudiments of Music.
- (b) Harmony in Four Parts, and
- (c) Counterpoint in Three Parts.

(Combined Counterpoint not required.)

Any candidate intending to present himself for examination must give notice to the Registrar, not later than February 1st, on a printed form, which will be supplied on application.

A candidate, on passing this examination, will receive a Testamur, signed by the Dean of Arts, the Registrar, and the Examiner in Music. His name will also be inserted in the University Calendar.

Part II.—The Second Examination, held on the day following Part I., will comprise:—

- (a) Harmony, in Five Parts.
- (b) Counterpoint, in Four Parts.
- (c) Double Counterpoint in the octave; and
- (d) Fugue, in Two Parts (particularly subject and answer.)

Any candidate intending to present himself for examination must give notice, and send his Testamur, received for Part I., to the Registrar, not later than February 1st, on a printed form, which will be supplied on application.

A candidate may be examined in Parts I. and II. on consecutive days by obtaining special permission from the Registrar, when he gives notice of presenting himself for examination. Without this *special permission* from the Registrar, there will be an interval of at least one year between Parts I. and II.

A candidate on passing Part II. will receive a Testamur, etc., as before.

Part III.—Consists of an Exercise, which must be a choral work, sacred or secular, with an accompaniment for a string orchestra (also, if desired, an organ), must occupy from twenty to twenty-five minutes in performance, and be written for the occasion.

It must contain at least four movements:—

- (a) A Five-Part Chorus.
- (b) A Solo or Duet.
- (c) An Unaccompanied Quartet; and
- (d) A Four-Part Choral Fugue.

This exercise must be in the hands of the Registrar by January the 1st, with the Testamur received from Part II., and

a Declaration signed by the candidate, and witnessed by a magistrate, certifying that the work is his unaided composition.

The Testamurs, signed, etc., as before, will be in the hands of the Registrar by the last day of February.

No part of an exercise, which has failed to reach the required standard, will be allowed to be submitted again for examination unless specially permitted by the Examiner, as all Exercises must be written for that particular occasion.

Part IV.—Final Examination, held on the first Tuesday in May, will comprise:—

- (a) Harmony in Five Parts.
- (b) Counterpoint in Five Parts.
- (c) Double Counterpoint.
- (d) Canon in Four Parts.
- (e) Fugue in Four Parts.
- (f) History of Music.
- (g) Form in Composition.
- (h) Instrumentation.
- (i) Critical Analysis of a Standard Work, previously announced.

The work for 1899 being the 42nd Psalm, "As the Hart Pants," by Mendelssohn.

A candidate intending to present himself for examination must give notice and send his Testamur for Part III, to the Registrar, not later than the first day of March.

A candidate on passing Part IV. will receive a Testamur, signed, etc., as before, which will have to be given by him to the Registrar, when he presents himself for his Degree on Convocation Day in June.

FOR THE DEGREE OF DOCTOR IN MUSIC (MUS. D.)

The examination will consist of Two Parts, viz.:—

- Part I.—The Exercise.
- Part II.—The Final Examination.

Part I.—The Exercise must be a choral work, sacred or secular, scored for a full orchestra, to occupy from forty to sixty minutes in performance, and must be written for the occasion.

It must contain an overture, written in the "form" of the first movement of a symphony; some portion for one or more solo voices; at least one specimen of Canon for four voices; also of Fugue; and at least one movement written in eight-part counterpoint.

(Instead of writing this Special Exercise for Part I., a candidate may submit not less than three works—of his own—published or unpublished—upon which he would found his claim for a Doctor's degree; such works must include either a cantata, or an opera, or an oratorio, or an example of chamber music, or a concerto, or a symphony for full orchestra.)

This exercise (or its equivalent referred to above) must be in the hands of the Registrar by January the 1st, with the Testamur received by the candidate on his taking the Mus. B. Degree. The Testamur of Part I., signed, etc., as before, will be in the hands of the Registrar by the last day of February.

Part II.—The Final Examination will be held on the first Tuesday in May, will consist of:—

- (a) Harmony and Counterpoint up to Eight Parts.
- (b) Double, Triple and Quadruple Counterpoint.
- (c) Canon of various kinds, in Four Parts.
- (d) Fugue in Six Parts.
- (e) Form in Composition.
- (f) Instrumentation.
- (g) Musical History.
- (h) Critical Analysis of some work previously announced.

A candidate intending to present himself for examination must give notice and send his Testamur for Part I to the Registrar, not later than the first day of March.

A candidate on passing Part II. will receive a Testamur signed, etc., as before, which will have to be given by him to the Registrar when he presents himself for his Degree on Convocation day in June.

PROCEEDINGS IN MEDICINE.

The Faculty of Medicine has its seat in Montreal (Ontario and Mance Streets). Convocations are held annually for the conferring of Medical Degrees in that City.

The Degrees of this Faculty are those of Master of Surgery (C.M.) and Doctor of Medicine (M.D.), the former being conferred only upon those who at the same time obtain the Degree of Doctor of Medicine.

The College building contains large lecture rooms, several smaller lecture rooms for Practical Chemistry, Practical Physiology, Histology, Bacteriology, etc., and large, airy, well-lighted dissecting rooms at the top of the building, isolated from the rest of the class-rooms. Under the new Anatomy Act of the Province of Québec, ample material for dissection is provided at moderate rates.

The Histological, Physiological and Bacteriological Laboratories are supplied with a complete outfit of Microscopes, Microtomes and of Bacteriological and other modern apparatus. The Pharmacological Laboratory, besides possessing a very complete cabinet of drugs and their preparations and alkaloids, has all the necessary appliances and means for the working of B. P. preparations and every facility for practical dispensing. Recently the Faculty has expended another large sum for apparatus in several departments, to facilitate practical teaching.

The 28th session of this Faculty will commence on Monday, 3rd October, 1898, and will be continued regularly until June, the usual Christmas vacation intervening.

The course leading to the degree of C.M., M.D., extends over four years, and consists of four sessions of six months each, and three Summer Sessions. Students who require the Québec license will be given an extended course in order to comply with Québec laws.

The lectures and demonstrations in each Annual Course are given during a period of nine months, beginning in October.

The Faculty of Medicine of Bishop's College aims at imparting a thoroughly practical medical education, and its facilities for doing so are in many respects unequalled in Canada. In addition to the regular course of didactic lectures, students have the advantage of extensive and varied hospital privileges.

The Infirmary has been much enlarged and improved at great expense, and a resident Trained Nurse is now one of the regular staff of the Institution.

There are also (1) a Resident Drill Sergeant (Mr. Perrin) and (2) a Cricket Professional (Mr. Hainsworth).
