

REPORT OF THE GRAND CHIEF TEMPLAR.

Officers and Members of the Grand Lodge of British Columbia, I. O. G. T.:

Dear Brothers and Sisters.—In the providence of God we are permitted to meet in this, another Session of the Grand Lodge of our beloved order in British Columbia. We shall miss the presence of an important officer who took a leading part in all the labors of this Grand Lodge, whose presence always gave an inspiration and shape to all the deliberations of our sessions, but we bow in meek submission to the will of Him who governs the destiny of nations, as well as that of individuals. He has gone to the everlasting reward may his zeal inspire us to endeavor to live as he lived, and may his mantle fall on some one to lead in this glorious cause, with which we are identified in battling against the Liquor Traffic, (the greatest foe with which humanity has to contend,) until victory shall crown our efforts and Prohibition of the sale and manufacture of alcohol as a beverage shall be made a uniform national law for this broad Dominion.

In taking a retrospective view of our labors during the past year we may be able to gather lessons from our failures as well as from success. We are able to report an increase of five in the number of our Lodges; one organized at Nicola by our late Bro. Hemlaw, one on Lulu Island, organized by Bro. O. D. Sweet, one organized on Salt Spring Island by Bro. S. Gough, one at New Westminster and another at Vancouver, organized by your shumble servant, making two lodges at the former and three at the latter cities, and there is a probability of the fourth being organized at Vancouver shortly, and another at Chilliwhack. Total number of Lodges and membership will be reported to you by the Grand Sacretary.

Hemlaw, informed the body that he was negotiating with Mr. Lou J. Beauchamp, a distinguished Temperance Lecturer in the United States, with a view of engaging him to deliver a series in this jurisdiction.

DOMINION ALLIANCE.—Early in August I received a communication from the Secretary of the Dominion Alliance stating that the annual meeting was to be held at the City of Toronto on the 12th and 13th of September, and they expected this would be the most important gathering they ever had, and asked us, as a Grand Lodge, to send representatives. I consulted some of the Executive upon the matter, and they generally were of the opinion that we could not afford the necessary expense that would be

Talking this matter over shortly afterwards with our worthy Grand Marshall, Bro J. A. McAllister, he informed me that he purposed going East and would attend the Toronto Exhibition, which would be held about the same time, so we concluded to appoint our G. M. as the representative of the Independent Order of Good Templars from British Columbia. And we are happy to learn that our Brother not only associated himself with the Dominion Altiance, but entered into another alliance which I am well as-

sured this Grand Lodge will endorse.

CONSTITUTION.—Your attention is called to the fact that the R W. G. L. has disallowed as unconstitutional some portion of our Constitution

APPEALS.-I am happy to report that general harmony and good will has prevailed throughout our jurisdiction, and that no appeals have been brought before me during the year.

QUESTIONS.—A few questions from members have been submitted to me, but are of no serious consequence, any member wishing to see them is re-

ferred to envelope marked E.

Immediately after the ending of last session I placed myself in communication with Mr. Beauchamp, who was at that time engaged in California in behalf of the Prohibitionists of that State in supporting the Candidate for the Presidency at the Presidential Election of the United States. formed me that it was impossible for him to leave there until after the close Early in November I received information from Mr. Beauof the election champ that he had arrived in Seattle, and purposed taking a rest for two or three weeks to recruit himself after his arduous campaign of several months.

In about a week after receiving his first communication I had another informing me that he was taken ill very seriously at Seattle, and his consulting physician advised him to return at once to his home in Ohio, as the

only possible means of his restoration to health and strength.

I expected him early in the spring as he promised, and in further correspondence intimated that he might be out in June or July, and in his last communication promised to be out likely in November or February next. However, I have abandoned the hope of securing any help from Mr. Beau-champ, and have been corresponding with a Mrs. Lila A. Moore, of the

State of Kentucky

Our worthy representative to the R. W. G. L., Bro. J. A. Wood, met this lady at Chicago in May last, and he recommended her as a lady of ability and experience in Temperance Lecture work, and a suitable person for British olumbia, therefore I concluded an engagement with her for a three months' campaign, and have expected all along that she would be here in time to attend the session of our Grand Lodge, but she informs me in a letter received on Saturday last that she will not be able to leave her State until about the 15th on account of her being G. V. T. of the Grand Lodge of her native State and is holding its session same week as our own.

LITERATURE.—We regret that we have no official organ published within our own jurisdiction, but would earnestly urge on the representatives from the different Lodges to use all their influence with the members of the Lodges to subscribe to "Good Templar," the official organ of Ontario, and other Temperance papers to enable all our members to be read up on the different phases of the great moral question in all parts of the world. And I am firmly of the opinion that the free distribution of sound temperance literature among the people would be money well spent by this Grand Lodge.

G. C. T. OFFICE—I regret that I have not been able to visit our Lodges during the year, although I was requested to do so by the Executive. My principal reason for not doing so was that I have been all the time expecting a Lecturer to take the field, and being deeply conscious of my own inability to entertain or to create enthusiasm such as a regular Lecturer would likely do, has carried me to rest on the hope of our engaging a good lecturer, although if I had known that our experience with reference to a lecturer would have been what it has turned out to be, I would certainly have made the attempt, although it is very inconvenient for me to get about, and have not much strength to expend.

THE FUTURE.—Brothers and Sisters, that should be the all-absorbing question for our deliberations. What shall we do? Let every thought and act be made subordinate to the one ideal to make Good Templary in this fair Province more than it has ever been before in moulding and creating public sentiment in favor of National Prohibition as the only effectual remedy for this great evil, the Liquor Traffic. Let us talk it and carry the question up to the ballot box unitedly in a solid phalaux. I cannot do better than quote you the words of the poet on example:

"What man could watch a drowning friend,
Beat the wild waves without a hope,
And his strong aid refuse to lend,
Or hinder those who throw the rope.
Or who upon a summit high,
Could see a blind man shrinking stand,
And utter not the warning cry,
Nor forward stretch the guiding hand.
Our brethren neath the waters sink,
The rich, the poor, the old, the young,
Blind men are slipping from the brink,
Shall we stand by with silent tongue.
Let none turn from the sight or gaze with pitying smile.
But weave example's rope with strands of self-denial.

POLITICAL ACTION.—Before another session of the Grand Lodge is held there will be a general election to elect a new Legislature for the Province, and as Good Templars, I believe we should exert all the influence we can towards electing a House that would be more favorable to the cause of temperance than the present

JUVENILE TEMPLARS.—Some progress has been made during the year in the nursery of Good Templary. The G. S. J. T. is one of our most earnest and devoted officers, and his report will be laid before you.

FINANCES.—Our Treasury will show a surplus over and above the expenditure which will be required to pay the expenses of a lecturer.

By referring to the foregoing you will see that the membership is 928, and an increase over last year of 172. You will also see that there has been organized during the year, five new Lodges, and also that two Lodges have

been suspended, leaving twenty Lodges now in good standing.

The cash receipts are \$911 75, which would have been larger had the Lodges paid ther per capita tax promptly. The amount received for the R. W. G. Lodge Mission Fund and the Finch Memorial Fund are very small. You will notice an item of \$60 received from Bro. J. A. Wood, being the mileage allowed our representative to the R. W. G. Lodge, by this payment the cost to this Grand Lodge of the representative to the R. W. G. I odge last year was placed at the remarkably low figure of \$90, and the heartiest thanks of this Grand Lodge are due to Bro. Wood for having so faithfully looked after the welfare of this jurisdiction.

I beg to call your attention to the large loss our order in the province annually sustains through suspensions. One great cause of this drain is that Lodges grant too many dispensations to ballot for and initiate candidates the same night they are proposed. In my opinion every candidate should be personally visited and questioned by the investigating committee and the committee should be satisfied that the candidate is ready and willing, not only to be a tee-totaller, but that he is ready to become a templar, which means more than total abstinence, and every candidate should receive official notice of his election. Any person who joins in this way is not so likely to leave the order, as a person who is pushed into the order without knowing or having the least conception of what the obligation is.

NEW Lodges .- Phoenix Lodge, No. 19, located on Salt Spring Island, organized on the 6th day of December, 1888, by District Deputy S. Gough. Nicola Lake Lodge, No 20, organized on the 14th day of December, 1888, by P. G. C. T., the late Bro. Hemlaw, located in Nicola Valley, making the

second Lodge east of the Cascades.

Lulu Lodge, No. 21, organized on the 20th day of March, 1889, by Special Deputy, Bro. O. D. Sweet, D. R. W. G., located on the south side of Lulu

Mount Pleasant Lodge, No. 7, organized on the 4th July, 1889, by the

G. C. T., and being the third in the terminal city (Vancouver,

Excelsior Lodge, No. 8, the last (but not least) organized, being the second in the Royal City (New Westminster) organized on the 5th July, 1889, by the G. C. Templar.

All these Lodges seem to be in a fairly healthy and vigorous condition, and are organized in districts where there is enough material to make good lodges.

OFFICIAL ORGAN.—I earnestly think that some effort should be made to make the "Good Templar of Canada" our Official Organ in more ways than name, and also to have it circulated more among the members, and to have templar and temperance literature scattered among the Lodges.

After considerable correspondence with the object of reviving Advance Lodge, Fo. 17, the charter was surrendered and the supplies sent to this office. Owing to some disagreement among the members of Hope of Salt Spring Lodge, No. 7, it was decided to surrender the charter, and shortly afterwards

Phoenix Lodge, No 19, was organized in its place

GRAND LODGE BY-LAWS —During the year I sent our By-laws to the R. W. G. T for consideration, and he approved them except in some minor particulars where they conflict with the Constitution and By-laws of the Right Worthy Grand Lodge—His letter will be laid before you.

MISCELLANEOUS —During the year everything pertaining to the Juvenile work has been transferred to the department of the Grand Superintendent, and as no reports have come to this office, I am not aware of what has been accomplished in this important line of work, but you will be fully acquainted with the same in the report of our efficient superintendent.

The work of this office has increased somewhat during the year Over 750 letters and packages have been mailed since I came to the office, on which the postage was \$22, of this sum a large amount was postage on supplies to lodges, which in other jurisdictions is paid by the lodges buying

There seems to be a general movement on foot among the Lodges to own their own lodge-rooms This is a good idea and it has been suggested that a committee be appointed to consider the best means of securing this most

desirable object and report before the session closes.

To the Grand Lodge of British Columbia, I. O. G. T.

Dear Brothers and Sisters .-- Another year of our Grand Lodge has passed and we meet again in this fair city, where we first assumed the duty of governing ourselves. But some who then met with us have passed on to their reward. How we miss our first Grand Chief Templar-none have missed him more than myself, as I ever found him a true friend and counsellor in Temple work

As this office was without funds until January, 1889, (which, I hope, will never occur again) the best time for work was lost. During the year I visited Wellington. Unfortunately I was delayed on the way by a storm, so that I missed meeting with the Lodge, but engaged a sister that was recommended to me for a superintendent. Afterwards I visited the Lodge Deputy who said that the Lodge wanted Bro. , so I had to give him a

new outfit as the old set was missing.

I organized Golden Rule Temple, No 6, of North Arm. They have all the children but three in that School District. At my request Bro. Rev. J. W. Winslow organized Nicola Lake Temple, No. 7, and from the reports to

hand I have great faith that it will be a good work.

This has been a very hard year for the Juvenile Temples. One had to close during the summer, it being impossible to meet during the busy sea-Two members of Temple No. 5, died, namely, Sarah and Charles Braden. Temple No. 3 lost two by death, Jessie Thomson, Treasurer, and Dolena Nord, but I am glad to state that all the Temples are now at work with good prospects. One of the troubles of this office is that there are too many changes of superintendents, and the failure to send regular reports-sometimes only a line is sent. I would recommend a return to the old system of issuing commissions, and that the duty of the superintendents elected by the Lodges be to assist the commissioned officer, making report as often as may be required to the codge as to the progress of the Temple, as the present rules only tend to confusion. I would recommend that superintendents be recommended annually and commissioned by the G. S. J. T, the S. J. T. to see that all blanks are filled and forwarded to the G. S. J. Temples. I

REPRESENTATIVE TO R. W. G. LODGE.

Rev. J. A. Wood presented the following report:-

Clinton, B. C, 3rd October, 1889.

To the Officers and Members of the Grand Lodge of British Columbia, I. O. G. T.

The Right Worthy Grand Lodge of the Independent Order of Templars commenced its 34th session at 10 o'clock on Tuesday morning, May 28th 1880, and closed on Thursday, June 6th, at 2:30 a. m.

If met in the First M. E. Church in the city of Chicago, and was the longest and largest session, the body ever held. Representatives were present from nearly all the United States, every province in Canada, England, Scotland, Ireland, Central South Africa, India, Australia, New Zealand and Sweden, numbering altogether of representatives, honorary members and visitors, four hundred and forty-three present during the session.

On the morning of the second day your representative was very kindly received and seated among as excellent a body of Good Templars as ever met in session. All were as one family and seemed to be moved by one great thought—the utter destruction of the liquor traffic and the salvation of men.

Although this was the first session since Union, everything was done in such a brotherly manner that no one could see anything to remind him that there had ever been a separation. Nearly every representative attended all the sessions, and did their very best for the good of our noble order throughout the world.

You will find that some important changes have been made in this Con-

stitution and Ritual.

I did all in my power to show the Executive of the R. W. G. Lodge how much we were in need of lecturers, and how much we were in need of financial aid. Promises were given that all would be done for us that was possible in the way of financial aid, and promises were received from Bros. Oronhyatekha and Beauchamp to visit us at an early date.

Thursday afternoon, May 30th, which was Decoration Day, was given to a memorial service in honor of our lamented leader, the late Hon. John B. Finch. Although the rain came down in torrents nearly two hundred Good Templars proceeded to the cemetery. The service at the cemetery was one of the most impressive I ever attended—it was as though each one present had lost a brother beloved, and the obituary address delivered by Bro. W.

W. Turnbull; R. W. G. C., was one of the grandest to which I ever listened. One of the grandest features of the R. W. G. Lodge was the decided utterances of the members on Sabbath observance, and on any point that affected Christian principle. No one could attend our R. W. G. Lodge without being convinced that through all and above all it was an intensely earnest Christian organization. It was a recognized fact that our only and sufficient hope of success in our great work is in the Almighty arm of God. At first it was arranged to meet every morning half an hour before the opening session for a prayer meeting, but this was found to be too short and we agreed to meet at half-past eight, which gave us an hour for prayer every morning.

While the representatives from all parts of the world joined our prayers and received inspiration from the earnestness of the pleading and from above, we felt that the time must soon come when the world will be saved

to God and Good Templary.

While willing to go and represent British Columbia in the R. W. G. Lodge, I could not shake off the grief caused by the sad fact that made my going necessary. I was sad on account of the great loss our order had sustained, but I was particularly sad from a sense of personal loss, in losing Bro. Hemlaw—he was more than a brother to me. After the meeting of the

OBITUARY OF BROTHER REV. R. B. HEMLAW.

Brother Rev. Robert Bruce Hemlaw, who was elected Representative to the R. W. G. Lodge at our last session, and who held the office of G. C. Templar with conspicuous ability, was called away to his heavenly reward on May 1st, 1889, at the comparatively early age of 34 years. The undaunted zeal which he had displayed, and the acknowledged influence which he had acquired in this, his adopted province, as well as his many other good qualities of head and heart which had all been laid under tribute to the cause of Good Templary, combined to render his decease a severe loss to our beloved order

The founding of this (irand Lodge was due, very largely, to Bro. Hemlaw's efforts, for the cause of temperance lay near his heart' His position as a ('hristian minister became a more luminous example of virtue because of his self-consuming devotion to temperance work. And now that we see his face no more, the memory of his useful and heroic life becomes to us a stimulus and inspiration, saying to us in effect, "Whatsoever thy hand findeth to do, do it with thy might."

We regarded Bro. Hemlaw as an eminent Temperance Reformer and had hoped for many years of valuable service at his hands, but the Great Master has willed otherwise, and while we bow submissively to the Divine Will we trust that the mantle of our departed brother may fall upon some of our younger brethren, who may take the place and do the work of the fallen standard bearer.

May Heaven's richest consolations attend and sustain Sister Hemlaw under her heavy bereavement.

APPENDIX.

I. O. G. T.

Grand Lodge of British Columbia By-Laws.

Annual Session.

Article 1. This Grand Lodge shall hold a regular session not later than the third week in the month of October, and shall continue to meet from day to day (Sundays excepted) until the close of the session.

Place of Meeting.

Article 2. The Grand Lodge shall, during its Session, determine the place of the next Annual Session, and the majority of all votes cast shall be necessary to a choice.

Representatives.

Article 3. The basis of representation in the Grand Lodge shall be one for the Charter and one for every fifty members or fraction thereof.

Alternate Representatives.

Article 4. Every Lodge shall have the right to elect for the same term as a regular representative, any member in good standing in the Lodge as alternate to act only in the absence of the regular representative.

Election of Officers

Article 5. The election of Grand Officers shall take place on the second day of the session. Any member of the Grand Lodge, under Section 3, Article 1, Grand Lodge Constitution, shall be eligible, and a majority of the votes given shall be necessary for a choice; but no member shall hold more than one office. In case no candidate shall have received a majority on the first ballot, the representatives shall proceed immediately to ballot again, dropping the candidate receiving the lowest number of votes on each ballot, and in case of a tie the last named in the order of nomination, until some candidate shall receive a majority of all the votes cast

Lodge Deputies.

Article 6. At the first meeting in August in each year each Subordinate Lodge shall nominate a member for the position of Deputy Grand Chief Templar, whose name shall be transmitted to the Grand Secretary, with the quarterly returns. In case of a vacancy occurring in the office, the Lodge shall make and forward recommendations as at the beginning of the term.

District Deputy Grand Chief Templar.

Article 7. District Deputies shall have the power anywhere in their respective districts to institute new Lodges in accordance with the law, to instalt the officers of any Lodge when requested to do so by the Deputy of such Lodge, or in the absence of such Deputy, by the Lodge; and to grant dispensations and perform the other duties of their office in any Lodge in said district in the absence of the Lodge Deputy, or in case of a vacancy in such office. They shall forthwith report to the Grand Chief Templar all

Trial of Officers.

Article 8. No officer shall officiate in the Grand Lodge during the time occupied in his trial. Whenever the Grand Chief Templar or officer acting as such, shall be on trial, or whenever the resolution for the removal of the Grand Chief Templar or officer acting as such, shall be submitted, the Grand Lodge may direct any Chief Templar then present to occupy the chair.

Misconduct of Representatives.

Article 9. Any representative may be expelled from his seat, as such, for misconduct upon the vote of two-thirds of all the representatives present at any meeting after a copy of the resolution of expulsion shall have been served upon him.

Executive Committee.

Article 10. Of the Executive Committee the Grand Chief Templar shall be the Chairman, and he shall call meetings thereof as often as occasion requires, and at such points within the jurisdiction of the Grand Lodge as shall seem for the best interests of the Order, at which time the Grand Lodge degree may be conferred on those entitled to receive the same, under Article I, of the Constitution, and none but the members in possession of that degree shall be admitted to the deliberations of the committee.

Appeals.

Article II. All appeals on questions connected with the Constitution, or with the Ritual, Laws and usages of the Order, shall be from the Chief Templar to the Lodge, from the Lodge to the Grand Lodge, if that body be in session; if not, to the Grand Chief Templar, and from him to the Grand Lodge at its next session. On questions of construction of By-Laws, Rules of Order, etc., of particular Lodges or of parliamentary law, appeals shall lie to the Subordinate Lodge, the decision of which shall be final; provided, that if any member deem himself or any other member personally wronged or aggrieved. he may appeal from such decision of the Subordinate Lodge to the Grand Lodge, if that body be in session, otherwise to the Grand Chief Templar, and from him to the Grand Lodge.

Voting.

Article 12. The vote on any question shall be taken by ayes and nays whenever required by one-fifth of the members present. In such cases the roll of the Lodges represented shall be called, with the number of votes to which each is entitled, and the result shall be recorded in the Journal of the Grand Lodge. When a vote is taken by ayes and nays the representatives present shall be entitled to cast the full vote of their respective Lodges, provided, that on the question of the expulsion of a representative, each representative shall be entitled to only one vote.

Revenue.

Article 13 Sec. 1. The Revenue of this Grand Lodge shall be raised for the purpose of defraying the necessary expenses thereof.

their relaw, to eputy of to grant Lodge in acancy in uplar all to what may be received for Charter Fees, etc., to meet the necessary expenses of the Grand Lodge for the current year, and the amount so estimated shall be assessed upon each Subordinate Lodge in proportion to the number of its members returned at the quarterly report thereof. Such assessments shall be paid by the Lodges quarterly on the first of February, May, August and November of each year, and shall be forwarded by the Deputy of each Lodge to the Grand Secretary, and shall be sent in registered letters, or in the shape of money orders, otherwise the Grand Lodge will not be responsible for moneys claimed to be sent but not received.

Charters

Article 14. When a Charter is granted for the organization of a new Lodge, such Lodge shall receive its instructions from the Grand Chief Templar or Deputy Grand Chief Templar, and if a special Deputy be appointed, he shall be a Chief Templar or a Past Chief Templar. An application for a Charter shall be presented to the Deputy Grand Chief Templar of the District in which such Lodge is to be located; and if approved by him the application and charter fee, which shall be Twelve Dollars and a certificate of approval shall be forwarded to the Grand Secretary, when a Charter may be issued in accordance with the Constitution. If the Deputy shall disapprove of the application he shall nevertheless transmit the same and the Charter fee to the Grand Secretary, accompanying them with a statement of his reasons for disapproval, for the consideration of the Grand Chief Templar or Grand Secretary. The supplies to accompany a Charter shall include, in addition to those necessary for the organization of a Lodge, a copy of Roberts' Digest.

Trial of Subordinate Lodges.

Article 15. Before any Lodge can be put on trial, charges duly specifying the offence shall be preferred to the Grand Lodge by the proper Deputy Grand Chief Templar of another Lodge, or by any member or the Grand Lodge, a copy of which shall be served on the said Lodge; and its answer, together with the charges, shall be handed to the Deputy Grand Chief Templar, and by him sent to the Grand Secretary, when the Executive Committee shall take such action as to them shall seem expedient. This rule shall not interfere with the powers of the Grand Lodge Executive, as defined in Section 5, Article VII., Grand Lodge Constitution.

Suspension of Subordinate Lodges.

Article 16. Any Subordinate Lodge failing to hold meetings for six months, or to make its returns as required by the Constitution, for one year, shall be deemed an extinct Lodge, and its Charter shall be forfeited.

Certificates to Members of Extinct Lodges.

Article 17. Before granting certificates of membership to members of extinct Lodges, the Grand Secretary shall require a recommendation from the Deputy of such extinct Lodge, or some other Deputy in the district, or other satisfactory evidence.

Restoration of Charters

Article 18. Applications for restoration of Charters of extinct Lodges must be accompanied with satisfactory evidence that a fair opportunity has been given to all who were members in good standing at the time the same became extinct to petition therefor.

Duties of Financial Secretaries.

Article 19. Financial Secretaries of Lodges are required to present the accounts of members in arrears for collection, regularly each quarter, before another quarter's dues shall have accrued.

Sessions.

Article 20. This Grand Lodge shall not hold open sessions at any time while transacting Grand Lodge business, but may set apart a specified hour during the continuance of the session for instruction in the Subordinate Lodge work, should there be a demand for it and the business of the Grand Lodge permitting, admitting all who were at the time entitled to a seat in the Subordinate Lodge.

Standing Committees.

Article 21. The Grand Chief Templar shall at the opening of each session appoint the following standing committees, to consist of five each: Credentials and Returns, State of the Order and Constitutions, and after the installation of officers at each session the Grand Chief Templar shall appoint standing Committees on Appeals, Finance and State of the Order.

Trustees of Subordinate Lodges.

Article 22. The election of Trustees shall take place at the first meeting in August in each year.

Regalia.

Article 23. That the badge authorized by the R. W. G. Lodge be the recognized regalia for Subordinate Lodges in this jurisdiction.

The following questions were handed to the Grand Chief Templar, and answers given:-

Ques.—Can a person who professes to believe in the existence of a Supreme power, but not in a personal God, be admitted in our Order?

Ans.-No. The questions in Subordinate Lodge Rituals must be answered in the affirmative to initiate a candidate. See Robert's Digest, page 12, decision I A.

Ques.—Has the Lodge Deputy any right to give a decision without the Lodge asking for it?

Ans.-No; but he can call the attention of the Lodge to any irregularity. Ques.—In case a Lodge Deputy gives a decision on a question arising in the Lodge, and afterwards by writing to the Grand Chief Templar for approval finds himself in error, should he not report such error to the Lodge?

Aus.—No. Unless the question was referred to him by the Lodge.

Ques .- When a Lodge finds that four of its members have violated Art. II., of our Constitution, can a fine be imposed collectively, or must it be done individually?

Ans.-Individually. See Art. VII., Constitution.

Ques.—Can a Lodge frame a code of By-Laws for its own guidance?

Ans.—Yes; but it must be in accordance with the provisions of the Constitution.

Ques.—Can a Lodge after it comes to the Order of Business, "Good of the Order," have open doors?

Ans.—Yes, if closing ceremonies are gone through either before or after.

Ques. 1st—If a member signs a petition for a hotel with a bar-room in his district, does he violate his pledge?

" 2nd.—How should such member be dealt with?

Ans. 1st.—Yes; see Roberts' Digest, page 116, No. 26.

" 2nd.—Under the provisions of Art. VII., Secs. 1 and 2 of Constitution. Ques.—If a member holds up his left hand in voting can it be recognized as a legal vote, when the Constitution calls for the uplifting of the right hand?

Ans.-No.
