16. To consider notice of R. W. Bro. J. B. Charleston :  
 "That all the words in Art. 181, page 44, of Book of Constitution, after the word "rejection," in the fifth line be struck out."

Of W.: Bro. G. R. White :

"That paragraph 185, page 45, of the Book of Constitution of this Grand Lodge, be amended by striking therefrom the words, 'and in every case the entire fee for the degrees shall accompany the application, also such application shall not be received,' and the following substituted: 'that the fee of at least five dollars shall accompany every application, else such application shall not be received.'"

Of V.: W.: Bro. E. T. D. Chambers :

"That it being expedient that the prohibition of dual membership by the Constitution of the Grand Lodge of the Province of Quebec be now revoked, so as to permit the weaker of the Lodges in this jurisdiction to accept an increase in numerical and financial strength from many members of other Lodges whose assistance they are now reluctantly compelled to decline, it is now therefore

"*Resolved*, (a) That Art. 191 of the Constitution of the Grand Lodge of Quebec be amended, by adding after the word 'dimit,' in the fourth and last line, the words 'or by a certificate showing that he is a member in good standing of some other Lodge under the jurisdiction of the Grand Lodge of Quebec.'

"(b) That Art. 252 be expunged from the Constitution.

"(c) That Art. 263 be amended by striking out the words 'by acquiring membership in another Lodge, and,' in the sixth line, and the word '5th' in the seventh line.

"(d) That form No. 6 (application for affiliation), on page 72 of the Constitution be amended, 1st, by adding after the word 'mason,' at the end of the fourth line, the words 'and member'; 2nd, by adding after the word 'standing' in the fifth line, the words 'of.....Lodge No.....on the..... of.....(or as the case may be)."

Of V.: W.: Bro. H. D. Moore :

"That the masonic district of Bedford (as now existing) is much too large in its geographical area, for masonic uses and purposes, so much so

that it is found almost impossible for any brother, acting as District Deputy, to visit the different Lodges under his care and to perform the many duties attached to his office in a manner satisfactory to himself and to the interests of the craft; therefore said district shall be separated and divided into two masonic districts, the limits, boundaries and names of each to be fixed and defined during the present session of Grand Lodge."

The R.: W.: Grand Secretary read the rules and regulations for the government of Grand Lodge during its business.

MINUTES, ETC.

The minutes of the Emergent Communication of Grand Lodge, which was held on 6th June, A.D. 1883, A.L. 5883, at Coteau Landing, Q., were read and confirmed.

The R.: W.: Grand Secretary proceeded to read the minutes of the last Annual Communication held at the city of Quebec, when it was moved by V.: W.: Bro. W. Simpson Walker, seconded by R.: W.: Timothy Leet :

"That the minutes of the proceedings of this Grand Lodge at its Thirteenth Annual Communication having been printed and distributed amongst the different subordinate lodges, they shall be considered as read, and they are hereby confirmed."

## AFTERNOON SESSION.

The Grand Lodge resumed labour at 2.30 P.M. this 30th day of January, A.D. 1884, A.L. 5834, the M.: W.: the Grand Master on the Throne.

The M.: W.: the Grand Master delivered the following address which received the earnest and wrapt attention of all members of Grand Lodge and visitors.

### GRAND MASTER'S ADDRESS.

#### BRETHREN IN GRAND LODGE ASSEMBLED :

You have in due course been summoned to leave your avocations, to lay aside your ordinary work, to assemble in Council to review the past, consider the present and legislate for the future. The fourteenth year of our existence as a Grand Body is finished. The record is complete. The book closed. All our errors of omission and commission are there recorded. Likewise are our deeds of charity, love and kindness made mention of. The volume is consigned to the archives of history, and will outlast the heavens and the earth. A new book is now opened and placed before us; its pages are white, pure and unsoiled. It is the volume of 1884, or with us volume fifteen. We hear the command write, and we must write therein, and every thought, word and act is going down. May we not venture the hope that when it too shall become historic, and find its place on the shelves of time alongside its predecessors, it may exhibit fewer torn pages, fewer blots and erasures. To that end has our esteemed Chaplain invoked the Divine aid: Thankful we are to the "Giver of all good" that He has brought us together at this time under circumstances so favorable.

I notice with much pleasure the presence to-day of several brethren who were gathered together on the 20th day of October, 1869, in "an upper room" in the city of Montreal, for the purpose of organizing this Grand Lodge. That was an eventful moment in their Masonic lives. Many of them have been in attendance upon each annual Convocation from that time to the present. Still true, faithful and loyal in their allegiance. Still prepared I trust to do battle for the cause they then so zealously espoused. Still prepared to defend the territory of this Grand Lodge against all invaders and usurpers.

Some who were with us on that memorable occasion have "passed beyond." They died not without hope that their fond desires would be realized at an early day. God grant they may be.

For the first time we meet in the young, flourishing and prosperous city of Sherbrooke; the metropolis of the Eastern Townships. We view with pride the rapid strides this place has made within the last few years. We note with satisfaction the fact that foremost in the front ranks of her eminent citizens, in the learned professions, and in all the walks of life, stand members of our cherished fraternity. Sherbrooke welcomes us here. May our presence prove beneficial. Happy are we to know that the life of our beloved Queen has been precious in His sight during the past year. Long may she live to be the Patroness of our order in England. The re-election of His Royal Highness the Prince of Wales to the Grand Mastership of the Grand Lodge of England, gives us great encouragement.

"Their tributes other Queens have laid  
Upon the land and sea;  
But never earthly monarch swayed  
So many hearts as she.

And for her truly gallant heir,  
A kindred love prevails;  
God, hear a nation's fervent prayer,  
God bless the Prince of Wales."

#### AT REST.

During the past year "the last enemy" has made inroads in our ranks. Many brethren have fallen beneath his thrusts. One by one we have laid them aside. May the thought that the time will come, sooner or later, when we, too, shall be summoned into "the eternal presence" make us more diligent and faithful in the discharge of our high Masonic trusts. It is my sad duty to inform you that on the 3rd day of June last I received intelligence of the death of our late M. W. Bro. W. B. Simpson, P. G. M. of G. L. of Canada. A desire was expressed that his funeral services should be conducted by G. L. of Quebec. I immediately instructed our Grand Secretary to summon G. L. for the purpose. Our departed brother was made a Freemason in Sussex Lodge, Brockville, on the 2nd March, 1853, being thirty-five years of age. He entered upon the work with enthusiasm and energy. He brought to the Craft a bright intellect and matured judgment. He soon saw the advisability and necessity of forming a G. L. in Canada. The interests of the Craft required it. To this end a preliminary meeting was held at Niagara Falls in July, 1855, at which he was present and took an active part. At his suggestion a

convention was called at Hamilton on the 10th October, 1855, which resulted in the formation of a Grand Lodge. He was elected D. D. G. M. for one of the most important districts. In 1860 he was elected D. G. M. On the 15th July, 1864, he was elected G. M., which high office he ably filled during the following two years. Although devoting much time to Craft Masonry, he still found opportunity to advance to the higher walks of Masonic life. As a brother he was esteemed. As a public official he was respected. On the morning of the 6th day of June Grand Lodge, accompanied by M. W. Bro. Col. A. A. Stevenson, P. G. M. of G. L. Canada, M. W. Bro. Col. McLeod Moore, Grand Prior of the Grand Priory of Canada, and P. G. M. Col. Hutton, 33°, C. G. Geddes, 32°, H. S. Evans, 32°, W. S. Walker, 32°, together with a large number of G. L. officers and brethren, proceeded from Montreal to Homewood, Coteau Landing, the ancestral residence of our late lamented brother. We were met there by R. W. Bro. W. L. Hamilton, D. D. G. M. of Prince Edward District, Canada, and R. W. Bro. George M. Wilkenson, P. D. D. G. M. of Ancient St. John, a lodge with which our deceased brother was at one time connected. Being a member of the Church of England, the beautifully impressive service of that Church was read by His Lordship the Bishop of Ontario, assisted by the Rev. L. A. Young. A large and mournful concourse of friends followed the remains to their last resting place. The band of the 1st Prince of Wales Rifles, playing the Dead March in Saul, preceded the band of faithful brethren in that melancholy march from that small country church to the lonely country graveyard. M. W. Bro. A. A. Stevenson, representing the G. L. of Canada, ably assisted me in the service at the grave. We surrounded the mortal remains of our lamented brother, and deposited the sprig of evergreen, emblematical of that immortality which, we trust, his soul has entered upon. And amid the singing of spring birds, the bursting of buds, the blossoming of early flowers, beneath a grand old oak, with the wind sighing through the branches of the Balm of Gilead, and beside the River St. Lawrence, whose waters he loved so well, we left our brother at rest, awaiting the coronation day.

Another, too, has passed into the valley and under the shadow, one who was eminently serviceable to the Craft at the time of the inception and organization of this G. L. I find that R. W. Bro. Borlase was, under the G. L. of Canada, D. D. G. M. for the Eastern Townships District. His name appears appended to a circular addressed to all the lodges in the Eastern Townships and Quebec Districts, calling a convention to be held in Montreal, to take into consideration the state of Masonry in the Province of Quebec. This bears date July, 1868. He presided at that very important meeting. He witnessed the consummation of his efforts in the formation of this Grand Lodge on the 20th October, 1869. He has



left his impress on a very interesting page of Masonic history. Peace be to his ashes; rest to his weary soul.

Eminent and esteemed brethren in other jurisdictions have been called to lay aside their working tools. We mourn their loss and sympathise with the bereaved. But, having confidence in one of the cardinal tenets of our faith, we believe that the time will come when He, our elder Brother, who raised His voice at the grave of His friend, will again speak, and call earth's true, tried and faithful ones from the domains of death to a glorious immortality and eternal life.

#### CLARITY AND BENEVOLENCE.

"To feed the hungry, clothe the naked, and bind up the wounds of the afflicted" is part of the mission of Masonry in this world of ours. Identified this institution in the past has been with deeds of mercy, acts of love and kindness. Its characteristics in this respect must never be lost sight of. Our charities, since formation, have not been ostentatious, and the outside world may have known little of them. Yet many hearts have been cheered; many a widow and many an orphan has been encouraged by what we have done. At present an asylum or school may not be within our reach. Still it is our duty to look forward to the accomplishment of so desirable a result. To this end, let there be a united effort. I would suggest that the D. D. G. Masters take the matter in hand in their respective districts, and make a special appeal to each lodge to set apart a percentage of its revenue to aid in this enterprise. My brethren, no prouder laurels will ever be worn by you, than will be, should you accomplish this purpose.

During the past year I have been much interested in reading the reports of the different Grand Lodges, and no feature has attracted my attention more than the work that is being done in this direction. If the amount that is annually distributed for educational, benevolent and charitable purposes by the fraternity at large could be ascertained, it would surprise all. I undertook the same but had not time to complete it. Here is a field for some diligent brother to labor in.

England's benevolent fund is £50,000, with an annual income of about £8000. Her charities amount to as much more. Our noble Queen deems it not beneath Her high station to be the Patroness of the Royal Masonic Institution for Boys.

The Grand Lodge of Canada donated for charitable and benevolent purposes from 1876 to 1882 inclusive, the sum of \$71,296.52. Who shall say that her mission in Ontario is not for good. This G. L. sent \$800 to the sufferers by the Chicago fire. Upwards of \$500 was forwarded to St. John, New Brunswick, at the time of the disastrous fire in that city, by

the Masons of this Province. In 1881 a cry for aid went forth to the world from the burnt districts of the State of Michigan. Families were homeless and much distress prevailed. In a short space of time Freemasons contributed upwards of \$23,836 to relieve the suffering. This money was distributed without regard to nationality or creed. It was not confined to members of the fraternity. It went where it would do the most good.

“BY THEIR FRUITS YE SHALL KNOW THEM.”

Before that tribunal Freemasonry is prepared to be arraigned. At that bar, we, my brethren, must stand or fall. Degrees, titles or professions will not save us or the craft.

#### GRAND LODGE OF CANADA.

It was my privilege to attend the 28th Annual Communication of that Grand Body in the month of July last, accompanied by the M. W. Bro. Graham, P. G. M., M. W. Bro. Tyler, P. G. M., M. W., W. J. B. McLeod Moore, Grand Prior and P. G. M., together with several officers and past officers of this Grand Lodge. We were received in the most courteous, friendly and fraternal manner. The event will ever be remembered.

We found in convention there upwards of four hundred and fifty delegates, representing three hundred and ninety-nine private lodges, with two under dispensation. Her charity and benevolent work is deserving of emulation. During the past year a very worthy brother, J. Ross Robertson, has erected on the Island, opposite Toronto, a building to be called “Lakeside Home for Little Children,” into which children of members of the Masonic fraternity must be admitted.

Will not some brother in this jurisdiction be impressed with a like generously Masonic spirit, and go and do likewise? We take pride in Her prosperity. The most intimate relations exist between us. Such is the case, notwithstanding the fact, that there is within the territory of this G. L. a body of Freemasons, that has received within its portals and made a mason, a man who had previously been blackballed in a lodge in Toronto. This G. L. has been and is powerless to prevent such unseemly and unmasonic conduct. How soon will there be a repetition of this act, and another friendly Grand Lodge be attacked in the same way? How long, my brethren, shall the territory of this Grand Lodge continue to be the recruiting ground of another Grand Body? England defended her private lodge in the course she pursued, and still sustains her.

#### DISPENSATIONS.

These have mostly been required for the wearing of regalia on festive occasions and attending church. There is an increased tendency among

our Lodges to attend Divine service as a body once at least during the year. I would commend this custom to all. For good reasons given and endorsed by the D. D. G. M., I granted dispensation to make, pass and raise a candidate in less time than is required by the Constitution. I did this reluctantly, believing that the G. M.'s prerogative should be exercised with much caution and prudence. The written law must only be departed from in cases of emergency.

#### AMALGAMATIONS.

Recently Antiquity number 1 and Victoria number 26 have amalgamated, the new lodge retaining Antiquity's charter, name and number. Have no doubt but what good will result from this union. A strong, healthy and vigorous lodge will be formed. It is possible the example thus set may with advantage be followed by others.

#### BY-LAWS.

During the past year the By-laws of a number of lodges have been submitted to me for approval. This has been occasioned by reason of our new Constitution differing in some important features from the old. Doubtless many other lodges require to take the same action.

#### RENUMBERING OF LODGES.

Consequent on the placing of Elgin, King Solomon and Argyle on our register, the re-numbering of the Lodges became a necessity. To effect this a committee was named at the last communication, which will report at the present.

I have no doubt but what their labors will prove satisfactory. It is the second time this work has been done, still we find lodges numbering 440, 640 and 374 within our jurisdiction. We have but sixty-seven all told. Sister Grand Lodges will fully comprehend the situation when I inform them that the initials E. R. follow the above named numbers. The present committee will doubtless be discharged, though this work remains incomplete.

#### MISSISQUOI PARK.

This beautiful spot, on the shores of Lake Champlain, was again visited by our brethren, accompanied by their wives, daughters and lady friends, from Montreal and Bedford Districts. I was with them on the occasion. This place is beyond our jurisdiction, but our friends in Vermont, of whom we met many, did not raise the question. Our occupation was temporary, and we sought not recruits. The morning was overcast, and at mid-day dark clouds rolled up from the lake. The rain came down in torrents, much to the discomfort of all. After lunch we assembled beneath

a large awning, where addresses were delivered by M. W. Bro. Thos. White, M.P., P. G. M., your own Grand Master, R. W. Bro. Isaacson, and other brethren. The day, though unpropitious, was much enjoyed.

#### FREELIGHTSBURGH.

I was with the brethren in this locality for "a day out" on the 25th of June. It was in this village where a few years ago G. L. laid the corner stone of a church edifice. That church is now completed. Our predecessors were characterized as builders. We, too, are erecting monuments which will abide when marble shall crumble and brass pass away. Let us then see well to our work. On this occasion a large number gathered in a beautiful grove for a basket pic-nic. Games and sports formed part of the day's amusement. All were on pleasure intent. Addresses were delivered by R. W. Bro. Nye, the G. M., and several others.

#### MOUNT ORFORD.

This Lodge, as is her custom, held her Mid-Summer Festival on the shores of the far-famed Lake Memphremagog, beneath the shadow of the mountains. I cannot too highly, my brethren, commend these social reunions, and never neglect to take with you, your wife, your sisters, your daughters, or some brother's sister. Our lady friends can be of incalculable assistance to us in our work. What a source of strength they would be if identified with us in our charity and benevolent undertakings. Masonry is for them, as well as for ourselves.

#### TEMPERANCE.

This is an age when strenuous efforts are being put forth by good men and true, in the church and out of it, to stay the tide of intemperance, which like a wild wave has so long rolled over our country. In this good work, my brethren, we must not be backward. By precept and by example let it appear that we are engaged in it. It is a tenet of our faith. I call your earnest attention to the same.

#### VISITATIONS.

These have not been as frequent as I anticipated at the commencement of the year. Several Lodges in Montreal and in the Townships have, however, been visited. I have to thank the brethren for the universal courtesy and kindness with which they met me. The District Deputies too, were most assiduous in their attentions. I have found harmony prevailing. The brethren recognizing the golden cord by which they are bound. Prosperity has attended them. I believe the work done has been in excess of former years. Still, I would remind you that our

strength rests not wholly in a large membership. That is desirable, but excellence is more so. Guard well the outer door. See that none enter except such as are well qualified. Has the petitioner the requisites in body, heart, soul and intellect to make him a true and faithful worker among us? If so, admit him; we care not for his ancestry, so be that he is free born. The semi-fossilism of an age that enquired had he a grandfather, is passing away.

#### GRAND REPRESENTATIVES.

Owing to the decease of R. W. Bro. Borlase, the office of Grand Representative of the Grand Lodge of Illinois, near this Grand Lodge, became vacant; I suggested R. W. Bro. Alexander Chisholm as his successor.

The Grand Lodge of Iowa having adopted the three year term as the tenure of office of its Grand Representatives near other Grand Bodies, the office of R. W. Bro. Samuel Johnson became vacant. I nominated W. Bro. H. E. Channell, of Golden Rule, as his successor. I received a communication from Grand Lodge of Greece, asking in the most courteous language for the exchange of Grand Representatives with this Grand Lodge. This has been done.

#### NEW GRAND LODGES.

The Grand Lodge of New South Wales was founded in 1877, since which time she has been seeking recognition. Her efforts have been very successful. At the last Communication of Grand Lodge of Canada a hearty welcome was extended to her. She has, I understand, a majority of private lodges of the Scotch and Irish Registers with her, but not of the English Register. The concurrent jurisdiction of three, and now four, Grand Lodges in that colony, must prove anything but advantageous to the Craft.

#### VICTORIA.

This far off sister colony is struggling for Masonic Independence. On the second day of July last, a Grand Lodge was organized at Melbourne. It is sustained by a number of private lodges, though not a majority. Here also are found lodges under the English, Scotch and Irish constitutions. A few Grand Bodies have recognised this Grand Lodge.

I submit both cases for your consideration.

#### RELATIONS WITH ENGLAND.

I approach this portion of my address reluctantly but fearlessly. Reluctantly, because the question is of such vital importance to this Grand Lodge, and in its solution fond ties may be severed and hearts made sad. My views and expressions will be sharply criticized. Comment and discussion will ensue throughout the entire Masonic world.

Many an anxious eye is even now turned towards us. Fearlessly, because I am conscious of the rectitude of our cause and the strength of our position. Confidently we will appeal to that great tribunal, the court of *dernier resort*, the Grand Lodges of the world, and patiently await the verdict. I wish to call your attention to a few circumstances connected with this G. L. from the time of its inauguration down to the present, to trace its struggle for the principle of Masonic supremacy during the years of its existence. I shall do so but briefly, as they have been so often before you that you are familiar therewith, though, it is possible some of the younger brethren may not be quite conversant with the same. It was fourteen years ago last October since this G. L. was formed. At that time the Grand Lodges of England, Scotland and Canada were in possession of this territory, and had private lodges herein. One of the fundamental principles enunciated at that time was sovereign, independent and exclusive jurisdiction in and over the Province of Quebec. It was the key note in our appeal for recognition to sister Grand Lodges. It was the corner stone of our whole superstructure. Within one year from that time we were welcomed into the sisterhood of Grand Lodges by nine Grand Bodies, stretching from Maine to Nevada, including the Province of Nova Scotia. At the first meeting of this G. L., I find the then G. M., M. W. Bro. Graham, giving utterance to the following sentiment: "Having duly confirmed the minutes of the Convention of Lodges that formed this, the Grand Lodge of the Province of Quebec, and having solemnly ratified and adopted all acts and proceedings had at its organization, it is now fitting and desirable, and in accordance with the general custom of the Craft under similar circumstances, that this G. L. declare its sovereign independence and its right to undivided supremacy and to the exclusive Masonic jurisdiction within the Province of Quebec." During the following year thirteen more Grand Lodges extended to us a most cordial recognition, making twenty-two in all. In M. W. Bro. Graham's second annual address he lays down the following fundamental principle: "In every distinct territory having a Legislature of its own, there exists the Masonic right to found an independent sovereign Grand Lodge. The consent of any mother G. L., however desirable, is not essential or necessary. Nor can any G. L. constitutionally interfere with or in any way rightfully hinder private lodges in the exercise of their inherent right to form a G. L. of their own in such legislatively distinct territory, no matter what prior authority she may have exercised over them. A Grand Lodge thus formed in unoccupied or discovered territory possesses the inalienable right of exclusive jurisdiction over all symbolical lodges of Freemasons within such territory." At this communication the following resolution was passed by a majority of forty-three votes: "That the Grand Master be authorized to proclaim at any

"time before the next annual communication of this Grand Lodge, as "may seem best to him, non-intercourse with any lodge or pretended "lodge in this jurisdiction that persistently refuses to recognize the "supremacy of this Grand Lodge." In 1872 the same eminent Grand Master announced to G. L. that we were in fraternal communication with thirty-one Grand Lodges. It was during this year that the correspondence between the G. L. of England, then presided over by His Lordship the Marquis of Ripon, and ourselves commenced. In the month of June of that year a copy of the foregoing resolution was forwarded that Grand Body. On the 29th August following a reply was received thereto through R. W. the Hon. W. Badgley, of Montreal, enclosing an extract from a letter received by him from the M. W. the G. M. of England. The defence put forth by His Lordship at that time on behalf of the G. L. of England consisted chiefly in an allusion to an agreement entered into between the G. L. of England and G. L. of Canada at the time of the recognition of the latter by the former, namely: "That it was agreed that all such "lodges as desired to remain under the English constitution were at "liberty to do so, and that all their rights and privileges were to be "retained, but no other warrants would be issued by the G. L. of "England to lodges in Canada." The answer to this plea is, that since that unfortunate article in the treaty between the G. L. of England and the G. L. of Canada was agreed to, British North America has undergone radical political changes. The Province of Canada, which existed at that time, and was the territory of G. L. of Canada, is now no more. In its place stand the Provinces of Quebec and Ontario, with separate and distinct legislative governing bodies. The lines dividing the same are as well defined as are those dividing the States of Vermont and New Hampshire. A new order of things has arisen. A new system of government, to a great extent, has been introduced. A Dominion has been constituted composed of Provinces *quoad*, each to the other separate and distinct.

Under the application of the territorial principle, the Quebec Grand Lodge was formed and took possession of her legitimate territory. Such formation and subsequent recognition by the Mother Grand Lodge, Canada, vested in her all the transmissible rights of that Mother Grand Lodge to the extent of transferring to this Grand Lodge, all Master Masons subject to her previous to our creation, all her lodges and our share in the common fund; and it went further. Masonic law as to jurisdiction became at once applicable, and this Grand Lodge became the sole Masonic power in this Province. It was on the part of the Grand Lodge of Canada an absolute assignment of all her territorial rights in this Province in favor of this Grand Lodge, which thereby became seized thereof and concurrently with the application of the principle before mentioned, which at once operated in our favor, made this Grand Lodge the possessor of the territory of Quebec, to the exclusion of any other Masonic body.

We thereby became *de facto* the peer of sister Grand Lodges, clothed with the same powers, and possessing the same rights. No continuing reservation was stipulated in the act of recognition in favor of foreign lodges, and even had there been, it is my opinion, that so soon as it became apparent that such stipulation was detrimental to craft Masonry in the Province, such foreign lodges could be invited to withdraw, failing which, resort could be had to the usual Masonic practices to remedy the wrong.

During this year, the Grand Lodge of Louisiana recognised this Grand Lodge in the following terms: "That this Grand Lodge of Louisiana recognises the Grand Lodge of Quebec as a just and legally constituted Grand Lodge. And as such is entitled to sole and exclusive Masonic jurisdiction in and over the Province of Quebec, and hereby extends to her a cordial welcome unto the family of Grand Lodges."

Our Fourth Annual Report discloses the fact that we had established fraternal relations with thirty-six Grand Lodges, which comprised nearly all the Masonic Grand Bodies on this continent, and some in Europe. The doctrine of Grand Lodge Sovereignty is prominently brought to the front in the proceedings.

1874.

This year was made memorable by the withdrawal of Grand Lodge of Canada from this Province, and the uniting of her private lodges with this Grand Lodge. This happy event was the occasion of much congratulation. Since that time these two Grand Bodies have maintained the utmost cordial and fraternal relationship, each toward the other. At the Annual Communication of this year an earnest desire was expressed for the early adjustment of the difficulties between England, Scotland and ourselves.

1875.

M. W. Bro. Dunbar announced in his address that forty-three Grand Lodges had acknowledged this Grand Lodge as the sovereign Masonic authority in and for the Province of Quebec. Among these was the honored Grand Lodge of Ireland. He also communicated the intelligence that England had offered recognition on terms similar to those upon which she had recognized the Grand Lodge of Canada, as stated heretofore. He referred this important matter to the Grand Lodge for its "careful consideration." After much discussion, the following resolution was passed by a vote of eighty-four against seven:

"That the consideration of the acceptance by this Grand Lodge of recognition by the Grand Lodge of England, in the terms proposed by the latter, as set forth in the address of the M. W. the Grand Master, be postponed until the next Communication of this Grand Lodge, and that a committee be appointed by the M. W. the Grand Master to confer with Lodges now existing in this Province under warrants from other juris-



"dictions, with a view to effect, if possible, the amicable junction of said  
 "Lodges with this Grand Lodge, and that said committee report progress  
 "to the M. W. the Grand Master, from time to time, in order that such  
 "report may be submitted for the consideration of this Grand Lodge,  
 "whose decision only in the matter shall be final."

1876.

Again M. W. Bro. J. H. Graham, presided in the Grand East. We learn that he appointed a Committee in accordance with the foregoing resolution, "He exceedingly regretted to report that no conference had been had, chiefly on account of the non-co-operation of the said private lodges," to wit: St. Lawrence, St. Paul, St. George and Elgin. I would recommend brethren to read the correspondence had at that time on this subject. He again declared "That the exclusive sovereignty of each Grand  
 "Lodge within its own territory must be maintained. It is the foundation  
 "and keystone of our Grand Lodge existence, and the principal source of  
 "our unity, harmony and prosperity. For many obvious and important  
 "reasons he could not recommend the acceptance by Grand Lodge of the  
 "conditional recognitions proffered by the Grand Lodge of England." This view was endorsed by the Board of general purposes. The report declares that we had received recognition from forty-two Grand Bodies.

1877.

M. W. Bro. Dunbar again presided. He conveyed the gratifying intelligence "That the Grand Lodge of Scotland had opened fraternal communication, and had exchanged Grand Representatives with this Grand Lodge." This gave great pleasure to the fraternity. It was thought another foreign element had been removed from our midst. That the goal of Independence and Sovereignty was almost within our grasp Vain hope.

1878.

This Masonic year, that dawned so auspiciously, closed amid confusion. During this period the Grand Lodge of Scotland withdrew her recognition and recalled her commission to her Grand Representative here. Not satisfied with this she granted charters to form two new lodges within the limits of this Province. The then G. M. M. W. Bro. Tait, "Lost no  
 "time in issuing a proclamation declaring such action on part of Grand  
 "Lodge of Scotland as an unjustifiable and unlawful invasion of the ter-  
 "ritory and jurisdiction of this Grand Lodge, declaring the warrants  
 "irregular and suspending intercourse between this Grand Lodge and all  
 "in obedience thereto, and the G. L. of Scotland and all in obedience  
 "thereto." G. M. Tait, continuing his very able address, says:

“Brethren, not only does the question of the recent action of the Grand Lodge of Scotland now come before you for your consideration, but it seems to me a fitting time has arrived to consider generally your relations to these foreign Grand Lodges which had, at the formation of our Grand Lodge, and still have, subordinate lodges in our jurisdiction working under them, as well as these subordinate lodges themselves.

“Brethren, you have seriously to consider if patient protest against this state of things may not pass into tacit acquiescence. I leave the whole matter in your hands, believing that you will give the subject that consideration it deserves, and take only such steps as will advance the interests of Masonry in general, and this Grand Lodge in particular.”

The Board of General purposes, in reporting on the G. M. address, used the following strong language :

“Under these circumstances—under this great provocation—all its offers of fraternal intercourse and protection to these foreign lodges, which existed here prior to the recent action of the G. L. of Scotland, having been rejected—it is surely time for this Grand Lodge, if it desires to maintain the respect of the Craft throughout the world, the esteem of its sister Grand Lodges, and the support and obedience of its own brethren, to assert and maintain the authority and discipline with which, as a Grand Lodge, it has been intrusted, and to proclaim and enforce, as far as possible, by all proper and lawful means, that no lodge of Freemasons shall exist in the Province of Quebec which shall not own allegiance to the M. W. Grand Master and Grand Lodge of Quebec—obey the laws made by it for the government of lodges and members of lodges—and contribute its portion to the support of this Grand Lodge and the relief of distressed brethren, whether of our own jurisdiction, or who, coming from other countries, may be here in want and distress—and that all lodges not acknowledging this allegiance, and giving this support and obedience to the Grand Lodge of Quebec, shall be declared irregular and illegal lodges, no matter by what authority they may assume to act.”

The following resolution, moved by our late lamented W. B. Simpson, seconded by M. W. Bro. Dunbar, was passed :

“*Resolved*,—That the M. W. the Grand Master be and is hereby earnestly requested and authorized, either by personal interview or by the appointment of a delegate to the Grand Lodge of England, to endeavor to secure a speedy and amicable solution of all pending difficulties between the two Grand Lodges, and that the M. W. the Grand Master do report the result of this mission.”

1879.

M. W. Bro. Tait again Grand Master. The committee referred to above was named by the G. M. Circumstances prevented the members thereof from going to England, as was anticipated. From the reports of different Grand Lodges, it appeared that the Grand Master was fully sustained in the issuing of his proclamation regarding the Scottish invasion.

1880.

Again M. W. Bro. Graham presided over the deliberations of this Grand Lodge. Under the head of "England and Scotland," he expressed strong hope "That in the then immediate future he would be able "to communicate to G. L. a happy settlement of all our difficulties. "Correspondence and events strengthened his expectations." "But," he went on to say, "should it be that these seemingly well-grounded "anticipations of a peaceful, honorable and constitutional adjustment of "these unhappy international differences be not soon realized, the Grand "Lodge of Quebec will be fully prepared for any other emergency which "may unhappily arise; and, in case it is unfortunately required (which "we fervently trust may not be), there will be in readiness to submit, for "approval of Grand Lodge, at an Emergent Communication, if need be, "such a course of action as, I believe, will be strictly warranted by the "constitutions and ancient practices of the Fraternity; and will, in my "opinion, be generally sanctioned and sustained by the Craft, as "Quebec" "has hitherto been by nearly all the regular sister Grand Lodges of the "world."

At this time we were in fraternal intercourse with sixty Grand Lodges.

1881.

During this year the three Lodges under the Scotch registers (Elgin, King Solomon and Argyle) surrendered their charters and united with us. A happy consummation of the earnest and devoted labors of faithful brethren whose names will long be remembered. There then remained the three lodges under English Register, standing a barrier to our supreme exclusive Masonic jurisdiction in this Province. To attain this end, so fervently desired in the interest of this Grand Lodge and of the Craft at large, M. W. Bro. Graham brought the full force of his Masonic wisdom, his great abilities and untiring zeal and earnestness. The correspondence with the Grand Lodge of England was renewed, Grand Master Graham addressing himself directly to His Royal Highness the G. M. of England, and in a series of letters that stand unexcelled in Masonic literature, assailed and carried every stronghold and barrier erected by that Grand Body. He corrected mistakes made by its Grand Secretary, shewed the

errors into which he had fallen. Proved most conclusively that England had not so thorough a knowledge of Masonic matters on this continent as she might have.

From constitutional precedents derived even from the records of Grand Lodges of England and Scotland, from the jurisdictions of other portions of the Old World, as well as the new, he established beyond a doubt that we were, and are, entitled to have and maintain exclusive Masonic jurisdiction in this Province. He urged the expediency, in the interests of the Craft here and elsewhere, "That England either recall "and cancel the warrants of these three lodges, or that they become of "obedience to the G. L. of Quebec. That the joint occupancy of this "territory by two Grand Bodies was tending to produce much uneasiness, discord and confusion among the Craft." No more earnest and forcible language could have been used, yet all in the most fraternal spirit. But what availed the argument, the protest and almost pleading? The Grand Secretary of that Grand Lodge, in reply to one of the above mentioned letters, said: "With reference to the points once more urged "in your letter on the subject of the English lodges by you, H. R. H. our "Grand Master can only again express his regret that he cannot comply "with your wishes." Another communication was addressed to His Royal Highness under date of June 14, 1881. This received a brief fraternal reply. The ultimatum had been given. The correspondence closed. Further representations and appeals would be of no avail.

At the last communication of this G. L. held in the city of Quebec, the M. W. the then G. M. in a masterly and most exhaustive manner set forth our cause and pretentions. Yet, no relief is afforded, aggressions are more frequent and of a more virulent nature. In the address delivered on that occasion we find the following:

"Frequent and continued violations with seeming intent and avidity, "of fundamental laws governing the craft here, such as the acceptance of "material rejected by Quebec lodges, and the like irregularities, and with "which probably no other Grand Lodge would have borne with as long "as the Grand Lodge of Quebec has; and thus the circumstances have "been increasingly aggravated, and have thereby put a still greater "strain upon the forbearance of this Grand Lodge."

I have thus endeavored to follow the principle of exclusive jurisdiction as understood by this G. L. from the time of its formation until I was called upon to preside over its deliberations and measurably guide its destinies. Another year has passed, and I fear the breach is wider today than it was. The happy realization of our fond hopes, labors and efforts, seems indefinitely deferred. If we may judge from the tone of the public press, a most deplorable state of affairs exists in masonic circles in

this Province, and all arising out of England's determination to maintain her position, or rather perhaps the determination of these three private lodges to continue with that Grand Body and bid defiance to the only legally constituted Masonic authority now existing in this Province. England has recognized Grand Lodges who, in their turn, have recognized us. They Her peer, We Their peer, and yet not Her peer.

In recognizing the Grand Lodge of Pennsylvania, the Grand Lodge of England used the following language, sentiments so inconsistent with her present attitude toward us: "Having perused your book of Constitutions, we reflect with pleasure that the Grand Lodge of England has given birth to a Grand Lodge in the Western World, whose strict adherence to the ancient and immutable landmarks of our Order reflects honor on its original founders. We conceive that in constituting your Grand Lodge we necessarily communicated to it the same independent Masonic authority within your jurisdiction which we ourselves possessed within ours; amenable to no superior jurisdiction under Heaven, and subject only to the immutable landmarks of the Order. All Grand Lodges in Masoury being necessarily free, independent and equipollent within their respective jurisdictions, which consequently excludes the idea of subjection to any foreign authority, or the establishment of an *imperium in imperio*."

She, to whom we are bound by so many ties, refuses to do for us that which she has done for the stranger. The question now comes with increased force, shall this state of affairs longer continue? Shall we tamely and quietly submit to have our rights trespassed on and our territory occupied by others? Shall we content ourselves with the delusive declaration that we are a sovereign grand body? With all due deference to that Mother Grand Lodge whom we love so much, and of whose ancestry, benevolence, renown and glory we are so proud, I unhesitatingly answer no! The time for action has arrived. I fear a longer submission will tarnish our fair name and record with those sixty-three Grand Lodges who have extended to us the fraternal hand of welcome as being their peer, an independent Sovereign Grand Body. Many of them received us in an hour of danger and peril, gave us much comfort and support, and wished us God speed. Our Masonic standing in the Masonic world, our honor, dignity and integrity demand your earnest and immediate attention to this question. Let us either exercise our constitutional privileges and maintain the landmarks, or hereafter hold our peace. We have done all in our power to obtain an amicable adjustment of these differences. I advise that we now assert our rights, avow our position. That all who are not with us are against us, and declare Masonic non-intercourse with those Lodges who will not array themselves beneath our banner and join our register. This to be preceded by due notice. Such,

after much thought and reflection, are my views. I submit them to you, leaving the matter in your hands, believing that your calm and deliberate judgment will dictate to you that which is for the best.

#### SECULAR PRESS.

During the past year articles have appeared denouncing the fraternity in no measured terms. We have been accused of shielding and covering other secret organizations with our mantle. I have not deemed it my duty to controvert such assertions, trusting to the working of the order to dispel these delusions. In this Province, as elsewhere, we seek to accomplish good, not to sow the seeds of discord and evil. We know no Isms, either in theology, politics or society. We submissively yield obedience to the powers that be, whether in Church or State. We assail no man's convictions. We seek not converts. We acknowledge one God, and the Bible as his revealed will. We believe in His Fatherhood and the brotherhood of man. We most emphatically deny that we are in fellowship or communion with any other secret society.

#### CONCLUSION.

The year now closing has been one of anxiety, trial and perplexity. Those who know us not have spoken ill of us. But our fiercest assailants have been from within. They have been wicked and malicious. They have brought reproach on this time-honored institution. They have caused the finger of scorn to be pointed at us. They have caused the inquiry,—Where now are your principles? They have caused our hitherto good name and legal *status* to be questioned. Theirs be the responsibility. Freemasonry in the past has undergone trying ordeals, and has come forth triumphant, Discouragement and failure are not emblazoned on our standard. Faithfully, earnestly let us pursue the even tenor of our way, *living* rather than talking Masonry. Continuing such a course, victory will attend our efforts.

I must express my thanks to our venerable Grand Secretary for his faithful attention to the duties of his office, as well as to all my associate officers.

To the eminent brethren who have preceded me I am under great obligation for their words of counsel and advice.

The thanks of this G. L., and my own, are due to M. W. Bro. A. A. Stevenson, P. G. M., and M. W. Bro. Thos. White, M.P., P. G. M., for valuable services rendered during the year. I should be an unfaithful chronicler did I not in this connection make special mention of the names of M. W. Bro. Tait, P. G. M., and R. W. Bro. T. P. Butler, P. D. G. M., as having been faithful in season and out of season in the interests of this Grand Body. I now return to you the high trust you reposed in me a

year ago, fervently praying that He who has so signally favored this Grand Lodge in the past will still continue to bless her, to guide and direct her course.

#### GRAND SECRETARY'S REPORT.

The Grand Secretary submitted the following report :

*To the Most Worshipful the Grand Lodge of Quebec, A. F. & A. M.*

Your Grand Secretary begs to present this his report for the past year viz., from 15th January, 1883, to similar date of present year ; at the same time to submit copies of the correspondence of his office for that period.

Since last audit and inspection of books the aggregate amount of two thousand one hundred and ninety-eight dollars and sixty-five cents has been received on account of Grand Lodge from the different sources detailed in the annexed statement, and paid over to the R.: W.: the Grand Treasurer, as per his receipts herewith produced.

The following named lodges are in arrears of dues to Grand Lodge for a period of twelve months and over ; under the provisions of the Constitution, they are disqualified from being represented at, or taking any part in the proceedings of Grand Lodge at the present communication :—  
Prevost, No. 7 ; Excelsior, No. 46 ; Corner Stone, No. 37 ; Browne, No. 24 ; Aylmer, No. 22 ; Olive Branch, No. 50 ; Rouville U.D.

Your Grand Secretary has again to bring to your notice the fact, that the warrant of Constitution, books, papers, and property of Aylmer Lodge, No. 22, are not in possession of Grand Lodge, notwithstanding that the Lodge has ceased to work for a period of over two years, and that demand has been made for them through the R.: W.: Dis.: Dep.: Grand Master for Ottawa district, who reports that they are in possession of R.: W.: Bro.: Dr. Church of Aylmer, one of the Past Masters of the Lodge.

The dispensations issued to establish Rouville Lodge at Rougemont, and St. Louis Lodge at Lachino, are not returned to Grand Lodge. The former was in operation only for a few months; the latter never fully organized.

Your Grand Secretary at the last Annual Communication of Grand Lodge, in his quality of Grand Librarian, ventured to offer a suggestion with the view to aid and increase Grand Lodge Library. His proposition has not been met as enthusiastically as he had anticipated; the following Lodges only have responded, each sending the amount set opposite its name:—

The above total sum is with Your Grand Secretary awaiting instructions as to its disposal.

No outlay has been expended during the year on account of the Library, and Your Grand Secretary is encouraged to hope that a grant will be made at the present session sufficient, at the least, to have all unbound matters put into volumes.

Your Grand Secretary ventures to express the hope that a disposition will yet be shown by the Craft of the Jurisdiction to aid and foster the Library when its utility will be more generally recognized.

Your Grand Secretary requires that notice be taken of the fact, that in returns made to his office from subordinate Lodges it sometimes happens that the given or surname of members reported are not correctly sent, such, for instance, as "Charles John Smith," should be "John Charles Smith." The consequence is a Grand Lodge certificate is issued for "C. J. S.," which is returned and a new one demanded for "J. C. S." As this is not an unfrequent occurrence, and as each certificate costs about fifty cents, the sum thus lost to Grand Lodge is not, on the aggregate, inconsiderable.

Your Grand Secretary suggests that if such cases occur in the future the Lodge with whom the mistake originates shall be held to pay full charge for a duplicate certificate.



Your Grand Secretary in the prosecution of certain of his defined duties during the past year, has been subjected to some trifling annoyance, arising out of his arrest on the charge of publishing "a criminal libel." He attaches no importance to the occurrence, but as it has transpired, in the performance of routine duty it is incumbent that it be mentioned. These are the facts. In the month of August last, a Wor.: Master of a Lodge in the City of Montreal, holding under a Foreign jurisdiction, namely, that of England, induced by motives into which Your Grand Secretary declines to be interested, (could it be the hope—illusive hope!—to impede the progress of this Grand Lodge?) *stabbed Your Grand Secretary with a feather!* The victim still survives! and has the satisfaction to see that Grand Lodge, having gotten rid of the insignificant aggressor, continues its course "onward and forward," apparently oblivious of the event.

Your Grand Secretary hopes the G. L. of Q. may never have a more formidable opponent.

## REPORTS OF DISTRICT DEPUTY GRAND MASTERS.

## QUEBEC AND THREE RIVERS.

The Grand Secretary in the absence of R.: W.: Bro. Samuel Kennedy, D.: D.: G.: M.: for Quebec and Three Rivers, for that Brother presented and read the following report :—

*To the Most Worshipful the Grand Master, Officers and Brethren of the Grand Lodge of Quebec, A. F. and A. M.*

In accordance with the Constitution, I submit my report upon the state of Masonry in the district over which I have had the honour to be elected D. D. G. M.

The number of Lodges remain as at last Annual Communication, five chartered, and one working under dispensation. I regret that circumstances beyond my control made it impossible for me to visit the Lodges in my district other than those of the city and immediate vicinity.

During the month of December last I wrote to the Secretaries of Shawenegan and Good Samaritan Lodges but received reply only from the latter, the address to the former being, I presume, at fault.

Rev. Bro. Blaylock, Secretary of "Good Samaritan," gives a very cheering account of the progress made by the Lodge since formation, and prospects of continued prosperity. They have doubled their number during the past year, and trust to make material addition to the same in the near future. I would recommend that a "Regular Warrant" as prayed for be substituted for the dispensation under which they have hitherto existed and worked.

On the 25th June I had the pleasure of installing, assisted by W. Bros. Higgins, of Albion, and Lee, of St. John's Lodges, the W. Master and Officers elect of Tuscan Lodge, and feel convinced that under the Officers then installed, it will continue to hold the high position it has hitherto occupied, viz.: of being one of the really live lodges of this jurisdiction.

The city Lodges have enjoyed during the past year a very fair measure of prosperity, the numbers added being, circumstances and surroundings considered, very satisfactory.

With sincere regret I have to report that death has taken from our midst V.: W.: Bro. M. Winn, late of Albion Lodge, who was called from labour to rest suddenly in October last. Bro. Winn was known to the fraternity as an earnest hardworking mason, conscientious in the discharge of every duty. He was buried with Masonic honours, and the large number who attended to pay that last tribute of respect to his memory, bore ample testimony to the estimation in which our departed

brother was held by the fraternity of the district. I would respectfully recommend that a page in the proceedings of Grand Lodge be inscribed to his memory.

Owing to illness I was compelled to forego the pleasure of installing the Officers elect of the several lodges of the city on St. John's Day. Those ceremonies were very kindly and most ably performed by our D.: G.: M.: R.: W.: Bro. E. Fitch, to whom I beg here to tender my sincere thanks

The masons of the city and vicinity celebrated St. John's Day by holding Divine Service, for which a dispensation to appear thereat in regalia was granted, the various lodges were well represented, and an appropriate sermon preached on the occasion by the Grand Chaplain, R.: W.: Bro. Rev. M. M. Fothergill.

In conclusion, I tender my sincere thanks to the brethren of the district for the more than kindness invariably shewn me on every occasion of our meeting official or otherwise.

MONTREAL DISTRICT.

R.: W.: Bro. J. Frederic Walker, D.: D.: G.: M.: for the Montreal District made the following report :

*To the Most Worshipful the Grand Lodge of Quebec, A. F. and A. M.*

In my last report I mentioned the prosperous and harmonious condition of the craft in the Montreal district. During the year just past, the prosperity has been still greater, and the harmony and good feeling has been such as to convince all, that the brethren of the Q. R. in the Montreal District are embued with the true spirit of our Craft.

The lodges remain the same in number as last year, twenty-three, but Antiquity No. 1, and Victoria No. 26, have completed all arrangements for amalgamation, which now only needs the confirmation of Grand Lodge to drop the latter from its register, all the members of Victoria have been placed upon the roll of Antiquity, and the charter of Victoria has been handed to me to be returned to this Grand Body.

Hochelaga lodge, No. 57, by a vote of sixteen against four, decided to move its place of meeting to a situation more convenient to the

majority of its members. This resolution was submitted to me for approval. After my approval had been given, I received a protest from seven members of the lodge, against the place of meeting being changed, but having granted permission, I considered that it was out of my power to interfere until a two-thirds majority of the lodge should again decide to remove.

I have visited all the lodges in my district once, and many of them several times, and I cannot speak too highly of the work done by the officers, the interest displayed by the members, and the determination of all, that the fair fame of masonry should not suffer through those attached to the register of the Grand Lodge of Quebec; thus proving to the world at large, and, what is of more importance to ourselves, that the falsehoods and slanders, circulated by the enemies of Freemasonry in this district, can neither make us swerve from the right path, or create discord in our ranks. I take this opportunity of giving a most emphatic denial to the untruthful statements which have been made, anonymously, in the press.

As a sample, I will take the only case which can be located, as in it a name has been mentioned. It is as follows:—"Recently, P.: M.: Dunn, of Zetland, just after the lodge closed, took off his jewel, and laid it on the Secretary's desk. He then turned round and put on his overcoat, and having done so, he immediately turned again to the desk and found the jewel had mysteriously disappeared. *The jewel has not yet been found.*"

In a circular dated March, 1881, signed "Loyal Unity," it was stated "Not long ago one of its Past Masters was robbed in the Lodge Room."

Is this the same case; if so, why designate it now as "recently"?

As a matter of fact, P.: M.: Dunn never was robbed of his jewel. It was presented to him some years ago and he still wears it with pride, and I hope may long continue to do so.

There appears a desire on the part of these anonymous writers to fix upon our lodges the stigma of intemperance. Nothing could be more false; the large majority of the lodges in this district insist upon their festivals being conducted on total abstinence principles, and the few who do not, preserve a decorum which must meet the approval of even the majority of our members who condemn the use of anything stronger than coffee.

I would point with pride to the brethren selected by the various lodges in this district, as rulers for the ensuing twelve months, their high character and standing, should be a sufficient answer to the aspersions referred to.

I must thank the M.: W.: Grand Master for his many kindnesses in granting dispensations to wear regalia at the various social entertainments held by the different lodges in this district; for being present and delivering an address at the general excursion to Highgate Springs; and



for the official visitations he made to Antiquity, Mount Moriah, Ionic, Corinthian, and King Solomon lodges.

As this will be my last report, as D.: D.: G.: M.: of Montreal District, perhaps the M.: W.: Grand Body will pardon my taking the opportunity to bid an affectionate farewell to the District over which I have presided for more than two years.

To say that I have been treated with kindness is hardly expressive enough, and if I searched for cause of complaint, the only one I could find would be, that Masonry has been so successful, and the enthusiasm so great, and the consequent demand upon my time has been such, that I have rarely found an evening that I could devote to anything but the duties of my office.

The Grand Secretary, in the absence of R.: W.: Bro. H. W. Wood, D.: D.: G.: M.: for Bedford District, for that Brother presented and read the following report :

*To the Most Worshipful the Grand Master and Grand Lodge of Quebec  
A. F. and A. M.*

In making the following brief report of the state of Freemasonry in the district of Bedford, I have to state, in the beginning, I regret very much that I have been unable to visit all the lodges in the district and I must plead, as an excuse for not doing so, that sickness has prevented me.

However, I am happy to be able to report nearly all the lodges are in a very prosperous condition.

The only ones that are not so, are Browne Lodge, at West Farnham, Prevost Lodge, No. 7, at Dunham, and (I fear I must add) Olive Branch, at West Shefford.

I think it would be in the interest of masonry in this District, if the members of these lodges would see fit to return their warrants to the Grand Lodge.

I have had communication with the officers of the two lodges first named, and from the information I have been able to gain, there seems very little prospect of their being resuscitated.

With regard to Rouville Lodge, I have to report that I have been unable to get an answer to my communication addressed to the supposed Worshipful Master of said Lodge.

Quite a number of the Lodges in this District are working the new ritual in a very satisfactory manner.

I may mention in particular that I was greatly pleased at the manner in which I saw the work done by the Worshipful Masters of Shefford and Frelighsburg Lodges.

The increase in membership has been quite large in all the lodges I have visited, and the material selected seems to have been good and fit for the masonic building.

I would here state that some of the lodges which I have failed to visit are among the most prosperous in the District.

The following lodges applied through me for dispensations to appear publicly in regalia, and the said dispensations were granted by the M.: W.: the Grand Master, viz.: Brome Lake Lodge, for the purpose of attending Divine Service on St John's day, the 24th June; Frelighsburg Lodge, for a festival on 25th June; St. John's Lodge, Mansonville, for a festival, and public installation on 27th December, St. John the Evangelist day; Shefford Lodge, for a festival on 28th December; and Stanbridge Lodge, for a festival on 11th January, 1884.

On November, 27th I had the satisfaction with R.: W.: Bro. Isaacson, Grand Secretary, of attending a special communication of Nelson Lodge, St. Armand Station, where we had the pleasure of seeing the work of the third degree very ably exemplified by the officers of a lodge under the jurisdiction of the Grand Lodge of Vermont, and hailing from St. Albans.

The only subject of importance likely to come before Grand Lodge at the approaching session of special interest to the Craft in this district, is the notice of motion given by V.: W.: Bro. Moore, in reference to the division of the District.

After taking the opinions of many of the leading masons in different parts of the District, and giving the matter very careful consideration, I am obliged to report that, in my opinion, it is not at present advisable to divide the District of Bedford into two districts.

The Masonic District is at present co-terminus with the judicial District of Bedford.

There is a probability that the number of lodges in the District will be less than at present, and when it is taken into consideration that nearly every part of the District is easy of access by rail, it would seem that there need be no great difficulty in visiting every lodge in the District once during the masonic year.

No masonic complaint has been made to me during the year with the exception of one, which referred to the jurisdiction of two lodges, matter, I believe, was amicably arranged.

It is pleasing to be able to report no deaths among the Craft in this District during the past year.

In conclusion, I beg to return my sincere thanks to the officers and members of the lodges I have visited for the cordial and fraternal manner in which they have received me.

IN THE MATTER OF THE COMPLAINT OF FREDERICK C. SAUNDERS.

The Committee on Jurisprudence have the honor to report that they have carefully examined the complaint of Brother Frederick C. Saunders, a non-affiliated Brother holding a demit from Bedford Lodge No. 59 Q. R., the substance of which is, that having been invited to the annual ball of the Bedford Lodge on the 19th January, 1883, by the ball committee, he presented himself with the ladies of his family for admission, but was not allowed to enter by the W. M. of that Lodge upon the ground that he was not an affiliated mason.

Your Committee are of opinion that the Grand Lodge cannot entertain this complaint. The Constitution provides that the District Deputy

Grand Masters of the several districts shall have original jurisdiction to try and determine all complaints preferred against the Master of any Lodge within their respective districts.

The Committee on "The State of Masonry" made the following reports on the Grand Master's address :

The Committee on "The State of Masonry" beg to report.

They have had submitted to them the address of the M.: W.: the Grand Master to report thereon for the information of Grand Lodge. In the fulfilment of the duty thus devolving upon them they have carefully perused and examined the same, giving to each subject referred to therein their earnest consideration.

With the preliminary observations of the M.: W.: the Grand Master, Your Committee are in perfect accord. They hope with confidence that at the conclusion of the year upon which we have entered, when the record of its events shall have been written, so far as the same shall have concerned the Craft here, it will be found transcribed, that our Masters and Overseers have accepted with alacrity, and discharged with ability, all the duties and responsibilities incumbent on them—to guide, instruct and govern; and that our workmen have been found skilful, laborious, and loyal in all their works and acts; the whole working in that peace and harmony which should on all occasions characterize Freemasons.

With the M.: W.: Grand Master, Your Committee hope, the present meeting of Grand Lodge in the City of Sherbrooke may prove as well beneficial to its generous and hospitable inhabitants, as of pleasure and advantage to our Society. In mixed communities such as we have in "this Canada of ours," and which are fairly illustrated in the population of the city wherein we are now holding our deliberations, the prejudices against Freemasonry existing amongst the ill-informed may perchance be dispelled, or at least mitigated by our prudent conduct and circumspect behaviour during our sojourn in their midst.

To be loyal to the Government under which we reside, and which affords us the protection of its laws, is one of the first teachings of our Order. Your Committee are confident that the Grand Lodge will gladly accept as its own, the sentiments of the Grand Master referring to Her Most Gracious Majesty, Queen Victoria, and to their illustrious Brother, Albert Edward, Prince of Wales.

Your Committee are assured that the words of the M.: W.: Grand Master alluding to those "at rest," will find a sympathising response in the heart of every member of Grand Lodge. The two late eminent brothers spoken of—M.: W.: Bro. W. B. Simpson and R.: W.: Bro. Borlase—will ever be remembered with gratitude and respect by this Grand Lodge as having been amongst its best and most useful friends and advisers.

Your Committee recommend that a memorial page for each be set apart in the appendix to the printed proceedings of Grand Lodge, commemorative of their virtues and services.

Your Committee are of opinion that the utterances of the M.: W.: the Grand Master on the subject of "Charity and Benevolence," are peculiarly suitable to the occasion. They desire to direct the earnest attention of Grand Lodge thereto, and advise that at this session, if it be found practicable, at the last, some of the suggestions be carried into effect. The subject, however, will doubtless receive the attention of the Committee to whom such matters are referred.

Your Committee are convinced that Grand Lodge, as representing the Craft in this Province, will be gratified to learn that the reception at its last meeting, by the Grand Lodge of Canada, of several of our prominent officers and members, referred to by him in his address, was of so flattering a nature—may the connection and attachment now existing between the two bodies ever continue as between mother and daughter, the former exemplifying all the excellencies and benefits of our brotherhood, the latter zealously following in the footsteps of her good parent.

Your Committee, with the M.: W.: the Grand Master, have much satisfaction in noting the increased tendency of our brethren to attend Divine service, as a body, at least once during each year. Our records show that when our Grand Lodge was first established, it was an annual custom for its members during session "to offer up their adoration to the Most High, in His Temple."

Your Committee would advise that the habit, which was one of our first Grand Master, be revived and continued.

Your Committee feel that the announced intended amalgamation of Lodge of Antiquity No. 1 and Victoria No. 26 will be received with pleasure as it has been demonstrated that the result will be to the advantage of both.

Your Committee are confident that Grand Lodge will approve the remarks offered by the M.: W.: the Grand Master as to the celebrations and festivals generally observed amongst masons. These ceremonies tend to make individual members of the Craft better known to each other and to the world at large, so creating a more extended "social" intercourse which cannot but result in good to the Craft.

Especially would Your Committee direct attention of Grand Lodge to the remarks of M.: W.: the Grand Master on the subject of Temperance.

If our Order expects to keep pace with the progress of the times, to do so, its members must be guided by the excellent advice on this head given by its chief ruler.

Your Committee are sure that Grand Lodge will appreciate the labors of the past year of the M.: W.: the Grand Master—his visitations have been most acceptable—it is a source of satisfaction to learn from him



that he has found in every instance his executive officers so efficient and courteous. Grand Lodge will doubtless endorse the counsel he has given to promote and secure such prosperity to lodges as is desirable.

Your Committee advise Grand Lodge to ratify the appointments of Grand Representatives near Foreign Grand Lodges made during the past year by the M.: W.: the Grand Master, and reported in his address.

Your Committee heartily concur in the remarks of the M.: W.: Grand Master in regard to the Grand Lodge of New South Wales, and calling to mind the words of M.: W.: P.: Grand Master Graham in his address to this Grand Lodge at its last Annual Communication, wherein he said "that should it further appear that unjustifiable and unmasonic means continue to be, or should hereafter be taken to prevent this legitimate and desirable consummation (*i. e.*, the adhesion to this new Grand Lodge of a majority of lodges in that Colony) "the Grand Lodge of Quebec may then deem it to be her duty to consider what action "shall be taken by her under the circumstances"; and as Your Committee are thoroughly convinced that such unmasonic means have been, and continue to be, adopted by the Grand Lodges in the mother country, and their officials in New South Wales; and that many of the lodges and individual brethren have been, by intimidation and otherwise, prevented from exercising their inherent and constitutional rights as Freemasons, and this Grand Lodge deeming it to be their imperative duty to sympathize with and support in such and such like circumstances their brethren in the dependencies of the British Empire, and elsewhere. Therefore, Your Committee respectfully and earnestly recommend this Grand Lodge to recognize the M.: W.: the Grand Lodge of New South Wales, as entitled to have and to exercise exclusive sovereign Masonic authority in said Colony, and that Grand Representatives be interchanged therewith.

Your Committee are of opinion that the M.: W.: the Grand Master did wisely in submitting to Grand Lodge the salient and more important facts enunciated by his predecessors in regard to the cause which had been followed by them, or to all the questions involved in our relation to the mother Grand Lodge of England, all of which has been unanimously adopted by this Grand Lodge and approved of by nearly all the Grand Lodges of the world.

Fully recognising the grave importance to this Grand Lodge of any proceedings it may adopt in regards to its relations with England; and well aware of the measure of responsibility they assume in advising in the premises, Your Committee desire to say, that they have pondered well on the views, expressions, and advice of the M.: W.: G.: M.: on the subject; they have carefully followed and studied his statements and arguments, have verified each and every one of them, with this result, viz.: It is their duty to recommend Grand Lodge, in view of the past

and present course of the Grand Lodge of England, so truthfully traced by the M.: W.: G.: M.:, and her persistence to encourage within our territory the existence of lodges holding warrants from her, and which continue to violate and set at nought the rights, privileges, and prerogatives of this Grand Lodge, thus depriving this Grand Lodge of its sovereign, independent, and exclusive jurisdiction over its territory; to follow the advice given by the M.: W.: the Grand Master, namely,— after due notice, to declare non-intercourse with all lodges and brethren in the Province of Quebec who will not array themselves beneath our banner and join our register.

Your Committee doubt not but that if the course now advised, be pursued firmly, yet judiciously, a speedy and final consummation will be arrived at. It will take less than the fourteen years already past of attempted conciliation to bring about the entire unity of government of the Craft in our jurisdiction so much to be desired.

Your Committee submit for the approbation of Grand Lodge the correct and dignified position taken by the Grand Master in connection with the denunciations propagated by a portion of the Press against our fraternity.

With the concluding remarks of our M.: W.: G.: M.:, Grand Lodge will doubtless coincide. His denunciations of our "assailants from within" are delivered with force and emphasis. Your Committee urge upon members of Grand Lodge to adopt them as the unanimous expression of their own sentiments.

The Committee on the State of Masonry beg to report that they have examined the several reports of D. D. G. M. and beg to report thereon—

MONTREAL DISTRICT.

The report of R.: W.: Bro. J. Fred. Walker imparts the satisfactory information that in this important district the prosperity of the Craft is greater, and the harmony amongst them more complete than on the

occasion of his former report, which it will be remembered was of a flattering nature.

The amalgamation of Lodge of Antiquity No. 1 and Victoria No. 26 is officially reported; as Your Committee in another of their reports have recommended that Grand Lodge should confirm this act, it need not be further mentioned here.

The question of the removal of Hochelaga Lodge, and the action of its members concerning the same, will doubtless receive the proper consideration of Grand Lodge.

Your Committee trust Grand Lodge will note the faithfulness with which R.: W.: Bro. Walker has performed the arduous duties of his office, he has visited all his lodges once, and many of them several times during the year.

Your Committee trust Grand Lodge will fittingly recognize its obligations to so pains-taking and efficient an officer

Your Committee, from their own personal knowledge, can corroborate the accuracy of the statements made by the District Deputy in reference to the untruthfulness of the anonymous statements which have been published in regard to the matters referred to in his report.

#### QUEBEC AND THREE RIVERS.

Your Committee learn with much satisfaction, that in this district the Craft continues to more than hold its own, notwithstanding the powerful influences brought to bear against it. The number of lodges continue as at the termination of the preceding year, but the returns from these lodges shew an increase in membership.

The report from our youngest daughter, "Good Samaritan Lodge," located at New Carlisle, in Bonaventure County, is very gratifying, and realizes the expectations of its success which were formed at the time the dispensation was granted for the establishment of the lodge. Your Committee doubt not but that under the able and judicious management and control of its very earnest and prudent officers; "Good Samaritan" will rank amongst the foremost of our lodges as to good work and material. Having examined the work and proceedings of the lodge which is satisfactory, and the necessary certificates required by the Constitution as to the skill of the officers; Your Committee have much pleasure in advising, that the recommendation of R.: W.: Bro. Kennedy be at once acceded to, namely, that a Regular Warrant be granted at this session of Grand Lodge to establish "Good Samaritan Lodge."

Your Committee are of opinion that a still further impetus to the advancement of the Craft in the extreme eastern section of our province would be given, if an arrangement could be effected whereby Grand

Officers, and others of the Craft desiring it, could be present at the consecration and erection of this lodge at some early and convenient period of the forthcoming summer, and it is hoped that this project will be carried into effect.

The favourable report of the prosperity of all the lodges in the district of Quebec and Three Rivers will doubtless be received with satisfaction by Grand Lodge.

R.: W.: Bro. Kennedy reports the death of W.: Bro. Martin Winn, a Past Master of Albion Lodge; pays a deserved tribute to the memory of the deceased; and asks that a memorial page in the proceedings of Grand Lodge be inscribed to his memory. It is almost needless to say that Your Committee advise Grand Lodge to accede to the request.

Your Committee are convinced that Grand Lodge will give its hearty approval to the form of celebration of St. John's day adopted last year by the fraternity in the city and environs of Quebec, namely, by attending a Divine Service at the Cathedral of Church of England, where an instructive discourse was delivered by R.: W.: Bro. Fothergill, our Grand Chaplain.

Your Committee are grateful to learn that Shawenegan Lodge at Three Rivers, with its excellent membership, continues to enjoy a large degree of prosperity under the able guidance of efficient and well skilled officers, thus to some extent restoring the prestige of Freemasonry at Three Rivers which it had nearly 100 years ago.

#### ST. FRANCIS DISTRICT.

Your Committee is much gratified to learn by the report of R.: W.: Bro. Gustavus Lucke, the D. D. G. M., that those essentials to success, peace, harmony and prosperity, prevail throughout his district.

It is doubtless a satisfaction to Grand Lodge to receive through its officer renewed assurances of allegiance and respect from its subordinate lodges. Expressions of such a nature invariably tend to strengthen the tie which binds together the "governing" and "governed," so long as each shall render to the other loyal support, and encouragement, there will be no need to fear as to the future.

Your Committee have reason to expect at an early day a substantial increase in the number of lodges in this important district.

#### BEDFORD DISTRICT.

Your Committee are glad to know from the report of R.: W.: Bro. Dr. H. W. Wood that on the whole the Craft in his district is in a very prosperous condition. It appears, however, that Prevost Lodge No. 7 and

Browne Lodge No. 24 and Olive Branch No. 50, are the exceptions. From facts which have come to the knowledge of Your Committee, endorsing the remarks of the D. D. G. M. in regard to these lodges, they regret to be compelled to advise Grand Lodge to call in warrants of Provost Lodge No. 7, Browne No. 24, and Olive Branch No. 50.

A like proceeding should be taken as to the dispensation granted to establish Rouville Lodge.

A pleasing feature in the report of R. W. Bro. Wood is the announcement of the fact, that in Nelson Lodge No. 9 the M. M. degree was worked and exemplified by the officers of Franklin Lodge under the jurisdiction of the Grand Lodge of Vermont. Acts and courtesies of this nature between lodges holding under different jurisdictions are calculated to do immense good in various ways, they not only create and strengthen brotherly good will, but they also impart information, and should be encouraged on every available occasion.

Your Committee would call the attention of "all whom it may concern" to the remarks of R. W. Bro. Wood on the suggested division of Bedford masonic district. But they desire to leave the decision of this important question to Grand Lodge upon the motion to be submitted by V. W. Bro. Moore.

OTTAWA DISTRICT.

Your Committee observe that this district is no exception from all the others so far as prosperity and harmony are concerned. The only drawback appears to be with Aylmer Lodge. In this matter your Committee suggest that the Grand Secretary, or other officer, proceed at as early a date as possible to Aylmer with the view to confer with the brethren there in regard to the resuscitation of said lodge or the surrendering its warrant.

The Committee on "The State of Masonry" made the following report on Grand Secretary's report :—

The Committee on the State of Masonry beg to report—

Your Committee have considered the report of the Grand Secretary and statement thereto annexed which cannot but be considered as satisfactory, exhibiting as they do, *inter alia*, evidences of the progress and working of almost all the subordinate lodges making their annual returns to Grand Lodge.

The remarks of the Grand Secretary on Aylmer and Rouville Lodges go to strengthen the recommendations of Your Committee already made as to the advisability of Grand Lodge possessing itself of warrants not in use and property of defunct lodges.

These remarks in a moderated form apply to the proposed lodge at Lachine.

Your Committee concur with the Grand Secretary in his observations anent the advisability of aiding and establishing a Grand Lodge library. They gather, however, from what he reports that the time has not yet arrived for more active operation in the premises.

Your Committee cheerfully advise Grand Lodge to meet the views of Grand Secretary and grant a sufficient sum to have all unbound matter put into volumes.

Your Committee are of opinion with the Grand Secretary that the matter his report refers to, personal to himself, has received more prominence than it deserves.

Your Committee have noted the remarks of the Grand Secretary calling attention to the necessity of issuing duplicate Grand Lodge certificates by reason of erroneous mention of names in returns from subordinate lodges, and recommend that in the future any duplicate certificate issued through the fault of any lodge or its officers will be paid for at full rate.

It was moved by M.: W.: Bro. Graham, seconded by R.: W.: Bro. H. L. Robinson :

“That the report from the Committee on ‘The State of Masonry’ just read be received and is hereby adopted.”

#### REPORT OF THE COMMITTEE ON RE-NUMBERING LODGES.

R.: W.: Bro. J. Fred. Walker, for the Committee named at the last annual meeting of Grand Lodge to re-number the subordinate lodges, made the following report :—

As this Committee understands that the object of their appointment was merely to find a proper place for the three Scotch lodges, according to agreement made that they should occupy the rank to which the dates of their respective original warrants entitled them, beg to report as follows :—

As the adoption of the report on "State of Masonry" has left No. 7 vacant, we suggest that that number should be given to Elgin Lodge, The date of the charter of St. Andrew Lodge, No. 6, is 1876 ; that of Provost Lodge, No. 8, is 1855. The charter of Elgin is 1847, hence this is their natural and proper place.

We suggest that King Solomon Lodge take No. 64, and Argyle Lodge No. 65; Friendship Lodge No. 66, and Argenteuil No. 67.

By this means only two lodges are required to alter their numbers, which is fortunate, as it prevents the expense to the various lodges of altering their seals.
