REWARD.

WHEREAS the Subscriber, of *Lyme*, in *New-London* County *Connecticut*, was wickedly left on shore about the 24th of *August* last, at *Cape Negro Island*, by one **THOMAS PRESCOTT**, with whom he sailed from *St. Andrews*, *Passamaquoddi*, in *New-Brunswick*, bound for *Halifax*. And whereas said *Prescott* is indebted to the Subscriber One Hundred and Twenty Pounds, for Goods sold him at *St. Andrews*, and has carried off with him a Number of Grindstones and Moose-skins, belonging to the Subscriber, shipped on board said *Prescott's* Schooner at *St. Andrews*, as also his Chest, containing his Money, Cloathes, and Papers, among which were sundry Obligations to the Amount of Three Hundred Pounds: The above Reward will be paid to whoever will secure the said *Prescott*, that he be brought to justice, by me
ELIJAH ELY.

N. B. Said *Prescott* has four Notes of Hand for Twenty Pounds each, given him by said *Ely*, being the Balance of some Bills of Exchange on *London*, drawn by said *Prescott*, and given by him in Payment for the aforementioned Goods, and which said Bills he was to redeem in *Halifax* with Cash and the Notes of Hand abovementioned but which Bills he has now carried off with him, and which said *Ely* has Reason to suppose were good for Nothing. He therefore warns Persons from purchasing said Notes.

Said *Prescott* is in a Schooner of about eighteen Tons, rebuilt at *St. Andrew's*, has her Mast and Topmasts in one Piece, and has her Cabin cieled over head. He is a small Man, about thirty Years of Age, thin Face, black Hair which reaches to his Waistband, and has on two Scars on the Top of his Head. He says he came from *England*, he speaks *English*, *French*, *Spanish*, and *Dutch*, and shifts his Dress very often.
