n, the Repren the return mbers is the otion to the cause as well as of the interest your respective Subordinate Divisions continue to take in the general affairs and prosperity of the Order, of their duty and obligations in conducting and sustaining the same, as well as of their undiminished devotion to that cause for the promotion of which our organization exists.

The repeated returns of seasons like the present and the generally prosperous state of the Order, of which the Grand Scribe's Report will inform you, render it quite unnecessary for me to detain you by the perusal of a lengthy Semi-Annual Report, and the more especially as I shall submit a special Report upon the performance of a grave duty assigned me at the last Session of the Grand Division.

I must refer you to the Grand Treasurer's Report for the financial, and to the Grand Scribe's Report for the statistical, details of the Order.

That our Grand Scribe can report the issue of thirty Charters for new Divisions during the past half year; that eight Subordinate Divisions have been resuscitated, while but nine are reported defunct; that Reports of Deputy G.W.P.'s and Recording Scribes testify to the healthy, vigorous state of the Subordinate Divisions generally—presents the most certain and gratifying evidence of the general and well sustained prosperity of our organization.

This well sustained position of the Sons of Temperance in Canada West, to be fairly judged of and appreciated, must be viewed in connection with the condition of our Order in North America, with the effects of time and the influences of those inimical to such a cause, under every phase, upon a purely voluntary association; and also of the large increase reported on the Order of Good Templars—occupying the same ground, engaged in the same cause, advocating the same principles; and with all the fascination of novelty and the propensity to change, operating so strongly in favor of that Order.

It must be remembered, too, that we are battling against the influence of a depraved and vitiated taste, begotten and fostered by the wide-spread traffic in an article peculiar in its effects upon the human system, creating an appetite so unappeasable that it devours estate, and reputation, and honor, and health, and happiness of self and friends, and yet insatiably cries "Give, give," until life itself is consumed; an article, the most potent instrument in the hands of the arch enemy in leading fallen man, by rapid strides, down to perdition. Nor must it be overlooked that we are endeavoring to counteract and uproot habits which are interwoven with the very tissues of social intercourse, confirmed by centuries of use, sustained by the influences of pernicious license laws, insatiable avarice, and the clamor for "vested rights"; habits insidious, destructive, and so general as to pervade all classes and ranks in society; embracing almost indiscriminately in the list of victims, the peasant in his cottage, the prince or noble in his castle, the divine at the altar, the plebeian at the plough, the soldier in the field, the civilian upon the mart, the statesman of loftiest intellect, the almost witless boor, the scholar and the clown, the rich and the poor, the husband and the wife, the parent and the child.

Thus, the real, the intrinsic value of the object, intent and labors of our organization, and of those of all phases engaged with us in the Temperance Cause, can only be estimated when proper views are obtained of the magnitude and prevalence of the vice of Intemperance, against which we contend; and while we may with thankfulness congratulate ourselves upon the success which has crowned our labors as moral suasionists, we, with advanced views

and higher, bolder aim, seek to obtain a legal power with which to strike at the very foundation of the stronghold of the monster, by the erasure from our Statute-book of the last vestige of a right to perpetuate a legalized

Liquor traffic.

We have again and again sought this power at the hands of our Legislators. In 1854, we placed before the Houses of Parliament our petitions, to which were appended 80,000 signatures; and again in 1856, when I had before the honor to hold the office of Grand Worthy Patriarch, we, with no small amount of labor and expense, rolled in our volumes of petitions, with 110,000 signatures, praying for a Prohibitory Law.

Our prayer was not granted; but, though foiled we are not beaten—though refused, we are not silenced; and when the proper time comes, with renewed vigor and determination, our battle-cry will again ring through the

land, "Up ye Temperance Hosts and at them!"

Has your Grand Worthy Patriarch failed in duty in omitting to call upon the Order to renew their demands by petition during the present session of Parliament?

We are dazzled with the prowess and chivalry of a Cardigan, leading a forlorn charge at Balaklava; but we admire and love a Sir Colin, who with paternal prudence and caution, saves his men, watchful for the proper time to strike the blow, and with least expense of life or limb, to secure the victory.

Our ambition leads us to emulate the prudence, and aim at the success of the latter—to avoid the fatal recklessness of the former.

Reference to the Proceedings of this Grand Division at the last Session will show that, while specific expression was given as to the duty of Sons of Temperance in supporting candidates at the then ensuing election, none such was recorded upon petitioning the Legislature during the first Session. This was by common consent left an open question, to be decided as circumstances might present.

Your Executive, with anxious, watchful care, gave this subject every consideration—freely consulted others of our own and kindred organizations, and the result arrived at was the conviction that we would not advance the interests of the cause of Prohibition by attempting to get up Petitions to lay before the House at the present Session. We have reserved our strength—laboring to increase our force—ready to strike at the proper time with telling power.

The conclusion we came to was communicated, by circular, to the subordinate Divisions; and, so far as we have been able to judge from the Reports of our Deputies, received, the course we decided upon was approved of

almost universally.

The Hon. M. Cameron has two Bills before the House—one on prohibition, which, I understand, he presents for the purpose of showing that the principle is not and will not be abandoned; the other, a stringent License Law, which, he affirms, he hopes to see adopted by the present House.

News from abroad of the progress of temperance and prohibitive principles, is generally of a cheering character. In Great Britain the United Kingdom Alliance and the Scottish Temperance League are doing a noble work in directing the public mind and educating the masses in the science of Temperance and the fearful evils of intemperance.

Discussions, lectures, periodicals and tales present these subjects in every possible form, and with most beneficial effect on the public.

Another effort has been made to obtain the enactment of a Prohibitory Law in our sister Province, Nova Scotia. The effort failed, however, by the small adverse majority of four. But the friends of the cause, with the spirit and pluck of "true blues", declare that they are not to be discouraged, and already are inaugurating another campaign, to be prosecuted with the utmost vigor.

We will not attempt to express our feelings of pleasure and satisfaction upon the triumphant achievement of the Banner State, in the recent reenactment of what must be, par excellence, designated the "Maine Law."

How many Jessie Browns, with prospects blighted, and life almost crushed out, under the ruthless Sepoy power of intemperance, which has scathed and violated so many social circles, will again raise their heads, and with exultant hopes, cry, "Dinna ye hear it? The Temperance slogan! Prohibition has triumphed: our State is free!"

All hail to the noble sons of Maine: may the most abundant success attend them in operating, as in achieving, the re-enactment of the law.

Let us imitate their example: let us emulate their patient indomitable endurance and perseverance under reverses however frequent or disheartening; and we shall have the happiness of enjoying with them the peaceful triumphs of prohibitory legislation.

We hope that you will be favored with a Report from our esteemed Brother Moffat, the Grand Division Lecturer, and who, fresh from the Grand Council of our Order, the National Division, will be able to state the condition, progress, and prospects of the Order throughout the United States.

I have to call the attention of this Grand Division to the important matters contained in the special Reports which will be submitted by your Grand Officers, and to request that early and most careful attention may be directed thereto.

With confidence we again affirm that our beloved Order is in a sound prosperous condition, and it is of the more essential consequence that the foundation upon which we stand shall be morally and legally unassailable.

OFFICE OF THE GRAND SCRIBE,) Kingston, 21st June, 1858.

To the Officers and Representatives of the Grand Division of the ORDER OF THE SONS OF TEMPERANCE, CANADA WEST:

Your Grand Scribe would respectfully submit this his semi-annual Report for the past term; and in doing so, he would congratulate the Grand Division upon the continued prosperity and progress of the Order of the Sons of Temperance in this jurisdiction.

A good evidence of progress and activity is evinced by the fact that thirty Charters for new Divisions have been issued since we last assembled together. Eight Divisions have been resuscitated. While we have lost, by forfeiture and voluntary surrender of Charters, nine Divisions.

The Annual Returns to the National Division from this Grand Division show a decided improvement over the previous year. The present quarter has not yet expired: still I am in receipt of Quarterly Returns from 241 Divisions, exhibiting in membership from those punctual Divisions 10,200 male members, and 3,400 female visitors.

This exhibits a decidedly healthy condition of the Order in Canada West, and that the Subordinate Divisions have an efficient and healthful existence. It must be reasonably expected that some Divisions will be found at times less prompt and accurate than at others. Still, on the whole, we have cause to rejoice that so many Divisions maintain those healthy characteristics of promptitude and exactness.

The present position of our Order in Canada West, and of the Grand Division, is of commanding importance, and we should be humbly thankful to the Father of Mercies for His protecting love and care.

Upon application from Hamilton Division No. 25, a Charter and set of books were procured to present to their esteemed Worthy Patriarch for the purpose of instituting a Division in Dublin, Ireland.

One thousand copies of the Journal of Proceedings of the last Session were prepared and printed, and were forwarded to the Divisions, Deputies G.W.P., and Representatives, as early as was practicable.

The revised or new Ritual has been received and supplied to 102 Divisions. I had to procure one thousand additional Ode cards, which are now exhausted. Fifty sets of Ritual remain on hand.

As far as I am informed, the new Ritual is giving the greatest satisfaction. I trust that each and every Subordinate Division will adopt it; otherwise I fear that great inconvenience and confusion will ensue. It would be well for this Grand Division to consider what should be done with the old Rituals, not in use, that are now in the hands of Subordinate Divisions.

During the past term continued effort has been exerted to extend the principles of our beloved Order, and to increase the efficiency of the Divisions. Brother John Moffat, P.G.W.A., has been lecturing continuously. The many assemblies that have listened to his logical and powerful arguments in favor of prohibitory laws, have, we think, been permanently impressed with the absolute necessity of such enactments, for the peace, happiness and safety of our fellow men.

The subject of preparing and presentation of petitions to the Legislature for a Prohibitory Law has received due attention, not only from the executive of this Grand Division, but from the leading temperance men of the Province; who, after mature deliberation, concurred in not throwing away valuable effort, and wasting the energies of temperance men at the present time in getting up petitions.

From the position of things in the House, it was quite evident that instead of a Prohibitory Law, in answer to our petitions, we should have another Licence Law—instead of bread, a stone.

A leading temperance gentleman in the House, who introduced the measure, "believed that a Prohibitory Law could not pass this House," and therefore proposed to bring in a measure to improve the Licence Laws. The only effectual way that could be recommended to improve the Licence laws would be the radical process, and to let the powerful streams of enlightened public sentiment flow in and obliterate the abominable Licence Laws from the Statute-book for ever.

The sentiment that still pervades the Order is, "Down with the traffic"; and we have never been unmindful of the recommendation of our National Division, that the principles of prohibition should be "the object of the Order."

It is indeed cheering to report the state and progress of the Temperance cause in Great Britain and Ireland. The principles of "The Alliance" (identical with our own) are rapidly extending in our fatherland. From Maine we are rejoiced to find that the Prohibitory Law passed by the Legislature of that State has been ratified with almost universal accord by the people.

The melancholy intelligence has reached this office of the decease of two highly valued Brothers, veterans in the cause—Nathan Fellowes, Esq., D.G. W.P., and A. McGregor, Esq., D.G.W.P. They were two of the oldest and

While the prospects of the Order in Canada West are generally good, there are many localities where considerable apathy exists; and this would be a fitting opportunity to devise some plans for the revival of the cause. We need a Division of the Sons of Temperance in every village and hamlet of the Province; and with small effort this inestimable benefit could be conferred upon every community. Let each Son of Temperance be a missionary in this glorious work, procure sufficient names of applicants for a charter, and with the assistance of a Deputy G.W.P. a Division would soon be in admirable working order, and be a blessing to the neighborhood.

There is much needed in Canada West a good Temperance paper, the acknowledged organ of the Order; and we believe that sufficient support would be given to sustain such a journal if countenanced by this Grand Division.

Papers purporting to be appeals to the National Division against the decision of this Grand Division were forwarded to this office by the suspended Frontenac Divison, from E. W. W. Linton, the (so-styled) R.S. The appeals were not in accordance with facts, and being untruthful and in improper terms, I did not feel myself justified in vouching for their correctness or in affixing the seal of the Grand Division to those appeals. I forwarded them, however, to the Most Worthy Scribe with the above explanation. The malcontents of the Frontenac Division, when suspended, treated the notion of appeal to the National Division with supreme contempt, and it was only a few days before the National Division Session that the appeals were received, and at that time our most important documents were in the courts of law, which subject will be referred to in Reports specially prepared on this matter.

I have to express how much I am indebted to our esteemed Grand Worthy Patriarch and the officers of this Grand Division, and to many beloved brothers, for their valued counsel; and also to our noble Subordinate Divisions which have sustained me with their sympathy, and thus enabled me to perform more vigorously the arduous duties of this office.

In concluding this Report, permit me in the name of my brethren in this district to bid you welcome to good old Kingston, and trust that your visit to this city may be to you very agreeable, and that your deliberations in Grand Division may be directed by Infinite Wisdom to such measures as will tend to promote the best interests of our noble Order and the great cause of Temperance.

The Grand Worthy Patriarch read his Special Report, which is as follows:

TO THE REPRESENTATIVES OF THE ORDER OF THE SONS OF TEMPERANCE OF CANADA WEST:

Brothers-

The action of the Grand Division at its last Session, relating to certain charges against Messrs. Joseph George and E. W. W. Linton, members of Frontenac Division, No. 2, located in Kingston, and an appeal of Brothers White and Benedict against the proceedings of said Frontenac Division, will be fresh in the memories of the Representatives then present.

However, that those proceedings may be familiar to all now present, we refer briefly to the printed minutes—pages 45 and 46, and again 49 and 50. (See and read.)

As this matter and the proceedings therewith connected are peculiar and of importance, I have thought it best, instead of alluding to them in our General Reports, that Special Reports should be submitted thereupon by myself and the Grand Scribe, that the performance of the duty assigned me, and the results thereof, may be duly considered in their proper place.

Your Grand Scribe communicated to Frontenac Division the proceedings of the Grand Division, and informed them that the Grand Worthy Patriarch would visit them, at an early day, to discharge the duties specially delegated by the Grand Division.

The majority of the members of Frontenac Division did not deem it proper to await the visit of the Grand Worthy Patriarch, or to comply with the injunctions of the Grand Division, but at once a resolution was submitted rejecting the requisition to expel Messrs. George and Linton, repudiating the charge that any spirit of insubordination had or did exist in the Division. Your Grand Worthy Patriarch was also invited to visit them, that he might see for himself that the Division was in good working order. According to appointment I visited the Division on the evening of the 24th December, found a fair attendance of members, with Joseph George in the Worthy Patriarch's Chair, and a number of visitors from Mechanics' and Williamsville Division.

I found that the resolution referred to had not been passed, but remained over for consideration and final adoption.

After the reading of the Minutes I assumed the Chair and entered upon the business delegated to me, in the most dispassionate manner.

I explained clearly and minutely the action of the Grand Division, the position of the Frontenac Division in relation to the Grand Division, and exhorted, in the most earnest and affectionate manner, that the Division should carry out the requirements of the Grand Division. I was met with a spirit of the most determined opposition on the part of a large majority of the members then present. I patiently restrained and prevented several attempts made to enter into the discussion of the original subjects of dispute, firmly curbed the attempt on the part of some to indulge in passionate declamation, entreated them to consider the consequences, that suspension of the Division must result if they persisted in resisting the injunctions which were distinctly laid before them, and assured them of my determination to enforce the authority of the Grand Division. The issue was placed upon the adoption of a resolution, moved by a member of the Division, con-

firming the action of the Grand Division. After discussion, explanation, and ample time for deliberation, and in full view of the consequences, this was rejected by a vote of 35 to 9. I then informed the members of the Division that it was my painful duty, acting under the instructions and authority of the Grand Division, to declare Frontenac Division, No. 2, suspended until the next Session of the Grand Division. I then demanded from the Worthy Patriarch the delivery of the Charter and Books in his charge, in compliance with his pledge as Worthy Patriarch of the Division. This was refused in such a manner that I at once saw there was no hope of compliance. I then declared I would, in the name of the Grand Division, resume the Charter, the right to retain which was forfeited by the act of suspension, and I accordingly took possession of the same.

My proceedings evidently took the malcontents by surprise, and elicited some angry exclamations from the more excited, with the significant inquiry, "Did the Grand Worthy Patriarch suppose he was able to take the Charter

out of the room?"

The spirit which prompted such an inquiry was,

The spirit which prompted such an inquiry was, however, promptly put down by the majority.

I subsequently demanded the Books, Funds and Properties, from the respective officers, but was refused, and I made no attempt to possess myself of them.

My proceedings were protested against by the malcontents with great warmth, as unconstitutional, tyrannical, &c., &c. I informed them that they could have redress against any such proceeding, if I acted unconstitutionally, by an appeal to the Grand Division; but this was rejected with the utmost scorn, as was likewise the declaration that they could appeal to the higher power, the National Division, if they thought themselves unjustly used, upon their appeal to the Grand Division.

Having performed this painful duty, I then informed them that they had no power to proceed or act as Frontenac Division, No. 2, until the next Session of the Grand Division, save that they had the right of appeal to the Grand Division, and afterwards to the National Division—a right they repeatedly declared they would never condescend to use—and I then left the Chair. Immediately upon my doing so, one of the persons present called upon "the members of old Frontenac to remain and reorganize No. 2," and moved "that Brother Joseph George be Worthy Patriarch." Against this proceeding, on the floor of the Hall, I firmly remonstrated, pointing out to them that I had possession of the Charter of No. 2, and consequently they had not a vestige of right to act as a Division of the Order of the Sons of Temperance.

"Well, then," was the reply, "if we cannot act as Sons of Temperance, we will organize and carry on our operations as temperance men, and that Brother Joseph George do take the Chair"; and this was done.

The first act, on the chair being taken, was to move that their thanks, as temperance men, be presented to Dr. Beatty, G.W.P., for the kind and gentlemanly manner in which he had conducted the business and performed his duties that evening.

This was, of course, accepted as an act of formal esteem.

I then left the Hall, taking the Charter with me, accompanied by the visitors and by those members of No. 2 who were desirous of sustaining the authority of the Grand Division.

The subsequent proceedings of the malcontents have been of the most annoying and vexatious character; but as all the proceedings on our part have been conducted by Brothers Deputy Grand Worthy Patriarch RUDSTON and the Grand Scribe, with ay authority, sanction and advice, I have requested the Grand Scribe to submit a Special Report, setting forth these subsequent actions up to the present time, so that unnecessary repetition may be avoided, and the Grand Division may have the advantage of the narration of events by the officers personally engaged therein.

I am most happy to record my unqualified testimony to the zeal and untiring devotion to the interests of our Order exhibited by the Brothers above referred to, and by the Brothers in Kingston loyal to our cause, throughout the course of these proceedings, and which has subjected them to the annoyances of private slander and public abuse.

It is my duty to call the attention of the Grand Division to the nature of the powers conferred by the Act of Incorporation.

It is contended that this Act constitutes the Subordinate Divisions separate independent organizations, nullifying the obligation and conditions upon which Charters are granted, and placing any refractory Subordinate Division beyond the control of the Grand Division, and consequently of the

We recommend this subject to the careful consideration of the Grand Division, that an amendment to the Act may be obtained, correcting the Act of Incorporation, so that it may conform to the great moral principles upon which our Order is instituted.

To the Grand Worthy Patriarch and Representatives of the Grand DIVISION OF THE SONS OF TEMPERANCE OF CANADA WEST.

The Report of Brother William Rudston, D.G. W.P., and Brother Edward STACEY, G.S., on the case of Frontenac Division, No. 2, is herewith respectfully presented.

The undersigned, deputed by the Grand Worthy Patriarch to take charge of the case on the part of the Grand Division, beg leave to report-

That at the last Semi-annual Session of the Grand Division the following resolutions were adopted, after a fair and impartial trial by a Committee, the proceedings of which were revised and confirmed by the Grand

"Resolved 1st-That the charges and appeals against Joseph George and E. W. W. LINTON are fully sustained, and that the decision of Frontenac Division, No. 2, be reversed, and that Frontenac Division, No. 2, be required to act in accordance with the Constitution and Rules of the Order forthwith against the accused parties, J. George and E. W. W. Linton, they having violated their sacred obligations.

"Resolved 2d-That the protest and appeal of R. C. Benedict and others, members of Frontenac and other Divisions in and about the City of Kingston, are fully sustained; and further, with reference to the action of Frontenac Division, No. 2, in passing those resolutions on the 15th October,

1857, is guilty of insubordination.

"Resolved 3d-That the Grand Worthy Patriarch be delegated from this Grand Division, and that he is hereby delegated to visit Frontenac Division, No. 2, to counsel the members thereof, and encourage them in goodness, and generally to keep a watchful supervision over their proceedings; and that the Grand Worthy Patriarch have power to suspend said Division No. 2, or otherwise deal with it as he may deem expedient and necessary."

To carry out this decision of the Grand Division, the Grand Worthy Patriarch, after due notice thereof previously given to Frontenac Division, No. 2, proceeded to Kingston on the 24th day of December last, and attended the meeting of said Division in his official capacity the same evening, accompanied by the Grand Conductor, Brother Rudston, D.G.W.P.,

Brother STACEY, G.S., and others.

After formally reading the above resolutions to the members of Frontenac Division, No. 2, the Grand Worthy Patriarch called upon the members to give effect to the same in accordance with the Constitution and By-Laws of the Order. Instead, however, of yielding that obedience to the Grand Division, which is the duty of every Son of Temperance, a majority of said Division set the authority of the Grand Division at defiance, and refused to recognize its authority in the premises. The Grand Worthy Patriarch thereupon solemnly warned the refractory members of the serious consequences of their conduct, and informed them that it would be his duty to suspend the Division if they persisted in their insubordination; but, instead of giving heed to his kindly administered and brotherly admonitions, they treated his authority, as well as his advice, with contempt, and he was compelled to vindicate the authority of the Grand Division by suspending said Frontenac Division, No. 2, which he did in the manner prescribed by the Constitution, and resumed its Charter. The Grand Worthy Patriarch also demanded the custody of the Regalia and other property of said Division; but, although in such a case it is provided by the Constitution that these shall be delivered into the custody of the Grand Division, to await its further action in the premises, the officers of said Division refused to deliver them, thereby subjecting themselves to the penalty of forever being excluded from membership of the Order of the Sons of Temperance.

On the 26th December, 1857, the subscribers, acting under the authority of the Grand Worthy Patriarch, and on behalf of the Grand Division, took possession of the meeting room of the Frontenac Division, No. 2, of which they (the subscribers) are two of the lessees, also the said Regalia and other property therein, in accordance with the Constitution and Rules.

In all these proceedings the Grand Worthy Patriarch carried out the Constitution and Laws of the Order in their integrity, and if the said parties claiming to be Frontenac Division, No. 2, felt themselves aggrieved, they had their constitutional remedy, in an appeal to the National Division. But, instead of taking this legitimate and constitutional course, the recusant majority above alluded to, openly declared their independence of the Grand Division, refused to recognize either its authority or that of its officers, broke open the doors of the Temperance Hall, took possession thereof, and, setting at defiance the laws and constitution of the Order, took out a writ of

replevin, to recover possession of the property of the suspended Division; openly, and with the greatest effrontery, declaring that they would divide the property among themselves, and thereby defraud those members composing the minority (the oldest members, who remained true to the Grand Division and Constitution,) of their share in the accumulated fund, which had accrued chiefly from their subscriptions. In addition to this high-handed, unjust and unbrotherly conduct, these parties, acting upon their Declaration of Independence, illegally proceeded to elect officers of said suspended Frontenac Division, No. 2, and caused said officers to be installed by a Grand Worthy Patriarch of their own creation; caused scurrilous articles to be inserted in several newspapers, in which false, slanderous, and malicious charges, calculated to injure the cause of Temperance and the Grand Division, were made against them; subsidized worthless and disreputable persons, enemies to the Temperance cause, to attack the Grand Division at public meetings; and committed many other unprincipled acts, utterly disgraceful to them as Temperance men, and utterly disqualifying them ever again to be received as brothers by the Sons of Temperance.

These malcontents have, with Mr. Flynn, got up a public meeting, for the purpose of stigmatizing the Order; have held weekly meetings which were, in fact, nothing but conspiracies against the Grand Division and the Order in Kingston. It is a fact that these parties have assumed to be an independent Order, and announced the same in newspapers of this city; have initiated persons known to be unfriendly to the Sons of Temperance; have caused to be printed the private cards of the Order; exposed our private ceremonies to those who are not members; issued spurious clearance cards; elected officers and installed them by our private ceremonies, by a Grand Worthy Patriarch of their own creation: thus showing their utter contempt of the Grand Division.

The Grand Division and its proceedings have been exposed and scandalously falsified at public meetings called by these parties, in the Temperance Hall, and the proceedings of the Grand Division read and garbled, and held up to ridicule, by these malcontents.

A small paper called the "Kingston Mail" has been got up and sustained principally to denounce the Order; and Mr. George and associates, it is well known, are the instigators, and, with Mr. Flynn, have not left a stone unturned to stigmatize the Grand Division and its officers. The Grand Worthy Patriarch has been denounced by them in the newspapers of this city as "acting like a despot on his throne," "and Rudston, Stacey and their Banditti," &c., &c.; and week after week have the most shameful statements appeared in the newspapers, calculated to prevent persons from joining our Order, and to mislead the public.

We refer you to fyles of the "Mail" and "British Whig" since the suspension. This "Mail" of Mr. Flynn's, while denouncing the Sons of Temperance, is very glad to insert the liquor advertisements in the same sheet. The most shameful proceedings have been resorted to by these malcontents, and whenever any supposed advantage had been gained by these parties in the courts of law against the officers of the Grand Division, flags have been suspended from the Temperance Hall, and inscribed thereon, "Frontenac Division, No. 2, has won the day."

It has been with great difficulty that the loyal Sons have been prevented from disgracing themselves by noticing such gross insults.

With reference to the suits at law, under the sanction of the Grand Worthy Patriarch, and as counselled by our legal advisers, application was made to the Court of Chancery for an injunction to restrain these recusants from using the name of the Frontenac Division, and sueing in its corporate name, and dividing the funds. After some preparatory proceedings, it was deemed advisable to withdraw the application, having discovered that the Act of

Incorporation was considered defective.

As has been stated above, the recusant majority of the suspended Division, claiming certain rights under the Act of Incorporation, independent of the Constitution and By-laws, took out a writ of replevin, which was twice dismissed by the Judge of the Division Court; not satisfied with which they sued out another before the Quarter Sessions, which was appointed to be tried on the ninth day of June last. The Grand Worthy Patriarch being detained in Cobourg by important judicial business, and an important witness for the Grand Division being absent, an application was made for a postponement of the trial; but, through some technicalities, the Judge refused to put it off, and as the said parties calling themselves Frontenac Division, No. 2, refused to allow of a postponement, a formal verdict was taken against the subscribers for \$116, the alleged value of the property taken possession of. Of course, it is needless to state, that this verdict was a mere formality, and that a new trial will be allowed, as a matter of course, regarding the result of which there is not the slightest room for doubt; for the Act of Incorporation of the Grand Division is the Act which rules and regulates the acts of the Sub-Divisions, and the Constitution, Rules and By-laws must be taken along with the Act, as explanatory of the intentions thereof, as it is based upon them. It is only necessary to add that the parties referred to, finding that they had no ground to stand upon, at the last moment made a kind of informal appeal to the National Division, for the purpose of throwing dust in the eyes of the Court, by pretending they had not declared their independence (which they have done by all their acts, words and deeds, for six months past), thereby hoping to strengthen their case with the Court, by pretending that they still belonged to the Order, it having been ascertained (a fact admitted by the legal gentlemen on both sides), that the instant these parties cease to be members of the Order, their rights under the Act of Incorporation lapse, and the property of the Division falls to be administered by the Grand Division; the only legal doubt at present, being, whether, in the event of the suspension of a Division, the members thereof cease to be mem-

COMMITTEE ROOM, GRAND DIVISION, Kingston, June 24, 1858.

To the Grand Worthy Patriarch, Officers and Brethren of the Grand Division of the Sons of Temperance of Canada West:

Your Committee to whom was referred the Report of the Grand Scribe, beg to report that they have given their careful attention to that very ably written document.

The parts of the Report upon which your Committee would venture a suggestion or two, and which seem to require the attention of the Grand Division, are the following, in the order presented by the Grand Scribe:—

That, although our prosperity is not so great as we would desire, yet we must be unfeignedly thankful for our present position, and must hail with encouragement any increase in our membership, such as is evinced by the thirty new Divisions recently chartered, and the nine which have been resuscitated. As shown by the Annual Returns from Subordinate Divisions, presented in the Grand Scribe's Report, the number of our members is very little greater that that of the year just previous; but we hope that the excrescences are now about removed—so that henceforth our growth will be more rapid and more uniform; and if Subordinate Divisions will only make an effort, next year's increase will be much greater. In relation to suspended Divisions, this fact is in our favor—that many who, from indolence

We have now 10,000 members, and among so many, the number of deaths, being only thirty-four, is certainly a convincing proof that the per centage of deaths among Temperance men is very much smaller than the general per centage, as shown by tables prepared by Life Assurance Societies and Health Associations. In our organization last year we had only about one death to every 300.

Your Committee would recommend that the financial part of the Grand Scribe's Report be referred to the Finance Committee. We are glad to perceive the healthy condition of our money affairs, as exhibited by the balance sheet accompanying said report; and, as suggested, we would again call the attention of Representatives, and, through them, the attention of the few lax Subordinate Divisions, to the necessity of a promptness in making their quarterly returns.

Your Committee would call the attention of the Lecturing Committee to those localities where Divisions have suspended their operations; that those

Divisions may by some means be resuscitated.

We hail with delight the prospect of extending our Order beyond the ocean, especially to the metropolis of Ireland, and hope that the charter given to the W.P. of Hamilton Division will include those who will be the nucleus of a large and powerful army in that city.

We recommend a continuance of the practice of printing in pamphlet form the proceedings of the Grand Division, and their transmission to Subordinate Divisions; as they tend greatly to increase the interest of members in our

Your Committee would recommend the Grand Division to urge upon Subordinate Divisions the necessity of uniformity in the use of the New Ritual. As it is the Old Ritual, improved only in what was acknowledged by all to be defective, we think the Subordinate Divisions will be universally satisfied with it.

We notice with great pleasure the good results of Brother Moffat's lectures. He has faithfully, earnestly, and eloquently, told truths to Canadians; and if at all practicable, we would recommend keeping him in the field. And while we see the importance of a professional lecturer, we would not forget the great good resulting from local effort; and would recommend the Grand Division to ask (by circular) Ministers of every denomination who agree with us that our principles are founded upon the basis of eternal truth as given us in the Scriptures, to advocate them to their hearers, and thus co-operate with us in our work of reform.

While your Committee are prepared cordially to sustain the course taken by the Grand Worthy Patriarch in reference to circulating petitions to be presented at the present Session of the Legislature, yet in view of the change in public sentiment, which now seems to be more in favor of a prohibitory liquor law, your committee would express the hope that by the time of another annual Session of Parliament the prospects of the Temperance cause will be such as to afford the Grand Division every encouragement to resume the work of petitioning with renewed energy and activity.

for our prinit to the will of an all-wise Ruler; and while He removes some of the advocates of our cause, He leaves others who will occupy the vantage ground obtained by their predecessors.

Your Committee cannot adopt the suggestion of the Grand Scribe in reference to the establishment of a paper as the acknowledged organ of the Sons of Temperance, inasmuch as those papers at present established in the Province for the propagation of Temperance principles are not sufficiently sustained by Temperance men; and in this connection we would recommend that the members of the Grand Division do more universally manifest their approbation by their subscriptions for at least one of those papers now published in the Temperance cause.

In reference to that part of the Report alluding to the matter of appeal from the Grand Division to the National Division, by the Frontenac Division No. 2, your committee would simply say that as everything in connection with this much vexed question has been referred to a special committee, they deem it a work of supercrogation to do anything in the matter, but would express that the Grand Division, in discussing the Report of that Committee, would take steps to have all the troubles amicably arranged.

We hail so large an attendance of Representatives as a token of good, and hope the increased interest which the people of Canada are taking in our excellent organization will swell our numbers greater than they have ever yet been.

1. In the matter of the application of Brother W. F. Lowe for a Clearance Card, we recommend that the Grand Division accede to his wishes and grant his request.

2. In reference to the communication of Brother J. A. Davidson, your Committee are of opinion that this excellent Brother deserves every encouragement which the Grand Division can afford him. 4. We hail the "Fountain" as a useful Temperance publication, especially in the matter of promoting juvenile effort, and would recommend that our zealous Brother, W. J. Kelly, turn his attention exclusively to the advocacy and promotion of the organization of Sections of Cadets, Bands of Hope, &c., and that in such case the "Fountain" be recommended to the support of all Sons of Temperance.

5. Your Committee regret exceedingly that there are to be found in our midst unprincipled and designing persons, who, for the sake of filthy lucre, if not from worse motives, hesitate not to impose upon the Temperance community beverages not only of a questionable character, but decidedly intoxicating, designating them "Temperance drinks," and among such we have no hesitation in naming "Ginger Wine" and "Lager Beer." We think that all Sons of Temperance ought to be on their guard against using any beverages in Taverns, except Tea, Coffee, or Water; and that, even when beverages named "Temperance drinks" are offered by known friends, if there be a doubt of their true character, the benefit of such doubt be given

GRAND DIVISION COMMITTEE ROOM, Kingston, June 24, 1858.

To the Grand Worthy Patriarch and Representatives of the Grand Division of the Sons of Temperance of Canada West.

Your Committee to whom was referred the matter of the Unfermented Juice of the Grape for Sacramental purposes being easily obtained in the City of Kingston, prepared with the utmost care and upon strictly scientific principles, by our esteemed and zealous friend, Dr. Mair, beg leave to report—

That your Committee conceive it to be the duty of the Grand Division to take into their serious consideration the following facts:-That there are Christians, members of this Order and not of this Order, who have conscientious objections to the use of any kind of alcoholic or drugged wines in the Sacrament of the Lord's Supper; that the number of such individuals increases as our members multiply and our principles become understood; that the indefatigable exertions of such generous hearted men as Dr. MAIR of this city, and others who might be named, have demonstrated the fact, that in our own Province, yea, at our own doors, can be procured an unintoxicating wine, such as, if approved by the respected and venerable ecclesiastical bodies laboring in this portion of the vineyard of our Divine Lord and Master, would meet the conscientious scruples and remove the cause of exclusion from His table of those brethren in and out of the Order who desire to show forth the Lord's death till He come again, in the use only of a pure unfermented wine; and we rejoice to call attention to the cheering truth, that the Churches themselves are now more attentively and prayerfully considering the claims of our cause than at any former period.

Your Committee having examined the wine prepared by Dr. Mair, are of opinion that it may be safely recommended for the use of such churches as may deem it proper to make the change which the foregoing observations suggest; and as Dr. M. has no pecuniary interest to serve or sinister design in its preparation, he has kindly consented to make public the recipes for its manufacture, and generously bestowed a sample for the Committee and members of the Grand Division to examine for themselves.

TO THE GRAND WORTHY PATRIARCH, OFFICERS AND BRETHREN OF THE GRAND DIVISION OF THE SONS OF TEMPERANCE, OF CANADA WEST, IN SESSION ASSEMBLED.

Your Committee, to whom was referred the consideration of the Prohibitory Liquor Law recently enacted in the State of Maine, and its adaptability to our Province, beg most respectfully to Report—

That they have examined and considered said Act as closely as their limited time would permit, and find that with a few clerical amendments to suit the character of our municipal and other institutions (differing as they do in many respects from those of the State of Maine), the Act is as wisely and judiciously framed as the advocates of Temperance could well desire, and its transfer to our Statute Books could not fail to operate as an inestimable boon to the community at large.

The principle of legal prohibition of the sale and manufacture of all intoxicating liquors lies at the base of the Temperance movement, and until this is effected, all efforts, no matter how vigorous or united, must prove comparatively impotent in eradicating the deep-seated and wide-spread evils of intemperance.

With this object in view, your Committee would urge upon the Grand Division the importance of bringing this subject before the attention of the Legislature now in Session.

The only amendment your Committee would venture to suggest in reference to the said Maine Law, is in regard to the adulteration of liquors by the admixture of noxious or poisonous ingredients. Your Committee cannot express themselves too strongly on this heinous offence. They deem it a misdemeanor of the gravest kind, and think that a severer punishment than that for ordinary violations under the Statute should be apportioned to such high offenders. Every one who would poisonously adulterate or knowingly sell such adulterated liquors, shortening the lives of their fellows for the sake of a paltry gain, deserve to be tried and punished as felons of the most dangerous description; and if a new Law is to be enacted in the Province on this subject, such law would be defective if it did not contain a penal clause to this effect.

Your Committee on Appeals having considered the Appeal of E. D. Ron-GERS against the decision of J. B. CALDWELL, W.P. of Newmarket Division No.108, and of P. P. Pearson, D.G.W.P. of that Division, beg leave to Re-

That they find the grounds of appeal to be as follows:-That on the 6th of April last, under the sanction of said officers, said Division No. 108 was thrown open to the public, and that the ordinary business of the Order, including the initiation of new members, was transacted in the presence of those who were not members. The appellant protested against such conduct, but was overruled-from which he now appeals.

It is the opinion of your Committee that said conduct of said named officers is—first, a violation of the obligation which every member takes upon his admission into the Order; second, it is a violation of the W.P.'s obligation taken on his installation into office; third, it is a still more gross violation of the obligation of every D.G.W.P.

Your Committee would therefore Report that the Appeal be sustained, and recommend that said offenders be dealt with according to the laws of

the Order.

In the appeal of J. Cuppage against the Orillia Division No. 122, your Committee would Report that a charge was preferred by the Appellant against certain members of said Division for violating Article 2 of our Constitution, by signing a recommendation for one Humphrey Harmer to keep a house of public entertainment in the village of Orillia. The Division decided that this act was not a violation of said Article No. 2 of the Constitution.

Your Committee would report that said Appeal be dismissed, and the action of the Division confirmed. They would also point out the inconsistency of members of the Order promoting by their influence, either directly

or indirectly, the interests of those engaged in the liquor traffic.

Your Committee tender their warmest congratulations to the friends of sobriety and good order everywhere, on the unmistakeable evidence of an increasing interest in the cause of Temperance in general, and of our Order in particular, which is manifesting itself in almost every part of our jurisdiction. This awakening interest calls us to a more earnest and ardent devotion of all our powers to increase this interest, and give it such a direction as will result in the greatest practical effect for good.

It is a truth, whether our philosophy of human society will

account for it or not, that

"There is a tide in the affairs of men, Which, taken at the flood, leads on to fortune,"

and the amount of effort required to accomplish any desired result is much less when this tide is in our favor than when it is against us. The present is a propitious time for our labor of love. The horizon, which but a few months ago was hung with darkness, is now streaked with the dawn of a temperance revival, which, if we are but faithful to our mission, will cheer many a desolate home, will save from disgrace and ruin many a tempted youth, and will be crowned with results and consequences which the cycles of eternity alone can fully unfold.

Of the ultimate triumph of our cardinal principles we cannot for a moment doubt, while we have any confidence in truth, faith in God, or hope for humanity. In the great conflict of life the cause of truth and righteousness may seem to be stricken down for the time, but our reverses should only teach us wisdom, and we should rally our forces again to the battle, strengthened

and made wiser by the experience of the past.

The causes conspiring to produce the present hopeful state of the Order, and, by implication, of the cause of temperance

generally, are mainly these:

1st. The revision of our Ritual of Ceremonies. Experience has taught us that the more simple and plainer our forms, the more impressive they become, and the better adapted to that universal acceptance which is so desirable in an Order intended to scatter its blessings among the ranks of society. True beauty is not made up of meretricious ornaments, but of simple unadorned worth.

2d. The introduction of a swarm of Orders and institutions based on the central idea of total abstinence, but varied to meet the necessities of time, place and circumstances, real or imaginary, had divided our ranks, and, in the ratio of this divi-

sion, had weakened the temperance army, and unfitted it for anything like simultaneous or concerted action, in which alone we could hope for success. Mature reflection—the sober second thought has convinced us that the Sons of Temperance is an indispensable organization, an essential element of progress in the temperance reform, and one which it is the duty of every temperance man to maintain. This returning sanity is bringing back to the Division those who had been deluded by the false hope of exerting more influence for good in some other association. This re-concentration of effort is producing, in many localities, the happiest results, not only on the Order directly, but reflexly on society in general, producing a healthy tone of public sentiment, and moulding the fates and fortunes of thousands. Those who have studied the genius of our Order cannot fail to admire its peculiar adaptation to the wants of this versatile and progressive age. While the great central principles of the Order, the internal skeleton, remains as fixed and immoveable as the everlasting hills, the internal investments, the mere drapery, can be changed with every changing whim of fashion, the wants of each succeeding year, or the demands of a better cultivated taste. It is, therefore, a great mistake to suppose that every year, and each successive phase of the temperance question, demands a new organization to meet these new exigencies. The Sons of Temperance is an institution that most admirably meets these ever changing indications. It combines most completely "diversity in unity," and while moving to the fulfilment of its mission, its "manifest destiny," the achievement of a sober world, it yet accommodates itself to all the reasonable demands of its social surroundings, and, in the large discretion left in the hands of Subordinate Divisions, adapts itself as far as possible to the various grades of society, as well as to the demands of widely separated localities. It thus justifies its claim to be the great temperance instrumentality of the age, embodying, as far as human imperfection will permit, the elements of prevention and cure for the evils of intemperance, and as such has peculiar claims on all the friends of sobriety everywhere.

3d. Another, and not the least among the causes which are adding lustre to the star of our Order, is the interest which our sister visitors are taking in the prosperity of our Divisions. He who supposes that any great moral reform or social revolution can be successfully carried forward without the aid of woman's influence, has wholly misread human society in the meridian of the nineteenth century. This influence we have happily se-

eured, and its effects are not only apparent in the prosperity of the Divisions, but it is sowing good seeds around the hearthstones that will spring up in the homes of the land, and bear

fruit in coming generations to happyfy millions.

The recommendation of the M.W. Scribe on the subject of admitting ministers of the gospel without fees or dues, involves a question which should not be lightly passed over. The influence of the pulpit is one that we should, by all means, enlist in a cause so holy as that of ours, but we doubt the propriety of making any special discrimination in favor of any particular class in society. If ministers are admitted without fees or dues, should we not extend that privilege to professional teachers? Temperance lessons in the school are nearly as important as in the church; and if we begin to discriminate, where will we end? Moreover, the discretionary power now left with Subordinate Divisions in the management of their funds, we think amply sufficient to meet the emergency, and Subordinate Divisions are the most competent judges of when they should exercise that power. Nevertheless, we would not undervalue the importance of securing the aid of so powerful an auxiliary as the pulpit on all moral questions.
