W. O. C. T. A. Elect and Nominate Officers for 1894.

Messrs. R. C. Struthers and J. M. Dillon Stand for the Presidency.

A Large Meeting—These Present—Some Elections by Acclamation—Annual Meeting Dec. 23.

The annual meeting of the Western Ontario Commercial Travelers' Association is held at hand, when the election of officers will take place. A great deal of interest is always taken by the "knights of the grip" in this portion of the business, and on Saturday night a meeting was called for the nomination of candidates for the various positions. Mr. R. C. Struthers, president, occupied the chair, Mr. A. H. Robinson acting as secretary, with the following members present: Messrs. Before the nomination took place Mr. Struthers made a short address as president. He was, he said, one of the first members who had formed the association, and had seen it rise and grow in numbers since then. Up to the time he was asked to run for the presidency he had attended the meetings but very seldom. Since then he had taken a deep interest in the affairs and the association had prospered. Mr. Struthers concluded by thanking all for the hearty support tendered in the past, and hoped that the new president would receive as hearty co-operation from the members as he had.

THE PRESIDENCY.

Nominations were opened for president, Mr. Sam Munro being the first to open them. He said that a fit person should be chosen for such an important office. They wanted a president who understood the needs of the travelers, and with such a fact in view he had great pleasure in nominating Mr. R. C. Struthers for another term. This was seconded by Mr. S. Scraton.

Mr. J. M. Dillon (who ran last year) was nominated by Mr. W. D. Brock, seconded by Mr. H. Line.

These were the only nominations for the presidency, and the contest will be between these two popular members.

THE ANNUAL MEETING.

The Dresden Times says the Chatham township people intend to prohibit raffles, which are being conducted by a gang of toughs. The farmers report that they are looking after the dogs, and are of the opinion that the parties who conduct raffles are the ones who are robbing them of their birds.

The Benheim Township Council has decided to pay E. L. Brown, Galt, \$200 for injuries sustained by Mrs. Brown and himself recently by being precipitated over an embankment where the road was narrow.

Chatham sold \$17,000 city debentures to G. A. Simson, Toronto, at 98. They bear 4½ interest.

LAMBERTON.

Donald Simpson, a well-known resident of Sarnia township, died at the residence of his father, J. D. Simpson, last week, aged 38 years. He had been for years an active business man, and was associated with his father in colonization roads construction in the Sarnia district, where he had an attack of the grip over a year ago, from the effects of which he never recovered.

W. J. McKelvey, gent's furnisher, Sarnia, made an assignment last week.

Conn, the alleged Alvinton forging banker, has been brought back to this country for trial. He made one of the most determined fights against extradition which has been known here for many years, and it was not until Tuesday that the United States Court of Appeals ruled his fate at Louisville, Ky., where they dismissed the appeal taken from Judge Swan's decision rendered some months ago. Conn failed for about \$50,000, and is charged with forging the name of A. Gilroy to commercial papers and depositing it as collateral. He fled to Detroit, and was there several months before his whereabouts were discovered. He was finally apprehended, and Commissioner Davidson held him for extradition.

OXFORD.

Thos. Sedon, of Woodstock, furnished a shipment of 3,000 turkeys Saturday, destined for the English market. Two thousand turkeys went from Bothwell.

Rev. R. J. Elliott, pastor of the Dundas Street Methodist Church, Woodstock, preached a sermon to his congregation Sunday on the subject of gambling and cards.

THIRILLING RIDE!

A McGillivray Farmer's Narrow Escape from Death.

PARKHILL, Dec. 3.—Mr. Joe Maller, a farmer of McGillivray township, driving through town yesterday morning, was struck by the mixed train, due here at 9:45. It struck the wagon just at the front wheels, breaking the tongue and freeing the horses, throwing the box onto the cat-catcher, carrying him along in the box to the station, a quarter of a mile. Stopping there the unfortunate man was lifted off, being quite unconscious, bleeding at the head. Up to a late hour he seemed to be doing very nicely, only having the one cut, though apparently otherwise hurt, but not thought to be fatal.

Blown Out to Sea.

MEAT COVE, C. B., Dec. 3.—A very heavy and sudden squall and wind with snow struck here at noon yesterday. A boat containing John and Michael Donohoe, both young men, is supposed to have been blown out to sea or foundered.

A school house here was blown down and reduced to kindling wood.

The Nelson Monument Affair.

MONTREAL, Dec. 2.—The three young French-Canadians, Mercier, Pelletier, and Denantigny, charged with conspiring to blow up Nelson's monument, appeared in court this morning to answer to the charge. After hearing the evidence of a detective, a constable and an expert from the Hamilton powder works the case was adjourned for a week.

Peterboro Patrons.

PETERBORO, Dec. 3.—A meeting of the Patrons of Industry of the east and west ridings of Peterboro, was held in the town council chamber yesterday afternoon, about 75 delegates being present. Grand President C. A. Mallory gave an address. After full discussion it was decided not to bring on a candidate for the west riding. In reference to East riding, the matter was left in abeyance until the next meeting of the County Union Association, which will be held at Newwood on the first Saturday in February.

"Well," replied her listener, cautiously, "some people may admire red hair and—"

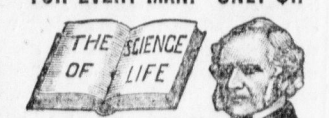

THE ELECTIONS.

The result of the bye-elections for the Legislature which took place on Saturday, while practically making no difference in the standing of the two political parties in the Provincial Assembly, certainly affords food for reflection, seeing that a general election is booked for the next six months.

Owing to the peculiar circumstances under which the contest took place, the outcome does not surprise us. We have all along confessed that in both constituencies the uncertainties were great, and the polling has confirmed this view.

In East Lambton, a debatable constituency, because the Liberal majority has rarely been more than from 100 to 200 when a straight fight was on, the Conservatives did not put up a candidate. Privately, their leaders confessed their despair of defeating the candidate selected by the Liberal convention. They therefore waited till the P. P. A. institution resolved to vote for Mr. McCallum, a Liberal who had confessed that "the Mowat Administration was the best that Canada has ever had," and then resolved to cast their lot with him, with the object of defeating the nominee of the convention. They have accomplished their aim, for, as the returns demonstrated, Mr. McCallum was able, with the assistance of his own personal friends, and supported by the Conservatives, to defeat Dr. McKinnon.

Those who have been through the riding know how ardently the Conservatives worked to foment religious cries and prejudices and to work upon the susceptibilities of the farming community by claiming that there were too many professional men in the Parliament, and therefore it was the duty of the electors to vote for the farmer and defeat the farmer's son, who had found use for his talents in the profession of medicine. The result was not attained without the circulation of untruths and misrepresentations without number. As soon as one false cry was silenced by the production of evidence another was raised, and so seeds were sown that may bring forth fruit which the sower may yet reap in bitterness. We recite these facts to show the influence by which the Liberal candidate was met. They but emphasize the weakness of the Provincial Opposition, whose failure to put up a candidate squarely and fairly has proved its utter lack of ability to cope with the record of the Mowat Administration in a manly and honest way.

The North Bruce vote, however, far more effectually reveals Mr. Meredith's weak position at this time. Until last bye-election, when Mr. Porter, an exceptionally strong Liberal, won the seat, North Bruce has always sent a Conservative to the Legislature. In 1886 the Conservative candidate carried the seat with a majority of 119, and in 1890 it again returned a Conservative. Through Mr. Porter's death a vacancy was this summer caused. The farmers' organization, known as the Patrons of Industry, being exceptionally strong in North Bruce, took an early opportunity to put a man in the field. Some cleverness was displayed in the nomination. Mr. McNaughton, the candidate selected by the Patrons, was an exceptionally popular man. He was a representative farmer and experienced in municipal life. His home is in the township of Bruce, a Liberal stronghold, and he has always been allied with that party. The Liberals also put a good man in the field, in the person of Mr. Pierson, a farmer, and an ex-warden of the county, but he was brought out at a rather late hour and in the patron had made headway in his canvass. For the Conservatives, Mr. George, the former member for the riding, and an admittedly strong man, was nominated. A triangular fight is always doubtful, but as the Patron candidate has always been a Liberal, the general impression until polling day was that the Conservative candidate would slip in. This view received further support from the fact that with the exception of one or two planks the platform of the Patrons is in substantial accord with that of the Liberals.

The vote, however, resulted in the election, by a considerable majority, of the Patron candidate, and left the Conservative nominee practically nowhere. The Patron got his majority in the rural districts, and the towns and villages about divided their votes for the other two candidates. One effective plea used on behalf of the Patron candidate, as against the old member and the Liberal nominee, was that the election of the Patron would neither help nor injure either of the two great parties, seeing that a general election was so near at hand, and as he was the first in the field, and a farmer unobjectionable to the electors as a whole, he should be allowed to secure the seat. This plea, as we have seen, has been responded to with a vote that shows the Patrons to be a strong factor in public affairs in North Bruce. Whether or not they will so remain has yet to be demonstrated. In a general election the same all-potent appeal could not be made. Nevertheless, the lesson of the contest will be laid to heart by those in authority.

As for the East Lambton election, it has proved nothing except the utter lack of policy and manliness of Mr. Meredith and his associates. The Conservatives dared not put a candidate in the field; they did not assail Sir Oliver Mowat's record on the platform, but they fanned the flames of sectarian bigotry by misrepresenting in secret ear-whispering the policy of his

Government. Then they united their votes with those of Mr. McCallum's personal friends in Forest and elsewhere, and succeeded in electing that gentleman. We see no reason why Mr. McCallum should not, now that he is elected, rise superior to many of the influences that secured him the seat. He should show by his stand in the Legislature that he is prepared to give that independent support to the Government that it deserves. He has already confessed that it is the best Administration which the Dominion has ever possessed. If that view is well founded, and any honest student of our history must confess that it is, neither of the new members will be able to find fault with the overwhelming proportion of its legislative programme. When Mr. McCallum reaches the Assembly, he will very soon discover how very little foundation there is for the underhand cries that were raised in his favor by the bitter political enemies of the aged Premier of Ontario. It is not objectionable to "heckle" a Government, but let it be done honestly and above-board.

WHAT NEXT?

Sir John Thompson told his audience at Picton that "a great number of Liberal manufacturers want a free market in order to move their factories to the States to employ cheap labor and flood Canada." The Premier of Canada must expect somebody to believe that twaddle, or he would not utter it. Just think what it implies. The United States has had the protective system in force nearly twenty years longer than Canada, and now we are assured by no less authority than Sir John Thompson that labor is much cheaper in the States than in Canada; that Canadian manufacturers would like to move their factories over the border to take advantage of the cheap labor. If the man stopped to reason at all, would it not occur to him that labor can migrate much more cheaply than a factory can be moved? How long would cheap labor in the United States and dear labor in Canada continue alongside of one another, especially when there were unemployed men in both countries? Sir John Thompson could not, to save his life, name one Canadian manufacturer who desires free trade to make it profitable for him to remove his factory from Canada to the States. This theory may be original, but it is utterly silly that his friends will wonder how a man capable of talking such nonsense could get to be Premier of Canada.

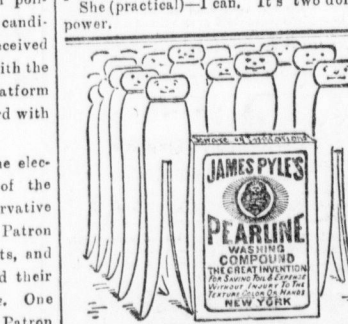

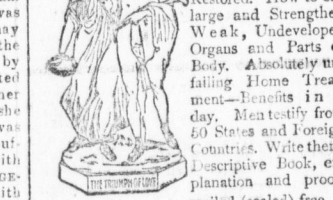
