



Dear Sir:-

While passing the McGill Tennis Courts last week I was attracted by an unusually large crowd, and being interested in tennis I went in to see what was in progress. I learned that it was the finals for the Martin Cup, and having had the pleasure of seeing Mr. Crocker play on a previous occasion I stayed to watch the match. I was very soon even more interested in the loser than the winner and made further enquiries concerning him.

Not wishing to detract one whit from the winner of this match who certainly displayed his usual form and thoroughly deserved his triumph, I wish to state that never before have I seen greater sportsmanship than that shown by Mr. D.R. Morrice, who, like a true Britisher, "does not know when he is beaten" - nor is he beaten until the last point is scored. So impressed was I with his game fight that I made further enquiries about him and learn that this is his final year at college. I am therefore taking the liberty of asking you if you will please have the accompanying token presented to Mr. Morrice, not as consolation prize, but as concrete evidence of the sincere admiration of a mere passer by.

Dear Sirs:-

AS no doubt you are aware McGill University has inaugurated courses of lectures in English and Psychology in Quebec and Sherbrooke for the benefit of the Protestant Teachers in these two centres. Should we charge a fee of \$10.00 for each teacher attending one of these courses we would not be able to meet the expenses of putting them on. We feel, however, that these Teachers cannot afford to pay a larger fee.

It has occurred to me, however, that you, as Trustees of Morrin College, might feel willing to vote a sum of money to cover the expenses incidental to the putting on of these lectures and in that way make them available to the Teachers free of charge.

Similar lectures have been given in Montreal for the past two years and we are offering them in Quebec and Sherbrooke this year in response to a request from the Teachers in those places.

Dr. Cyrus Macmillan has already started his lectures in English in Quebec, and Dr. W.D. Tait has started his course in Psychology in Sherbrooke. I would like, therefore, to hear from you in regard to my proposal at your early convenience.

My dear Dr. Percival,

There came to see me yesterday a Mr. Morrison who is, I believe anxious to resume teaching in the Province of Quebec, and who has written to you about this. He probably has given you full information of what he has done since graduating from this University as Bachelor of Arts in 1913. I can only tell you a little more definitely the kind of man he is.

He gave up his post-graduate work at the University of Wisconsin to go to War, where he had a highly creditable service with the Canadian Artillery. He married a young woman from Victoria, B.C. whom I knew; she, unfortunately died about five or six years and I think I know the second Mrs. Morrison. His sister is the wife of my Professor Corbett, Dean of the Faculty of Law. The family is, all through, of the best type, and I think Mr. Morrison is just the kind of man who would make a first-class high school teacher.

Morrison has told me of the difficulty in his case:-
although a high school teacher at one time in the Province,
he cannot, apparently, resume unless he has further qualifi-
cations, and these he is willing and anxious to acquire.
You need have no doubt on that score. He would lose no
time in getting the qualifications you insisted upon.

I think the future would give you abundant satisfac-
tion for any consideration extended to him now.

I wish to thank you for your letter of May 18th, advising me in the matter of my endeavour to resume teaching in the Province of Quebec.

I have discussed my case with members of the Protestant School Board of Lachine and with Prof. Clarke and others of McGill University, and, acting on their advice, I wish to submit the request that my case be referred to the Board of Examiners at their next meeting. In this connection please allow me to briefly outline again the reasons why I feel that I should be permitted to teach while completing the course of professional training now required as qualification for the high school diploma.

I was born and brought up in this province; had my early education at Ormstown Academy; matriculated from the Montreal High School, with an entrance scholarship to McGill; obtained my B.A. degree from McGill in 1913, having been awarded the McKenzie Scholarship in 1911.

In 1913 I was appointed assistant-principal at William Dawson School, Montreal, and after acting in this capacity for a month I was given a position on the staff of the Montreal High School where I completed the term of 1913-1914. I gave up this position in order to take postgraduate studies in the University of Wisconsin. These were interrupted by my enlistment in the C.E.F. early in 1915.

Upon my return from overseas in 1919, and during subsequent years, I found it impossible, owing to family ill health and other circumstances, to resume teaching, although I was again offered a position in the Montreal High School in 1921. Having lately returned to the province, and being now in a position to remain here, I am very anxious to resume work in that branch of our social and national life which I have always considered these the most important.

I fully realize the Department's position in view of the large supply of fully qualified teachers and the present opportunity to raise the standard of efficiency by reason of this over-supply. On the other hand I honestly feel that I am very well qualified, from the standpoint of academic training, teaching experience, character, and general business and industrial experience, to compete with others in the vocation of teaching, training and influencing our youth. If some years have lapsed since I was engaged as a fully qualified teacher in the province, I think that the circumstances which interrupted my academic work, entitle me to some consideration.

I should of course want to complete the full course of professional training at present required for the high school diploma, and I am advised by Prof. Clarke that I could undertake such studies while teaching in this district.

With regard to my general character and fitness for this work, I would again refer you to Dean Corbett, of the Faculty of Law at McGill, and to Mr. H.G.Hatcher, Superintendent of Protestant Schools in Lachine, in whose jurisdiction I have been doing some substitute teaching.

I trust that my request may meet with due consideration by the Board of Examiners. In the meantime I shall be glad to fill out the official application form, or to supply you with any further information or references which you may require.




