JOURNAL OF A SPECIAL SESSION

OF THE

Synod of the Diocese of British Columbia.

1892.

Pursuant to the provisions of the Canon "For the Election of a Bishop," the Synod was summoned to meet in the City of Victoria, on Tuesday, November 22nd, 1892, for the purpose of electing a successor to the See, vacant by the resignation of the Right Rev. George Hills, D.D., First Bishop of the Diocese.

There was a celebration of the Holy Communion at Christ Church Cathedral, at 8 a.m. The celebrant was the Rector, the Rev. Canon Beanlands, assisted by the Rev. J. B. Hewetson.

At 10 a.m. Matins was said by the Rev. J. B. Hewetson, followed by a celebration of the Holy Communion, the Ven. Archdeacon Scriven being the celebrant, assisted by the Rev. Canon Beanlands and the Rev. S. C. Scholefield.

At eleven o'clock, the Clergy and Lay Representatives assembled in the Cathedral School, the Ven. A. Scriven, M. A., Archdeacon of Vancouver Island and Bishop's Commissary, in the chair.

The Synod was opened by the Rev. Canon Beanlands with the appointed office.

The Chairman appointed the Rev. J. B. Hewetson to act as Clerical Secretary for the Session of Synod.

In accordance with the Canon, the Chairman appointed a Committee consisting of the Rev. W. D. Barber and Lt.-Col. Wolfenden, with the Lay Secretary, Mr. E. Baynes Reed, to examine the certificates of the Lay Representatives elected since the last Session of Synod.

The Committee reported that the following Lay Representatives had been duly elected, and that their certificates were in due order.

NANAIMO, ST. ALBAN'S.—Mr. A. E. Planta, and Mr. J. H. Simpson, elected July 28th, 1892, in place of Mr. W. H. S. Perkins and Mr. T. L. Browne, resigned.

NANAIMO, ST. PAUL'S.—Mr. P. L. Good, elected Sept. 6th, 1892, in place of Mr. S. G. Langton, resigned.

ESQUIMALT, ST. PAUL'S.—Hon. Jas. Baker, M.P.P., elected Oct. 28th, 1892, in place of Mr. J. H. Williams, resigned.

CEDAR HILL, ST. LUKE'S.—Mr. B. H. Tyrwhitt Drake, elected Nov. 9th, 1892, in place of Mr. John Vantreight, declined to act.

LAKE, ST. MICHAEL'S.—Mr. Percy Wollaston, and Mr. R. H. Hall, M.P.P., elected Nov. 10th, 1892, in place of Mr. E. S. Wilkinson, and Mr. H. E. Croasdaile, resigned.

On motion of Mr. E. Baynes Reed, seconded by the Rev. J. B. Hewetson, the report was adopted.

ROLL CALL.

The rolls of the Clergy and the Lay Representatives were then called by the respective Secretaries, when 19 Clergymen and 34 Lay Representatives responded to their names.

Subsequently, two more Clergymen and five more Lay Representatives entered and took their seats.

SYNOD ASSESSMENTS.

The Lay Secretary presented a Report shewing the Parishes whose Synod Assessments were unpaid, as follows:

A vote by orders being demanded by Mr. P. A. Vidler, the vote was taken with the following result :

The resolution was declared *carried.*

Moved by the Lay Secretary, seconded by the Rev. W. H. G. Ellison,—That the delegates from Metchosin be allowed to take their seats upon a personal guarantee being given by them to pay the assessments, \$40, by the ensuing Christmas.—*Carried.*

DIocese OF NEW WESTMINSTER.

The Chairman informed the Synod that he had received the following communication :

Extract from the minutes of New Westminister Diocesan Synod, held Nov. 16 and 17, 1892.

It was moved by the Venerable Archdeacon of Columbia, seconded by the Rev. R. Small, passed by both orders and assented to :

That the Synod of the Diocese of New Westminister beg to express their sympathy with the Synod of the Diocese of British Columbia in parting from the first Bishop of the Diocese, and at the same time to offer them the assurance of their hopes and prayers that, under the guidance of the Holy Spirit, a fit successor may fill the place and carry on the work, the foundation of which has been so well laid by Bishop Hills.

VACANCY OF THE SEE.

The Chairman laid before the Synod the correspondence that had been received from the Bishop relating to his resignation, and explained in what manner the Synod had been summoned to meet.

1. Letter from Right Rev. Bishop Hills.

MY DEAR ARCHDEACON AND MR. BAYNES REED,

I beg to inform you that on Saturday, August 6th, I forwarded to the Archbishop of Canterbury my formal resignation of the Sec and Diocese of British Columbia.

The date on which the resignation is to take effect is November 15, 1892.

I have asked his Grace to accept it in consideration of a Ministry in the Church of England of over 52 years, and of my increasing sense of infirmity.

I enclose copies of the instrument of resignation and of my covering letter to the Archbishop.

This letter now addressed to you as secretaries of the Synod, will be, I believe, the formal notice of resignation alluded to in clause 1 of the amended Canon on the election of Bishop.

MY DEAR LORD ARCHBISHOP,

I beg to enclose the formal instrument of my resignation of this Bishopric of British Columbia, which I hope your Grace will kindly accept, subject to the condition that actual vacancy does not occur until November 15th, 1892.

I append a copy of the Canon on election of Bishop in this Diocese, as amended at the Synod, held June 19, 1883. In this is provided that formal notice of resignation, to take effect on a fixed date, may enable the Synod to meet and so reduce the interval (in this case by three months) before appointment of a successor. I also add an extract from my Letters Patent (1859) upon the subject of resignation.

RESIGNATION OF THE SEE OF BRITISH COLUMBIA BY THE RIGHT REVEREND
GEORGE HILLS, D. D., LORD BISHOP OF BRITISH COLUMBIA.

*To the Right Honourable and Most Reverend Father in God, Edward White, by
Divine Providence Lord Archbishop of Canterbury, Primate of all England
and Metropolitan:*

I, George, Lord Bishop of British Columbia, having on the Festival of S. Matthias, 1859, taken the oath of obedience to the Most Reverend John Bird, Lord Archbishop of Canterbury and his successors, do, to your Grace as my Metropolitan, resign the office and dignity of Bishop of British Columbia as from the 15th of November, 1892.

I trust that in consideration of a Ministry in the Church of England of over 52 years and of my increasing sense of infirmity, your Grace will be pleased to accept this, my resignation, and allow it to take effect on the date specified, namely, the 15th November, 1892.

Remaining your Grace's faithful and humble servant and brother in Christ.

Witness my hand and seal, this 6th day of August, one thousand eight hundred and ninety two, at Bishopsclouse, Victoria, British Columbia.

4. Copy of Canon on Election of Bishop in the Diocese of
British Columbia.

I. When the See is vacant, or when formal notice of resignation shall have been given to the Synod, the Bishop, or in his absence the Dean, or in his absence the Senior Archdeacon, or in his absence the Archdeacon next in seniority, or in his absence the senior Priest of the Diocese, shall, within one fortnight of the date of such vacancy being brought to his knowledge, or after formal notice shall have been given, as aforesaid, summon a special meeting of the Synod to meet at the Cathedral City of the Diocese, in not less than three, nor more than six months from the date of such summons, for the purpose of electing a successor to the See, and during the vacancy of the See no other business shall be transacted by the Synod.

II. No election shall take place unless half of all the Clergy and Lay Representatives be present.

The vote of a majority not being less than two-thirds of each order present, shall be necessary for such election, the Chairman voting with the Clergy. If the required number of Clergy and Lay Representatives should not assemble at such special meeting, the members present shall adjourn to any day within one week, and so on from time to time until the required number of Clergy and Lay Representatives shall assemble, when the election shall be proceeded with.

The Chairman, for the purpose of this rule, shall be the Dean, Archdeacon or Senior Priest of the Diocese, or in his absence one of the Clergy to be elected by the meeting.

III. On the day and at the place appointed, the Holy Communion having been first celebrated, the Chairman shall declare the meeting constituted, and it shall be in the power of the Synod to elect any Clergyman in Priest's Orders, and

of Canonical age, of this or any other Diocese of the Church of England, or of any Colonial branch of the said Church, being duly licensed in the same, to fill the vacant See, or to delegate to any person or body the power of choosing a Bishop for the vacant See, such choice to be accepted by the Synod as final. All such proceedings to be with closed doors until the final declaration of the result.

IV. Should the election be made by the Synod, the Declaration of Election shall be signed in duplicate, in presence and on behalf of the Synod by the Dean, Archdeacon or other Chairman presiding, witnessed by one Clerical and one Lay member.

One of these declarations shall be transmitted without delay to the Archbishop of Canterbury, and the other kept in the Registry of the Diocese.

The approval of the Archbishop of Canterbury having been obtained, his Grace shall be requested to take the necessary steps for the consecration of the Bishop elect.

5. Extract from Bishop of Columbia's Royal Letters Patent January 12th, 1859.

"And for removing doubts with respect to the validity of the resignation of the said Office and Dignity of Bishop of British Columbia, it is our further will, that the said Bishop or any of his successors, shall, by instrument under his hand and seal, delivered and sent to the Archbishop of Canterbury for the time being, and by him accepted and registered in the office of the Vicar-General of the said Archbishop, resign the Office and Dignity of Bishop of British Columbia, such Bishop shall from the time of such acceptance and registration, cease to be Bishop of British Columbia, to all intents and purposes, but without prejudice to any responsibility to which he may be liable in law or equity in respect of his conduct in his said office."

MY DEAR ARCHDEACON AND MR. BAYNES REED,

Formal notice of my resignation to the Archbishop of Canterbury of the See and Bishopric of British Columbia having been given to the Synod through you, the secretaries of the same, by my letter of August the 6th, the Canon next requires that the Bishop, within 14 days after such formal notice shall have been given, shall summon a special meeting of the Synod to meet at the Cathedral City of the Diocese, in not less than three nor more than six months from the date of such summons, for the purpose of electing a successor to the See.

I now therefore request you on my behalf, to issue a summons for a special meeting of the Synod, to meet at Victoria in the Cathedral School, on Tuesday, November 22nd, at 10 a. m., for the purpose of electing a successor to the See.

Hon. Mr. Justice Crease then announced his intention of moving a resolution with a view to the postponement of the Synod for three months, and was speaking thereto when

It being 1.15 the Synod adjourned to meet again at 2.30 p. m.

2.30 P. M.

The Synod reassembled in the School House, the Ven. Archdeacon Scriven in the chair.

Hon. Mr. Justice Crease resumed and moved the following resolution, seconded by Dr. Praeger :

Whereas doubts exist as to the legality and competency of this present meeting of Synod to complete the election of a Bishop, because the notice required by the constitution of at least three months after such vacancy has occurred, has not been given for the required period.

Be it resolved, for the purpose of avoiding doubts, that the meeting of the Synod for the purpose of electing a Bishop, be disbanded, and that a fresh summons be issued in accordance with the Canon for the election of a Bishop.

After some discussion the motion was withdrawn.

ADDRESS OF THE CHAIRMAN.

My brethren of the Clergy and of the Laity :

I make no apology for seeking an opportunity, not specially provided in our "Order of Proceedings," to address to you a few words at this Session of our Diocesan Synod.

We are meeting for the first time as the representatives of a Diocese without a Bishop. It was a long and eventful Episcopate which closed last Tuesday. For more than three and thirty years has this Diocese been under the rule of one man; and he has left behind him a noble record of work. In the presence

of so many who have known Bishop Hills for years, it is unnecessary for me to say much. But after eight years of intimate official and personal relations with him, I must claim the privilege of bearing my testimony to the unvarying kindness, which has made that period one of so great happiness to myself.

And my own experience has been also that of all the Clergy who have worked under him. We had learnt to love him. Nor are we alone in this feeling. There are many of the Laity of this Diocese who have always regarded their Bishop with the warmest affection. There are some in this room to-day who, when they parted with him three weeks ago, felt that they were parting with a lifelong, trusty friend. And there are none who will not join with me in the hearty wish and fervent prayer that he may be spared to enjoy many years of hard-earned rest.

I feel myself, very strongly—I am sure you must all feel—how much we shall miss the dignified, courteous but firm President, who has hitherto guided our deliberations. I could have wished that the responsibility of presiding over this Synod had fallen into abler and more experienced hands. But I confidently ask the assistance of you all, to sustain and support me in the discharge of the duty which I am called upon to perform. We are Christian men, assembled, under the Guidance of the Holy Spirit, for an object of unspeakable solemnity and importance. Let us prove our fitness for the grave responsibility which rests upon us by the honesty and sincerity of our motives, and by the Christian courtesy and the harmony with which we conduct our deliberations. For indeed the business upon which we are to-day engaged, is both solemn and important. Solemn, because we profess and believe that the Holy Ghost is with us to guide and help us to a successful issue.

Important, because upon our action to-day depends, humanly speaking, the welfare of the Church in this Diocese for many years to come.

Suffer me then, to remind you and myself, that our object in this meeting must be the good of the whole Diocese; not the good of one order, of one party, or of one section: but of all; clergy and laity, city and country. There is no divergence of interest between us. We all desire the same thing: that this Diocese may have—and have shortly—a Bishop worthy of his high office; to whom all of us alike can look up with respect; and to whose governance we may all submit as to that of a ruler sent to us by God in answer to our prayer.

That this, our object, will be attained, I have no shadow of doubt. Our prayers for the Holy Spirit's guidance can not

be in vain. In His Hands is the issue: we are but his instruments.

Strengthened by this conviction, let us set about our work in God's name. And when the choice is finally made, let us all accept it loyally, and when our new Bishop comes to us, accept him as sent to us by God.

In the absence of Mr. S. M. Robins, who was unavoidably detained by ill health, it was moved by Capt. Dillon, seconded by his Honor, Judge Harrison,—That selection of three names by the Archbishop of Canterbury and of three names, one each by the Bishops of Ontario, Montreal and Toronto, be submitted for ballot at an adjourned meeting of the Synod after Easter of next year; and that such names for election shall be in the hands of each member of the Synod at least thirty days before such meeting takes place.

This motion was ruled "out of order" as being contrary to the provisions of the Canon on Election of a Bishop.

RULES OF PROCEEDURE.

Moved by Rev. Canon Beanlands, seconded by Rev. Canon Good,—That the rules of procedure recommended by the Executive Committee be adopted "en bloc," with an alteration in rule 16, that the words "with their contents" be added after the word "envelopes," and the substitution of the word "before" in place of "after."

Moved in amendment by Rev. G. H. Tovey, seconded by Dr. Praeger,—That the rules be considered clause by clause.

On the vote being taken on the amendment, 20 voted for and 28 against, and the amendment was declared *lost*.

The original motion was put to the Synod and declared *carried*.

THE FOLLOWING RULES ARE RECOMMENDED BY THE EXECUTIVE COMMITTEE TO BE ADOPTED BY THE SYNOD.

4. As soon as the names of the Clergy and Lay Representatives entitled to vote shall be ascertained, the list shall be signed by the Chairman of Synod.

5. All members of the Synod present, shall sign their names in a book provided for that purpose.

6. The Chairman shall appoint Scrutineers to take the ballot, as follows : For the Clergy vote, one Clergyman and one Lay Representative ; for the Lay vote, one Lay Representative and one Clergyman.

7. The list of those entitled to vote shall be handed to the Secretaries, and no one not on that list shall be entitled to vote.

(The Synod shall then adjourn to meet in the Cathedral for the purpose of election at such time as the Synod may appoint.)

PROCEEDINGS IN THE CATHEDRAL.

8. The Synod having been called to order at the hour appointed, the Clergy on the right of the Chair, and the Laity on the left, the Archdeacon will request that a few moments may be devoted to private prayer, and that during the proceedings there shall be no manifestations of feeling, but that all, by quiet and orderly demeanour, shall pay the deepest respect to the solemnity of the sacred duty in which they are engaged.

The voting will then commence, and be conducted according to the following regulations :

9. Votes shall be taken by ballot, and deposited in the boxes provided for that purpose.

10. All ballot papers shall be stamped by the Scrutineers before being delivered to the voters.

11. The list of the Clergy shall be called over by the Clerical Secretary, and the list of the Lay Representatives by the Lay Secretary.

12. During the process of taking the ballot, every person shall keep his seat until his name is called by the Secretary, he shall then approach the Scrutineers table, receive his ballot paper and retire to the table provided for that purpose, when he shall mark his ballot, he shall then return his ballot paper folded with the stamp outside, to the Scrutineers, containing the name of the Clergyman for whom he desires to vote, or if he desires to delegate to any person or body the power of choosing the Bishop, the name of such person or body. The ballot paper shall then be placed by the Scrutineers in the ballot box, and the voter shall return to his seat.

The name of the person voting shall then be marked by the Secretaries of the list as having voted ; all names shall be called in like manner until the list be exhausted.

The Chairman shall then, having first asked, if all members who desire to vote have voted, declare that ballot closed.

13. The Scrutineers shall then retire to the place provided for them, and count the ballots. The Scrutineers shall see that the result corresponds with the number of those voting, as ascertained by the Secretaries from the list marked as aforesaid.

14. The Scrutineers shall be entitled to vote, but their vote must be placed in the ballot box before any one else is called on to vote.

15. The Scrutineers shall hand to the Registrar their report of the result of the ballot, who shall proclaim it to the Synod, at the same time stating the number of Clergy and Lay votes required for an election.

16. The ballot papers shall be placed in an envelope by the Secretaries after every ballot is completed, with the number of the ballot and the initials of the Secretaries placed on the outside, and these envelopes with their contents shall be destroyed by the Secretaries before the final adjournment of the Synod.

17. No nomination of any individual to fill the vacant See, or of any person or body to choose the Bishop, shall be allowed; and after the commencement of the ballot, no speeches shall be made.

18. After the ballot has commenced, no discussion on points of order shall be verbally raised, but any appeal shall be reduced to writing, and presented to the Chairman, whose decision, announced through the Registrar, with the point submitted, shall be final.

19. The Synod shall adjourn from time to time until the ballot is completed.

20. When the balloting is concluded, and election made, or the selection of a Bishop left in the hands of a person or body, the Chairman shall proclaim the result, and declare the Synod adjourned.

The lists of the Clergy and Lay Representatives were then ascertained and given to the Secretaries, and the members signed their names in a book provided for the purpose.

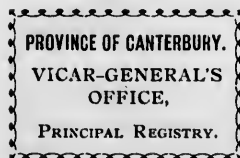

On Saturday, the Twenty-fifth day of March, in the year of our Lord, One Thousand Eight Hundred and Ninety-three, (being the Feast of the Annunciation of the Blessed Virgin Mary) and in the Eleventh year of the Translation of The Right Honourable and Most Reverend Father in God, Edward White, by Divine Providence Lord Archbishop of Canterbury, Primate of all England, and Metropolitan, in the Collegiate Church of Saint Peter, in the City of Westminster.

The said Right Honourable and Most Reverend Father in God, the Lord Archbishop of Canterbury, by virtue and authority of a certain Royal Mandate or Warrant under the Royal Signet or Sign Manual of Her Most Gracious Majesty and Our Sovereign Lady Victoria, by the Grace of God of the United Kingdom of Great Britain and Ireland, Queen Defender of the Faith, to wit : " Victoria Reg., Victoria by the Grace of God of the " United Kingdom of Great Britain and Ireland, Queen Defender " of the Faith : To the Most Reverend Father in God, Edward " White, by Divine Providence Lord Archbishop of Canterbury,

“Primate of all England and Metropolitan, Greeting. Whereas,
 “you the said Archbishop have humbly applied to Us, for Our
 “License by Warrant under our Sign Manual and Signet,
 “authorizing and empowering you to Consecrate Our Trusty
 “and well beloved William Willcox Perrin, Clerk in Holy Orders,
 “Master of Arts, to be a Bishop to the intent that he should
 “exercise his functions in one of Our Possessions abroad. Now
 “it is Our Will and Pleasure and We do by this Our License
 “under Our Sign Manual and Signet, authorize and empower
 “you the said Archbishop to Consecrate the said William Will-
 “cox Perrin to be a Bishop, and We do further authorize and
 “empower you to do, perform and execute all and singular those
 “things which belong to your pastoral office in respect of such
 “Consecration as aforesaid, according to the Laws, Statutes
 “and Canons in this behalf made and provided. Given at Our
 “Court at Osborne House, Isle of Wight, this First day of
 “February, 1893, in the fifty-sixth year of Our Reign. By Her
 “Majesty’s Command.—RIPON.”

(The Right Honourable and Right Reverend Father in God Frederick, Lord Bishop of London, The Right Reverend Fathers in God Daniel Lewis, Lord Bishop of Bangor, Churchill Julius, Bishop of Christ Church (New Zealand), The Right Reverend George Howard Wilkinson, Bishop of Saint Andrew’s Dunkeld and Dunblane (of the Scottish Episcopal Church), The Right Reverend Doctor Adelbert John Robert Anson, late Bishop of Qu’Appelle, and The Right Reverend Doctor John Mitchinson, late Bishop of Barbados, assisting him, the said Lord Archbishop) Consecrated the said Reverend William Willcox Perrin, Master of Arts, now Doctor in Divinity, to be a Bishop, as mentioned in the said Royal Mandate he the said William Willcox Perrin, (now Bishop of British Columbia) having before the Consecration Service taken the Oath of Allegiance to Her Majesty the Queen before the said Archbishop, and in my presence in the following form: “I, William Willcox Perrin, to be Consecrated “a Bishop, Do swear that I will be faithful and bear true “Allegiance to Her Majesty Queen Victoria, Her Heirs and “Successors, according to Law. So help me God. Signed, “W. W. PERRIN.” And the said William Willcox Perrin, having also at the appointed time of the said Consecration Service taken the Oath of due obedience to the said Right Honourable and Most Reverend Father in God The Lord Archbishop of Canterbury, and his Successors for the time being, and to the Metropolitan Church of Christ, Canterbury, in the following form: “In the Name of God, Amen, I, William Willcox Perrin, to be consecrated a Bishop, Do profess and promise all due reverence and obedience to the Archbishop and to the Metro-

litical Church of Christ, Canterbury, and their Successors. So help me God, through Jesus Christ." Signed, "W. W. PERRIN." The rites, circumstances and ceremonies anciently used in the Church of England being observed and applied according to the form and manner prescribed in the Book, intituled, "The Form and manner of making, Ordaining and Consecrating of Bishops, Priests and Deacons," in the presence of me, Sir John Hassard, Knight, Notary Public, Principal Registrar of the Province of Canterbury, there being then and there present the Very Reverend George Granville Bradley, D. D., Dean of the said Collegiate Church, The Reverend George Prothero, M. A., one of the Canons of the said Collegiate Church, The Rev. George Body, D.D., one of the Canons Residentiary of the Cathedral Church of Durham, The Rev. Samuel Flood Jones, M.A., one of the Minor Canons and Precentor of the said Collegiate Church, The Reverend Leonard Jaunsey White-Thomsen, M.A., and The Reverend Hesketh France-Hayhurst, M. A., the last two named being Domestic Chaplains of his said Grace, and Henry Wilmot Lee, Esquire, Secretary of his said Grace, with with many others then and there assembled.

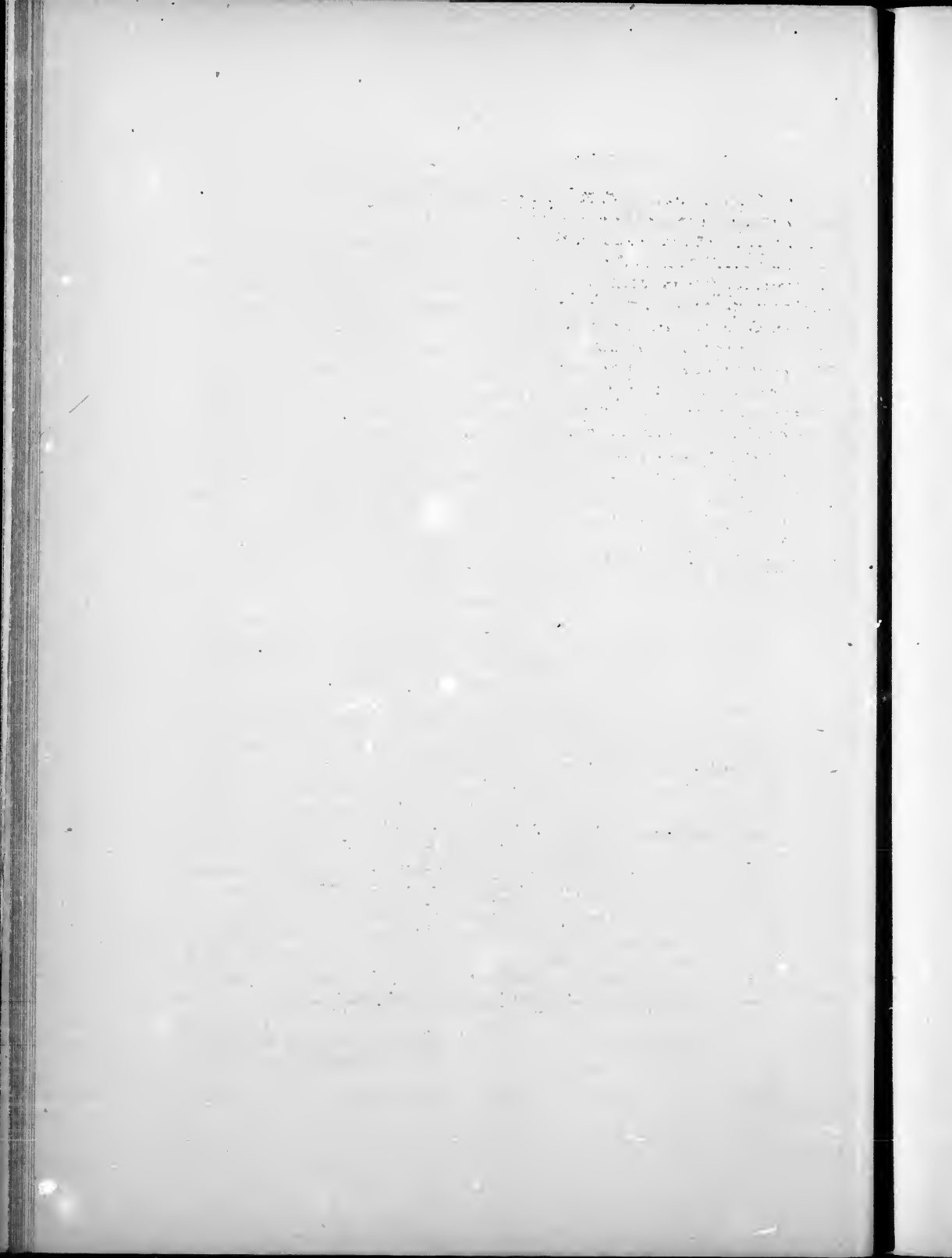

PROCEEDINGS

DIOCESE OF BRITISH COLUMBIA.

THURSDAY, JUNE 29th; 1893.

The Synod assembled on June 29th, 1893.

There were celebrations of the Holy Communion at Christ Church Cathedral at 7.15 a.m., and at 8 a.m. The celebrant at the first service was the Rev. J. B. Hewetson, M. A., and the celebrant at the second service was the Rev. Canon Beanlands, M.A.

The third service was held at the Cathedral at 10 a.m.

The sermon was preached by the Ver A. Scriven, M.A., Archdeacon of Vancouver Island.

The Holy Communion was celebrated by the Lord Bishop of Columbia, assisted by the Ven. A. Scriven, Rev. Canon Beanlands, M.A., and the Rev. Canon Good.

Prior to the service, the Right Rev. William Willcox Perin, D.D., was duly enthroned as Bishop of the Diocese.

SEATS IN SYNOD.

The Bishop invited Rev. A. Schildrick, Rector of Kamloops, Diocese of New Westminster; Rev. G. H. Marwood, M. A., Chaplain of H. M. S. Royal Arthur, and Rev. T. T. Griffiths, M.A., Chaplain of H. M. S. Champion, to seats on the floor of the Synod.

Immediately after the service, the Clergy and Lay Representatives assembled in the Cathedral School, The Lord Bishop presiding, and the Synod was opened by the Ven. Archdeacon Scriven with the appointed office.

Moved by Judge Harrison, seconded by Lt.-Col. Wolfenden,—That Mr. A. J. Weaver Bridgman and Mr. J. Coltart be elected Auditors.—*Carried.*

ELECTION OF MEMBERS OF EXECUTIVE COMMITTEE.

Moved by Rev. G. H. Tovey, seconded by Mr. P. Wollaston,—That in the election of the Clerical and Lay Members of the Executive Committee the election shall be made by the Clergy and Laity respectively.—*Carried.*

A ballot then took place for the required number of eight members for each Order for the Executive Committee. The President appointed Judge Harrison and Lt.-Col. Wolfenden scrutineers for the Clerical ballot, and Rev. G. W. Taylor and Rev. C. E. Sharpe for the Lay ballot.

THREE O'CLOCK P. M.

The Synod re-assembled. The Bishop in the chair.

ADDRESS.

The Bishop delivered his inaugural Address.

My Reverend Brethren, and Brethren of the Laity :

My first words to you must be to express my most sincere thanks for the way in which I have been received in this Diocese. The act of thanksgiving and prayer in the Cathedral upon the evening of my arrival in Victoria, was a fitting prelude to the hearty welcome which I have experienced on all sides during the past month. In addition to the official reception in the Odd Fellows' Hall, I have had the advantage of being personally introduced to a large proportion of the members of the Church at receptions, which have been arranged in the several parishes. This has been a decided help to me in the difficult position in which I find myself called to follow one who was so true a friend to you all, as my revered predecessor.

It would be impertinent of me, comparatively a stranger, to attempt any analysis of the work and character of Bishop Hills, but I cannot refrain from saying, that to my mind, he was an ideal pioneer Bishop. It is impossible to exaggerate the advantage which this Diocese has had in the guidance of his firm hand during the past 33 years. He has indeed borne the burden and heat of the day, and cleared the way for his successor. "He soweth and another reapeth." May he be spared to see here on earth the development and growth of all that was so dear to his heart in this Diocese, in which his name will never be forgotten.

During the interregnum of six months you know better than I can tell you the admirable way in which the Venerable Archdeacon Scriven has administered the affairs of the Diocese, and I shall leave it to one of you to propose that a recognition of his services shall be enrolled upon the minutes of the Synod. I shall never forget the great personal kindness which he has already shown to me, and I am profoundly thankful to have such a fellow-worker in the ministry.

May I also add a single word of my appreciation of the able and careful way in which the Lay Secretary, Mr. Baynes Reed, has put me in possession of the details of the work of the Diocese.

You are aware that one of the last official acts of Bishop Hills was to appoint Canon Beanlands as Rector of Christ Church Cathedral, which gives me the distinct advantage of being set free for a larger amount of general Diocesan work than otherwise I could possibly have hoped to undertake. The parishioners are to be congratulated upon the appointment of one whom they have known for so many years. and whom they can trust.

I have to ask your indulgence for being unable to present to you the usual statistics with regard to the spiritual work of the Diocese during the past year. On the other hand I have been able to grasp with tolerable clearness the financial condition of affairs.

The endowments stand as a monument of the work of the late Bishop, but there is a pressing need of increased subscriptions to the Mission Fund of the Diocese, and I have to ask your most careful attention to the Report that will be presented to-day. The amount collected and subscribed cannot really represent the interest taken in the general work of the Church, and I earnestly trust that a special effort may be made to clear off the present liabilities, and considerably to augment the amount annually collected. The basis and principle of my work will, I hope be that of hearty co-operation with this Synod and its several Committees. With the ever increasing population, new spheres of work must constantly offer themselves, but for the present we must be content to strengthen the existing organizations. With increased support we may be able to secure the help of one or more itinerating Clergymen, who may visit the scattered settlements in the island itself and in the smaller islands with which we are surrounded.

I have been advised that the present would, unfortunately, not be a good time to make a special appeal for funds for the new Cathedral. With the beautiful site, and with the other buildings erected, or soon to be erected in Victoria, it is quite impossible, however, to think that it will be very long before something definite is done.

A very important resolution is to be laid before you with regard to the meeting which will be held (D.V.) in Toronto, in September, to consider the question of the consolidation of the Anglican Church in Canada. I hope that the subject will be fully and carefully debated, and I need hardly say that I shall cheerfully accept whatever decision is adopted by this Synod.

I have no special schemes to-day to set before you for enlarging the borders of the Church ; for deepening the spiritual

life of the people ; for delivering the message of the gospel to the Chinese and Indians in the Diocese. We must all feel that "There remaineth yet very much land to be possessed," (Joshua xiii, 1 ;) and I assure you that it is in my heart and that I realize to the full the great responsibilities of being called upon to have a share in such a work.

Need I add that I hope to be the Bishop of no one particular party in the Church, but to strive to enlist the sympathy and support of all.

May the Holy Spirit of God guide us in our deliberations in this Synod and help us to a truer devotion of ourselves, body, soul and spirit, to the work which has been committed to us, and may we all "grow in grace and in the knowledge of our Lord and Saviour Jesus Christ."

To add the following clause to Section VIII of the Canon on Diocesan Finance: "And also that the Clergyman in

accepting an appointment be guaranteed that sum in the case of an entirely new Mission for two or three years."

Moved by Hon. Mr. Justice Drake, seconded by Judge Harrison,—That hereafter every Clergyman appointed to a Parish or Mission shall be guaranteed his stipend for a period of two years by the Synod.—*Carried.*

SUSPENSION OF RULES OF ORDER.

On motion, duly carried, the Rules of Order were suspended to enable the Reports of Committees to be considered at this sitting of the Synod.

CONSIDERATION OF REPORTS OF COMMITTEES.

REPORT OF THE EXECUTIVE COMMITTEE.

The Executive Committee present the following Report to the First Session of the Sixth Synod of the Diocese :

1. Since the last Report was presented, the resignation of the First Bishop of Columbia, Right Rev. Geo. Hills, D.D., has been accepted by the Archbishop of Canterbury, and the See remained vacant for a period of five months.

The Committee feel bound to place on record their grateful recognition of the value to the Church in this Diocese of His Lordships 33 years of unwearied labours, and their earnest hope that he may be spared to enjoy for many years the rest which those labours have earned for him.

2. The Resignation of Bishop Hills took effect on Nov. 15, 1892, and on the 22nd of that month a Special Synod was held in Victoria for the purpose of electing a successor in the See.

By a unanimous vote of the Clergy and a two-third vote of the Laity, it was decided to delegate the choice of a Bishop to the Archbishop of Canterbury. His Grace accepted the responsibility and appointed Rev. W. W. Perrin, M.A., Oxon, Vicar of St. Luke's, Southampton, who to-day was enthroned in the Cathedral Church as the Second Bishop of British Columbia.

3. The Committee regret to have to report a serious deficiency in the Mission Fund, amounting to one quarter of the sum required to pay the grants for the year ending June 30th, 1893. The cause of this deficiency will be dealt with in the Report of the Mission Board.

4. The arrival of the present Bishop on the 18th of May, is a matter for great thankfulness. At a public reception held in the Odd Fellows' Hall, kindly lent for the occasion, an address was presented to His Lordship by the Committee on behalf of the Synod, and was read by Hon. Mr. Justice Crease.

5. Inasmuch as the next Journal of Synod will contain the full report of the Session held in November for the election of a Bishop, as well as that of the present Session, the Committee recommend that an extra Synod assessment of \$100 be made to meet the expense; and with a view of making more widely known the work of the Synod, they suggest further, that the number of copies printed be raised from 300 to 500.

6. The annual accounts of the Synod, duly audited, will be presented to the Synod.

The Report was read, and on motion of the Lay Secretary, seconded by Lt.-Col. Wolfenden, and duly carried, was adopted.

REPORT OF BOARD OF MISSIONS.

The Board of Missions present the following Report to the First Session of the Sixth Synod of the Diocese.

1. The grants to Missions have been fully paid up to March 31st, 1893, as follows, being for one quarter at the rate of the schedule of the previous year, and for three quarters at the rate of the schedule passed at the last Synod :

2. In paying these grants for the March quarter the Board was obliged to notify the Clergy that there were no funds available for the payments of the grants for the quarter ending June 30th. The Fund being largely overdrawn on the date of 31st March, and the income for the June quarter only just being sufficient to pay the overdraft which amounted to \$1,222.42. It is most urgent that immediate steps be taken to raise the sum of \$987.50, the amount required to pay the grants for the quarter ending 30th June.

3. This failure of the Mission Fund is due, amongst other things, to two chief causes: (a) The present commercial depression which has lasted for a whole year, and has not yet by any means abated; (b) The resignation of our late Bishop and the consequent long vacancy of the See.

4. The Board are glad to be able to report an increase in the number of parishes which have sent contributions to the Mission Fund; but they regret to have to report that there are still one or two congregations which have neglected to make even the collections ordered by the Canon. The Board feel that such conduct is unworthy of parishes professing loyalty to the authority of the Synod, and they cannot recommend the continuance of a Mission Fund grant to any parish so offending.

5. A sub-committee was appointed to consider the schedule for the ensuing year, consisting of the Bishop, The Archdeacon, Mr. Justice Drake, Mr. T. R. Smith, Mr. W. C. Ward and Major Dupont. The sub-committee met, all members being present, except the two last named, and the following schedule was prepared, which the Board amended and recommend for the adoption of the Synod, as follows:

With regard to the parish of Cedar Hill and Lake, the Board do not recommend that any grant be made, in view of the fact that this parish has neglected to make the collections required by the Canons, for the period of eighteen months;

should the Synod however, decide to reinstate the parish upon the payment of all arrears of collections now due, the Board are prepared to recommend a grant of \$500, on condition that the services of a Curate are provided ; such grant, however, only to be paid while such Curate is employed in the parish.

[NOTE.—During the morning's session, \$17.50 was paid in by Rev. M. C. Browne, on account of arrears of collections due from St. Luke's, Cedar Hill.]

The Report was read, and on motion of Ven. A. Scriven, seconded by Lt.-Col. Wolfenden, and duly carried, after considerable discussion was adopted.

At 6.15 the Synod adjourned to meet at 8.

CLERGY WIDOWS' AND ORPHANS' FUND COMMITTEE REPORT.

The Standing Committee of the Clergy Widows' and Orphans' Fund beg to present the following Report :

Seventeen Churches made the required collection on Christmas Day, 1892, amounting to \$259.10; \$1 was also received for arrears of former years, making a total of \$260.10. Since the books were closed, two other congregations have returned their collections, \$16, namely, St. Barnabas', \$11.60; Cedar Districts, \$4.40. \$53.45 was transferred to the Capital Account which now amounts to \$2600.19.

The usual allowance of \$100 was paid to Mrs. Reynard.

The Committee regret to notice that there are some congregations that ignore the Canon of the Widows' and Orphans' Fund, and make no returns whatever of the offertory on Christmas Day.

Moved by Rev Canon Good, seconded by Rev. Canon Paddon,—That the Report be adopted.—*Carried.*

CONSIDERATION OF MOTIONS

No. 2. By Rev. W. H. P. Arden. On formation of Benevolent Society.

After amendment, it was moved by Rev. W. H. P. Arden, seconded by Rev. W. D. Barber,—That the mover be requested to communicate in the name of the Bishop with the other Dioceses of the Dominion as to the advisability of forming an Anglican Benevolent Society under the control of the Church.—*Carried.*

No. 3. By Rev. G. W. Taylor. On sending delegates to the General Synod at Toronto on Church Consolidation.

Moved by Rev. G. W. Taylor, seconded by Rev. W. D. Barber,—

Whereas, at a meeting held at Winnipeg, on the 15th and 16th days of August, 1890, at which all the Dioceses of the Church in Canada (except British Columbia and Caledonia) were represented, a "scheme for the consolidation of the Church of England in British North America," was discussed and adopted;

And Whereas, the Provincial Synod of Canada, at a meeting in September, 1892, agreed to the said scheme with certain verbal alterations;

And Whereas, it is provided by the said scheme that a "General Synod of the Church of England in the Dominion of Canada and the Diocese of Newfoundland" shall be formed, and that a first meeting of such Synod shall be held in the City of Toronto on the second Wednesday in September, 1893;

Be it Resolved, that one Clerical and one Lay Delegate be appointed to represent this Diocese at the said meeting in Toronto, with instructions to report to this Synod at its next session.

The communication from the Provincial Synod of Canada was submitted by the Bishop to the Synod. (See Appendix.)

After a lengthy discussion the resolution was *carried*.

At 10.45 the Synod adjourned until 10.25 to-morrow morning.

SECOND DAY.

FRIDAY, JUNE 30th, 1893.

The Synod assembled at 10.30 a.m., immediately after Divine Service.

The appointed office was said by Rev. Canon Beanlands.

MINUTES.

The minutes of the previous day were read, confirmed and signed by the Chairman.

REPORT OF THE REGISTRAR.

The Lay Secretary in the absence of Mr. Lindley Crease, read the Report of the Registrar, and moved, seconded by Capt. Dillon,—That the Report be adopted.—*Carried*.

Most of the trust deeds to the Synod's property are now transcribed in the Register, and they are all placed in separate envelopes and numbered for reference.

The business of the Synod being finished, the members rose and joined together in singing the *Te Deum*, after which the Lord Bishop pronounced the benediction, and declared the First Session of the Sixth Session of the Diocese of British Columbia to be concluded.

APPENDIX E.

Scheme for the Consolidation of the Church of England in Canada as amended and adopted by the Provincial Synod of Canada at its Session, September, 1892.

[N. B.—The italics represent the new matter introduced into the “Winnipeg Scheme” by the Provincial Synod. In the foot notes the original wording of the scheme is indicated.]

1. CONSTITUTION. There shall be a General Synod consisting of the Bishops of the Church of England in the Dominion of Canada and the Diocese of Newfoundland, and of delegates chosen from the Clergy and the Laity.

The delegates shall be chosen by the several Diocesan Synods according to such rules as they may adopt, or, in a Diocese which has no Synodical organization, may be appointed by the Bishop.

The representation shall be as follows :—Dioceses having fewer than twenty-five licensed Clergymen, one delegate from each order ; Dioceses having twenty-five and fewer than fifty licensed Clergymen, two of each order ; Dioceses having fifty and fewer than one hundred, three of each order ; Dioceses having one hundred licensed Clergymen and upwards, four of each order.

2. TIME AND PLACE OF MEETING. (1) *A General Synod shall meet for the first time in the City of Toronto, on the second Wednesday in September, 1893, and shall be convened by the Metropolitan senior by consecration.*

3. The Synod shall consist of two Houses ; the Bishops constituting the Upper, and the Clergy and Laity together the Lower House.

The Clergy and Laity shall vote by orders if required.

4. The President of the General Synod, who shall be styled the Primate, shall be elected by the House of Bishops from among (2) *their own number.*

The Primate shall hold office for life, or so long as he is Bishop of any Diocese of the General Synod ; nevertheless, he may resign at any time.

5. The General Synod shall have *the* power to deal with all matters affecting in any way the general interests and well-being of the Church within its jurisdiction. Provided, that no Canons or resolutions of a coercive character, or involving penalties or disabilities, shall be operative in any Ecclesiastical Province, or in any Diocese not included in an Ecclesiastical Province until accepted by the Synod of such Province or Diocese, and that the jurisdiction of the General Synod shall not withdraw from the Provincial Synod the right of passing upon any object falling within its jurisdiction at the time of the formation of the General Synod.

The following, or such-like objects, may be suggested as properly coming within the jurisdiction of the General Synod :

(a) Matters of Doctrine, worship, and discipline.

(b) All agencies employed in the carrying on of the (3) *general work of the Church.*

(c) The *general* missionary and educational work of the Church.

(d) The adjustment, *with consent of the Dioceses*, of the relations between Dioceses in respect to Clergy Widows' and Orphans', and Superannuation Funds.

(e) Regulations affecting the transfer of Clergy from one Diocese to another.

(f) Education and training of candidates for Holy Orders.

(g) Constitution and powers of an Appellate Tribunal.

(h) The erection, division or re-arrangement of Provinces (4.)

(i) *To provide for the revision or disallowance by the Supreme Court of Appeal in addition to its other powers, of the Acts or Canons of any Provincial or Diocesan Synod as being ultra vires, on appeal of any Bishop or of one-fourth of the delegates of any Provincial or Diocesan Synod.*

(j) *That nothing in the foregoing scheme or in the Constitution to be framed thereunder shall effect any Canons or enactments of this Provincial Synod in force at the time of the ratification of said Constitution by this Synod.*

6. For the expenses of the Synod, including the necessary travelling expenses of the members, there shall be an annual assessment of the Dioceses, proportioned to their representation, exempting those which (5) *have not more than ten Clergymen.*

7. The words Ecclesiastical Province heretofore used shall mean any group of Dioceses under the jurisdiction of a Provincial Synod.

RESOLUTIONS PASSED BY THE PROVINCIAL SYNOD OF CANADA IN REFERENCE
TO THE SCHEME FOR CONSOLIDATION.

(1) "That it is expedient to unite and consolidate the various branches of the Church of England in British North America."

(2) "That the scheme of Union should not either affirm or disaffirm the necessity for the retention of Provinces under the General Synod; but on the contrary, the retention or abolition of the various Provincial Synods should be left to be dealt with according to the requirements of the various Provinces, as to such Provinces and the Dioceses therein may seem proper."

(3) "That in order to avoid complication, this House accepts the third paragraph of Article 1, but refers to the general meeting at Toronto the question of the advisability of increasing the number of Diocesan representatives of each order."

(4) "This Provincial Synod in assenting to this clause (Article 2) does not thereby surrender any powers or jurisdiction now possessed by it, nor does it intend thereby to take away from or interfere with any rights as to the acceptance of the said amended scheme of Union possessed by the several Diocesan Synods in regard to the formation of such General Synod."

(5) "That the General Conference be requested to incorporate in the constitution of the General Synod a solemn Declaration, corresponding to the Declaration issued by the Bishops and delegates of the Clergy and Laity assembled in the first Provincial Synod of this Ecclesiastical Province, reciting the intention of the General Synod to hold and maintain the Doctrine and Sacraments of Christ as the Lord hath commanded in His Holy Word, and as the Church of England hath received and explained the same in the Book of Common Prayer and Administration of the Sacraments and other Rites and Ceremonies of the Church, according to the use of the Church of England; together with the Psalter or Psalms of David, pointed as they are to be sung or said in Churches; and the Form or Manner of Making, Ordaining and Consecrating of Bishops, Priests and Deacons, and in the Thirty-nine Articles of Religion."

(5) "That the Resolutions and the Scheme now approved by this House as the basis upon which the General Synod may be formed be communicated in due form to the several Diocesan Synods of this Ecclesiastical Province, with the expression of the earnest hope that the said several Synods may be able to accept thereof and, upon the basis so agreed on, send delegates to the meeting to be held in Toronto in September, 1893; and that it should be a further instruction to the said Committee to take such steps as they shall think desirable to acquaint the Province of Rupert's Land and the other Dioceses outside the jurisdiction of this Synod with the action of this Synod in respect of the said scheme."

(1) W. S. "The." (2) W. S. "the Metropolitans." (3) W. S. "Church's." (4) W. S. but the erection, division, or re-arrangement of Dioceses, and the appointment and consecration of Bishops, within a Province, shall be dealt with by the Synod of that Province. (5) W. S. are entitled to send only one representative of each order.
