




The Society has adopted the following by-laws of the Diocesan Church Society of New Brunswick.

CONSTITUTION OF THE SOCIETY.

which shall be binding upon all members of the Society, and shall remain in force until such time as the Bishop shall determine.

The Society shall be called THE DIOCESAN CHURCH SOCIETY OF NEW BRUNSWICK.

No constitution, by-law, rule or regulation of the Society, or any abrogation, repeal, change or alteration of the same, shall be of any force until it shall have been sanctioned and confirmed by the Bishop of, and administering the Diocese for the time being, by writing under his hand.

III.

The payment at any one time of a sum not less than Ten Pounds, shall constitute a Life Member; and the payment annually of any sum, however small, shall constitute the person paying the same a Member of the Society.

IV.

The Society shall have a President, who shall be the Lord Bishop of the Diocese; two or more Vice Presidents, of whom the Archdeacon shall be the first; one or more Treasurers; one or more Secretaries; two Auditors of Accounts; and an Executive Committee of twenty-four Lay Members of the Society, being Life Members of the Society, or Subscribers of at least One Pound to the funds of the Society; who, with the exception of the President and Vice Presidents, shall be annually elected at the Anniversary Meeting.

V.

The Officers of the Society and the Clergy of the Diocese shall be ex officio members of the committee: five to be a quorum, and three of the five Laymen.

VI.

The Society shall embrace the following objects, and none other, viz.:

1. Missionary Visits to places where there is no settled Clergyman, and aid to new and poor Missions.
2. The establishment of Divinity Scholarships at King's College, Fredericton; and assistance, where necessary, to those who may be under preparation for the Ministry, especially Sons of Clergymen.
3. Aid to Sunday and other Schools, in which Church principles are taught, and the training and encouraging of Schoolmasters and Catechists.
4. The supply of Books and Tracts, in strict conformity with the principles of the Established Church.

5. Aid to the building and enlarging of Churches and Chapels.

6. Aid to the building of Parsonage Houses.

7. The creation of a fund towards the augmentation of the stipends of poor Clergymen—towards making a provision for those who may be incapacitated by age or infirmity—and for the widows and orphans of the Clergy—and towards the education of the children of poor Clergymen.

VII.

The Society will employ no Clergyman on Missionary services, without the Bishop's license and appointment; and will submit his choice of Divinity Scholarships to his Lordship's approbation.

VIII.

The Society will circulate no Books which are not in the catalogue of the Society for Promoting Christian Knowledge, except such as the Bishop shall approve.

IX.

It shall be competent to any Member of the Society to limit his subscription to any one or more of the objects above recited, which he may be most anxious to promote.

X.

The Members of the Society in each Mission, or in each Parish of each Mission, at the discretion of the Missionary, shall constitute a Local Committee.

XI.

It shall be competent to each Committee to recommend any of the above recited objects to the special consideration of the General Committee, in the appropriation of the funds of the Society.

XII.

The Society shall hold its Anniversary Meeting at Fredericton and Saint John alternately; at the latter place on the Thursday after third Tuesday in January, and at the former place on the Thursday after the second Tuesday in February in each year.

XIII.

The Committee of each Parish or Mission shall hold an Annual Meeting, on some convenient day, previous to the Anniversary Meeting, when the recommendation to the General Committee of special objects shall be determined upon.

XIV.

Each Local Committee shall be empowered to depute two of its Lay Members, to be elected at the Annual Meeting of the Committee, to assist the Missionary in submitting the recommendations of the Committee to the consideration of the General Committee.

XV.

For this purpose the Missionaries and Lay Deputies shall meet in General Committee on the two days, or more if need be, previous to the Anniversary Meeting, to make the annual appropriation of the funds of the Society.

XVI.

The Executive Committee shall meet either at Fredericton or Saint John, on the first Wednesday in January, on the day after the Annual Meeting, on the first Wednesday in March, on the first Wednesday in June, and on the Wednesday after the first Tuesday in October.

XVII.

The Clergy are requested to preach annually two Sermons in their respective Churches, with a Collection on each occasion for the General Purposes of the Society.

Read Reports and Returns from the several Local Committees, of which the following is an abstract:

SAINT ANDREWS.—The Rev. Dr. Alley reports that the Local Committee held their meeting on the 18th December, and with much regret that the contributions are smaller this year than in former years, owing to the almost general distress in money matters, forwards contributions to the amount of £16 5s. 8d. and collections at Sermons to £3 16s. 9d.; making a total of £20 9s. 5d. J. W. Chandler, and G. D. Street, Esquires, were appointed the Lay Deputies to the General Committee.

CHATHAM.—The Rev. Samuel Bacon states, on behalf of the Chatham Local Committee, that they view with great satisfaction the continued prosperity of the Society, which cannot, they think, be estimated too highly or supported too warmly by every one. Thanking the Society for the grants made at different times towards their Lending Library, they express their regret that their contributions fall a little short of those of the last year. They are as follows: Missionary Visits, £13; General Purposes, £2; Collections at Sermon, £12 5s. 8d. Total, £27 5s. 8d. The Lay Deputies are J. A. Street and William Wright, Esquires.

KINOSUELA.—Rev. J. Black reports contributions to the amount of £10. 19s. 3d., and collections at Sermons to that of £3 5s. 2d.; making a total of £14 4s. 5d., and states that Thomas S. Wetmore, Esquire, M. D., is appointed Lay Deputy.

MONTREAL.—Rev. W. N. Bowyer reports that the contributions for the general purposes of the Society amount to £2, and the collection at a Sermon, to 16s. 8d. The smallness of the contributions being owing to the inability of the people to do more at present; at the same time he hopes that next year he may be able to send a larger sum. He states that B. Botsford, Esquire, and Leb. Botsford, Esquire, M. D., were appointed the Lay Deputies.

GRAND MANAN.—Rev. G. T. Carey states that he has forwarded contributions to the Lord Bishop for the general purposes of the Society, which amount to £2 5s. 7d., which has been paid into the Treasurer's hands. He has also subsequently forwarded collections to the amount of £1 9s. 8d.

**EXTRACTS FROM THE MINUTES OF THE
EXECUTIVE COMMITTEE.**

Fredericton, June 7th, 1848.

Read the minutes of the last Meeting of this Committee.

The Report of the Loan Committee having been read—On motion,
Resolved, That the same be received, and entered upon the Minutes.

REPORT OF THE LOAN COMMITTEE.

In pursuance of the powers vested in the undersigned by the foregoing Resolutions, they have had the matters referred to, under their consideration, and beg leave to report:

First. That they have instructed the Treasurer to call upon the persons to whom the funds of the Society have been loaned, to repay with interest immediately on the same becoming due, to the Treasurer of the Society; and in case of the borrowers wishing to continue their loans, to give unexceptionable landed security for the same, with power of sale: which the Treasurer has promised to do without delay.

Secondly. The undersigned beg leave to suggest the following scheme for loaning the monies of the Society, so long as the Society remains unincorporated, viz.: that a Loan Committee of three persons be appointed, Members of the Church Society, whose duty it shall be to loan all monies of the Society, from time to time directed to be appropriated in that way.

Thirdly. That such Committee loan the said monies in their joint names, by bond and mortgage, with power of sale in case of default of payment of interest or principal, agreeably to the terms of the loan.

Fourthly. That the securities thus taken for the monies loaned, be in the names of such Committee as Trustees of the said Church Society, payable to them and the survivors of them, and the heirs and assigns of such survivors, as such Trustees as aforesaid, with a covenant in each mortgage to the Bishop of the Diocese for the time being by the said Trustees, in behalf of themselves and the survivors of them, and the heirs and assigns of such survivors, that they or the survivors of them, or the heirs and assigns of such survivors, do and shall hold such bonds and mortgages, and all monies received thereunder, for the sole use and benefit of the said Society, and subject to such orders and directions of the said Society as shall from time to time be made by the Society or the Executive Committee thereof, and agreeably to the Rules and Constitution of the said Society for the time being; and

further, that when and so soon as the said Society shall be incorporated (should the same at any future time be incorporated) by Act of Assembly, by Royal Charter, or other means, that they the said Trustees, their survivors, and the heirs and assigns of such survivors, shall and will immediately, on being so directed by the Corporation, transfer the said mortgages and securities, and all monies that shall be in their hands, to the said Corporation, or to such purposes as the said Corporation shall direct.

Fifthly. That a Solicitor to the Society be appointed, whose duty it shall be to see that the Securities for the monies to be loaned, be properly and legally drawn up, and taken agreeably to the plan or scheme agreed upon by the Executive Committee.

Sixthly. That one of the conditions of all loans by the Society shall be, that the Borrower shall pay all the professional expenses incurred in preparing the securities for the loan.

The undersigned also beg leave to report, that after giving the respective applications of J. F. W. Winslow for a loan of £100, Thomas Wright for £70, and the Carleton Corporation for £400, full consideration, recommend that Mr. Winslow's application be complied with. But the Committee cannot recommend compliance with that of Mr. Wright upon the security offered; nor the application of the Carleton Corporation, for the following reasons: 1st. That the security offered is in part, upon Glebe lands and in part upon lands belonging to the Corporation of St. George's Church, Carleton; that in respect to the Glebe property, the Committee are of opinion that the Corporation have no power to incumber that property beyond the incumbency of the present Rector, that the Glebe would not be bound by such incumbrance in the hands of his successor. 2d. That the Committee doubt the legality or even propriety under any circumstances of loaning money upon the Church Corporation property, especially for a large sum, inasmuch as the parties composing such Corporation cannot be personally bound: it must be therefore merely Corporation property to which the Society can look for repayment of the interest or principal; and to proceed to extremities against Church Corporation property in case of need would be invidious, and might not only be injurious to the Society but to the Church.

THE BISHOP takes this opportunity of suggesting to the Clergy, that as much difficulty has been found in sending the winter collection for the Church Society, in time to be inserted in the Report read at the Annual Meeting, he thinks it might be desirable to preach the two Sermons in behalf of the Society, in the early part of June and in the middle or latter part of October, by which means the contributions made each year would be kept perfectly distinct. Should this arrangement be found to be attended with unforeseen inconvenience, it may be altered hereafter; but the Bishop thinks it quite worth while to make the trial for this year. The Bishop desires to impress on the minds of all the Clergy, especially on those whose Parishes are largely assisted by the benevolence of the Church Society, the duty of exerting themselves to promote its objects, for its grants have always been given to meet and call forth local resources. There can be no parish possessing a resident Pastor, where by a little exertion, a local Committee may not be formed, and some contributions obtained.
