#### G. S. read his report.

Bedford, 9th Jan. 1867.

To the G. W. P. Officers and Brothers, of G. D. S. of T. of C.E. Worthy Brothers:—

By the merciful providence of a most gracious God, we are once more permitted to assemble in Annual Session to deliberate on matters tending to the promotion of the cause of Temperance, and the good of our common humanity. May He guite as in all our deliberations.

I regret that \( \frac{1}{2} \) m under the necessity of reiterating my complaint as to the irregularity, I may say increased irregularity, of Subordinate Divisions in making their Quarterly Returns to this office. Out of thirty divisions supposed to be in working order, only 22 have reported for quarter ending 30th of September last, and only 7 for December quarter. This renders it impossible for me to lay before you such statistics as would enable you to form a correct opinion of the condition of the Order in the jurisdiction.

From a retrospect of the Returns for the past four years it will be seen that the Order in the jurisdiction has not been progressive, but rather retrogade. This should not be, and I am convinced that, were a Lecturer or Agent kept constantly in the field, our membership would at least be doubled in the course of two years. It is, therefore, in my opinion, obviously the duty of this Grand Division to devise means for the employment of such Agent, either by levying an additional per cap. tax, say 2 or 3 cents per quarter, or by voluntary contributions from the members or both. I would also recommend that a By-law be passed imposing an initiation fee and annual dues on members of the Grand Division.

There are herewith laid before the Grand Division, two circular communications from the M.W.P., as follows:—

To the Grand Division Sons of Temperance of C. E.

Allow me to present to you a few words of encouragement and recommendation.

The cause in which we are engaged demands of us unceasing effort, and determined, persistent agitation. The "Great Destroyer" never slumbers nor sleeps, but pursues his victims with unceasing relentlessness and with destructive results. The Order of the Sons of Temperance, for twenty-four years, has resisted the "Destroyer of Millious," with a compact organization and with combined efforts. It has carried light and comfort and happiness to households on two continents, saved tens of thousands from a drunkard's grave, and distributed its blessings among hundreds of thousands more. It is now rapidly spreading over the land, still blessing and to bless.

Having kept pace with the demands of the age, it to-day presents an unbroken front to the "enemies of our people," and is eminently adapted to help carry forward our cause to the final triumph. In the States and Provinces where it has its strong foothold, it is constantly increasing in numbers and efficiency. It recognizes the moral and religious element of society and seeks to aid the Church in the great reformation. The attention of the Clercy has been turned to the Order in many places, and finding it an efficient helper, they have rejoiced at and aided in its progress. Many of our most successful and influential Divines are found in our Division rooms and in the higher courts of our Order, exerting a most salutary influence among their associates, and receiving encouragement for their more immediate work. Probably there has been no time during many years past when there was so much encouragement for effort as now. People are ready to listen to the voice of reason, and are easily induced to cast their influence in favor of Temperance and to become connected with our brotherhood. Shall we not improve the opportunity, and seek to extend, as widely as possible, the influence and the organization of the Sons of Temperance?

The recommendations to which I would invite the attention of Grand Divisions and Members of the Order everywhere, are—

1. That lecturers be sent out and supported by Grand and Subordinate Divisions, to awaken the public mind and arouse the community to united effort in the cause of Temperance, to circulate the Pledge and sound Temperance literature, to disseminate the principles and extend the knowledge of our Order, and to organize new Divisions in places where no Temperance organization exists.

2. That the different States, Provinces, and Grand jurisdictions be divided into convenient districts, so that a number of Divisions may meet in open delegative Convention, to receive reports from the various towns, devise agressive measures to carry on the warfare, discuss the moral, legal, schentific, financial, and religious bearings of the subject, and organize in the various localities for public meetings and lectures, and for the formation of new Divisions.

Let us then, all, consecrate ourselves anew to work, help fill up the ranks and push on the column. Invite the ladies to come every night to our Divi-

Read Resolution of Howard Division.

Howard Division Rooms, Montreal, C.E., January 3, 1867.

"Whereas, the members of this Division have contributed largely to the support of a lecturer, feeling as they do, the necessity of an Agent to represent our cause throughout this Province, and

Resolved, that we feel unwilling to pledge ourselves hereafter to contribute an unequal proportion of the funds necessary for the support of a lecturer, but we are ready at all times to furnish our just share in common with the other Subordinate Divisions.

Resolved, further, that we would strongly recommend the adoption of a law for an Initiation Fee in the Grand Division.

Resolved that our Delegates to the Grand Division of C. E. be requested to submit these Resolutions at the next Annual Session in Bedford, for their consideration.

Referred to Good and Welfare Committee.

Lecture Committee reported as follows:

Montreal, January 5th, 1867.

Grand Worthy Patriarch, Officers and Brothers of the Grand Division of C. E. Brothers,

Your Committee to whom was entrusted the matter of engaging a suitable person to represent our Order in Lower Canada, as Agent and Lecturer, herewith present their Report.

Having made an effort to secure the services of Bro. Manning, without success, as it was impossible for him to withdraw from the engagement he had already made as a minister of the Gospel at St. Andrew's, and having the good fortune to find Bro. Hutchings, open to an engagement, we made an arrangement with him, to travel through Lower Canada, as a Lecturer and Agent of the S. of T. during the space of three months, for the sum of two hundred dollars; and at the expiration of this time, a subsequent arrangement was made with him to continue his labors another Month, for the sum of fifty dollars.

His first meeting was held at Lacolle on the eighteenth day of May last, under very favourable auspices, a large number being present, who contributed generously towards the Lecture Fund.

The last meeting was held at the same place (Lacolle.) on the 28th of Sept. last, nearly as many being present as at the first meeting, and the receipts were nearly as large as on the first occasion.

During the whole period of his engagement, your Committee believe that Bro. Hutchings labored faithfully and assiduously for the advancement of the cause of Temperance, and especially for the furtherance of the interests of our Order. He sent your Committee from time to time, reports of the progress he was making, together with financial statements of his receipts and expenditures, the substance we have gathered together, and now present to you.

During the four months he held in all fifty-six meetings, being an average of three a week, and the total strendance at all these meetings was 3 115, being an average of fifty-six at each meeting. The best attendance was 115, being an average of fifty-six at each of meeting. The best attendance was Bedford, Lacolle, West Brome, Adamsville, Covey Hill, Howick and Durham, at each of which about one hundred were present. The smallest attendance was sat Farnham, Athelstan, Chrysostome, Leeds and Stukely, at each of which only about twenty-five were present. The largest collections were as follows, Lennoxville, \$4.68; Lacolle, first meeting \$4.00 second meeting \$3.05; (total \$7.05); Bedford, \$2.69; Dunham \$2.05; Weet Brome \$2.16; East Farnham, \$2.85, Knowlton. (2 meetings) \$3.40; Mag g, \$2.02; Massawippi \$3 62; Marlow \$2.21; Granby, \$2.57; Adamsville, \$2.50; St. Andrews, \$2.45; Covey Hill, (two meetings) \$3.205; Athelston (two meetings) \$3.79; Huntindon, \$2.04; Howick, \$3.60; Inverness, \$2.80; Danville, \$2.14; Durham, \$2.25. The above are the only collections made by our agent amounting to two dollars and upwards. The smallest collections were at North Gore, 38c; and at Farnham Centre, 124c.

The last Tour was made from Farmann Centre to Lacolle, Sept. 18th to 28th during very inclement weather, so that no meetings were held at West Brome, Sutton Flats or Brome Corners, at which places it was the intention of our agent to lecture. The Receipts during the last trip were only \$4.60 while the expenditure amounted to \$9.11.

The total amount of collections made by Mr. Hutchings was \$127.28 and the total expenses \$64.37; leaving a net balance of \$62.91; towards the liquidation of his salary.

Montreal, January 7th, 1867.

To the G. W. P. Officers and Brothers of the G. D. S. of T. of C.E.

We, your Committee, to whom were entrusted the arrangements for the reception and entertainment of the National Division of North America, at the Session held in Montreal, in June last, beg to report :-

That the aforesaid Session duly took place in said City, and that we exerted ourselves as much as possible to give them a reception worthy of our Province and as suitable as possible. We made arrangements for their accommodation at reduced rates at the St. Lawrence Hall and several private Boarding Houses; billeted such as we could find accommodation for, and did all in our power as far as our means would permit, to render their stay among us pleasant. The festival held in their honour was a complete success, and they enjoyed much the drive that we gave them round the mountain, especially as on our return George Winks, Esq., entertained the whole party at his residence, after which a Photograph of the party was taken in front of his residence by our Brother Martin, many copies of which were bought by the brethren, and one of which handsomely framed we presented to George Winks, Esq. Bedford, C.E. January 9th, 1867.

To the Grand Division S. of T. of C. E. Brothers,

By the merciful dispensation of our Heavenly Father we are again permitted to assemble in this our Annual Session of the Grand Division of Canada East, to deliberate on the means best adapted to promote the objects for which we are associated.

Since our last session nothing particularly encouraging has occurred with regard to the Remperance movement in our jurisdiction. The Temperance Act of 1864 has been adopted by many municipalities, but it does not seem to have the desired effect. Temperance men seem to depend too much on the law without making any exertion to carry it out, the consequence is that in many places where the law was adopted it has not been enforced, and there is no diminution in the use or traffic, but rather an increase of places where intoxicating liquors are sold.

The state of our Order in Canada East is not so encouraging as we would desire. The reports furnished me by my Depities indicate a state of apathy in the ranks in many localities; the members not being punctual in their attendance at the Division, the consequence is that in many cases the Divisions are unable to meet regularly. (This should not be the case.) Every Brother should feel that the prosperity of our Order in a measure depends on himself, and that he is occupying a responsible position, in that case they will seldom be absent from the meeting of their Division.

Like all great reforms the Temperance Cause has its time of elation and depression, of great success and apparent want of success; and I feel that we are too apt to be deceived by these appearances, either into a spirit of over confidence, or of undue discouragement. The great lesson which the earnest advocate of this or of any other great movement for the amelioration of the condition of the human race has to learn, is that of steady perseverance under all circumstances, and however, we may regret the fact, there is no concealing it, that the present is a period of depression in the Temperance movement, and that its practical influence upon the community is perhaps as little felt as during any time since the introduction of our Order into this country; but this is no reason why the true friends of Temperance should fold their arms and give up all for lost; they should rather buckle on their armour tighter and go into the great battle with a determination to conquer the worst enemy of our race. Let every Son of Temperance set himself to work to save drunkards and to impress the principles of total abstinence upon the young; and under the blessing of our Great Patriarch above, we may yet see the cause revive and its influence become greater and more permanently established in the community than it has ever yet been.

I think if this Grand Division could devise any way of raising funds to employ an efficient Lecturer during the winter, much good might be done, and our Order largely increased, I hope this subject will receive your serious consideration.

You will likewise be called upon to legislate in reference to the admission of Ladies to full membership in the Order, as the National Division at its last Session has left the matter in the hands of each Grand Division to do as they think best in their several jurisdictions. For my part I think if they were admitted to membership it would give our Order a fresh impetus and we would have many accessions to our ranks.

As to the financial condition of the Order, and other particulars, I would refer you to the Report of the Grand Scribe.

In closing this my final report, I would tender to the members of the Grand Division my thanks for their forbearance in my many imperfections, and hoping that you may elect some far more worthy Brother as my successor, and that our Order may go on and prosper until drunkenness shall no more be known in the country.

In considering the Report of G. S., we are sorry to note the same negligence on the part of subordinate Divisions to send in returns that is complained of in the Report of G. W. P., and trust that the W. P., R. S., and Deputy of each subordinate Division will assume the task of stimulating each other to a performance of their duties.

It is a cause for great mortification on our part that continued dissentions disturb the harmony of some of the Divisions, and we do sincerely hope that we have heard the last discordant note of complaint from any quarter whatever; and that all present differences will be presently adjusted to the full

satisfaction of all concerned.

In regard to the Report of Lecture Committee, it seems that as great difficulty attends the collection of the money that is subscribed, and which is necessary to carry out the design we have in view, we would respectfully suggest that for the present we discontinue the employment of a Lecturer, but trust that at an early date we shall be able to resume the engagement of an agent, when we are in a financial position to enable us to pay him when his salary is due. We hope that the balance now due Bro. Hutchings will be made up at once and we would call on those Brothers who have subscribed and have not paid, to come forward without delay.

We would recommend in case this Grand Division decides to allow subordinate Divisions the right to admit ladies to full membership, that they instruct such subordinate Divisions to adopt the views of the M. W. P., as contained in his circular to the G. S., or such parts thereof as may be applicable; and for that purpose we would suggest that the G. S., issue duplicates of this circular to the W. P's of each Division, as soon as the decision to

admit ladies to membership is made.

We would also recommend that the per. Capita Tax be increased to ten cents per quarter, the additional three cents over the amount fixed for last year, to be applied towards the Fund for defraying the expenses and paying

the salary of a Lecturer.
