Complains to House that Standard Published Mr. Murchie's Affidavit in Extenso and Did Not

Fredericton, April 23 .- The charges against Mr. Speaker Currie were brought vividly to the minds of members at the opening of the House this afternoon. When the formal procession entered, headed by the Sergeant at Arms, it was noticed that the Speaker was not in his place, Mr. C. M. Leger of Westmorland, who has acceptably filled the position of deputy Speaker, being temporarily elevated to the more important office. Mr. Leger presided during the afternoon and evening sessions, Hon. John Burchill, an ex-Speaker of the House, being called upon to tale the duties of deputy Speaker and chairman of the committee of the whole.

But this was not the only reminder of the Currie case given to the members. Mr. Arthur T. LeBlanc, Mr. Currie's colleague from Restigouche, arose to a question of privilege. In his hand he held a copy of this morning's Standard and with his usual voluability he proceeded to complain that while The Standard had published the affidavit of Mr. Murchie in extenso it had not given equal prominence to the affidavits of Mr. Currie and Mr. Richards.

Mr. LeBlanc said he had no complaint to make with the headings published over The Standard's account of the Currie matter or with the text of the article following those headlines, but he did not think it was fair that Mr. Murchie's affidavit should be published in full while all The Standard had stated concerning Mr. Currie was that an affidavit from him had made a general denial of the charges and that an affidavit from Mr. D. Losses Have Been Heavy, but Allies Have Inflicted Heavier, and Have Gained More than Million ENEMY RECEIVES A Men in Consequence of German Offensive -Moral Effects of Attack All on Entente Side.

London, April 23.-More than one million soldiers in addition to those who would otherwise be in the field against Germany, have been gained by the Allies in consequence of the German offensive, Winston Spencer Churchill, Minister of Munitions, said today in an address to the American labor delegation which is visiting England.

"So far as moral effects are concerned," he said , "all that the Germans have achieved by the battle has been an increase in the closer consolidation of the forces fighting against them. By their attack they have called into the field against them in this campaign alone more than one million soldiers additional to those who would otherwise have been there.






