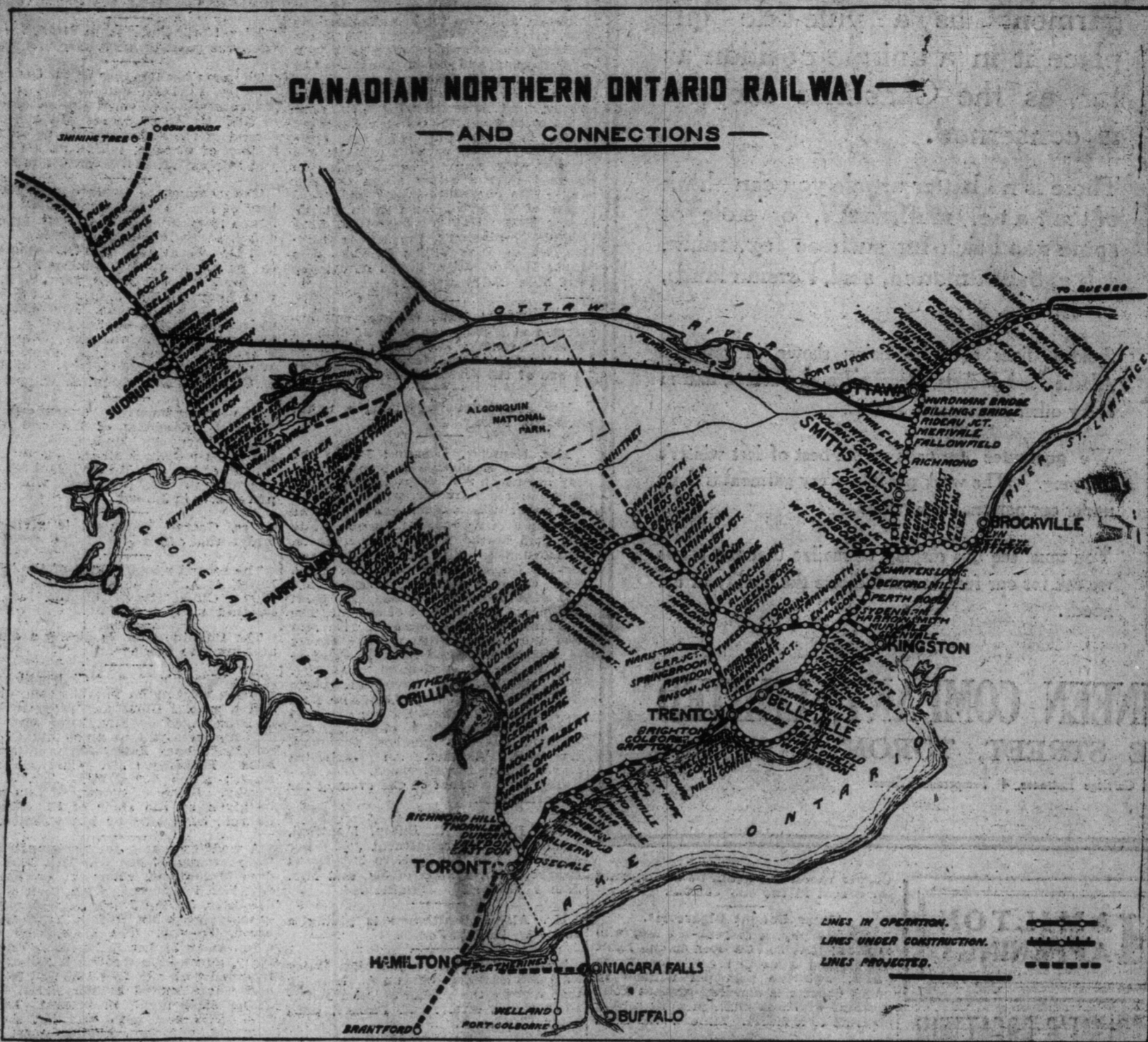

TORONTO'S TRANSCONTINENTAL ROAD



How the Canadian Northern is imposing itself on Ontario.

The above map, recently prepared by the Canadian Northern, shows the ambitious plan of that system in Ontario. It has sprung suddenly into existence and almost overnight. The great Ontario triangle has for corners Toronto, Sudbury, Ottawa. The company itself built from Toronto to Sudbury, and it is now building to Ottawa from Toronto—most of it is done. It has acquired all the included lines set out in the map, north of Trenton. It has also bought from Deseronto to Sydenham. It is rushing a link from Sydenham to Brockville Junction, where it owns a line to Brockville. It has a right of way into Kingston. It is also rushing construction from Brockville Junction to Ottawa. A few months will complete the line to Ottawa, and thereby the south side of the triangle. It has a line now running from Ottawa to Montreal.

The north leg of the triangle, from Sudbury to Ottawa, is to be started almost immediately. It is financed and the contracts let. This is the seaboard line, and it will be connected with Georgian Bay and west boats to Port Arthur. This will give it a quick and direct wheat line: for a couple of years the wheat will have to come by Key Harbor and Toronto to Montreal. But the ambition of the executive is to finish the north leg of the triangle and to connect Sudbury with Port Arthur. The contractors are pushing this 200 miles also. This will make a great and profitable system, both from a local and a continental standpoint. Then the filling in will be taken up, and especially lines extending from Toronto into all the peninsula of Western Ontario from Toronto to Hamilton, Niagara River, Detroit to Buffalo.

INDIA'S RULERS ARE PROCLAIMED

Ceremonials at Delhi—Carried Out With Impressive Pomp and Dignity—King's Generous Gift.

DELHI, Dec. 12.—(Can. Press)—King George V. and consort, Queen Mary, were proclaimed Emperor and Empress of India today. The extraordinary act of the monarch's accession to the throne of his vast Indian dominions took place amid a scene which for richness of color and magnificence of decorations has probably never been surpassed in modern times.

The huge amphitheatre, which had been erected in the Durbar camp was thronged with people from an early hour. The bright tissues and sparkling gems of the many Indian princes and the smart uniforms of the soldiers contrasted strongly with the white dress of the European ladies and the sober garb of civilian officials.

Four of a Kind Beat Adolph

Contractor Contracts Quadruple Sheaf of H. B. Woods—Court Will Deal Two Times More.

Famous Women Suffrage Orator Completely Captures Audience

Mrs. Emmeline Pankhurst at Massey Hall Enthralls and Convinces Men by Simple, Direct and Unanswerable Arguments.

Mrs. Emmeline Pankhurst once more enthralled a large Toronto audience when she spoke last night in Massey Hall for an hour and a half on the suffrage movement in England. There were 1000 people present and the applause was frequent and hearty, which showed the appreciation with which her lucid and logical remarks were received.

Mrs. Pankhurst is in fact a notable speaker. Without indulging in flights of oratory, she has the power of marshalling her facts in irresistible sequence; of making her points clear to the last degree; of maintaining an impregnable front of reasonable and moderate, but tremendously impressive statement.

Anti-suffragists simply decline to go to hear her, or if they do, succumb to the force of reason. Where they lack reason there is nothing more to be said. One of these gentlemen arose after the lecture last night and in the authoritative accents of dogmatic limitation, gave utterance to the fatuous message: "It never was intended that women should be the equal of men." The audience laughed hugely. Another gentleman, who had been in co-operation with a distillery, kept up a frequent disturbance. "The men are heartily ashamed of their one representative," remarked Mrs. Pankhurst on one occasion.

Women in England. She was perhaps most intensely interesting in her explanation of the present political situation in Great Britain as it is affected by woman suffrage and as suffrage affects it. She had arranged to come away from England, she said, with the impression that there would be no autumn session of parliament. It was a shock to her to discover that parliament was to meet, but a further piece of treachery, as she described it, was found when Mr. Lloyd-George declared that the facilities which had been promised to the suffrage bill were declared to belong to all bills. A second pledge was then sought and obtained from Premier Asquith that it was to be the "Reconciliation" bill the facilities were to be extended in letter and spirit. But on top of this came the announcement that next year Premier Asquith intended to introduce a manhood suffrage bill, and he absolutely declined to admit women to the benefit of its measures.

What would men think, asked Mrs. Pankhurst, if after fifty years agitation and six years of sacrifice, they were refused admission to their natural rights? Premier Asquith declared to a deputation which he had finally consented to receive, that he was opposed to woman suffrage, but if they could get a private member to propose an amendment to the manhood bill, to include women, and the house of commons carried it, he would not oppose it. This said Mrs. Pankhurst, was so obviously absurd a proposal, that no one could be deceived by it.

Lords Reject Naval Prize Bill "Declaration of London" Held Up

LONDON, Dec. 12.—(Can. Press.)—The house of lords to-night rejected the naval prize bill by a vote of 145 to 33. The Earl of Selborne, in moving the rejection, objected to the constitution of the proposed international prize court, pointing out that it gave the United Empire only the same representation as that accorded to petty Central American republics. Furthermore, he said, the bill permitted an appeal from the British Privy Council to the prize court, but no corresponding appeal from the United States Supreme Court, the representatives of the United States having discovered that under their constitution it is impossible to carry an appeal from their supreme court to any international tribunal. It was, therefore, possible, Lord Selborne argued, to get two sets of conflicting judgments.

HONORED DUKE IN MONTREAL

Rain and Mud Didn't Prevent Loyal Welcome on Part of Citizens—Degrees Conferred.

MONTREAL, Dec. 12.—(Can. Press.)—Their royal highnesses, the Duke and Duchess of Connaught and Princess Patricia of Connaught, arrived in Montreal at three o'clock this afternoon for a visit which will extend over four days.

Immediately on their arrival they were driven to the city hall where the civic address of welcome was read, together with loyal addresses from the British Army and Navy Veterans and the Canadian Army Veterans. The royal party then drove to Royal Victoria College, where a special convocation of McGill University was held and the honorary degree of LL.D. conferred upon their royal highnesses.

ARISTOCRACY OF LIVE STOCK MAKING GUELPH REAL MECCA

Horses and Poultry Are Also Features That Surpass Exhibitions of Other Years—Sheep Offer Keen Competition—Bad Roads May Affect Local Attendance.

GUELPH, Dec. 12.—(Special.)—This was the opening day of the provincial winter fair, and there was a large crowd in attendance. The horse ring was a big attraction, and all available space was occupied by those anxious to see the best exhibition of horses yet shown at the winter fair.

The heavy draught horses are exceptionally fine and some of the judges say a better collection has never been brought together in Canada. Another great feature of the fair is the poultry show, with over five thousand entries. The competition in sheep is very keen, there being about five hundred entries, many of which captured prizes at the Chicago International Show last week. The dairy test of milk cows was concluded last night. There were sixty entries in this class, about twenty more than last year. There were no Jersey entries.

MAKE TORONTO AN OCEAN PORT

Ministers Give Promise of Immediate Federal Improvement to Harbor—City Will Get Full Justice.

Prosperity in the way of an improved harbor and better public buildings will smile on Toronto in the near future if Hon. F. D. Monk, minister of public works for the Dominion, and Hon. J. D. Hasen, minister of marine and fisheries, have their way at Ottawa. So they promised in speeches delivered before the city council and representatives of various bodies interested in civic affairs at a luncheon tendered them in the King Edward Hotel yesterday afternoon.

Said Hon. Mr. Monk: "I do not believe we have, in the past, done justice to the development of the ports and harbor of Canada. I believe that the present government could not set itself to a more patriotic or more praiseworthy task than the equipping of the harbors and the developing of the ports of this Dominion and by so doing coping with the transportation problem. Among these ports surely none has greater claim to the consideration of the government than the harbor of Toronto. It seems to us that we should give every possible consideration to the claims of Toronto, not only with respect to the development of the harbor, but to the other claims of this city as well. Toronto has contributed most largely, most generously to the federal exchequer. If the buildings of Toronto are in the condition which has been made known to us it becomes our duty without delay and in justice to the Queen City to see that the buildings are placed

THE NEW FAUST.

Ontario politics consist, very largely, in trying to make things appear other than they are. Every now and again the people wake up, and see the facts.

The secret of Sir James Whitney's success has been his straightforward honesty. When he was returned in 1905 with a majority of 45 he was an unknown quantity, and the people were merely concerned to turn out the corrupt aggregation which had been in power.

Even that did not convince The Globe that new methods were necessary, and that the old crooked methods did not appeal to the people. The Globe and its comrades have urged and raved for several weeks, and tried to make it appear that Sir James government was the most ineffective and corrupt that could be imagined.

In fact the Liberal party has no higher standard, no more encouraging word for its people, than the assurance that some day the Whitney government will go rotten, and then the Liberals will be found to be less vicious than the Conservatives. The Conservatives have not yet proved themselves vicious in office.

It is all very well to elect Mr. Rowell, but Mr. MacKay is also elected with "a sweeping endorsement," which The Star declares is "a source of great satisfaction to Liberals." Why, then, was Mr. MacKay deposed from leadership, and what will Mr. Rowell do with Mr. MacKay when he begins to lead the ex-leader? If Mr. Rowell is in perfect agreement with Mr. MacKay, the people have rejected his policy. If Mr. Rowell does not agree with Mr. MacKay, what will become of the house divided against itself?

of the first things done by the new government should have been to make a public intimation that anything in the way of stock watering would be against the policy of the government; and even if it were done under an order in council of a previous government, that reprisals would follow.

The World believes that the Dominion Government would be justified in now putting its veto on this issue and in intimating to the Canadian Pacific that if it were not withdrawn some kind of reprisals—and the government of the day is all powerful if it cares to find a way—would result.

The people wonder why socialism spreads. Stock manipulation is one of the reasons, and it is all set out in an open letter distributed among members of parliament the other day. The letter asks all socialists to subscribe to a certain publication that is to champion their cause.

Its organization, the letter states, was a scandal about which there was a great outcry at the time. It was capitalized at \$13,000,000, with \$2,000,000 of other liabilities, while the assets are stated at \$18,000,000, including land, machinery, shares in other companies and goodwill.

The government is responsible for everything that transpires, and one placed by the open letter directly on

the shoulders of parliament that permits companies to be overcapitalized by the issue of watered stock. That permission it was which has brought the Dominion Textile Co. into existence and created the conditions which have destroyed the right of the workers to a living wage, in order that dividends may be paid on stock that should never have been issued.

How has this change that has already occurred been brought about? How is the general change that there is reason to fear is impending, being facilitated? By weakness in the management of the school system of the country, caused by the opening of English and French but English being insisted upon from the beginning these new colleges as they arrived would have merged into the general English-speaking population.

THE VIA DOLOROSA.

William Street, Kingston, as a home for single women or widows left alone, not having anyone to provide a home for them, on certain conditions named in the will. The houses indicated are in the City of Kingston, Ontario, and that was the intended site for the home contemplated by the testatrix, but she became insane after the making of the will and died in the Kingston Asylum in June, 1910. It became necessary to sell the land to pay for her support in the asylum, and this was done by the inspector of prisons and public charities in 1905, and from the proceeds of sale there now remain the sum of \$181. The value of all the assets, real and personal, in the hands of the executors is now \$357, of which \$175, about a half, is personally. The proceeds of the sale of the land under the lunacy proceedings retains its character of realty, and all the other incidents attached to it by the will, so that if possible it should be made available for charitable purposes akin to those directed by the testatrix. It is, of course, impossible to carry out, in any measure, the schemes of the will by setting apart the houses as a home for friendless women. I think the master at Kingston should report as to whether the money can be applied in general accord with the testatrix's wishes to the support of destitute women, in any established charity in that place, or, if not, in a like way in Toronto, and let the balance, after paying costs, be so applied.

FORM CREDIT ASSOCIATION

Toronto Commercial Men Follow Winnipeg's Example A Force For Legislation.

H. H. Pigott, president of the Canadian Credit Men's Association of Winnipeg, addressed about 70 members of the newly-formed local branch of the association, at their dinner at McCormick's Cafe last night.

The speaker gave the Toronto organization a lot of good advice. He reviewed the Winnipeg association's history and commented upon the many difficulties experienced there, both in putting the plan on a sound basis and in working out the scheme.

In the summary of the value of a credit men's association, he pointed out that the commercial conditions of the country demanded such up-to-date enterprise on their part. The association had the machinery for investigating business conditions which a firm did not possess, and with which no commercial agency could compete. Business men would soon realize this and join the association, which when its numbers increased, would be a force to obtain better commercial legislation and improved conditions in trade.

A committee of nine was chosen to nominate men for the various officers of the association.

LEAKS IN PIPE UNDER LAGOON

Bacteria Count of Filtration Plant Water is 148,000 Per Cubic Centimetre, States Dr. Hastings—Harmless, Tho.

It was brought out at the filtration plant enquiry yesterday afternoon that the condit running under the bay is not watertight and that it would cost about \$11,000 to make it so. Engineer Pillsbury quoted these figures as being those of Engineer Allan Hazen of New York, and said that it would be a waste of money to make the main absolutely watertight, as the leakage is slight.

Superintendent Longley also said that it was unnecessary and added that the way to get the best results from the water system, and especially the filtration plant, would be to have it under efficient management.

Joseph Pace, chemist, made nine tests of the water, three from the filter outlet and others from the pure water reservoir and the leak. The bacterial count was from 1800 to 15,900 per cubic centimetre, but the analysis failed to find any col. Four other tests were made at the reservoir, the count being from 115,000 to 148,000, but no col were found.

Dr. Hastings, M.H.C., and Dr. Nasmith testified to the fact that there is practically no danger of the water being contaminated while passing under the lagoon.

While Superintendent Longley was on the stand Judge Winchester pointed out that the specification in connection with the plant called for 250,000 bags of cement to cover 500 cubic yards of concrete, and that there was a deficit of five per cent, or 12,500 bags. Mr. Longley retorted for a few minutes. Mr. Pace returning said that the quantity of cement could not be estimated closer than five per cent, as in some sections not so much was required as in other parts.

The investigation will be resumed on Friday.

WOMAN STRUCK BY CAR DIES FROM INJURIES

Stepped From Ditch on to Metropolitan Track—Succumbs In Hospital.

Mrs. Lizette Tierneough, 155 Duchess-street, the aged woman who was struck by a Metropolitan car near Willowdale Friday night, died of her injuries at St. Michael's Hospital last night, and Coroner R. J. Wilson will open an inquest into her death at the morgue at noon to-day.

Mrs. Tierneough lived with her husband at the Duchess-street address. She had been wandering in her mind for some time and her husband had contemplated putting her into the care of an institution for the feeble-minded, fearing that she would set fire to the house or do herself or him some other injury. Friday she left the house in the morning and wandered up Yonge-street.

As a northbound car neared Willowdale she stepped out from the ditch directly in front of it and was struck. She was brought to the city in a special car and hurried to St. Michael's Hospital.

York police magistrate's court, where the white slave trade came under her attention. "The white slave traffic would come to an end because there would be no more countenance of it," she declared, if women had a hand in making the laws.

Third Victoria Rifles, was lined up along the platform. At 3.55 the train backed slowly into the station and His Royal Highness was seen standing alone on the back platform in the uniform of a British field marshal. Sir Thomas Shaughnessy was the first to greet the governor-general, and was followed by Mayor Guerin, Archbishop Brochu, Bishop Farrington, Col. Roy and other officers of the headquarters staff, and others. The Duke inspected the guard of honor, while the Duchess and Princess Patricia were met by Mayor and Miss Guerin, Controller LaChapelle and Sir Montagu Allan, and escorted to the mayoral chambers.

The Duke's Address.

Here the civic address was read in English and French, the governor-general responding "also in both languages. His Majesty's general response was as follows:

"Mr. Mayor and Gentlemen: I tender you my very best thanks for the charming address which you have welcomed my first official visit to your city.

"You have kept good records to call my stay amongst you of many years ago. I assure you that the recollection of those days remains green in my memory, and I look forward to renewing my old acquaintanceships amongst you and your surroundings.

"It would be hard to identify many of the old landmarks, for they have been obliterated by beaumont progress, but the city has opened to the south, east and west, and the open country, where formerly we used to drill the troops, has given place to the boulevard.

"A recent event has further proved that the wealth and generosity of your citizens has kept pace with the growth of the city and you must be indeed proud of the fest which was performed by Montreal in response to the appeal of the McGill campaign committee.

"Gentlemen, I have pleasure in thanking you for the splendid reception given me on my arrival to-day. I wish every success to you and your beautiful city and pray that you may be blessed with the prosperity which has been yours in the past may also be yours in the future.

The veterans then presented addresses to the governor-general, addressing him as "comrade," as he also is a veteran, which seemed to please him greatly.

Received Degrees.

The convocation hall at the Royal Victoria College was crowded with some 600 guests when the duke and duchess arrived to receive the honorary degrees. Besides the invited guests students of the college of an estimated number of three hundred had also crowded in and sat on every vantage point, and as their royal highnesses appeared, the stumorous cheering and noisy, the address of the university was presided by Principal Peterson, and the duke responded at some length. Dr. Rodolphe C. M. Hays, constituted the committee which attended to the formal ceremonies attendant upon the conferring of the degrees.

The McGill LL.D. is the severest honor to be conferred upon his royal highness.

This evening's reception was a brilliant affair, thousands of citizens being present, assisting all the leaders in business and professional life.

These reports are supported by the report of an American expert.

The reports of the chartered accountants cover a year and parts of a year, and, together with Toronto reports, establish some facts of paramount importance to advertisers. The reports establish—

- 1st. That The Montreal Star and La Presse are the two Montreal daily papers in the front rank, with La Patrie a good second.
- 2nd. That, in all Canada, The Montreal Star has the largest circulation of any Canadian paper, La Presse coming second and very close behind The Star.
- 3rd. The Montreal Star gives advertisers thousands of circulation more than it claims in its circulation table.
- 4th. That La Presse and La Patrie have for years been giving advertisers less circulation than they claimed in their circulation tables.
- 5th. That La Presse and La Patrie publish, besides their ordinary editions, special diminutive editions eliminating the bulk of the Canadian advertisements, but retaining the same title, that is, "La Presse" and "La Patrie." These miniature editions of La Presse and La Patrie are both circulated amongst the factory hands and others in certain cities and towns in the Eastern part of the United States, including Fall River, Lowell, Manchester, and Providence and other Rhode Island towns, and all this circulation has been included in circulation tables as bona fide circulation. This has been going on for years. In the case of La Patrie, the extraneous circulation referred to, improperly included in published statements of circulation intended for advertisers, amounts to 4,000 a day,—in the case of La Presse it amounts to some 20,000 a day.
- 6th. The Montreal Star's bona fide paid circulation exceeds by 14,000 a day the combined bona fide paid circulation of all the other English papers in the City of Montreal, that is, The Montreal Star exceeds the aggregate of all the others by a surplus of more than 14,000 a day.
- 7th. The local bona fide paid circulation of The Montreal Star, that is, the circulation of The Montreal Star in Montreal and suburbs (the Island of Montreal), exceeds by more than 13,000 a day the combined bona fide paid circulation of all the other English daily papers in the same territory.

Although there is no rivalry between the English and French papers, yet the question of relative position is interesting.

The figures of only The Star, La Presse and La Patrie are given here,—the other daily papers of Montreal falling below 30,000 a day each,—so that it will be seen that this is dealing only with the two papers of first magnitude, The Montreal Star and La Presse, each with circulations exceeding 75,000 a day, and a paper of the second magnitude, La Patrie, with upwards of 40,000 a day.

These figures are submitted as the more startling figures of the reports. It will be readily admitted that the reports justify the painstaking labors of the accountants and the expert.

As Canada has the distinction of having the only paper on the continent whose bona fide circulation is, and has been for twenty years, greater than the publishers have claimed in their circulation tables. It may be interesting to read what the American circulation expert has to say on the question. From a certified copy of his report here are his words: "Whereas the writer has, during the past year, audited the circulation of about thirty-five daily papers, it is absolutely the fact that The Montreal Daily Star is the only one whose publisher had actually more circulation than he was claiming."

The reports submitted manifest evidence of the most painstaking scrutiny.

This whole subject is of vast interest to advertisers and to advertising agents solicitous for the interests of advertisers. Here is an American expression of opinion: "A publisher who seeks business on false pretence or misleading claims of circulation, is not in a position to censure any other purveyor of goods who gives short weight or short measure."

Strong Turn to Cash Market and Argentine Developments Inspire Short Covering Move—Corn and Oats Higher.

CHICAGO, Dec. 12.—With crop conditions so unfavorable in the Argentine as to lead to withdrawal of wheat offers from that country, the market for the cereal to-day took an upward turn. The close was firm, 3-8c to 7-8c higher than last night. Latest trading left corn with a net gain of 3-8c to 5-8c, oats up 3-8c to 1-3c and provisions at 7-12c to 12-12c advance.

Fresh damage from rain had apparently hit the harvest fields in the Argentine in a manner that boded ill for a large exportable surplus of wheat. The serious character of the injury seemed to have made a considerable impression on European traders, as cables reported higher prices at Liverpool and Antwerp as well as at Buenos Ayres.

Other Cereals Dull. Corn, the strong all day, ruled very dull. The main cause of the firmer tone was the fact that owing to rains, country roads were bad and that shipping and hauling to rural stations had been checked.
