- 8. Each Local Council and Nationally Organized Society is asked to arrange with their delegates so that one of them shall attend each of the meetings of the Standing Committees.
- 9. In accordance with the usual custom of the National Council the session on Monday, June 23rd, 10 a.m., will be a private meeting of Council open to any member of any Society federated in a Local Council or in the National Council, but not open to the public generally or the press.

"Therefore be it resolved, that a petition be sent to the Honourable, the Prime Minister of Canada, asking that the opportunity be given the women of Canada to register at an early date in order that they may be able to vote at the next Dominion Election."
