AT THE
Goderich Wool Factory.

THIS substance, in mounting, is used
to clean the wool, and is the best
and most economical. It is used
in the following manner:—The
wool is placed in a tub, and
the water is heated to a
temperature of 100 degrees
Fahr. The wool is then
scoured, and the water is
changed several times, until
it is perfectly clean. The
wool is then dried, and is
ready for use.
