

THE THIRTY-SECOND SESSION

OF THE

TORONTO SCHOOL OF MEDICINE,

IN AFFILIATION WITH

THE UNIVERSITY OF TORONTO.

The thirty-second session of the Toronto School of Medicine will open on Thursday, October the 1st, 1874, and will close on the 1st April, 1875. There will be an intermission of ten days at Christmas.

Students will find it to their advantage to be present at the opening Lectures of the School.

The General Lectures will be given, as usual, at the Medical School building in University Park, which building has been thoroughly renovated and much improved by the University of Toronto. The Lectures on Chemistry and on Botany will be delivered at University College, where the necessary appliances of Laboratory and Museum are equal to any upon the Continent of America.

A very full course of Clinical Lectures will be delivered by the appointed Lecturers at the Toronto General Hospital, and carriage conveyance daily, to and fro, will be provided free of charge to the students, as in former sessions.

The opportunities afforded for the prosecution of the study of Medicine, in all its several departments, are of the most perfect character, and without individualizing any specialty, it may be safely asserted that in all respects the students of the Toronto School of Medicine will enjoy, as heretofore, those advantages which will enable them, with ordinary diligence, to secure the highest honors in Medicine conferred by the great Provincial University.

It is to be observed that no degree or status, imperial or colonial, entitles the holder to a license to practice in this Province; and in order to obtain the Provincial License, all students are required to pass their

Medical Examination before the Council of the College of Physicians and Surgeons of Ontario; and if not already a Matriculant or Graduate of some British or Canadian University, must also matriculate before that body.

The following regulations have been established by the Council of the College of Physicians and Surgeons of Ontario:

MATRICULATION.

1. The examinations in preliminary education will be held in Toronto and Kingston on the first Tuesday and Wednesday of January, April, July and October of every year.

2. Every Student must pass a satisfactory examination in the following subjects, viz :---

a. English Language, including Grammar and Composition.

b. Arithmetic, including Vulgar and Decimal Fractions.

c. Algebra, including Simple Equations.

d. Geometry, first two books of Euclid.

e. Latin, Translation and Grammar.

And in one of the following subjects, the student having the option of naming the one in which he will be examined.

f. Greek.

g. French.

h. German.

i. Natural Philosophy, including Mechanics, Hydrostatics and Pneumatics.

NOTE.—Students are recommended to select Natural Philosophy, or one of the Modern Languages.

3. The following are the text-books in the various branches enumerated below. Where more than one is named the student may elect which he will be examined in:—

a. Latin-Cæsar, Commentarii de Bello Gallico, first two books; Cicero, Manilian Law; Virgil, Æneid, first book.

b. Greek-First chapter of St. John's Gospel; first book of Xenophon's Anabasis.

c. French-First chapter of Telemaque ; Charles XII.

d. German-Adler's Reader, first part.

e. Natural Philosophy-Peck's Ganot; Sangster's first book.

4. Evidence of having passed a Matriculation Examination in any of the medical institutions of Canada, prior to July, 1869, will exempt from matriculating before the Examiners of the Council, on payment of two dollars.



5. Graduates and matriculants in Arts in any University in her Majesty's Dominions are not required to pass the examination, but must register their names with the Registrar of the Council, and pay the matriculation fee—ten dollars.

6. Graduates in Medicine of any College in the Dominion, excepting those of Ontario, are exempt from passing the Matriculation Examination of the Council upon paying ten dollars, provided they can show that they have passed a Matriculation Examination in the College from which they have graduated equal to that established by the Ontario Medical Act, and completed thereafter four years of study, &c.

7. Every medical student shall be registered in the manner prescribed by the Council after matriculating, and such registration shall be the necessary preliminary to medical study.

MEDICAL CURRICULUM.

1. Every student, after matriculating as above, must spend a period of four years in actual professional study, except as hereinafter provided.

2. A student who is a graduate in Arts of any recognized College or University will be required to pass three years after graduating in attendance upon medical lectures, before being admitted to examination.

3. Every student shall attend medical lectures for at least three sessions of six months each.

4. Each six months course shall consist of not less than one hundred lectures.

5. Every student must attend lectures in a University, College or School of Medicine, approved of by the Council, as herein provided, viz:--

a. Two courses of six months each upon

Anatomy,

Practical Anatomy,

Physiology,

Theoretical Chemistry,

Materia Medica and Therapeutics,

Principles and Practice of Surgery,

Principles and Practice of Medicine, and

Midwifery and Diseases of Women and Children.

. Two courses of six months each upon

Clinical Medicine, and

Clinical Surgery.

. One course of six months, or two courses of three months each upon Medical Jurisprudence.

d. One course of three months upon Practical Chemistry and Botany.

NOTE.—The certificate of attendance on any course is only valid when the Lecturer lectures upon only one branch of medical science and delivers only one lecture daily; but the Lecturer on Medicine may lecture on Clinical Medicine; the Lecturer on Surgery, on Clinical Surgery; and the Lecturer on Materia Medica, on Botany and Medical Jurisprudence. Furthermore, no certificate of pupilage or of attendance upon lectures in the Province of Ontario, shall hereafter be accepted, unless the person certifying the same be a duly registered practitioner, excepting in the subjects of Botany and Chemistry.

7. Every student must pass one period of six months in the office of a "regularly qualified medical practitioner," in compounding medicines, &c.

N. B.—The words "regularly qualified " shall be considered to mean, registered according to law.

8. He must attend the practice of a general hospital for eighteen months.

9. He must attend six cases of midwifery.

10. He must pass the primary and final examinations of the Council.

PERSONS FROM THE UNITED STATES OR OTHER FOREIGN COUNTRIES.

11. All persons from recognized Colleges outside the Provinces of Ontario and Quebec, who desire to qualify themselves for registration in this Province, shall pass the Matriculation Examination established by the Council, and attend thereafter one full winter course of lectures in some one of the Ontario Medical Schools, and such other course or courses as may be necessary to complete the curriculum required by the Council, and shall pass the primary and final examinations before the Board of Examiners of this College.

12. Nothing in the next preceding clause shall exempt residents of Ontario, who after this date elect to pursue their studies outside of the Provinces of Ontario and Quebec, from passing four years in the pursuit of their professional studies, such four years to commence at the date of their matriculation in this Province before the Examiners of this College.

EXAMINATIONS.

1. The examination shall be divided into two parts, a "Primary" and a "Final;" and will be conducted partly in writing and partly viva voce.

2. The Primary Examination may be undergone at the end of the second or third year, and the Final at the end of the fourth.

3. The following branches shall be embraced in the Primary Examination., viz :---

a. Descriptive Anatomy.

b. Physiology.

c. Theoretical Chemistry.

d. Toxicology.

e. Botany.

f. Materia Medica and Therapeutics.

IF NOTE.—The general professional examinations upon Materia Medica and Therapeutics may be undergone by students at either the primary or final Examination.

4. The following branches shall be embraced in the Final Examina-

tion, viz. :---

a. Medical Diagnosis.

b. Pathology.

- e. Surgical Anatomy.
- d. Practical Chemistry.
- e. Medical Jurisprudence.
- f. Sanitary Science.

g. Operative Midwifery.

- h. Operative Surgery and Surgical Anatomy.
- i. Materia Medica and Therapeutics.
- j. Midwifery, other than Operative.
- k. Surgery, other than Operative.
- I. Theory and Practice of Medicine.

5. The examination on the Primary branches and the first eight subjects of the Final is in all respects the same for every candidate.

6. Any candidate who at his *Primary* or *Final* Examination passes creditably in three or more branches, but fails in the others, shall receive credit for the subjects so passed, and be compelled to pass in the other branches only at a subsequent examination.

7. Students who intend to be examined by the Homeopathic or Eclectic Examiners in the last four branches of the Final Examination, shall signify their intention to do so to the Registrar previous to the commencement of the Examinations, in order that he may provide means of preventing their identification by other students, or by the Examiners.

8. In the event of any candidate signifying his intention to the Registrar to be examined and registered as a Homeopathic or Eclectic practitioner, due notice of such must be submitted to the Registrar, so that the Examination may be conducted by the respective parties appointed for that purpose, but prior to the acceptance of such notice from the candidates presenting themselves for such Examination, due notice to be given by the Registrar to the Special Examiners. All regulations of the Council inconsistent with the above to be repealed.

9. The next Medical Examination will be held in Toronto; due notice will be given of the time and place thereof.

N. B.—Every reasonable arrangement will be made for the convenience and comfort of candidates attending the Examination.

FACULTY OF MEDICINE.

DEGREE OF M.B.

The following are the requisites for admission to the Degree of Bachelor of Medicine, viz :---

(1) Having produced satisfactory certificates of good conduct.

(2) Having Matriculated in any Faculty in this University, or having been admitted ad eundem gradum or statum in Law or Arts.

(3) Being of the full age of twenty-one years.

(4) Having pursued Medical studies for the period of at least four years, and having regularly attended Lectures extending over a period of at least three Sessions of six months each, in the following branches of Medical education, for the respective periods hereinafter set forth :---

Anatomy, two courses of six months.

Practical Anatomy, two courses of six months.

Theory and Practice of Medicine, two courses of six months.

Principles and Practice of Surgery, two courses of six months.

Chemistry, two courses of six months.

Midwifery and Diseases of Women and Children, two courses of six months, and attendance on six cases of labour.

Therapeutics and Pharmacology, two courses of six months.

Physiology, two courses of six months.

Practical Chemistry, one course of three months.

Medical Jurisprudence, one course of three months.

Botany, one course of three months.

(5) Having attended for at least twelve months the practice of some general Hospital, and having attended, during six months, Clinical Lec tures on Medicine and Surgery.

(6.) Having passed in this University an Examination in all the subjects specified in Article 4.

DEGREE OF M.D.

The following are the requisites for admission to the degree of M.D., viz :--

Having been admitted to the Degree of M.B., being of one year's standing from the admission to the degree of M.B., and having composed an approved Thesis upon some Medical Subject.

DEGREES AD EUNDEM.

A Graduate of any of the Universities in Great Britain or Ireland may be admitted to the like Degree in the University of Toronto. He must send in his certificate to the Registrar, at least two weeks before the first meeting of the Session of the Senate at which his application is to be brought forward.

EXAMINATIONS.

The Examination for Matriculation will be held in the latter part of September.

Additional Examinations for Matriculation may be held at other periods, but no Honours or Scholarships will be awarded at such additional Examinations.

The Examinations, other than that for Matriculation, will be held in the month of April.

Notice will be given annually, in January, of the days on which the Examinations for the year will commence.

Every Student, who proposes to present himself at any Examination, is required to send to the Registrar, at least three weeks before the day appointed, a paper (according to a printed form which will be provided), stating his standing, and whether he is a Candidate for Honours or otherwise.

SCHOLARSHIPS.

One among Students of One Year's Standing.

One among Students of Two Years' Standing.

One among Students of Three Years' Standing.

No Scholarship will be awarded to any Candidate unless he shall have been classed in Honours in at least two-thirds of the Departments comprised in the Examination.

Each Scholarship is of the value of one hundred and twenty dollars a year.

Each Scholarship is tenable for one year only, but the Scholar of one year is eligible for the Scholarship of a succeeding year.

Students who have not previously Matriculated may compete for the Schelarship of the first, second, or third year, by taking along with the subjects prescribed for that year the subjects appointed for Matriculation.

Every Student taking a Scholarship is required to sign a declaration that it is his intention to pursue his Medical studies, one, two, or three years, according to the year in which he has taken such Scholarship, and to proceed to a Degree in the University of Toronto.

MEDALS, PRIZES, AND CERTIFICATES OF HONOUR.

A Gold Medal may be given, upon the special recommendation of the Examiners, to the Student who, at the Examination of the Degree of M.B., shall have been placed first in the First Class.

A Silver Medal will be given to each of the Students who, at the Examination for the Degree of M.B., shall have been placed in the First Class of Honours, except the successful Candidate for the Gold Medal.

No Medal will be awarded to any Candidate unless he shall have been classed in Honours in all the Departments comprised in the Examination.

Prizes, each of the value of Ten Dollars in Books, may be awarded annually among Undergraduates in Law, Medicine, and Arts, for the best Composition in Greek Verse, Greek Prose, Latin Verse, Latin Prose, English Verse, English Prose, French Prose, or German Prose.

Certificates of Honour will be given to those Students who, at any of the Examinations, have been placed in the First Class in Honours in any Department.

STARR MEDALS.

The late RICHARD NOBLE STARR, M. D., devised certain property for the encouragement of the study of the subjects of Anatomy, Physiology, and Pathology. In fulfilment of this object the Senate have established one Gold and two Silver Medals, called the "Starr Medals." These medals are competed for annually at the same time as the Examination for the Degree of M. B., and are conferred upon the three competitors who have attained the highest marks in the above subjects ; the relative rank of each Candidate being determined by the aggregate number of his marks in all such subjects. They are open for competition to all students who have received their medical education in any Medical School or Institution affiliated with the University, and have matriculated or been admitted ad eundum statum in the Faculty of Medicine in the University; but such competitors must be of sufficient standing to be entitled to present themselves for the Degree of M. B. Candidates are required take all the subjects appointed for Examination for the Degree of M. B. Every recipient of the Medal must have attained the standing of first class in each of the subjects of Anatomy, Physiology and Pathology and must be classed in Honors in all the other subjects of Examination. The "Starr Medal" may be taken and held by any Candidate to whom the University Gold or Silver Medal has also been awarded at the same Examination, in which case it is optional for him to receive, instead of such University Medal, the value thereof in money.

N.B.—THE MATRICULATION EXAMINATION OF THE COUNCIL OF THE COLLEGE OF PHYSICIANS AND SURGEONS IS ACCEPTED BY THE UNIVER-SITY OF TORONTO.
