Washington, Sept. 2.—The widening circles of the Alaska coal land fraud cases bid fair to include former Sec-retary of the Interior Garfield. As the case stands now, a record has been demanded by President Taft find such a record would include all the proceedings during the Roosevelt-Garfield administration as well as un-der the Ballinger administration.
