**An Act to supply an omission in Schedule B. to the Act
to amend the Upper Canada Municipal Corporations
Law Amendment Act of 1850.**

WHEREAS, in the Upper Canada Municipal Corporations Law Amendment Act of 1850, an error was accidentally committed in leaving out of Schedule B. the division of the Town of Picton into Wards :—Therefore be it enacted &c. Preamble.

5 That Schedule B annexed to the Act first above cited be amended by inserting immediately after the description of the boundaries of the Town of Picton the following words ; Schedule B of
13 & 14 Vict.
c. 64 amended.

“ The said Town to be divided into three Wards to be called respectively,
“ ly, Hallowell Ward, Brock Ward, and Tecumseth Ward, and to
10 “ comprise respectively the following portions of the said Town, that
“ is to say :

“ The said Hallowell Ward to comprise all that part of the Town
“ which lies west of Bowery Street.

“ The said Brock Ward to comprise all that part of the Town which
15 lies east of Bowery Street and north of the Bay.”

“ And the said Tecumseth Ward to comprise all that part of the town
“ which lies on the south side of the Bay.”

2. And be it enacted that notwithstanding the omission in the said Act of the description of the division of the said Town of Picton into
20 Wards, every act and thing done by the Mayor and Town Council of the said Town shall be as valid as if the above mentioned description of the division of the said Town into Wards had been inserted in the said Schedule B. at the time of when the said Act was passed, and the said Act shall be construed and have effect to all intents and purposes as
25 if the said description had been so inserted as aforesaid. Act to have
