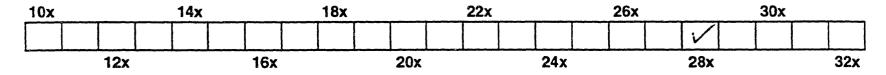

An Act to amend the Act incorporating the "Cobourg Manufacturing Company," and to increase the Capital Stock thereof.

WHEREAS the persons incorporated as the Cobourg Manufactur- Preamble. ing Company, by the Act passed in the ninth year of Her 9 Vict., c. 94. Majesty's reign, chapter ninety-four, have failed to carry the same into effect, and Patrick Wallace, John S. Wallace, Lewis Moffat, John D. 5 Armour, and Henry Mackechnie, have by their petition prayed that the said Act may be revived and amended, and the capital Stock of the said Company increased to two hundred thousand dollars, and that they may be permitted to carry the said Act so amended into effect, and it is expedient to grant the prayer of such petition; Therefore 10 Her Majesty, &c., enacts as follows:

I. The first section of the said recited Act is amended, so that the Petitioners said Patrick Wallace, John S. Wallace, Lewis Moffat, John D. Armour, and their as-sociates to Henry Mackechnie, and such other person or persons as shall be associ- form the said ated with them, under the provisions of the said Act, or of this Act, and Company. 15 their several and respective successors, executors, trustees, Administrators and assigns shall hereafter form the said " Cobourg Manufacturing Company," as therein provided.

II. The third section of the said Act is hereby amended so far as to per- Company may mit the said Company to invest so much of their Capital as they may invest their 20 deem expedient for the transaction of their business and for the purposes estate. of the said Company in real estate.

III. The fourth section of the said Act is hereby amended by increasing Capital inthe Capital Stock of the said Company to two hundred thousand dollars creased. and reducing the shares to twenty-five dollars each.

IV. The fifth section of the said Act is hereby amended so far as regards Reduction of 25 the subscription of shares which are by this Act reduced to twenty-five shares. dollars each.

V. The fourteenth section of the said Act is hereby amended, so that Non-liability hereafter no Director of the said Company shall be liable otherwise than of Directors. 30 as a stockholder of the said Company.

VI. The sixteenth section of the said Act is hereby amended, so that Number of Di the number of Directors shall be five instead of seven, as therein pro-rectors revided.

When the business may be commenced WII. The nineteenth section of the said Act is hereby amended so that so soon as fifty thousand dollars of the said Stock have been subscribed, and one half thereof has been paid up, the said Act and this Act shall take effect.

The said Act VIII. The said Act as hereby amended is revived and shall be in full 5 revived. force and effect, as if herein repeated and re-enacted.

Public Act. IX. This Act shall be decmed a public Act.
