The number of persons unemployed did not." in Great Britain was reduced by about 350,000 during the year 1923. Compared to the high level or unemployment in 1921, the number out of work was 907,000 fewer at the end of 1923 than in 1921. British Labor Ministry figures re-

ceived by the Bankers Trust Company. of New York, from its English Information Service show the improvement in employment as follows:--Number on


