The report of the Agent General of the Korean Reconstruction Agency has given a clear and impressive picture of the substantial progress made by the Agency in its work of rehabilitation in war-torn South Korea during the period covered by the report. Canada has been a member of the UNKRA Advisory Committee since its establishment by the General Assembly in December 1950. The Canadian Delegation has consequently had a direct and continuing interest in, and knowledge of, the development by the Agency of an over-all programme from which the Korean people would derive the maximum degree of benefit.

Until July 1953, the scope of UNKRA's work was necessarily limited by the military situation. As the Agent General has indicated, the period covered by his report is therefore the first one which has been free of hostilities, and the first in which UNKRA has been able to undertake comprehensive reconstruction and rehabilitation projects. The report shows graphically what really substantial progress has been made. We realize the tremendous task facing the Republic of Korea in transforming its economy from one devastated by war to one which will ensure that the Korean people are enabled, once again, to anjoy a reasonable standard of living. We believe that the UNKRA projects now under way will contribute towards this objective.

All this adds up to considerably more than \$1 billion in economic this adds up to constant the expenditure of which has made and assistance to Korea, the expenditure of which has made and is making a very important contribution to the relief of the Korean people and the rebuilding of the Korean economy.
