## APPOINTMENTS TO THE BOARD OF DIRECTORS OF THE EXPORT DEVELOPMENT CORPORATION

The Right Honourable Joe Clark, Secretary of State for External Affairs, today announced ten appointments to the Board of Directors of the Export Development Corporation (EDC).

"The government has put together a good team of knowledgeable and experienced people," said the Honourable James Kelleher, Minister for International Trade, through whom the corporation reports. "These board members will be able to pool their expertise from diverse backgrounds to manage EDC's newly stream-lined programs."

Following release of the Export Financing Consultation Paper in January 1985, the federal government undertook extensive consultations with the provinces and the private sector, including a 15-city tour by Mr. Kelleher. As a result of these consultations and internal EDC studies, the corporation has simplified its documentation procedures and decentralized financing services to its regional offices in order to improve access to EDC's facilities by small and medium-sized businesses.

The appointments are as follows:

Mr. V. Edward Daughney, who served as a Director of EDC from 1979 to 1984, is appointed Chairman of the Board. He is President and Director of First City Trust. Mr. Daughney was born in Fredericton, N.B., and educated at the University of New Brunswick and the University of Western Ontario. From 1973 to 1975 he was Vice-President and Director of Slater Walker of Canada Limited; from 1975 to 1976 he was President and Director of United Trust Company, and from 1980 to 1983 he was President and Director of Roxy Petroleum. He is presently on the Banff Centre School of Management National Advisory Committee and is a member of the Council of Trustees of the Institute for Research and Public Policy.

Mr. Sylvain Cloutier, formerly President and Chairman of the Board, will remain as President. He was a member of the Public Service Commission from 1965-1967, Deputy Secretary of the Treasury Board from 1967-1970, Deputy Minister of National Revenue for Taxation from 1970-1971, Deputy Minister of National Defence from 1971-1975 and Deputy Minister of Transport, 1975-1979, when he joined the Export Development Corporation. He was appointed Officer of the Order of Canada in 1979.

Ms. Judith Marlane Romanchuk, of Calgary is Vice-President and Director of Dean Witter Reynolds (Canada) Inc. Born in Edmonton and educated at the University of Alberta, Ms. Romanchuk became an investment dealer with Midland Doherty Limited in Calgary in 1970, and in 1975 with Walwyn Stodgell Cochran Murray Limited of Calgary. Since 1982, she has been Vice-President and Director of Dean Witter Reynolds (Canada) Inc. Roughly half of her business clientele are foreign, primarily German. Her work involves advising on Canadian and American investments, seeking venture capital pools for prospective corporate clients, and initiating prospective public underwritings.

Mr. Charles Diamond, of Vancouver, is President of B.C. Turf Ltd. Born in Vancouver, B.C., educated at the University of British Columbia, Mr. Diamond was admitted to the Law Society of British Columbia in 1958. In addition to being President and Director of B.C. Turf and associated companies, he also is President and Director of Vancouver-based C.D. Estates Ltd., Mohawk Handle Canada Limited of Winnipeg, and Bellevue BMW/Suburu in Bellevue, Washington. He is Chairman and Director of American Handle, Inc. of Los Angeles, Regional Financial Corporation of Vancouver, and Regional Trust Company of Vancouver. He is a director of John Labatt Limited.
