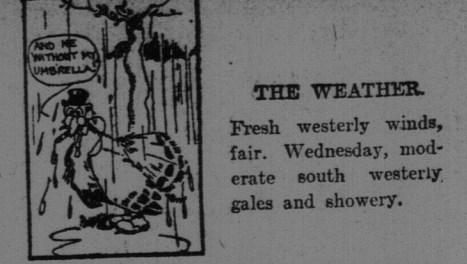

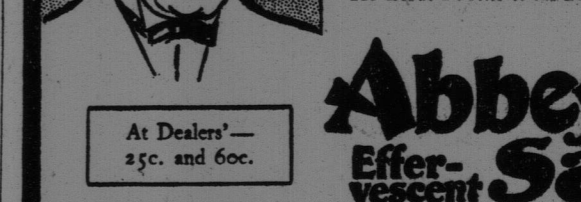

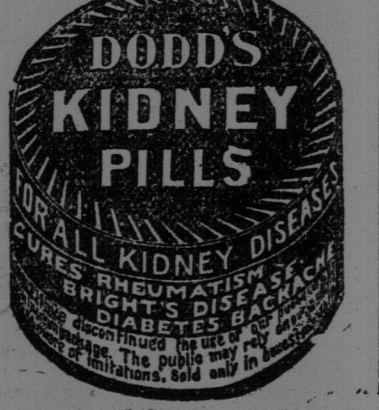

ST. JOHN SCHOONERS ARE BUFFETED BY STORMS

Crew of Schooner Eric Rescued When Half Dead—The Rowena Ashore at Machias and the Calabria on P. E. Island Coast.

A Provincetown despatch to the Boston Herald gives further particulars of the wreck of the St. John schooner Eric and thrilling rescue of her crew. The schooner Eric, of St. Andrews, N.B., is lying on bottom off Nauset. Her crew of five men were taken off the sinking vessel by men from the trawler Conqueror, of Gloucester, and landed yesterday at Provincetown.

The Rowena on Bar

Machias, Me., Nov. 2.—It was learned tonight that the schooner Rowena, which was ashore on Libby Island during the gale last Friday night, was the Rowena, of St. John, N. B. The vessel was blown ashore on the bar between Libby Island and Pettigrew's Island, and was apparently greatly injured. She lies in an almost upright position. At high tide the waves cut her in two and a tug will attempt to float the vessel.

Charlottetown, P. E. I., Nov. 2.—In the storm of Sunday the term schooner Calabria, Capt. McLean, was driven ashore near Summerside, P. E. I. The Calabria was a schooner of 450 tons, owned in St. John, and had on board Capt. Campbell, N. B., of Boston. She struck heavy at, causing her to fill with water.

THE FERRY SQUABBLE The aldermen are in the midst of another violent quarrel over ferry matters. As usual, a great deal of personal bitterness has been injected into the affair. As usual, also, the question whether this or that employe of the city shall have his way is apparently regarded as of more importance than the efficiency of the service. The council early in the year laid down the healthy principle that a director should direct, and a superintendent superintend. Then the council in this ferry matter reversed this decision and condemned the ferry superintendent for exercising the authority given him. Now there is to be another enquiry and more discussion.

ALL-CONQUERING WOMAN The dread of impending horror hangs over the town of High Wycombe, in England. The place is threatened with a lady mayor. There have been epidemics of various kinds in High Wycombe in the centuries past, but never a lady mayor. Indeed, it is said that English history knows none such, although sometimes a lady has sat upon the English throne. It appears that the town council accepted the nomination of the lady, Miss Dow, by a vote of 13 to 9, and when the town woke up and discovered that there was danger of her election on Nov. 9th a panic ensued, and when congratulations from other towns began to come in, and tributes to the broad-mindedness of the citizens of High Wycombe, these were repudiated with tears of rage. A town meeting was called to protest. It was pointed out that only 22 of the 32 members of the council were present when the nomination was accepted. A prospective coun-

cilor plaintively unburdened himself to the press as follows:—"It is not seemly for a woman to preside over 31 men. It is a man's task. Besides it will embarrass discussion of the town's affairs. Another objection is the impossibility of a lady sitting on the magisterial Bench. The town's interests must suffer."

WHO IS RESPONSIBLE? The Italian and his knife are entirely too much in evidence in this country. Even in this province tragic occurrences are becoming frequent as a result of failure to separate these bloodthirsty gentlemen from their weapons. The affair at Minto does not appear to have reflected overmuch credit on any of the parties concerned, but it should have stopped short of murder. Some degree of responsibility for the conduct of these Italians should be borne by the authorities. If they are to be brought into the country they should be searched occasionally for concealed weapons, and made to understand that justice in Canada does not sleep. One is led to wonder whether, in this country which sends many missionaries to heathendom, a little more effort might not be wisely directed toward the spiritual and moral welfare of men who work in mines, and on railroads and other constructive work, or do ours.

With three different organizations among the men who load and discharge vessels at this port, and with agreements covering a period of years there should be much less friction than formerly between employers and employed. A plea that was made by Rev. Father Chapman at the Associated Charities last week is worthy of consideration. He urged that the transportation companies should be prevailed upon if possible to do something in aid of the families of men who may be seriously injured while at work. The Compensation Act may cover most cases, but if it does not the burden of caring for the families of men hurt by accident might fairly be shared in some degree by the companies concerned.

The local option fight in the province of Ontario has been renewed this year with great vigor. The Toronto World says: "A hundred local option contests are now on in Ontario; of these 70 are for the abolition of the licenses in as many municipalities, and 30 are for the repeal of the local option by-laws in force. The secretary of the Ontario Alliance said to The World yesterday that the campaign is getting hotter every day. The Alliance has a staff of field speakers and organizers at work, and is publishing a special local option campaign issue by its paper, The Pioneer, this week."

The appeal of Dr. Grenfell, the hero of the Labrador coast, for a fund to establish a fishermen's institute at St. John's Nfld., will meet with ready response in Canada and the United States. The people know that what Dr. Grenfell seeks to do is worthy doing, and will be of genuine service to humanity. The members of the Seaman's Institute are to be congratulated upon the success of their efforts to provide a suitable building for the work at this port. Tonight's affair at the new home of the society on Prince William street should be joyfully patronized by the citizens.

CANADIAN WOMEN AND HEALTH OF THE PEOPLE

Valuable Report and Discussion at Meeting in Ottawa at Which Earl Grey Presided—40,000 People Afflicted With Tuberculosis—The Playgrounds.

(Ottawa Citizen, Friday.) His Excellency the Governor-General presided at the session of the National Council of Women in the Normal school building last evening. The principal theme of the meeting was the health of the people. The report of the committee on tuberculosis was read and discussed. The report stated that 40,000 people in Canada were afflicted with tuberculosis. The committee recommended that the government should take steps to improve the health of the people, such as the creation of playgrounds and the improvement of housing conditions.

The report also mentioned the importance of education in promoting health. The committee recommended that schools should be equipped with playgrounds and that teachers should be trained to recognize the signs of tuberculosis. Synopsis of Canadian Northwest Land Regulations.

ANY person who is the sole head of a family, or any male over 18 years old, may homestead a quarter-section of arable Dominion land in Manitoba, Saskatchewan or Alberta.

The applicant must appear in person at the Dominion Lands Agency or Sub-Agency for the district. Entry by proxy may be made at any agency, on certain conditions, by father, mother, son, daughter, brother or sister.

Duties-Six months residence upon and cultivation of the land in each of three years. A homesteader may live within twelve miles of his homestead on a farm of at least 80 acres solely owned and occupied by him or by his father, mother, son, daughter, brother or sister.

In certain districts a homesteader in good standing may pre-empt a quarter-section alongside his homestead. Price \$3.00 per acre. Duties-Must reside six months in each of six years from date of homestead entry (including the time required to cultivate five acres and erect a house worth \$2000).

A homesteader who has exhausted his homestead right and cannot obtain a pre-emption may take a purchased homestead in certain districts. Price \$3.00 per acre. Duties-Must reside six months in each of three years, cultivate five acres and erect a house worth \$2000.

McGoldrick moved to add a section to the director to be authorized to consolidate the existing assessment law and its amendment so as to provide for the exemption of income from personal services, of \$200 and for the substitution of a graduated scale of taxation on incomes from \$400 to \$600 as recommended in the assessment commission's report; also that they consider the whole question of assessment of personal property of small estates and the provisions of the act was to revert to two as large.

The report was finally adopted. Ald. Baxter's resignation as a member of the ferry committee was accepted.

Ald. Baxter then moved the following resolutions: "That the treasury board be directed to consider and report on the existing assessment law and its amendment so as to provide for the exemption of income from personal services, of \$200 and for the substitution of a graduated scale of taxation on incomes from \$400 to \$600 as recommended in the assessment commission's report; also that they consider the whole question of assessment of personal property of small estates and the provisions of the act was to revert to two as large.

The resolution was carried. The communication from Frank W. Morse, vice-president of the G. T. P., asking what would be done to assist the railway to enter St. John, was referred to the board of works.

A communication from A. W. MacRae, R.C., regarding the claim of Nathan Benjamin at Loch Long was referred to the recorder to report on the matter. The council then adjourned.

LIQUOR SEIZURES IN KINGS COUNTY

Curious Question Raised as a Result of Seizures at Sussex and Apohaqui.

Apohaqui, Nov. 2.—Several liquor cases with unusual complications are to come up on November 10 in the Sussex police court, and the outcome will be watched with keen interest by temperance people, liquor dealers, and residents of Kings county generally.

It seems that liquor sent to Sussex and Apohaqui addressed to private individuals and marked "for private use" was seized by the Scott Act people. The consignees are bringing actions against the station agents, and lawyers representing the temperance people will be on hand.

It is asserted by the persons to whom the liquor was addressed that it could not be seized unless it could be shown that it was not for their personal use.

WOMEN IN A ROW OVER FLOCK OF HENS

Their Troubles Were Ventilated in the Police Court This Morning.

Hens were the bone of contention in a family fracas yesterday afternoon, which was aired in the police court this morning.
 Mrs. Christina Addison swore out warrants for Mrs. Alice Stephenson and her son, Ward Stephenson, alleging assault in a yard off Brussels street. The accused pleaded not guilty.
 Mrs. Addison, the complainant, testified that she was in the yard on Monday afternoon with her young son, putting their hens in the barn to protect them from the Stephensons and others, when she was attacked by the woman and kicked on the leg. To repel further hostilities the witness took her assailant by the shoulders and gently placed her on her own doorstep. This infuriated her antagonist, and running at the witness, the woman pummeled her and when she turned her back the son jumped on her back and bore her to the ground. Mrs. Addison indicated a man in court viewing the proceedings as another assault and he was later called as a witness by the accused. The complainant claimed that she sustained several lacerations and scratches on the body in the fight and also said the Stephenson woman used bad language. According to her, several parties in the neighborhood have been persecuting her, and on a previous occasion the prisoner threatened to exterminate her. For herself and family and the flock of hens life has been a constant torment since she moved into the neighborhood.
 The magistrate was disgusted at the outset of the case at the prospect of seeing two talkative women in verbal combat, and repeatedly rebuked both for irrelevant testimony. "I can imagine what you are like in your own place when I can't curb you here."
 Albert Addison, the little son of the complainant, saw a boy tantalizing his mother and beating the hens. He corroborated the evidence of his mother. Lena Gray, niece of Mrs. Stephenson, stated that Mrs. Addison was the aggressor and threw the fowls forcibly against the casing of a door.
 Oscar Garnett and Lena Gray were witnesses for the defence.
 Mrs. Addison urged to question Garnet. Mrs. Addison replied, "Oh, what's the use; he's not telling the truth," and the solemnity of the court was somewhat disturbed by the angry husband of the complainant shouting, "Go on and ask him, can't you."
 The magistrate dismissed the case, remarking, "I tell you I'm glad to get rid of them."
