An Act to amend the Act incorporating the Port
Burwell Harbor Company.

WHEREAS it is expedient to amend an Act passed Preamble.
in the twelfth year of the Reign of Her Majesty
Queen Victoria, intituled, "*An Act to incorporate certain* 12 Vict. c.
160.
5 "*persons under the style and title of the President, Direct-*
ors and Company of Port Burwell Harbor," and to
extend the powers of the said Company, to impose and
levy tolls on certain articles of lumber and merchan-
dize, not mentioned or enumerated in the Schedule in
the said Act contained: Be it therefore enacted, &c.,

10 That from and after the passing of this Act, it shall and Company
may take tolls
on certain
articles.
may be lawful for the said President, Directors and Com-
pany, to impose, demand, receive, take, levy and collect,
with the like powers as in the said Act is provided for
the recovery of rates, tolls on the following articles pass-
15 ing out or from the said harbor, not exceeding the rate
hereinafter mentioned, and from time to time, to reduce,
alter or amend the same, viz.:

On every standard saw log, *five shillings.*

On every spar or mast, *five shillings.*

20 On all squared, hewn, sawed, or round timber, *two shil-
lings and six pence* per hundred feet running measure.
