

# Knox Church Managers' Annual Report.

#### For the Year Ending December 31st, 1894.

HE Board of Managers in respectfully submitting their Annual Report for 1894, are glad that by the good hand of God they have again to report well marked progress.

With the balance on hand from last year, \$416.05, the receipts for the year from seat rents and collections amount to \$4707.95, and the expenditure, including \$1000.00 in full of final manse settlement, \$300.00 paid on principal of Mortgage, and \$343.15 on repairs, mostly of a permanent sort, as drains, ventilators, rebuilding well and chimney, renewed joists and flooring, and the straightening and rebolting of church crest; leaves the balance on hand at the end of the year, \$39.99, with the bill of \$350.00 in the financial statement and about \$100.00 interest as contra to the arrears outstanding at the end of the year, amounting to \$1148.55, which arrears have been reduced at this date to \$836.80, and the bill of \$350.00 has now been paid.

Comparing the amount of our indebtedness on the principal of the Mortgage balance against the church property as it stood a year ago, \$3800.00, with what it is now, \$2600.00, the difference in our favor is \$1200.00, and to this adding the sum in bank at this date to credit of Mortgage account, \$440.00, it reduces the balance still to be received from volunteers and subscribers to \$2160.00, ere we can call upon you to jubilate with us over the full redemption of the church property from debt.

The ushers for 1894 did their duty well and are electable. The managers retiring this year are James Dow, Duncan Stewart and John McIntyre.

The Officers and Teachers again take pleasure in presenting their annual report. To our Father in Heaven we would offer our first tribute of gratitude for His goodness to us as a Sabbath School, in permitting us thus to work for Him, and for sparing in life and health, so many of those who are interested in this blessed work, although we have not perhaps, done everything to the best of our ability, or in the best way, yet we rejoice over the success that has attended our feeble efforts in the year just closed.

We are pleased to report that 14 members of the Bible Class and Sunday School have this year made public profession of their faith in Jesus Christ, by uniting themselves to the communion of the church. May the Holy Spirit lead many more of such who shall be saved to follow their example.

Our school has been progressing steadily in attendance and finances. We have had an increased attendance. The total for the year being 14,510, an average attendance for the days met, 292, and as shown by the financial statement, an advance in the regular contributions.

This year there has been no special effort put forth by the school to augment its receipts beyond the weekly collections, knowing that many of the congregation have been contributing so largely to other branches of church work.

The teaching of the Bible Class, by Mr. Malcolm, still continues to be highly appreciated, and has met 40 Sabbaths during the year. The average attendance has been about the same, viz: 52. Just in passing we would ask those who have been recently drafted into this Class, still to continue in their interest by their regular attendance on this means of grace.

# Secretary's Annual Report, Y. P. S. C. E.

During the past year, although our Society has decreased in point of numbers, yet the work has been continued faithfully, and we trust the interest has increased.

There have been 41 regular, 4 union and 15 executive meetings of Society. The first Union Meeting was held in this church, and was addressed by Mr. W. H. Frost, of China Inland Mission. The second also, held to appoint new officers for Union Executive. The third was held in C. M. Church and was addressed by Rev. Canon Richardson, of London. The subject of lecture was "C. E Work," which was very ably discussed by the lecturer. A great many practical suggestions were given, and questions or the work cheerfully and thoroughly answered. The last was held in the C. M. Church, and was addressed by Mr. Merchant.

At one of our meetings set apart for missions, a very interesting letter was read from our missionary, Miss Duncan, in India, giving an account of her Zenana work. At same meeting, it was decided to appropriate to the purpose intended, the missionary money collected, amounting to \$60.41. The necessary \$50.40 was sent for the support of the two native Bible women in India, and the remaining \$10.01 divided between Fr. Evangelization Fund and The Algoma Mission Scheme.

During the summer holiday months, owing to the number of members absent, it was deemed advisable to hold our meetings in connection with congregation weekly prayer meeting, the members to take part when no other arrangement had been made. By following this plan, the usual mid-week meetings was more largely attended.

The Society held Several open Social Meetings during the year, for the purpose of welcoming and becoming acquainted with strangers and students who attended our prayer-meetings while in the city. They distributed 213 articles of clothing among 10 families and Rescue Homes, and made 45 visits in connection with the work. Five dollars (\$5.00) of Relief Fund was voted to Union, towards Christmas Baskets.

On roll there are at present 5 honorary, 39 active, and 11 associate members, making a total of 55 members; the decrease since January 1893, being 19. On absent list are 29 names. Ten committees are actively at work, who report progress every two months.

During the past year several of our most active members have withdrawn from the Society on account of change of residence Eight new members have joined as active, three as associate, and two have been transferred from associate to active membership. From our number also, three have united with our church. We trust that the work may continue to prosper and bring forth good results during '95.
