



## BILL.

As Acr to place the Longueuil and Chambly Turnpike Road under the control of the Commissioners of Public Works.

THEREAS it is expedient that the Turnpike Road Preambles hereinafter mentioned should be placed under the control of the Commissioners of Public Works:

Be it therefore enacted, &c.,

That for and notwithstanding anything to the contrary The roads decontained in the Ordinance of the Legislature of Lower scribed in Ordinance of L. Canada, passed in the fourth year of Her Majesty's Reign, C., 4, Vic. e, intituled, "An Ordinance for establishing and maintaining 16, and in 8 "better means of communication between the city of transferred "Montreal and Chambly," or in the Act of the Parliament from control of this Province, passed in the eighth year of her Majesty's to that of Com-Reign, and intituled "An Act to amend and extend the Public Works." Ordinance relative to the Turnpike Road from Montreal "to Chambly," the four several roads in the said Ordinance, and Act mentioned and described, shall be and they 15 are hereby transferred from the control of the trustees appointed under the provisions of the said Ordinance to that of the Commissioners of Public Works.

II. And be it enacted, that from and after the passing Powers,&c.,of 20 of this Act, all the official powers rights, duties, obligations and liabilities as such of the persons holding office them, and be as Trustees under the said Ordinance, shall cease and come vested determine as to such person and each of them, and shall sioners: thereupon immediately become and be vested in and 25 imposed upon, and shall be exercised and enjoyed, and borne, discharged, fulfilled and incurred by the Commissioners of Public Works, in as full and ample a manner to all intents and purposes whatsoever as if they had been expressly named in the said Ordinance and Act, and as if every thing since the passing thereof lawfully done by the

30 Trustees of the Longueuil and Chambly Turnpike Road, as such under and in virtue of the provisions thereof, had been done by the said commissioners of Public Works.

III. And be it enacted, that all and every the real and sonal property of Trustees, as personal property under the provisions of the said Ordi-form Majesty, nance and Act or either of them since the passing thereof Act. lawfully acquired by, and at the time of the passing of this Act in the possession and the property of the Trustees of 5 the Longucuil and Chambly Turnpike Road, shall be and the same is hereby vested in Her Majesty, and shall be under the control of the Commissioners of Public Works as aforesaid.
