An Act to Incorporate "Les Dames Religieuses de l'Assomption de la Bienheureuse Vierge Marie."

THEREAS there has existed for many years, in the Parish of St. Preamble. Gregoire, in the District of Three Rivers, in this Province, a religious community known by the name of "Les Dames Religieuses de l'Assomption de la Bienheureuse Vierge Marie," whose objects are the 5 instruction of young girls and the practice of works of christian charity; and whereas the said community bath, by the petition of its Superior and principal officers, hereinafternamed, to the Legislature in its present Session represented that the advantages resulting from the said community would be increased by its incorporation, and hath prayed to be 10 incorporated according to the terms and conditions hereinafter mentioned; Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

1. Mesdames Hedwidge Buisson, Superior of the said community, Corporation Mathilde Leduc, Assistant, Julie Courtois, second Assistant, Delima constituted. 15 Boucher, Mistress of Novices, Marie E. R. Miller, teacher, and such other persons as shall become members of the said community, and fill the aforesaid offices, and reside in the said parish of St. Gregoire, shall be and are hereby constituted a corporation by the name of "Les Dames Religieuses de l'Assomption de la Bienheureuse Vierge Marie."

20 2. The said Corporation shall have perpetual succession; and three Power to of the members thereof, including the Superior, who shall always be the make Rules President ex-officio, shall form the quorum thereof, and shall have full Regulations. power to make and establish such rules, orders and regulations (not being contrary to the laws of this Province or to this Act) as they may 25 deem useful and necessary as well for the advantage of education and of works of christian charity as for the government of the community, and also for the management and administration of all movable or immovable property belonging to the Corporation; and the said Corpora- Power to take tion shall also have power in its corporate name to acquire and possess, and held real 30 for all the purposes of the said community, any landed or other property, estate. movable or immovable, which may hereafter be sold, transferred, given in exchange, given, devised, or granted to the said Corporation, and if need be to sell, hypothecate, alienate, convey, or lease the same; Pro- Provise.

vided always, that the annual revenue from the said immovable property 35 shall at no time exceed the sum of eight thousand dollars current money

Annual report 4. The said Corporation shall, at all times, when required by the Governor or either Branch of the Legislature, make a report shewing the amount of immovable and other property which it possesses under this Act, and the revenue arising therefrom, as well as the number of the members of the Corporation, and that of the teachers and pupils, 10 and lastly, a statement of the course of study.

Public Act. 5. This Act shall be a Public Act.
