An Act to amend the Act Chapter Seventy-seven of the Consolidated Statutes for Upper Canada, intituled, "An Act respecting the action of seduction and the support of illegitimate children."

WHEREAS the remedy provided by the Act respecting the action Presmble. of seduction and the support of illegitimate children, chapter seventy-seven of the Consolidated Statutes for Upper Canada, has proved insufficient in many cases of great hardship in which relief ought 5 to be granted, by reason of the neglect of the persons mentioned therein as being entitled to bring such action, or of their decease, or of their being absent from the Province, or being under other disability: Therefore Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:—
