## NOTICE.

This edition of Tee Ontario Medical Register, published under the direction of the Council of the College of Physicians and Surgeons of Ontario, in accordance with the thirty-second section of the Ontario Medical Act, contains a correct list of the names in alphabetical order according to the surnames, with their respective residences, together with their medical titles, diplomas and qualifications, with ine dates thereof, of all persons appearing on the register, as existing on the first day of January, 1870.

To avoid any misapprehension of the meaning of the abbreviations used in the Register, a table has been prefixed, which gives, in full, the names of qualifications for which abbreviations are used.

As there has been some misunderstanding in different parts of the Province as to the power conferred by the several. diplomas, I am directed to explain, that wherever the words "Provincial License," "Licentiate of the Medical Board," "'Licentiate,' or 'Certificate' of the Homœopathic Medical Board," or "'Licentiate,' or 'Ceatificate,' of the Eclectic Medical Board," occur, with onty the date appended; it is to be understood that the holder of such a diploma is legally entitled to practise Physic, Sureery and Mmwifery in the Proviuce of Ontario. Wherever eitier the word Physic, Surgery, or Afidwifery or any two of them, is introduced in brackets, before the date, thus :--Lic. Med. Board [Surgery] 1835 :-Lic. Homœopathic Med. Board [Midwifery] 1863 :-or Certif. Eclectic Mea. Buard [Pbysic] 1867 :- it is to be understood that the holder of such a diploma is licensed thereby to practise only the branch or branches specified in the brackets. The holder of such a duplowa, who practises any other branch than the cae so specified, does so illegally, uuless he possesses some other diploma which does empower him to practise it. Tbs Degres of Doctor of Medicine or Bachelor of Medicine
when conferred by any College or University in the British Empire, entitles the owner thereof to practise Physic, Sungery and Midwifery. Such degrees, however, when conferred by Foreign Colleges or Universities, confer no rights whatever, they are only entered in the Register as "additions" to the qualification.

A diploma issued by any of the Medical Bodies of the United Kingdom, confers no right in this Province which it does not confer upon the holder while he resiles in the United Kingdom. Thas, a diploma which qualifies its owner to practise either Physic, or Surgery, or Midwifery, does not entitle him to practise all of them when he registers it in this Province; but only the branch or branches which it entitled him to practise while he remained in the United Kingdom.

# AMEND AND CONSOLIDATE THE ACTS RELATING TO THE PROFESSION OF MEDICINE AND SURGERY 

[Assented to 23rd January, 1869.]

Wherras, it is expedient to amend and consolidate Preamble. the Acts relating to the medical profession; and to make more effectual provision for regulating the qalifications of practitioners of medicine, surgery and midwifery, and to incorporate the medical profession of Ontario: Therefore, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Ontaric, enacts as follows:-
I. The Act of the Parliament of the late Province of Acts 20 vic., Canada, twenty-nine Victoria, chapter thirty-four; the Act chapter forty-one of the Consolidated Statutes of Upper Canada; the Act passed in the twenty-fourth year of Her Majesty's reign; chapter one hundred and chap. 34 ; chap.41, Con. Acts and Acts amend ten; and all Acts amending any of the said Acts, are ingsamed. hereby repealed; and the provisions of this Act shall stand in the place of the provisions of the said Acts; but all proceedings heretofore taken, and all matters and things done under the said Acts, shall be valid and effectual notwithstanding such repeal, and may be carried on and completed under this Act as effectually as they could have been under the said Acts.
II. The Council and Board's established, and the Gouncil and Members thereof elected under the provisions of the viounds preActs repealed, shall be continued, and shall act until elected, and after the first election as hereinafter provided, but to bo continsubject in all other respects to the provisions of this ued, etc. Act; and all Dy-laws, rules and regulations heretofore made by the said Council and Boards, shall remain in
force until repealed or modificd under the provisions of this Act.

2. There shall also belong to the said Council five Additional Miembers to be elected by the duly licensed practition- members. ers in Homœpathy, who have been registered under this Act; and five members to be elected by the duly licensed practitioners in the Eelectic system of Medicine, who have been registered under this Act.
3. The twelve Members who shall be elected in the Cerain manner hereinafter provided from amongst and by the me resideniz registered Members of the Profession, other than those of territurial mentioned in the next preceding sub-section, shall be residents of the several Territorial Divisions for which they are elected.
LX. All Members of the Council, representing the Mrembers to Colleges or bodies in the eighth section mentioned, borexiteral shall be practitioners duly registered under this Act, or the before mentioned Act.
I. Of the trelve Members to be elected from onofrom smongst the registered practitioners of Aifedicine in reach territothe Province of Ontario, one shall be so elected for ctc. - each of the Territorial Divisions mentioned in Schedule C to this Act annexed, by the registered practitioners resident in such division; and the manner of holding such election shall, with respect to the time thereof, and the taking of the votes therefor, be determined by a by-law to be passed at the next meeting of the Council; and in default of such by-law being made, then the Lieatenant-Gorernor shail prescribe the time and manner of such clection.

SI. The AIembers of the Council shall be elected or Protison as appointed, as the case may be. for a period of three cocciniod and Years; but any Meraber may resign his appointment astorajiman, at any time by letter addressed to the President or cte, of Registrar of the Conncil; and apon the death or Sycmbers of resignation of any Member of the Council, it shall be the duty of the Registrar forthrrith to notify the College or body, wherein sach racancy may occar, of sach death or resignation, and such College or body shall
have the power to nominate another duly qualified person to fill such vacancy, or if the vacancy be caused by the death or resignation of any member elected from the Territorial Divisions, the Registrar shall forthwith cause a new election to be held in sach Territorial Division loy a notice to be published in the Ontario Gazette, and in, at least, three newspapers, published in the said Division, for, at least, one month, fixing the time and place for holding such election; and such election shall be conducted in accordance with the by-laws and regulations of the Council; but it shall be lawful for the Council during such vacancy to exercise the powers hereinatier mentioned.

2. In the event of the death or resignation of any member of the Council representing the practitioners of Homocopathy or the Eclectic system of Miedicine, it shall be lawful for the remaining representatives of Homœopathy or the Eclectic system of Medicine in the Council to fill such vacancy by selecting a person from among the duly registered practitioners in Homoopathy or the Eclectic system of Medicine, as the case may be.

SII. The first election under this Act for Members to represent the Territorial Divisions in the Conncil, shall take place on the second Tuesday in June, one thensand eight handred and sixty-nine, at such places in the several divisions as shall be fixed by by-law of the Council; and it shall be the duty of the Registrar to cause a notice of the time and place for holding the said, election to be published in the Ontario Gazette, and in at least three newspapers in each of the said divisions for at least one month before the said second Tuesday in June.

2. The first clection under this Act for Members to represent the duly licensed and registered practitioners in Homœopathy and the Eclectic system of Tredicine in the Council, shall talke place on the second Tuesday in June, one thousand eight handred and as shall be, in such manner and at such place or places time and place for holding the said elections to be published in the Ontario Gazette for at least one month before the said second Tuesday in June; and in
defanlt of such by-law being made, then the Liente-nant-Governor shall prescribe the terms and manner of snch election.
XIII. The said newly elected members of the First moetCouncil, as well as all members of the Councils to be ing otenowly hereafter clected, shall, together with the members to council. he appointed by the several Colleges and bodies as mentioned in section cight of this Act, hold tleir first meeting on the second Wednesday in July next after the said election in the City of Toronto, at such place as may be fixed by by-law of the retiring Council.
XIV. Erery subsequent election shall be held on Subscquent the second Wednesday in June, in every third year elections. after the said first clection, in the same manner as is provided for holding the first election as aforesaid.
XV. The persons entitled to vote at any election Whoentited under this Act, shall be the Practitouers duly registered under this Act.

SVI. The Council shall hold its first mecting under Time, place, this Act, in Toronto, and at such time and place as the ins meting President of the Council, or, in case of his absence or death, the Registrar for the time being shall appoint therefor, and shall make such rules and regalations as to the times and places of subsequent meetings of the Conncil, and the mode of summoning the same as to them shall seem expedient, which rules and regulations shall remain in force till altered at any subsequent meeting; and in the absence of any rale or regulation as to the sammoning of future meetings of the Future Council, it shall be larfal for the President thereof, or, moctings in the erent of his absence or death, for the Registrar to summon the same, at such time and place as to him shall seem fit, by circular letter to be mailed to each member; Provided almays, that at least two weeks' Proviso. notice of such meeting be given; and in the event of the absence of the President from any meeting the Fice-President, or in his absence, some other member to be chosen from among the nembers present, shall act as President; and all the acts of the Council shall quorum be decided by the majority of the members present, the whole nomber not being less than nine; and at all meetings, the President, for the time being, shall hare a casting vote only.

Expenses of XVII. There shall be paid to the members of the members.

Council such fees for attendance, and such reasonable travelling expenses, as shall from time to time be fixed by by-law passed by the said Council.

Duts of Re gistar.
XX. The Council shall cause to be kent by an officer appointed by them, and to be called the Registrar, a book or register in which shall be entered̈, from time to time, the names of all persons who have complied wish the enactments hereinafter contained, and with the rules and regulations made or to be nade by the Council respecting the qualifications to be required from practitioners of Medicine, Surgery and Alidwifury in this Province; and those persons only whose names have been, or shall hereater be inscribed ou the book or register aunre mentioned, shall be deemed to be qualified and lieensed to practice Medicine, Surgery or Midwifery in the Province of Ontario, except as hereinafter provided; and such book or register shall at all times be open, and subject to inspection by any duly registered practitioner in Ontario, or by any other person.

SII. It shall be the duty of the Registrar to keep his register correct, in accordance with the provisions of this Aet, and the rules, orders and regulations of the Council, and to erase the names of all registered persons who shall have died; and he shall, from time to time, make the necessary alterations in the addresses or qualifications of the persons registered under this Act; and to enable him duly to fulfil the duties imposed on
him, it shall be lawful for him to write a letter to any registered person, addressed according to the address of such person on the register, to enquire whether he bas ceased to practise or has changed his residence; and if no answer shall be returned to such letter within the period of six months from the sending of sach letter, it shall be lawful for the Registrar to erase the name of such person from the register: Provided proviso always, that the same shall be restored by direction of the Council, upon cause duly shown to that effect; and the said Registrar shall perform such other duties as shall be imposed upon him by the Council.
XXII. Every person now possessed, or who may, within the period of sir months from the passing of this Act, become possessed, of any one or more of the persing qualiProtision for qualifications described in the schedule A to this Act, shall, on the payment of a fee, not exceeding ten dollars, be entitled to be registered, on producing to the Registrar the document conferring or evidencing the qualification, or each of the qualifications in respect whereof he seeks to be so registered, or upon transmitting by post to the Registrar, information of his name and address, and evidence of the qualification or qualifications in respect whereof be seeks to be registered, and of the time or times at which the same was or were respectively obtained; and any person entitled to be registered before the first day of July, one thonsand eight hundred and sixty-five, may, on complying with the requirements in tris section mentioned, obtain such registration on parment of a fee of fire dollars: Provi- Provis. ded he register within one year after the passing of this Act: Provided also, no one registered under the Act Proviso. first above mentioned shall be liable to pay any fee for being registered under this Act.

Auy person who was actually practising Medicine, Surgery or Midwifery, or any of them, in Ontario, prior to the first day of January, one thousand eight hundred and fifty, and who shall have ittended one course of lectures at any recognized Medical School, shall, upon such proof as the Council may require, be entitled to registration under this Act.
3. Any person who was actually practising Nedicime,

XXIV. At the first regular meeting of the Council, after the passing of this Act, and at the annual meeting in each year thereafter, there shall be elected by the members of the said Council, a Board of Examiners, whose daty it shall be to examine all candidates for registration, in accordance with the by-laws, rules and regulations of the Council; such examinations to be held at Torontc and Kingston, and at the same time as examinations for matriculation of stadents.
XXV. The Board of Examiners appointed under Board of exthe preceding section, shall be composed as follows: composed. One Member from each of the three teaching bodies now existing in Ontario, and one from every other School of Medicine which may be hereafter organized in connection with any University or College which is empowered by law to grant medical or surgical diplomas: and nine members to be chosen from among those Members of the College of Physicians and Surgeons of Ontario, who are unconnected with any of the above teaching bodies: Provided always, that every candidate who shall, at the time of his ex amination, signify his wish to be registered as a Homoopathic or Eclectic practitioner, shall not be required to pass an examination in either Materis Medica or Therapentics, or in the Theory or Practice of Physic, or in Surgery or Midwifery, except the operative practical parts thereof, before any examiners other than those approved of by the representatives in the Council of tha body to which he shall signify his wish to belong.
XXVI. The Council shall, from time to time, as councll to occasion may require, make orders, regulations or mase orders, by-laws for regulating the registers to be kept under ters, feos, exthis Act, and the fees to be paid for registration; and shall, from time to time, make rales and regulations etc. for the guidance of the Roard of Examiners, and may prescribe the subjects and mode of the examinations, the time and places of bolding the same, and generally, may make all such rules and regulations in respect of such examinations, not contrary to the provisions of this Act, as they may deem expedient and pecessary; such examinations to be both oral and written; and shall also make by-laws and regulations appointing returning officers, and directing the manner in which elections shall be condacted, and the expenses of the same paid for.
XXVII. Any person entitled to be registered under Parscns not this Act, but who shall neglect or omit to be so re-repistered, gistered, shall not be entitled to any of the rights or not entitued privilegacisonferred by the provisions of this Act so ${ }^{\text {cte. }}$ long as such neglect or omission continues.
: XXVIII. If the Registrar make or cause to be Fural fald. made any prilfol falsificatiou in any matter relating to $\frac{\text { fration by }}{\text { Regitrar. }}$ the register, he shall incur a penalty of fify dollars, and shall be disqualified from again holding that position,

## Medricar Education.

Provision as to persons obtaining higher quallfication than that Registered.
XXIX. Fivery person registered under this Act, who may have obtained any higher degree or any qualification, other than the qualification in respect of which he may have been registered, shall be entitled to have such higher degree or additional qualification inserted in the register iu substitution for, or in addition to, the qualification previously registered, on the payment of such fee as the Council may appoint.

No qualification to beresistered unless Registrar satisfied

Every one registered may practise, and re cover his foes, otc.
XXX. No qnalification shall be entered on the register, either on the first registration or by way of addition to a registered name, unless the Registrar be satisfied by projer evidence that the person claiming is entitled to it; and any appeal from the decision of the Registrar may be decided by the Council, and any entry which shall be proved to the satisfaction of the Council to have been frandulently or incorrectly made, may be erased from the register by an order in Writing of the Council: Provided always, that in the event of the Registrar being dissatisfied with the evidence adduced by the person claiming to be registered, he shall have the power, subject to an appeal to the Council, of refusing the said registration until the person claiming to be registered shall have furnished such evidënce, duly attested by oath or affirmation before the Judge of the County Court of any County in Ontario.
XXXI. Every person who shall be registered under the provisions of this Act, shall be entitled, according to his qualification or qualifications, to practise Medicine, Snrgery and Midwifery, or any of them, as the cese may be, in the province of Ontario, and to demand and recover in any Court of law, with full costs of suit, reasonable charges for professional aid, advice and risits, and the cost of any medicine or cther medical or surgical appliances rendered or supplied by him to his patients.
XXXII. The Registrar of the Council shall, from tinie to time, under the direction of the Conncil? cause to be printed and published, a correct register of the names in alphabetical order according to the surnames, with the respective residences, in the form set forth in Schedule B to this Act or to the like effect, together with the medical titles, diplomas and qualifications conferred by any college or body, with the

XXXIII. The Conncil shall have power and anthority councll may to appoint an examiner or examiners for the admission ampoiners, ext of all students to the matriculation or preliminary for maticuexamination, and to make by-laws and regulations for ination. determining the admission and enrollment of students; and the following shall be the subjects for such matriculation or preliminary examination: Compulsory,English Language, including Grammar and Composition; Arithmetic, including Vulgar and Decimal examinarioin Fractions; Algebia, including Simple Equations; Geometry: first twe books of Euclid; Latin translation and Grammar ; and one of the following optional subjects: Greek, French, German, Natural Philosophy, including Mechanics, Hydrostatics, and Pneumatics.

It shall not be necessary for students graduating Graduates in any College in any of the Provinces forming the in other Dominion of Canada, other than Ontario, to pass the Provinces matriculation or preliminary examination in Ontario, not requircd prior to being examined by the Board of Examiners, as examination provided in the twenty-third section of this Act, oxamoducting if the person presenting himself for examination shall certincate, produce a certificate showing that he has passed a matriculation or preliminary examination at the College where he may have graduated, equal to that prescribed by the Council in Ontario.

XXXIV. The Council shall have power and authority to fix and determine from time to time a curriculum of studies to be pursued by students, and such curriculum of studies shall be observed and taught by ail colleges or bodies referved to in section eight of this Act: Provided always, that such curriculum of studies shall first receive the approval of the Lieutenant-Governor in Council, and be published once in the Ontario Gazette; and that no change in the curriculum at any time existing shall come into effect until six months after the first publication in the said Ontario Gazette.

## 'Penal and General Clatbes.

XXXV. Any registered medical practitioner, who shall have been couvicted of any felony in any Court, shall thereby forfeit his right to registration, and, by the direction of the Council, his name shail be erased from the register; or in case a person known to have been convicted of felony, shall present himself for registration, the Registrar shall have power to refuse such registration.

Interpretation of certain rords.
XXXVI. No person shall be entitled to recover any charge in any Court of law for any Medical or Surgical advice, or for attendance, or for the performance of auy operation, or for any medicine which he shall have prescribed or supplied, unless he shall prove upon the trial that he is registered under this Act.
XXXVII. The words "legally qualified medical practitioner," or "duly qualified medical practitioner," or any other words importing legal recognition of any person as a medical practitioner or member of the medical profession, when used in any Act or law, shall, in so far as such Act or law applies to this Province, be construed to mean a person registered under this Act.

Registration nocessary for appointment to hospitals, etc.:
XXXVIII. No person shall be appointed as medical officer, physician or surgeon in any branch of the public service of the Provisce of Ontario, or in any. hospital or other charitable institution, not supported wholly by voluntary contributions, unless he be registered under the provisions of this Act.

XL. If any person shall wilfully procure, or attempt Penalty for to procure, himself to be registered under this Act by wrongtuly making or producing, or causing to be made or pro- procuring duced, any false or fraudulent representation or declaration, either verbally or in writing, every such person so offending, and every person knowingly aiding and assisting him therein, shall incur a penalty of fifty dollars.
XII. Any person tho shall wilfully and falsely Punshment pretend to be a physician, doctor of medicine, licenti- of persons ate in medicine or surgery, master of surgery, bachelor tending to be of medicine, surgeon or general practitioner, or shall ${ }^{\text {physcians. }}$ practice medicine, surgery or midvifery, for hire, gain or hope of reward, or shall falsely take or use any name, title, addition or description, implying, or calculated to lead people to infer that he is registered under this Act, or that he is recognised by law as a physician surgeon or accoucheur, or a licentiate in medicine, surgery, or midwifery, or a practitioner in medicine, shall, upon a summary conviction before any Justice of the Peace, for any such offence, pay a sum not exceeding one hundred dollars, nor less than twenty-five dollars.
XLII. It shall be the duty of the Member of the Mambers of Council representing each territorial division to notify councin to the Registrar of the Council of the death cf any registered medical practitioner occurring within his division, so soon as he shall become aware of the same; and upon the receipt of such notification, the Registrar shall erase the name of the person so deceased from the register.
XLIII. All penalties imposed by this Act shall be Hop pentlrecorerable, with full costs of suit, by the Council in ed. the name of the College of Physicians and Surgeons of Ontario.

1. License to practise Physic, Surgery and Midwifery, or either, within Upper Canada, granted under the Acts of Upper Canada, fifty-nine George the Third, chapter thirteen, and eight George the Fourth, chapter three, respectively.
2. License or diploma granted nuder the second: Fictoria, chapter thirty-eight, or under the Consolidated Statutes for Upper Canada, chapter forty, or any Act amending the same.
3.
