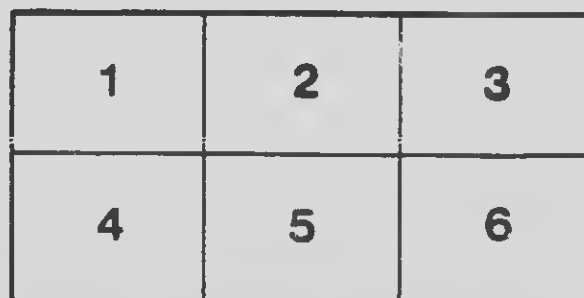

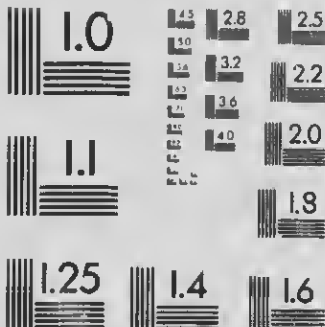

AS TO THIS COLLECTION.

This collection of maps and plans of the old town of York, now the city of Toronto, in the Province of Ontario, formerly part of the old Province of Canada, and afterwards the Province of Upper Canada, contains, I believe, every map or plan that has ever been issued by either the city or the military authorities since 1788.

The plans comprise original drawings, lithographs and photographs, or accurate copies of originals. These latter include plans made by the officials of the Civil Government and by the military authorities, from 1788, when the first plan of the proposed town of York was made to Capt. Gottermann.

The catalogue is divided into two parts, for the reason that the collection is in two forms. Part I. includes the plans contained in eleven portfolios, and Part II. comprises maps and plans that are mounted in single form, being too large to be inserted in portfolios.

Part I. also contains maps and plans of some other places in the Dominion which came to my hand in connection with my searches for maps and plans of places in Ontario.

For instance, the photo of Lake Ontario showing the British and French fleets in 1757, taken from the original in the British Museum, had never been published, not even copied, since it was made in 1757, until it appeared in Vol. 2 opposite p.p. 819-20, Robertson's Landmarks.

The plan of Annapolis Royal is unique, and was copied for me as an authentic representation of the fort within which the first Masonic Lodge in British North America met about 1737.

The plans of Louisbourg, 1757, of Montreal, 1744, and of the Island of St. John, now Newfoundland, 1758; of the River St. Lawrence, of Quebec and Montreal, all in 1759, are interesting reproductions.

The plans of Niagara and Fort Erie in 1812, and of Kingston in 1790, are originals, while that of Detroit in 1812 is a copy, the original being in the Canadian Archives.

The plan of Fort Niagara, 1773, is the most accurate ever made. The original is in the British Museum.

Part II. includes the larger portion of the collection. The description of each plan or map in the letter press of the catalogue gives all information that is necessary.

This part comprises originals and copies. All the copies are duly credited and acknowledged. All those copied from originals in the Archives Department at Ottawa were copied through the courtesy of my friend, Dr. Doughty, the Archivist of the Dominion, whom the people of Canada may thank for the admirable collection of maps, plans and drawings of places in Canada, now to be found in the Archives Building at Ottawa, which the country owes to the untiring efforts of the Hon. Sydney Fisher, the Minister of Agriculture.

I have been careful in preparing this catalogue to give the detailed facts connected with each map, plan or drawing, so that those who are interested in the history of Toronto or in Dominion history, may be fully informed as to the value in an historical sense of each map or plan.

The plan of Toronto in 1851, by Mr. Sandford Fleming, now Sir Sandford, is from the only original lithograph in existence. It is in my possession. The plan was drawn on stone by Mr. Fleming's own hand. The print I have is not in the very best of condition, but in order that I might have a perfect copy I had the print redrawn by Mr. Perelra, of the Department of the Interior, and it is so exactly drawn that Sir Sandford has kindly certified in writing to its accuracy.



The military plans of York and Toronto, copied for me by Mr. Perelra, under the direction of Dr. Doughty, are the best specimens extant of map work that I have ever seen. They are in each case perfect reproductions.

Some of the plans of the County of York and of Yorkville were kindly presented to me by my friend Mr. Gardner, of the Migt Directory Co.

The miscellaneous maps and plans from the Archives of the Provincial Government of Ontario were drawn for me by the late Mr. Revell, of the Crown Lands Department, Toronto. There are seven of these plans showing: (1) Canada under French Rule prior to 1713. (2) Canada after the Treaty of Utrecht, 1713. (3) Canada after the Treaty of Paris, 1763. (4) Canada after the Quebec Act, 1774. (5) Canada after the Treaty of Paris, 1783. (6) Canada in 1791 and in 1884. (7) Canada in 1896.

I have also given a Masonic Map of the Districts of the Grand Lodge of Canada in 1886, drawn by me when Chairman of the Committee of Grand Lodge which made the Redistribution of Districts. It is the first and only map of the kind drawn for a Canadian Grand Lodge.

To this catalogue is also added a list of the maps and plans of Toronto and the County of York in the City Engineer's and in the City Surveyor's Departments at the City Hall, duplicates of which are in my collection.

These maps and plans are not for sale. They have been collected by me for the purpose of preserving documents connected with the history of the city.

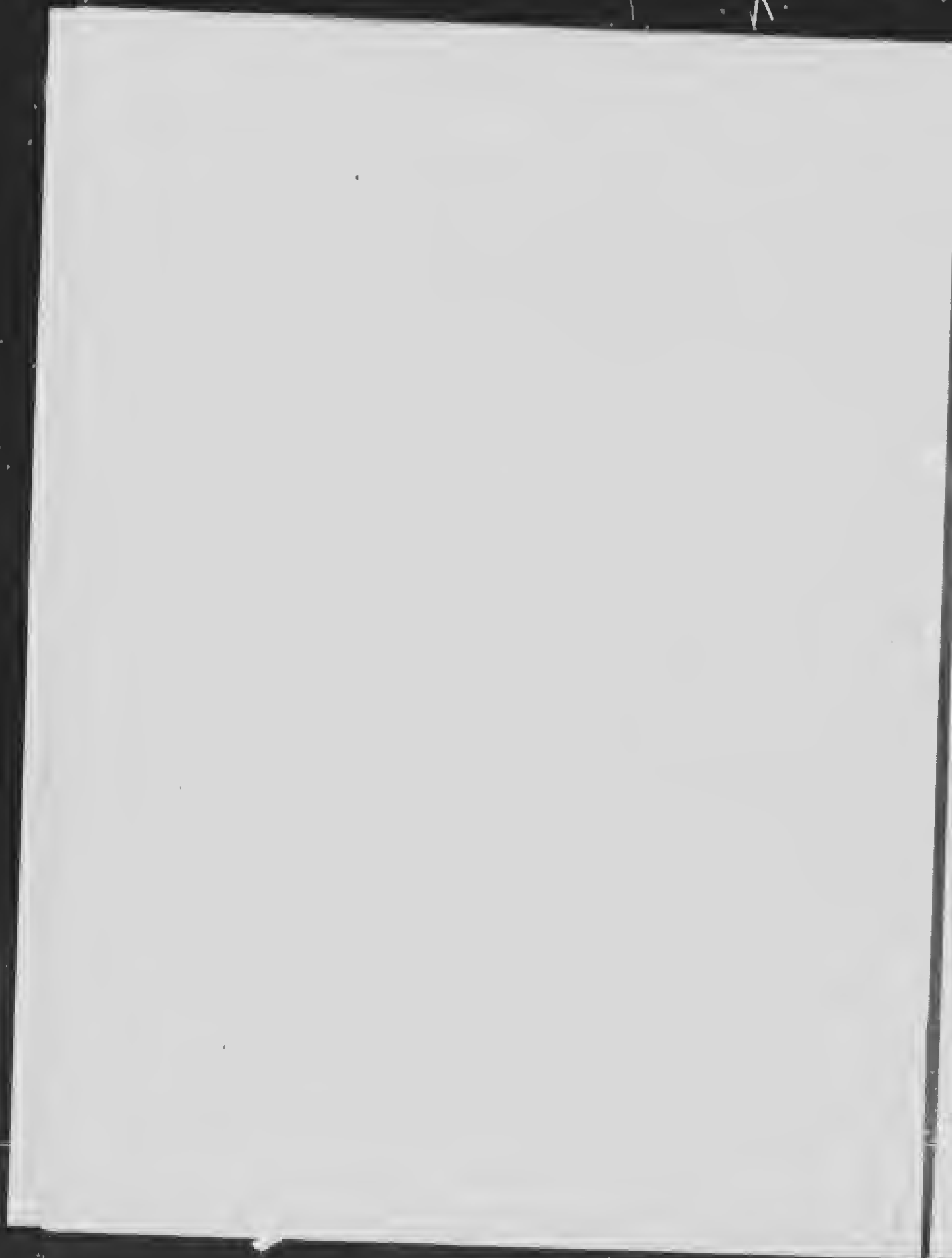
The collection is in the library of my residence, 291 Sherbourne street, Toronto.

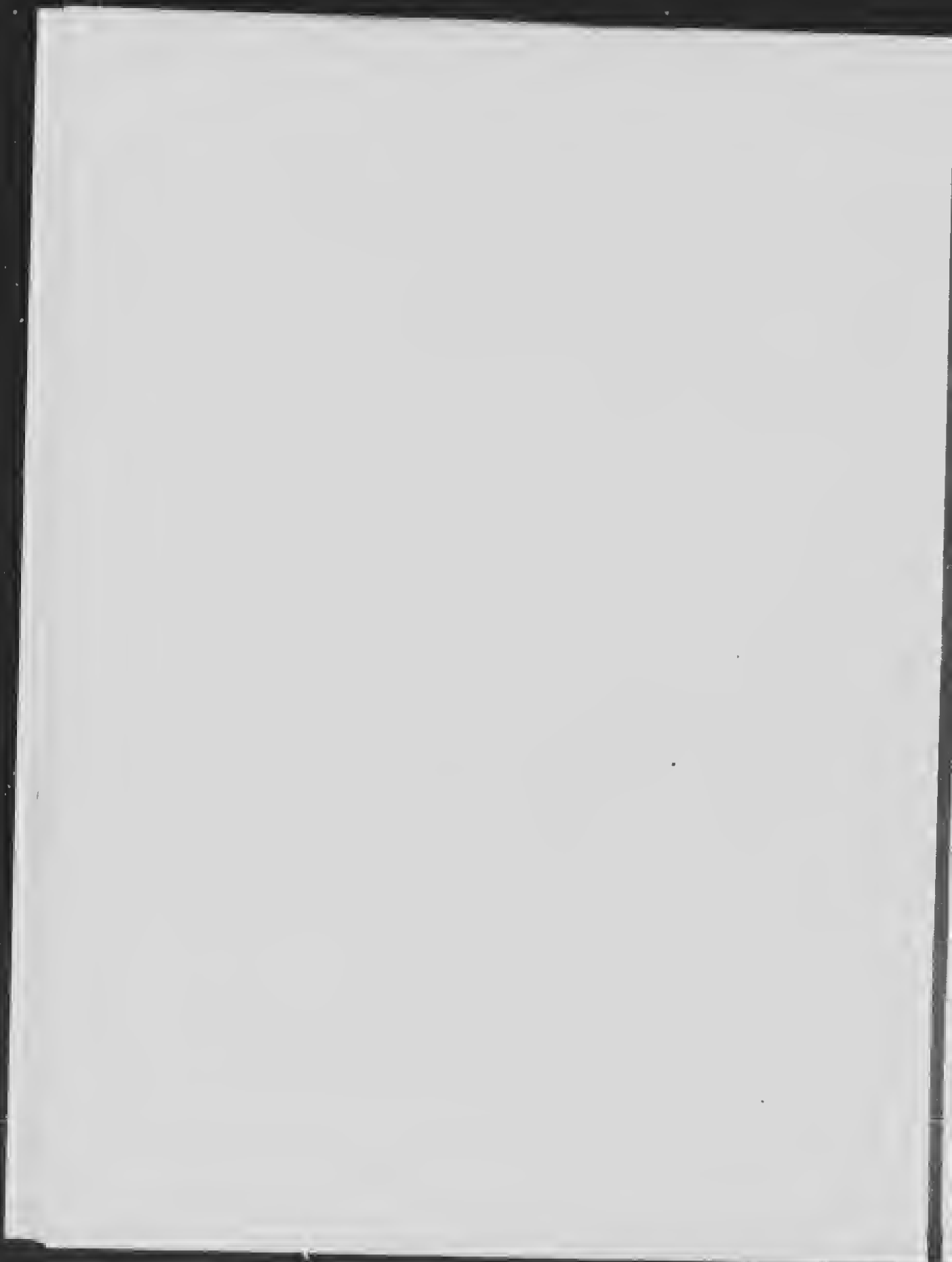

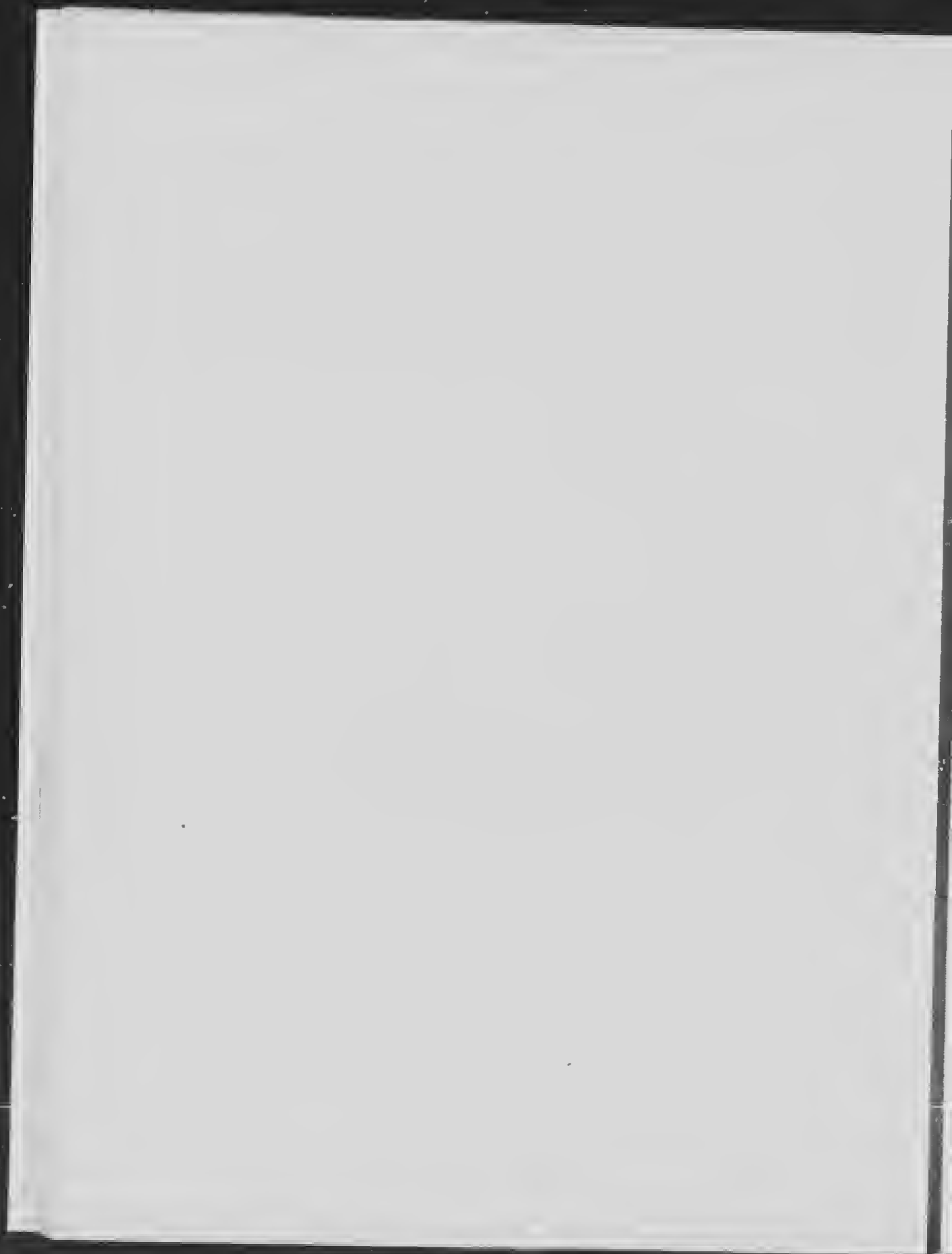

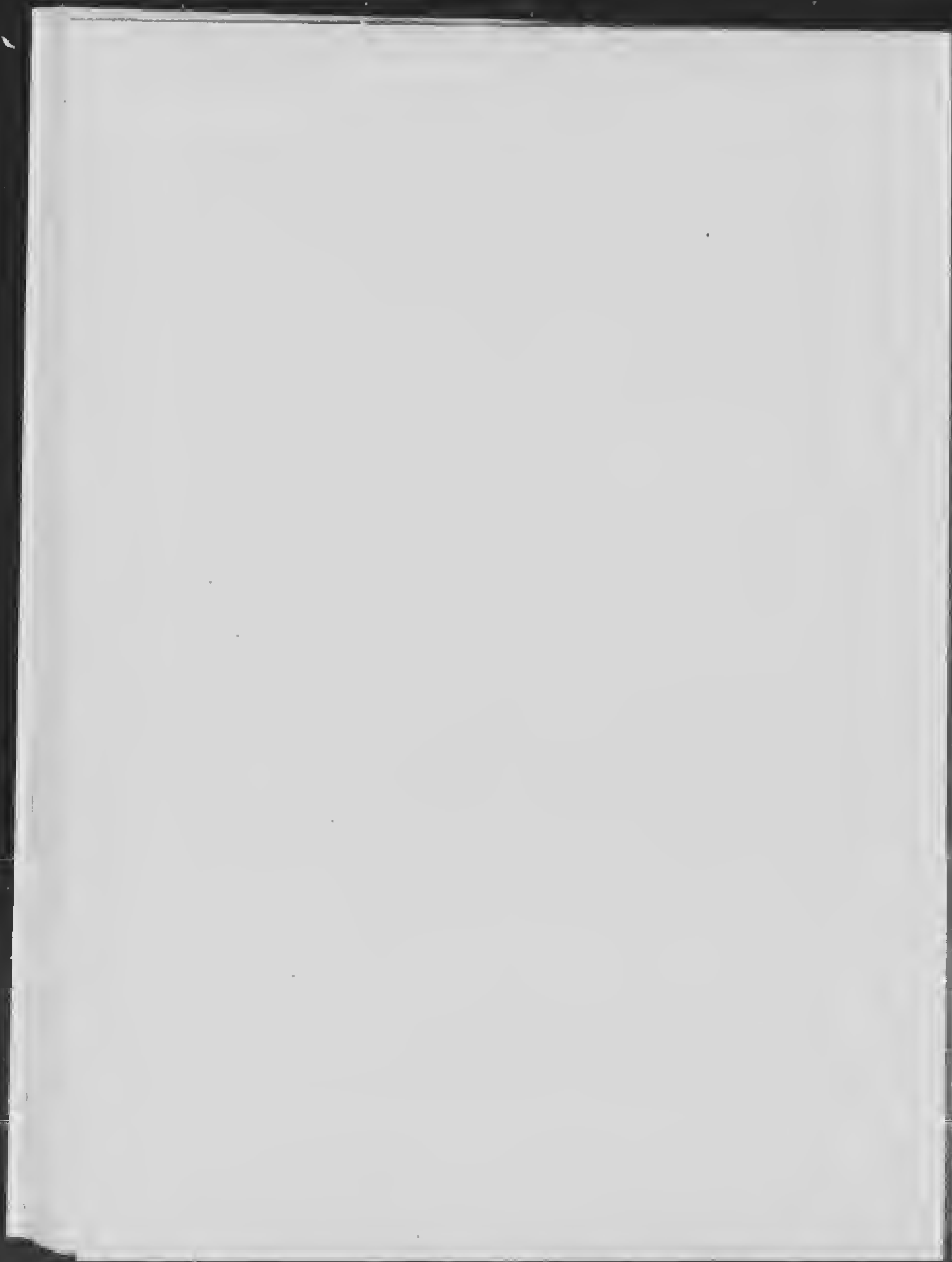

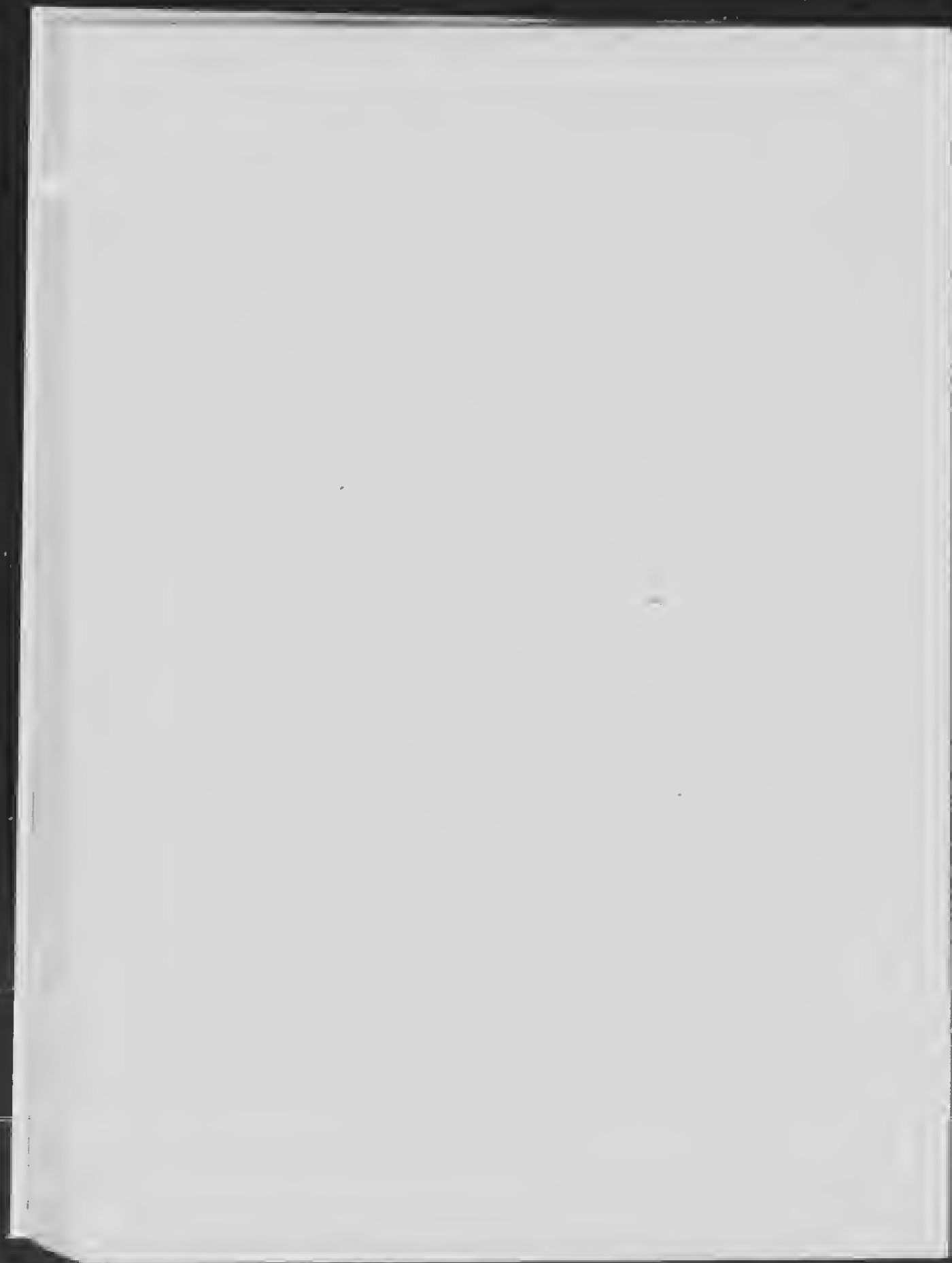

Memoranda.

The actual variation of the compass is not set down, as it is proposed to ascertain it this winter. It is, however, known to be very small; at Niagara it is nothing.

The shoal has extended of late years greatly to the westward. The soil on the Reserve and about the town is a strong clay, with large granite boulders on and in it. Also, it is full of small fragments of the same, of limestone, and of bituminous coal slate; it reposes on limestone rock full of ennermites; this rock has some good building layers near its surface; is uncovered on the beach at French Fort Point, but the beds being horizontal, as the land rises, is too thickly covered to pay the expense of quarrying. Building stone of fine quality is therefore, only to be had from Kingston, from Queenston, or from Hamilton on Burlington Bay.

Memoranda.

By a recent census, York contains 9,009 inhabitants in the town and suburbs. There are eight steamboats of the larger class and two smaller steam jacks constantly plying for the port, besides very many fine schooners and sailboats. There are two extensive foundries for steam engines in the town, a steam windmill, a paper mill near it, and an extensive and improving fishery for herring, whitefish and salmon has been established this year for home consumption and salting.

A salt spring has been discovered near the Military Hospital, and brine springs are met with in every part of the town in digging wells at a depth of from 30 to 50 feet.

Large pieces of bituminous slate coal are washed upon the lake shore after storms, and the clay forming the steep bank of the shore is full of small pieces of it.

Description.

On the 13th and following days of December, 1851, by authority of the headquarter respective officers of Her Majesty's Ordnance, dated the 28th November, 1851, I, Sandford Fleming, Provincial Land Surveyor, of Toronto, Province of Canada, proceeded to survey and define the boundaries and limits of certain parcels or tracts of land and water vested (under the Provincial Act VII., Victoria, Cap. XI.) in the principal officers of Her Majesty's Ordnance, for military purposes, after examining the various records in the Ordnance and Crown Land Departments in this province relating to the same, together with the titles of the adjoining pro



prietors and the evidence of several old inhabitants respecting the original boundary lines, and being guided by the Act, XII, Victoria, Cap. 35, commenced the survey of the Garrison Reserve at a point marked on the plan O.B.S. I., near the south-west end of the said reserve to the east side of road allowance between it and lot 31, in the broken front of the township of York, and about one chain from the water's edge of Lake Ontario; thence north fifteen degrees twenty-nine minutes west along said side of road allowance, twenty-four chains to O.B.S. 1½; thence on the continuation of said line forty-two chains, ninety-six links to O.B.S. II., on south side of Queen street; making the whole distance of said line sixty-six chains ninety-six links; thence north seventy-four degrees thirty-one minutes east along Queen street, eighteen chains thirty links to O.B.S. III., being the north-west angle of the land belonging to the Lunatic Asylum; the last mentioned line crosses the track of the Ontario, Simcoe and Lake Huron Railway at three chains forty-three links; thence from O.B.S. III. to O.B.S. IV., along the west boundary of the asylum grounds south fifteen degrees twenty-nine minutes east, twelve chains twelve links; thence to O.B.S. V. along the southern boundary of asylum grounds, north, seventy-four degrees thirty-one minutes east, forty-one chains twenty-nine links; thence along the east boundary of asylum grounds, north, fifteen degrees twenty-nine minutes west twelve chains twelve links, to O.B.S. VI.; thence along the south side of Queen street north seventy-four degrees thirty-one minutes east, four chains sixty-five links, O.B.S. VII.; thence along the west boundary of Farr's lot, south, fifteen degrees twenty-nine minutes east, three chains sixteen links to O.B.S. VIII.; thence along the southern boundary of Farr's lot north seventy-four degrees thirty-one minutes east, six chains thirty-two links to

O.B.S. IX.; thence along the eastern boundary of Farr's lot north fifteen degrees twenty-nine minutes west, three chains sixteen links to O.B.S. X., being a point in the south side of Queen street four feet westward from the west side of opening of Stone Bridge; thence from O.B.S. X. along Queen street (crossing stream) north seventy-four degrees thirty-one minutes east, two chains ten links to O.B.S. XI.; thence south-easterly along a curve (common to the town lots) of seventy chains radius, for a distance of eleven chains seventy-eight links to O.B.S. XII., being on the south side of the termination of Adelaide street; thence in continuation of the same curve six hundred and forty-six links more to O.B.S. XII., with the termination of the north side of King street; thence nearly in the same direction along a curve (with a radius of twenty-nine chains twenty-five links), eleven hundred and five links to O.B.S. XIX., in the east side of Brock street produced; thence to O.B.S. XIX. along the said line produced north sixteen degrees thirty-two minutes west two chains thirty-five links to O.B.S. XX., on the south side of Front street; thence along said side of Front street, allowing ninety feet for the width thereof) north seventy degrees twenty-two minutes east, nine chains eighty-six and half links, to O.B.S. XXI., in the west side of Peter street produced; thence along said side produced, south, sixteen degrees twenty-five minutes east three chains sixty-eight links to O.B.S. XXII.; thence in the same direction about one chain thirty links more to the water's edge; thence easterly along water's edge to a point in the east side of Peter street produced; thence along the said line produced common the City Waterworks lot, south sixteen degrees twenty-five minutes east, about thirteen chains twenty links into deep water, commonly called "The Wind Mill Line"; thence along this line south sixty-five degrees seventeen minutes west, about thirty-eight chains twenty-one links to the outer angle of Queen's Wharf, the place of beginning.

Thirdly — Commencing at O.B.S. XXII., top of bank, four chains sixty-eight links eastward from O.B.S. XXII., thence easterly along the top of the bank bounding the commissariat stores

wharf, etc., about eighteen chains to O.B.S. XXV., a point one chain fifty links from the south side of Front street, and distant from the west side of Simcoe street produced three chains seventy links; thence from O.B.S. XXV. south sixteen degrees twenty-four minutes east along the west side of Dr. Rees' water lot about fourteen chains twenty-five links to the deep water or Windmill Line; thence along said line south sixty-five degrees seventy minutes west about seventeen chains seventy links; thence north sixteen degrees twenty-five minutes west along east boundary of the City Waterworks Lot about fourteen chains ten links to the place of beginning.

Fourthly — Bathurst street Barracks — Commencing at O.B.S. XXVI., at the north-west angle at the Reserve Junction of Bathurst and Queen streets. The detail was then surveyed, and laid down in its true position as represented within the boundary lines, edged in "red" on this plan, and the several blocks computed separately, as shown in the Table of Contents, making a total (computing to the water's edge of five hundred and ten acres, two roods, and twenty-two perches of land and two hundred and three acres, two roods of water.

Boundary stones were also fixed in the ground by me at the points marked in plan O.B.S. I. to O.B.S. XXV., and from O.B.S. XXX. to O.B.S. XXXVII., inclusive, marked B.O., and numbered as shown on plan, and whose exterior faces represent the correct line of bound-

ary; the stones have been sunk in the ground where practicable three feet and standing above it about one foot. Broken glass bottles have been placed under them to mark their position.

The boundary stones from XXVI. to XXIX. inclusive were placed under the direction of the Royal Engineer Department in the year 1816.

The bearings of the boundary lines are from the true meridian, taken on the spot for the occasion, and compared with and verified by the meridian of the Magnetic Observatory of Toronto.

From the records of the Surveyor-General's office it appears the township of Dublin (now York), in the broken front of which these Reserves are situated, was first surveyed under authority of the Surveyor-General in the years 1791-3 by Mr. Augustus Jones, Deputy Provincial Surveyor. The extent set apart for military purposes by authority of Lieut. Governor Simcoe in 1792 or 1793 were nine lots in the same broken front from 24 to 32 inclusive, and consisted of about one thousand acres. It was bounded on the north by the road allowance (now Queen street), between the broken front and first concession; on the south by the waters of Lake Ontario; on the east by side line (now Peter street) of lots 23-24; on the west by side line of lots 32-33.

In the year 1808 about thirty-two acres were taken off by limiting the property to the north-east within one thousand yards radius from the easternmost exterior angle of "Old Fort." Of this quantity twenty-two acres was by Order-in-Council of 19th April, 1808, granted to William Holton, and ten acres by Order-in-Council of 20th November, 1810, to John McDonell. On the west side the property was reduced to the present limit by a grant of lots 31-32, containing two hundred and forty acres, to James Brock, by Order-in-Council dated 15th March, 1812.



That part of the original Reserve eastward of the railway and within the arc extending to Peter and Queen streets, was sold in town lots for the extension of the city with the consent of the Master General and Board of Ordnance, as laid down on the plan signed by Sir E. B. Hind, Lieut. Gov., dated 21st Feb., 1837. Lots 9, 19 and 11, in Queen street (between Bathurst and Portland streets) remaining unsold in the years 1838 and 1839, and being required for military purposes were reoccupied by the Ordnance, with the consent of the Local Government, and are vested in the principal officers of Her Majesty's Ordnance, by act 17th Victoria, Cap. 11. Lots 19 and 20 were relinquished by the original purchasers to the Government for commissariat purposes, and are vested in the Ordnance by the same act. The land along the beach east of Peter street has been occupied by the Military Department for nearly forty years.

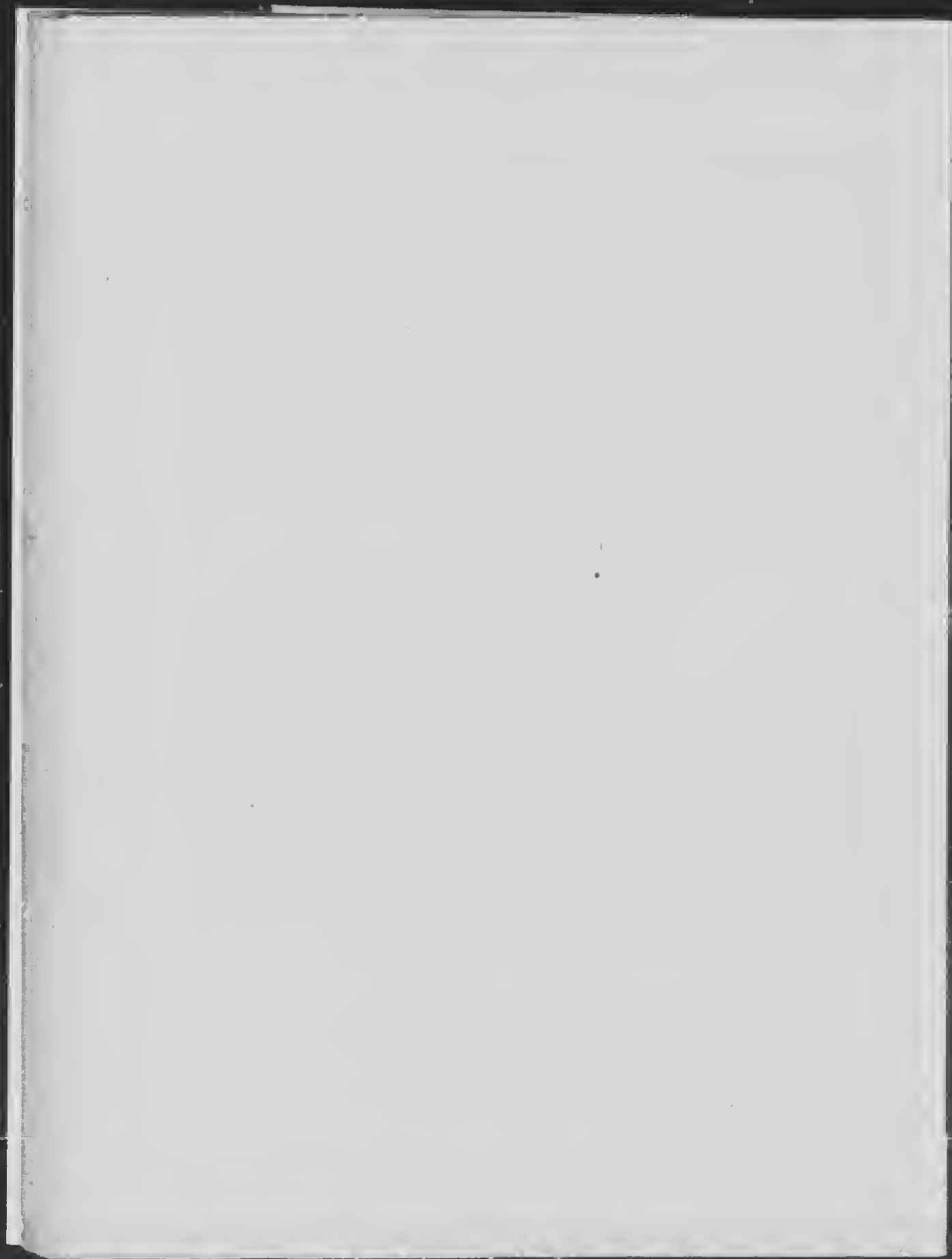
