

THE CIRCULAR LETTER OF THE NOVA SCOTIA CENTRAL BAPTI ASSOCIATION TO THE MEMBERS OF THE CHURCHES OF WHICH IS COMPOSED.

Now all y have and are, belong to Christ, and yet withhold the means of ancing his precious cause !

to report the the system your Committee would recommend is a quarterly ection through the medium of envelopes prepared for the pose and distributed among the members of the church and

congregation, so that all may have the opportunity of giving as God hath prospered them : the total sum thus received to be appropriated according to a scale of per centage previously agreed upon.

Your Committee would urge upon the different Pastors of the churches the duty and importance of bringing this matter befor their respective flocks, and of urging every member thereof to d something. Any professing Christian who cannot listen to sermon on the christian duty of giving-who cannot stand this kind o fire-is not fit to fight the battles of the Lord. It is found that the pastors who lead their churches in the work of Christia benevolence, receive a better support from them than those who And these ministers who are ever hinting that their own not. poor support is a reason why their people should not give the money freely to the Lord, hereby show that a poor support is about all they deserve.

In conclusion your Committee trust that the recommendations this report be not suffered to remain a dead letter, but be immed ately and efficiently carried out by all the churches.

The Baptists of the Province have affirmed in their annu meetings, for many years, their belief that education is an importa ally in christian work,-that provision should be made by which t churches may have the services of an educated ministry,-that it the duty of all parents to provide for the intellectual, as well moral, development of their children,-and that the property christians should be conscientiously used to promote the educati in its various grades and departments.

2. That the repeated affirmations of these truths have be something more than idle words is plainly proved by the la continued and growing attachment cherished by our people town their institutions of learning.

3. The advantages of an educational system, which is develop into distinct grades, are now within the reach of our people. (children can find in the common schools preparation for study in Academy; in that institution all students who desire it can fitted for College; and in that department young men are conduc through a higher course of education and are then sent forward the various professional schools. Some of these departments education may well be left in connection with a public education system; but it will be better that the Academy and the Col should be so far under denominational control that there may b them a free and full recognition of the truth and claims of the while B Christian Religion, that thus mental power may be developed to been com used in subjection to moral principles and purposes.

4. All measures that are adapted to make the common schools better and more useful, should receive cordial support from us : but the educational agencies which are in more immediate connection with the denomination, demand especial consideration at the present ime. In order that the Theological department may accomplish is purpose, it must have the generous and constant sympathy of the aders of our churches. It is an occasion for great thankfulness hat the Academy is so prosperous, both in its finances and in the number of students in attendance : but it must be remembered that a large debt still lies on the new Boarding Hall, and contingencies my arise in which this may prove a serious inconvenience. It is my important that the Governors of the College should have afficient funds to meet promptly all demands that may be made m them, in order that the College may maintain an bonorable mition in the educational work of the Provinces. The increase in he Provincial Grant will give assistance for a short time; but the fovernors must have larger resources at their command, or the mmise of the College cannot be fulfilled.

5. Collegiate education in the Province is evidently passing through an important crisis. What will result from the changes that have recently occurred and from others that are contemplated, it will be difficult to foresee. But certainly the questions concerning allegiate education, which have recently been presented for considertion and decision, are so serious that they demand the calmest isdom in deliberation and the greatest prudence in action.

It shall be the duty of the Moderator to preside in all the transas, maintain due order, and nominate Committees, unless otherwise red by the Association. A Secretary shall be chosen, whose duty it shall record the transactions of the Association, and to furnish a correct copy the for the press; he is also to remain in office till his successor is the.

n. 5th.—It shall be the duty of each Church to send by its messengers er to the Association giving an account of its state, particularly of the ons and diminutions within the last year, and generally of whatsoever is to its peace and prosperity.

r. 6th.—At each annual Meeting the letters from the Churches shall be anded in, from which the Secretary shall immediately make out a list legates. The election of Moderator and Secretaryshall then take place, which the letters shall be read. Committees nominated by the Moderator not consist of more than five brethren, of whom three shall constitute rum. When large committees are judged desirable they shall be need by the Association, and two-thirds of the members appointed shall neeten to act.

7.7th.—When any Church shall desire admittance into this body, apon must be made by letter, and satisfactory evidence furnished of imad order; this being done and a vote of acceptance taken, the Moderaall, in behalf of the Association, give to one of its messengers present thand of fellowship.

8th.—When any Church shall neglect to make communication for fars successively it shall be considered as having withdrawn from us, all be dropped from the Minutes, unless two or more members shall tits continuance and shall engage to enquire into its standing, and at the next meeting of the Association.

9th—Although as an Association all power over the Churches is med, so far as respects any interference with their independence and me; yet it is deemed a privilege belonging to the Association to judge elf of the propriety of receiving or retaining any Church in its ion ART. 11th.—That the Moderator be authorized at any time during t year, to call a special meeting of the Association in pursuance of a requisit signed by ten members thereof.

ART. 12th.—Alterations and amendments may be made to this Constitute by a vote of two-thirds of the members present at any of its regular meeting

All Associations had recommended that instead of an appeal to churches for financial aid by the voice of an Agent, applie should be made to them by letter. Your Board, therefore, alth doubtful of the propriety of this course, felt morally bom relinquish their hold on a General Agent. The Rev. Mr. Fra who had acted in this capacity was subsequently stationed at Glasgow, where he laboured for some time with encour success.

In compliance with the recommendation of the Association, Board prepared an appeal to the churches for financial assis A circular containing this Appeal was sent to each church in Scotia and P. E. Island. Your Board regret to say that, exa a few instances, the churches did not respond, and the appel almost a complete failure. What was to be done ? The F Missionary needed his salary. The money was not in hand. Board were compelled to act against their former exp opinions. They were forced to take the missionary from legitimate work and send him on a collecting tour. The ch visited kindly responded to the appeal made to them, and hoped that the addresses delivered by the missionary may a greater interest in the French Mission.

Had a fair share of encouragement been given the Board an immense deal of good would have been accomplish in this department, but objections were raised against the wh plan, and the efforts of your Board were in a great mes thwarted. The Board believe that the world has need of a Bap literature. Baptists need it too. When Temperance Reform wish to create a temperance sentiment, they spread abread temperance literature. If Baptists wish to spread their prince and indoctrinate their youth they should use a Baptist literat The Board wish to create a correct sentiment on this subject, they find it a difficult task. While prominent Baptist miniand influential laymen are officers of a so-called Union Book Tract Society, and while Baptist churches supply their Sad Schools from that source it is not an easy matter to make m progress in this department.
