SOME FACTS AND FIGURES

Remarkable Falling Off in the Amount of Japan Tea Imported into Canada.

Mr. P. C. Larkin Tells Why Ceylon Tea is Disappearing All Competitors.

The World yesterday morning published a despatch from Montreal to the effect that a movement is on foot to form a trust in the Japan tea trade with a capital of \$500,000. This report caused considerable talk among the wholesale trade in Toronto, and to ascertain the truth of the despatch, and the causes which have led to the combination, The World sought an interview with some of the leading tea importers. Mr. P. C. Larkin of the Salada Tea Company, importer of the "Salada" brand in Canada, said the trust had been formed with a view of checking the decline of the Japan tea industry, which has shown a remarkable falling off in the past year. "Why, do you know," said he, "the importation of Japan tea into Canada last year dropped to 3,000,000 pounds, the smallest amount imported in any previous year being over 12,000,000 pounds. This decline is the result of the competition of Ceylon tea. These have only been made in Ceylon during the past two years; previous to that time they were imported from India. The Ceylon tea is superior in quality and price, and it is only a matter of time before the Ceylon tea will completely displace the Japan tea."

THE ANGLE IN THE CENSUS

Recalcitrant Enumerators are Holding Back Returns Until Their Pay is in Sight.

BETTER PAY THAN LAST TIME.

Circular Sent Out By Mr. Fisher in an Effort to Settle Matters Satisfactorily.

Ottawa, May 29.—The Census Commissioners and their enumerators are having a dispute over the rate of pay and the returns are being withheld in consequence. The law provides that an enumerator shall be paid at the rate of \$3 for a day's work of eight hours; this shall be represented in rural districts by visiting six families and six farms, or in cities and towns 12 families of an average of five persons each. This is to be given when the work has been "faithfully and entirely performed," which is, of course, interpreted as including the furnishing of reports to the commissioners. At present, enumerators all over the country are holding back returns until their claims for pay are considered, while under the law the claims cannot be considered until the returns are in and the work "faithfully and entirely performed." Mr. Fisher is a special agent sent out by the census commissioners to see that there is not one complete return in the whole Dominion up to the present time. He says that he has seen some returns, but that they are not considered better paid than they were in 1891, as the following table will show:

It is pointed out that the delay in the returns is not due to the fact that the returns are not being made, but that they are being withheld until the enumerators are paid.

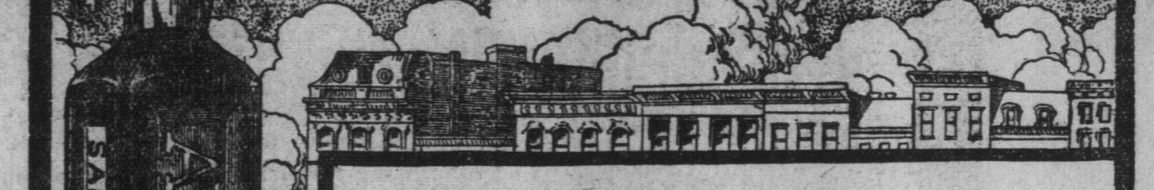
The Three Prisoners Are Refused a Postponement of the Trial—True Bills.

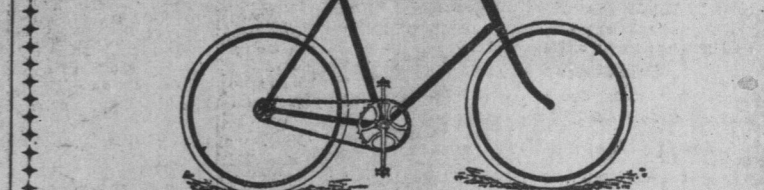

UNDER THE NEW ACT. Changes Made in the Composition of the Senate of Ontario University.
