Against Accused-Himself Committed for Contempt. San Francisco, Dec. 19.-Owing to the death of a juror's sister, there was no morning session in the Botkin day. The taking of evidence at the afternoon session commenced with Miss Lizzie Liv-ernash, a reporter, on the stand. Miss Livernash explained that she was de-tailed to interview Mrs. Botkin at Healdsburg, where the accused was in seclusion at the time of the marder. Miss Livernash told the story of Mrs. Botkin's acquaintance with Dunning, as Mrs. Botkin had told it to her. When told that she was suspected the accused woman became hysterical and said: "Why should I be suspected? It would have been better to have killed the man, and spared the mother to her child." Witness said the prisoner spoke of some letters in conection with the case, and asked witness if handwriting experts.
