

FIRES.

The manufacturing portion of the St. John's Stone-Chinaware Company's Works, owned and operated by Messrs. D. & A. MacDonald, was burned to the ground on Saturday last. The loss is estimated at \$100,000, on which there is \$55,000 of insurance.—Mr. J. E. Martineau's hardware store on St. Joseph street, St. Rochs, Qu..., was destroyed by fire last week. The loss is estimated at \$25,000, on which there is an insurance of \$20,000.—The wood-working department at the Central Prison, Toronto, a brick building 250 x 50 feet, together with all the machinery and tools, was destroyed by fire on Saturday last. The loss on the building is estimated at \$20,000, and on the machinery and tools \$30,000. There was no insurance on the building.—An explosion occurred in the manufactory of the Ontario Silver Company at Humberstone, Ont., by which the building and plant was almost totally destroyed. The damage to the building, which was a large one, is very extensive. The plant was valued at \$75,000, but it is thought some of it is not much injured.—A building at Lakefield, Ont., owned by the Lakefield Lumber Company and occupied by Strickland & Co as a canoe factory, Gerald Fitzgerald as a blacksmith shop, and the Lakefield Electric Light Company, has been completely destroyed by fire. The losses are as follows: Building \$1,500, partly insured: Lakefield Electric Light Co. \$3,000, no insurance; Strickland & Co. about \$2,500, partly insured; G. Fitzgerald \$300.—A Co. \$3,000, no insurance; Strickland & Co. about \$2,500, partly insured; G. Fitzgerald \$300.—A

building on Barrington street, Halifax, owned by the estate of the late W. Mackintosh, was destroyed by fire last week. It was insured for \$1,500, which will probably cover the loss.—A deputation consisting of Mayor Essery, Ald. Coo, Fitzgerald and Parnell, and Mr. A. O. Graydon, city engineer, recently visited Montieal for the purpose of enquiring into the question of fire alarms, electric lighting, and the cremating of garbage.—The store of Fred Ward, at Thurso, Que., together with the post office and G. N. W. Telegraph Company's office, were destroyed by fire on the 3rd inst. The building was owned by Mr. George Edwards, whose loss is about \$3,000.

#### TEST LOADS EOR BRIDGES.

Quite a lively little controversy has been going on for several weeks past in some of the German technical journals on the value of test loads for bridges, a matter which, at various times, has been discussed at such length that it might well have been considered as disposed of definitely and finally. The immediate cause of its revival appears to have been given by the results of a recent examination, by a railroad company, of one of the iron bridges on its line, the examination having revealed the existence of a very considerable degree of local corrosion. Test loading of the of local corrosion. Test loading of the bridge, just before and again just after this discovery was made, showed only a moderate degree of deflection, well within what was considered a permissible limit, and the company accordingly took the stand that the safety of the bridge was practically unimpaired, and that the structure might be continued in use without re-inforcement or repairs. Thereupon the Centralblatt de Bauverwaltung took up the matter, criticising the conclusions of the company, and giving emphasis to the fact that while unduly great deflection of a structure under a test load unquestionably demonstrates weakness, moder ate deflection is no guarantee whatever of The way having thus been paved for further discussion, several cor espondents were not slow to avail themselves of it and the bombardment with letters pa and con, therefore, merrily proceeded.

After all, however, the fact remains that the position taken by our German contemporary is substantially correct, and by far the larger number of bridge engineers both here and alread will readily agree. both here and abroad, will readily agree to it. Test loading of a bridge really seems to be but a strangely surviving relic of the usual opening ceremonies, and with the development of the science of bridge building, has gradually lost all significance as a measure of safety. The reason why it has been retained may be found largely in the fact that, in general, it lends impressiveness to the ceremonies which usually accompany the completion of a bridge or its surrender to traffic, and, further, that the public wants some occular demonstration of a structure's sustaining power before putting any trust in it To the engineer, however, the application of a test load tells nothing that his strain sheets have not already told him. It is strange only that there are still some practicing engineers who will not admit this.—The Mechanical News.

#### LEGAL DECISIONS AFFECTING MUNICIPALITIES.

IN RE MUNICIPALITY OF SOTTH NOR-FOLK v. WARREN.—This was an applica-tion by a defendant in an action brought against him in a county court by a rural municipality, to prohibit further proceed-ings in the action. The claim was for taxes on a half section of land for the year 1888, 1890 and 1891, and interest. The defendant entered a dispute note, whereby he denied liability, on the ground that he was not the owner of the land in question before the year 1891, and that previously to 16th October, 1800, the land was Crown land, the property of the Dominion of Canada, and exempt from taxation, the land on the last mentioned date having been purchased from the Crown by Duncan McArthur. The defendant also disputed the jurisdiction of the County Court to try the action so far as it related to taxes accrued before the year 1891, on the ground that the title to the land was in question. He paid into the Court the amount claimed for taxes for The action came on for trial on 10th June, 1892, and counsel for the defendant objected at the outset to the jurisdiction of the Court. The judge of County Court, however, proceeded with the trial. For the plaintiffs the assessment and collection rolls for the various years were produced and put in evidence. In the assessment rolls the defendant was

assessed as owner of the land mentioned: and in the collection rolls his name appears m columns headed "owner or tenant," but without anything to distinguish in which capacity he was assessed. The defendant stated he took up the land in 1852 as a homestead and pre-emption; he paid the taxes from 1892 to 1887; his entry was cancelled in 1890; that the Government allowed him to nominate a purchaser; he nominated McArthur; and letters patent were issued to him on 31st October, 1890, and that he had repaid McArthur, and was then, at that time of the trial, the owner of the land. It was contended on behalf of the plaintiffs that the assessment rolls were conclusive evidence of the defendant's liability for assessment in respect of the land; while for the defendant it was argued that until the issue of the letters patent granting the lands, they were not assessable, and that the inquiry as to the fact involved the trial of the question of title. The County Court Judge held, that the assessment rolls were not conclusive upon the question of exemption, but that lands of the Crown held under homestead or pre-emption entry were assessable as against the person so holding; that the mode of describing the defending in the assessment roll, whether as owner or otherwise, was im material to his liability; and that, as the defendant admitted his homestead and pre-emption entry, no question of title was in dispute. *Held*, by Killun, J, of Manitoba, that the County Court Judge was right in so holding upon all these points.

RE FOSTER AND CITY OF HAMILTON. -Judgment on summary application to quash a by-law of the city of Hamilton granting a bonus of \$275,000 in aid of the Toronto, Hamilton, and Buffalo Railway Co. The by-law set out in detail the conditions on which alone the railway committed to receive the beauty pany were entitled to receive the bonus. By sub-sec. 4 of s. 634 of the Municipal Act, 55 Vic., ch. 42, the corporation may pass a by-law for granting a bonus to any railway company in aid for the railway and for issuing debentures payable at suchsition to the railway and the such action to the such action to the railway and the such action to the such actions to the su fit. The objection taken amounted to this, that the by-law was defective because the debentures were not to be signed and delivered until after the fulfilment of certain terms and conditions. The learned Chief Justice holds that if effect were given to the objection of the applicant, it would not be possible for the corporation to make a conditional agreement, and that the corporation are expressly em-powered to pass a by-law setting forth the agreement and to make the bonus "payable at such times as the council thinks fit." Motion dismissed with costs.
