THE DELEGATES RETURN.

The Result of Their Mission Retired Outlined.

The delegates have returned from Ottawa with the exception of Mr. Robertson and they all express themselves well pleased with the reception accorded them by the ministers.

The reception given them by Hon. Mr. Foster, minister of finance, was in the words of many Thorne, most cordial and that gentleman expressed himself in full sympathy with our mission and ready and willing to do anything he could for St. John and New Brunswick, generally.

The delegates subsequently met Sir John, Hon. Mr. Foster, Hon. Mr. Cotnam, Sir Hector Langevin, Hon. Mr. Haggard and others and were accompanied by our representative at Ottawa, Sir John.

The government had fully decided that the Atlantic seaboard Steamers should go to Canadian ports only, but they thought the mail steamers being weekly boats, would hardly have to go around to St. John but would land mails and passengers at Halifax. He also said that for some years he had thought St. John was admirably situated for carrying on the West India trade and now the government would turn their attention toward developing that trade, and while he did not say he would allow some extra subsidy to have them come to St. John, he thought if freight offered the steamers would come to St. John for commercial reasons alone.

Mr. George Robertson was also interviewed and he was quite confident in calling attention to the kindly reception they had met with from the government. Mr. Robertson had no doubt as to what are the intentions of the government in relation to the port of St. John.

The government has decided that subsidies shall cease in all cases where foreign goods are imported into and from Canada, and they are trying to secure a fast Atlantic steamship line fully equal to any of the New York lines. That they require and in fact are after three steamers of from 200 to 250 tons each with a speed of from 20 to 22 knots an hour. This would be a large amount of shipping and would be a great benefit to the province.
