It is indeed a delightful privilege thus to come together from various and distant portions of Canada East, to meet each other in Love, Purity, And it has become my agreeable duty to present and Fidelity. for your consideration a Semi-Annual Report, of the state of the Order in Canada East. I am happy in being able to say that our noble Order in Canada East is in an increasing state of progress; and I understand is still more so in every Province and State around us, wherever its pure and spotless banner has been What reason then of gratitude and future and increased obligation to offer the grateful homage of our hearts to the Giver of every good and perfect gift, who has so mcrcifully dealt with us, and to supplicate for a continuance of His great goodness. The increase of Subordinate Divisions and Members, and the general prosperity of our Order since your last Annual Meeting, afford gratifying evidence that the Lord is with us. am happy to state that I had the pleasure to place my signature to two Charters for two new Divisions, and had the pleasure to organize one of these in person, viz., Balaklava Division, No. 30, in Leeds, County Megantic. The other hails from Clarendon; and I am also happy to state the reestablishing of Chatham Division, and still have hopes of ere long the rising to life of Point Levi Division. I, like my predecessor, have to complain of the negligence of some of the D.G.W.P's in not making out their Official Quarterly Reports, for the information and guidence of the G.W.P. Those in default are the D.G.W.P.'s of Ormstown, Aylmer, St. Andrews, Lancaster, Lochabar, Clarenceville, and Point Fortune, which certainly shows great laxity of interest towards the Subordinate Divisions under their respective care. I trust a word to the wise is sufficient. I therefore call their particular attention to Art. 3, Sec. 3, page 75, By-Laws of Grand Division. The D.G.W.P.'s of Montreal, Portage du Fort, Huntingdon, Lachute, Lacolle, St. Johns, Point a Cavagnol, and Bristol, have attended to their duty in this matter, and have sent to me favourable and encouraging reports of the respective subordinate Divisions under their charge; the only complaint being the working of the new Ritual. last mentioned localities will please accept my thanks for their kind co-operation in assisting me in carrying out the working of our noble Order. I have the pleasure in announcing to you the final passage of the Act of Incorporation, (the extension of the Act for Canada West) for which petitions were laid before Parliament, and would congratulate the Order in Canada East upon the important position they occupy, and the great influence they have at command; and would take occasion to impress upon this Grand Division the necessity of the greatest caution in the use of the power they now possess, that we may convince our fellow citizens, who are not members of our Order, that we are worthy of the confidence placed in us. In obtaining this Act. I avail myself of this opportunity of bringing to the notice of this Grand Division the two gentlemen in Parliament, viz., Messrs. Cook and Hartman, who so kindly interested themselves in having this our Act brought before the notice of the Legislature. I would also beg leave to suggest the propriety of furnishing each subordinate Division with definite instructions how to proceed to make the provisions of the Act available. This could be done by a circular, embodying the necessary instructions.

I would most respectfully call the attention of this Grand Division to the condition of the Order of Cadets of Temperance, In my opinion there is great cause and necesin Canada East. sity of a greater interest for their welfare on our part. At our last meeting we had anticipated ere we should again assemble, that an Act for the prohibition of the sale of intoxicating liquors would have passed our Legislature, and shortly become the law of this province; however in this important matter we have been disappointed; it being thrown out on a point of order in its last moments before the House, after being so nobly fought for by the Temperance members. It is all for the best; it will more plainly show to the country the strength of the house on this important question. We must again buckle on the armour, and to battle It appears to my mind that at the next meeting of Parliament the petitions for the Maine Law must be innumerable, and would suggest that the petitions should define the particular be unite alcohol cease n

The Grand Scribe submitted his Report as follows, which was referred to Committees on State of the Order and Finance:

#### GRAND SCRIBE'S REPORT.

Office of the Grand Division, S. of T., of C. E. Montreal, June 20, 1855.

Officers and Brothers,

Since the last meeting of this Grand Division, two new Divisions have been instituted, viz.:—

Clarendon Division, No. 29, Instituted 21st March. Balaklava Division, No. 30, Instituted 19th April.

In regard to those Divisions reported at last Annual Meeting as having ceased working, I have but little to report. I wrote to each locality, but got no reply from any of them. There seems good hope, however, of Chatham Division, being again this summer put in working order,—and Brother Wanless of St. Andrews Division has had full powers granted to him for that purpose.

The following Divisions have adopted the degrees, been supplied with Rituals, and are now in full working order, viz.:—Howard, Montreal; St. Lawrence, Quebec; Cameron, St. Johns; Bristol, Bristol; and Clarenceville, Clarenceville; — and just before leaving Montreal for this meeting, I received an order from Aylmer Division for the necessary Books, &c., for instituting degrees there.

As this Grand Division at its last Annual Meeting, when adopting the degrees, made no laws for the uniform guidance of the Divisions using them in Canada East, I would recommend that at this session some action be taken in this matter. The Grand Division of Canada West, at its last Annual Meeting, adopted certain rules for the Degree Divisions, which this Grand Division might examine, and prepare something similar.

At the meeting of the Grand Division held in June last, Howard Division made application for the return of the money loaned by them to this Grand Division; but as the Grand Division had no funds to meet this demand, it empowered the Grand Scribe

With ard Divis butions f abled to to endeavour to raise a loan from some other Division, and pay the amount borrowed from Howard Division. Your Grand Scribe was not able to accomplish this before the Annual Meeting of the Grand Division, when the subject was again brought up, and talked over, — and the names of several Divisions mentioned, which it was then thought would grant such a loan, if application were made to them. Soon after your Grand Scribe made application to them, but found that none of them had funds at their disposal to grant the required loan.

On finding that the amount required could not be raised in the way expected, the Grand Worthy Patriarch and several of the Divisions were consulted on the subject, and they unanimously recommended that an appeal be made to the Divisions under our jurisdiction, and asked to contribute as much as they were able towards the paying off of the debt incurred at the commencement of this Grand Division, viz: the sum of Thirty pounds, which was borrowed from Howard and Gough Divisions, £15 from each. Clarenceville Division in urging this recommendation offered to contribute One pound five shillings, and had no doubt but that each Division would at least give this sum, towards so desirable an object.

On the strength of this recommendation and with the consent of the Grand Worthy Patriarch, I made this appeal to the Divisions under our jurisdiction, with the full persuasion that it would be generally responded to.

In reply to that circular the following Divisions contributed the sums opposite to their names, viz:

Lacolle Division, 25s; Clarenceville Division, 25s; Cameron Division, 25s; St. Andrews Division, 20s; Wellington Division, 15s; Lancaster Division, 15s; Victoria Division, 25s; Aylmer Division, 25s; St. Lawrence Division, 26s 6d; Howard Division, 30s; amounting to £11 11s 6d.

With the help thus afforded I have paid off the debt to Howard Division, and I am still in hopes of receiving further contributions from some of the other Divisions, so that I may be enabled to pay off the loan from Gough Division soon, and thus

free the Grand Division from a debt which, as long as it lasts, weighs heavily upon it and retards it in its useful work.

And your committee would recommend the adoption of the accompanying forms, for enabling subordinate Divisions to become incorporated by law.

Rep. P. Outterson being in waiting was introduced and initiated.

who shall have been members of the Order in good standing Six Months, shall be eligible to receive the first Degree; and that in 3 months thereafter they shall be eligible to receive the second Degree; and that in 3 months thereafter they shall be eligible to receive the third Degree. Provided, that all present members of the Order of one year's good standing shall be entitled to receive all the Degrees at one time. Application for the Degrees must be made in writing, in open Division, to the officers and members of the Degree applied for, for their decision.

Candidates for Degrees shall be ballotted for, and admitted or rejected, in the same manner by the officers and members of the Degree applied for, as candidates for initiation into the Order.

Expulsion or suspension shall operate as a forfeiture of their standing in the Degree Division, and members so forfeiting their standing shall be subjected to re-election, and re-initiation in the Degrees, the same as required by the Constitution of Subordinate Divisions.

There shall be charged and paid by the Members initiated for each Degree, the following fees, namely—for the several degrees not less than one shilling and three pence each, but that Subordinate Divisions shall be at liberty to increase the initiation fee as they please.

That the several Sub. Divisions shall elect from among their W. P. or P. W. Ps., a Prefect who should appoint the time, and confer the Degrees in order to the institution of the Degree Division.

What great reason have we to offer the grateful homage of our hearts to Him, who has in the past year been so merciful unto us!

I am happy to have to report the institution of a new Subordinate Division, the Prince of Wales, in Montreal; also the resuscitation of an all but fallen Division, which is now in good work-

From all the Reports that have reached this Office, the Divisions in working order under our jurisdiction are in as healthy and active a condition as at any time in the history of this Grand Division.

On the 25th September, another new Division was instituted in Montreal under the name of "Prince of Wales Division, No. 31."

I have also received information from the D.G.W.P., for St. Michaels, that he had succeeded in re-organizing Manuingville Division. No. 22, which had ceased working some time ago, and that the Division is now started afresh with every prospect of success.

I have also received information from Brother Wanless of St. Andrew's, that the idea of re-organizing Chatham Division has been abandoned, after using every effort to accomplish that object, and he returns their emblems to this office in part payment of the amount due by that Division.

The proceedings of the 12th Annual Session of the National Division came to hand since last meeting, and copies have been forwarded to our Subordinate Divisions.

There are no alterations to the Constitutions to report this time, in consequence of a Committee having been appointed to take into consideration all the necessary alterations and additions suggested and required, and who are to report at next Annual Session.

In reply to communications sent from this Grand Division,

1st, Asking a change of Art. 8, Revised Rules; so as to permit resignation to take immediate effect, instead of at the end of the quarter.

The Committee of N. D. to which this was referred, Reported as follows, viz:—

"That the object of said rule is twofold; first, to have control over the conduct of a member, so long as he may have the password; and second, that a bother hastily resigning under the influence of momentary feeling may have an opportunity to withdraw his application. "Your Committee see no sufficient reason to alter the rule, and ask to be discharged from the further consideration of the subject." Agreed to...

2nd, Our communication asking the privilege of using the old B.B. along with the new Ritual.

The Committee to whom this was referred, reported that they deemed it inexpedient to take any action on these subjects at this time, and recommended that the subject be dismissed, which was agreed to.

These are the only items from the N. D. proceedings necessary for me to notice here at this time.

Since the Act of Incorporation and necessary forms were printed, several Divisions have availed themselves of the privilege, and become incorporated.

Annexed are the financial statements of this Grand Division since last meeting, and I have to congratulate you on the appearance of the same. It is with pleasure I have to inform you that both loans, which have so long weighed heavily upon us are now paid off. You will see by the list of balances (p. 20) of National Division proceedings, 12th Session, that the Grand Division of C, E. is one of five which stood clear on their books at that time. All the debts due by this Grand Division are paid off, and you are now in a position to take a fresh start in the advancement of our noble cause.

The Committee on the Good and Welfare of the Order, to whom have been submitted the Reports of the G.W.P. and G.S. beg to

#### REPORT:

That it is with sincere regret that your Committee notice the absence of the G.W.P. through indisposition. His urbanity, vivacity and sterling character would have materially added to the interest of our Session, and the Committee express a hope that so valuable a laborer in our great enterprise may not long be obliged to desist from active duty in consequence of physical indisposition, but speedily resume his position of usefulness and honor.

The Report of the G.W.P. contains several topics for grave consideration. The general state of the Order throughout your jurisdiction is healthy and progressive. New Divisions have been established, but your Committee feel it due to the interests of our Association to intimate that in their opinion much more ought to be done for the conservation of existing Divisions and for the establishment of many more. Intemperance lamentably prevails, and a greater degree of responsibility rests upon the Sons of Temperance, in consequence of the discontinuance in many places of those Societies which for many years kept in activity the temperance element. Your Committee would suggest for the good of the Order and for the resuscitation of the temperance cause, that whenever it can be done, public temperance meetings should be held—the pledge presented, and invitations given to union with one of the existing Divisions, or recommendations to locate new ones. For what has been done your Committee see reason for gratitude to God, who has given his blessed sanction to our operations, and as our chief dependence is on His divine presence and aid, so they pray for his countenance, approval, and direction.

That part of the G.W.P. s report, which refers to the order of Cadets deserves special attention. These juvenile associations were calculated to be highly beneficial to the youth of our country and their cessation in any place is much to be deplored. But your Committee fear that at the present time there does not seem to be a probability of the restoration of the Order to a state of efficiency. Yet Sons of Temperance can never cease to feel a lively interest in the deliverance of the youth of Canada from the dreadful evils arising from the liquor traffic and the drinking customs of the country; your Committee hope, that where there seems no likelihood of resuscitating or establishing the Cadets, a very vigorous and kindly effort be made to enlist the young under the banner of Tectotalism, that they may soon fill up our Division rooms, and in after life be efficient instruments for good. In them is our hope!

The efficient manner in which the G.W.P. has discharged his duties, deserves the commendation of this Grand Division, and our hearty thanks, and it is the prayer of the Committee that he may long be spared to benefit the order by his counsels and experience.
